Subject: Action Needed: Upgrade to DataInterchange Version 3.1

Effective January 31, 2001, IBM will discontinue program services for the following programs licensed under the IBM Customer Agreement as announced in Withdrawal Announcement 999-275, dated September 21, 1999:

## **Programs Affected**

DataInterchange/MVS-CICS Version 1	5695-076
DataInterchange/MVS-CICS Version 2	5655-A19
DataInterchange/MVS Version 1	5685-036
DataInterchange/MVS Version 2	5655-A18

It is imperative that current customers with DataInterchange Version 1.5 or Version 2.1 upgrade to the current level, Version 3.1, to continue receiving technical support after January 31, 2001. To upgrade and migrate successfully, we suggest you order Version 3.1 **today**, and begin migration and testing prior to production. Do not wait until the last minute!

## Program upgrade and migration details

The replacement products for the discontinued programs listed above are:

DataInterchange/MVS 3.1	5655-B29
DataInterchange/MVS-CICS 3.1	5655-B30
DataInterchange Client 3.1	Now included in Host Package

The replacement products were announced in Software Announcement 298-393, dated October 13, 1998.

#### **Direct customer support**

Installation and technical support from IBM Software Services and Support (SSS) will be withdrawn by January 31, 2001. In addition, the question submission function under IBMLink<sup>™</sup> Ask Questions — Support for the programs will be withdrawn by January 31, 2001. The IBMLink ServiceLink library of answered questions and other technical information for the programs remain available.

DataInterchange V3.1 is available and can be obtained by calling IBM at 1-800-IBM-CALL or 1-800-426-2255. (For more information, see "Ordering information" on page 3.) This version is a replacement for previous versions and releases of DataInterchange and has the following enhancements.

## **Enhancements included in DataInterchange V3.1**

- SAP status records extracted during translation
- MQSeries message queuing support
- DataInterchange Client is updated for 32-bit architecture and is included in the host package
- Expanded EDI control number assignment option
- Reduced trading partner setup
- Event log conversion into a DB/2 table
- Pageable translation for memory optimization
- · Envelope profile export and import from received maps
- "Where-Used" on data format fields
- Standards compliance checking

## DataInterchange interoperates with SAP R/3 System

DataInterchange (Version 2.1 and Version 3.1) has been certified by SAP AG/SAP America to interoperate with the R/3 System via a standard interface. Additional function is included in Version 3.1 to enhance the interface to SAP by improving status processing.

## DataInterchange V3.1 license charge changes

DataInterchange V3.1 is available via a monthly license charge (MLC). Primary License Charges (PLCs) and Annual License Charges (ALCs) are no longer available. MLC charges are slightly higher than previous versions to reflect several changes including packaging of the DataInterchange Client with the host, the changes in the IBM software pricing structure, and the new enhancements to DataInterchange. Customers currently on Monthly License Charges (MLC) will be billed at the new MLC. Customers currently on Primary License Charge/Annual License Charges will migrate to Monthly License Charges (MLC). #### **Migration considerations**

## DataInterchange V3.1 migration from V2.1 and V1.5

Support Services are available until January 31, 2001 to customers with currently installed DataInterchange/MVS and MVS/CICS V2.1 and V1.5 software that can migrate directly to DataInterchange V3.1. Upgrading is recommended to benefit from the new features combined in this product.

#### Installability

DataInterchange V3.1 replaces previously available DataInterchange releases and can be installed directly from either V1.5 or V2.1. Authorized program analysis reports (APARs) for DataInterchange V1.5 and V2.1 will be accepted up to the respective dates of discontinuance.

Customers using DataInterchange/MVS V1.4 release need to order and install DataInterchange V1.5 to include technical enhancements necessary to install DataInterchange V3.1. Following the testing and implementation of DataInterchange V1.5, customers need to order and install DataInterchange V3.1 and discontinue DataInterchange V1.5.

Customers using DataInterchange V1.3 need to order and install DataInterchange V1.5 (refer to the V1.5 *Installation Guide*) to include technical enhancements necessary to install DataInterchange V3.1. Following the testing and implementation of DataInterchange V1.5, customers need to order and install DataInterchange V3.1 and discontinue DataInterchange V1.5. DataInterchange V1.5 and V2.1 are available for ordering only to the currently installed DataInterchange customers for migration purposes only.
