This new extension will not be compatible with the ODBC connection that Director configures at setup.	Do NOT upgrade Microsoft Access to 2007 or 2010. Only Microsoft Access 2000 and 2003 are supported in this release
Mailbox Wizard Help button does not activate Help when the Mailbox Wizard is started through EDI Manager.	When using the Mailbox Wizard from the EDI Manager, activate Help by pressing the F1 key.
