Application Integration provides you with the tools you need to develop maps that translate:

- Your application files to an EDI standard format for documents you send to your trading partners (outbound mapping)
- An EDI standard format to your application format for documents that you receive from your trading partners (inbound mapping)
- An EDI standard format to another EDI standard format and an application format to another application format.

We believe that you will find this software and the supporting materials easy to use and directly beneficial to your business.

What's in This Manual

Assumptions

This manual assumes that you are familiar with using a PC and with Microsoft® Windows functions, including the terminology used to describe:

- ▶ Mouse and cursor actions.
- ▶ Windows-specific attributes, such as dialog boxes, icons, windows, and buttons.

This manual also assumes that you are familiar with your internal application format, data mapping concepts, and the GENTRAN:Server for UNIX or Workstation product.

Introduction

This chapter introduces you to mapping and the Application Integration subsystem.

Term	Description
compile	The process used to convert a map into a translation object.
DDF (Data Definition Format)	A file that defines a file format used in a map. It includes the hierarchical and looping structure of the data, the map objects and the attributes of the objects.
links	The visual lines that connect each field on the input side of the map to a field on the output side of the map.
loop	A mapping structure in which the records or groups repeat in sequence until either the group data ends or the maximum number of times that the loop is allowed to repeat is exhausted.
map	A file object that defines the corresponding relationship between document components in two different formats.
map version	The incremented number that indicates the rendition of the map. A lower number represents an earlier version; a higher number represents a later version.
translation object	A file containing information that instructs the translator how to convert a file from one format to another. When you compile a map you created, the result is a translation object.

Introducing Mapping

Maps

Definition A map defines a set of relationships between document components in two different data formats. You define maps in the GENTRAN:Server Application Integration subsystem.

Input and output files The input format and the output format can define the components of an:

- ▶ EDI standard file
- ▶ Application file with fixed-length fields
- ▶ Application file with variable-length fields
- ▶ ODBC file (if you have the ODBC translation option)
- ▶ XML file (if you have XML translation option)

Basic map types These are the basic types of maps:

Map type	Defines the relationship between components of a document in...
standard-to-application	Standard format and an application file format.
standard-to-standard	Standard format and a different standard.
application-to-standard	Application file format and a standard format.
application-to-application	Application file format and another application file format.

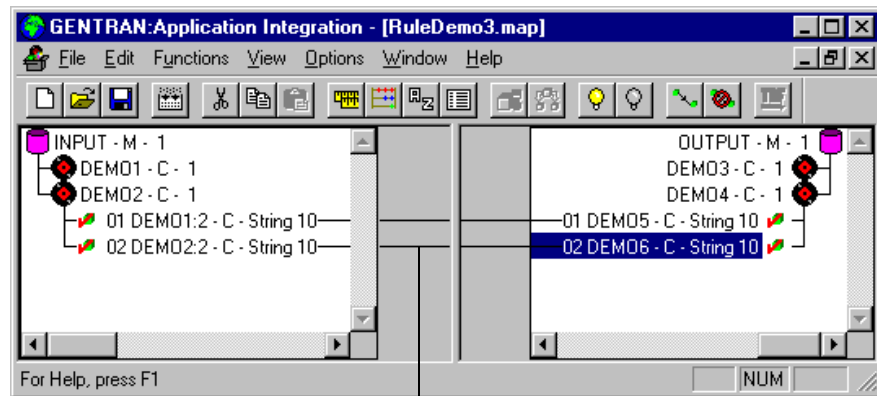

Mapping links

Mapping links are the visual lines that connect each field on the input side of the map to a field on the output side of the map. The default setting is to hide the links. You can choose another default display setting on the Links tab of the Application Integration Preferences dialog box.

Mapping operations

Mapping operations are sets of directions you attach to a mapping component on the input or output side of a map. Mapping operations include:

- ▶ simple or complex calculations
- ▶ constant values to load in a document
- ▶ qualifying relationships.

You attach mapping operations to a mapping component with either a Standard rule or an Extended rule.

Translation Objects

Definition A translation object is a set of rules that instructs the translator how to convert a file from one format to another, such as from an application format to a standard format. You can use the same translation object on any platform that GENTRAN:Server supports.

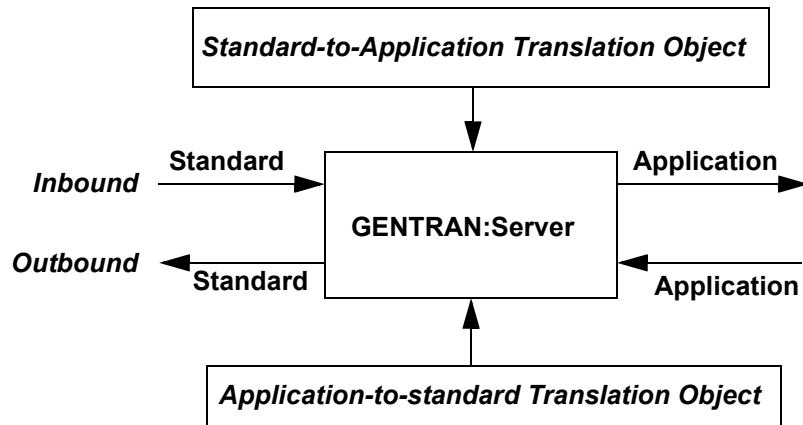
Relationship to a map A map is the source file of a translation object.

To transform a map into a translation object, you must compile the map. Compiling changes the information in the map into a set of instructions that the translator understands.

Where compiling takes place The compiler is part of the mapper and resides on your client or PC workstation machine. You compile maps on the client machine if you have GENTRAN:Server for UNIX or on your workstation if you have GENTRAN:Server Workstation.

The Translation Process

Diagram This illustration depicts the translation process for inbound standard-to-application and outbound Application-to-standard processing.



Data Definition Format (DDF)

Introduction A Data Definition Format (DDF) is a file that defines a file format used in a map. You can use a DDF to define your application, proprietary standard, and XML formats to GENTRAN:Server.

Contents A DDF includes the hierarchical and looping structure of the data, key field relationships, the map objects (groups, records, fields, etc.), and the attributes of the objects (names, descriptions, data types, etc.).

Format DDF files are expressed in XML.

Saving a file definition as a DDF If you have a map with a file format already defined, you can save the file format of the selected side of a map as a DDF file. This enables you to use it in another map.

When you save a side of a map as a DDF file, the system uses the GENTRAN:Server DDF Document Type Definition file, GENTRAN_DDF.DTD, to define the format structure of the DDF. The information in the GENTRAN_DDF.DTD file for storing a side of a map as a DDF includes which elements are required, how they are arranged, and which elements they can contain.

The GENTRAN_DDF DTD file is automatically installed on your system during the GENTRAN:Server installation process.

Using a DDF in a map

To use a DDF file in a map, you can either:

- Load an existing DDF and modify it to define a new data format for the input or output file format in a new map.
- Use the Open File Definition function to replace the input or output side of a map with a previously-defined file definition.

DDF restrictions

When you use a DDF in GENTRAN:Server, these restrictions apply:

- Generally, the DDF does not contain standard or extended rules, links, or any other map information that does not specifically relate to the file format. The one exception to this rule is the use of code lists and constants. If the map references a “Use codelist” standard rule on a field and instructs the system to raise a compliance error if the code is not found in the code list, GENTRAN:Server saves the standard rule and the associated code list. When you save the input or output side of a map as a DDF, the system saves code lists and constants defined in the map to the DDF.

- To use a DDF with GENTRAN:Server, you must have the Microsoft XML Parser installed. You can obtain the XML Parser by installing the latest release of Microsoft’s Internet Explorer. If you do not have the XML Parser installed, GENTRAN:Server cannot support DDFs and will not display DDF as an available option.
- GENTRAN:Server assigns acceptable default attribute values to objects when the DDF does not include the attributes.

Example

If you do not specify a value for Minimum Length, the system assigns zero.

Positional Application File Definition Map Components

Introduction

If the input or output of your map is an application file, you must define your application to the GENTRAN:Server Application Integration subsystem. Your application file definition must contain all the information that you need to extract from your partner's document (if the map is for inbound processing) or to send to your partner (if the map is for outbound processing), so that your system can accurately process the data.

Your application file has either:

- Fixed-length fields (positional format) or
- Variable-length fields (delimited EDI format).

This topic describes the map components for positional application file definitions.

Reference

If your application file has variable-length fields, you must define your application in delimited EDI format. See [Standard and Delimited File Definition Map Components](#) for a description of the components of an application file in delimited EDI format.

Map components





Positional file definitions contain three basic map components. Each is represented by an icon in the Application Integration subsystem.

- groups
- records
- fields

Map icons

This table lists the icons that visually represent the map components of a positional application file definition.

Icon	Description
	A positional file definition is the primary node in the file structure. All other components are subordinate to it.
	A group is a looping structure that contains related records and groups. “Looping” means that the records or groups repeat in sequence until either the group data ends or the maximum number of times that the loop is allowed to repeat is exhausted. Nested looping structure A group that is subordinate to another group is a subgroup . This corresponds to a nested looping structure – a loop within a loop.
	A record contains a collection of related fields. A record can occur once or can repeat multiple times.
	A field is the smallest piece of information defined in the application file definition. A field is the application map component that you map (link) to a corresponding field to show the input and the corresponding output when the data is translated. Note When a field has a mapping operation or link performed against it, the system displays a red check mark over the field icon.

Standard and Delimited File Definition Map Components

Introduction

The file format for standard file definitions and application file definitions with variable-length fields is **delimited EDI**. The file definition must contain all the information that you expect to receive from your trading partner (if the map is inbound) or need to send to your partner (if the map is outbound), so that your system can accurately process the data.

The specific standard map components that you use depend on the type of map you are creating.

Standard file definitions

If the input or output of your map is a standard file, there are three possible ways to create the file definition:

- Define the file to GENTRAN:Server.

If you want to use a specialized (proprietary) version of a standard that is not available in the GENTRAN:Server standards database, you must define the standard file definition yourself.

- Have the system generate the file definition for you and accept all its components.

If you select a standard for the input or output side of a map, the Application Integration subsystem generates a standard file definition for you. The system bases the file definition on the standard (agency), version, and transaction set, and, for a TRADACOMS standard only, the release you select when you create your map. The system includes all the groups, segments, composites, and elements that the standards agency defined for the version of the document you selected.

- Have the system generate a file definition for you and then customize it.

If you are creating an application-to-standard or standard-to-application map, you probably need to customize the system-generated standard file definition. You can modify the properties of the map components and use specialized GENTRAN:Server functions to manipulate the standard file definition structure.

The EDI standards define groups. Nested looping structure A group that is subordinate to another group is a subgroup . This corresponds to a nested looping structure – a loop within a loop.
	A segment contains a group of related elements or composite data elements that combine to communicate useful data. The EDI standards define segments. A segment can occur once or can repeat multiple times. (Continued on next page)

(Contd) Icon	Description
	A composite is a data element that contains two or more component data elements or subelements. The EDI standards that use them (EDIFACT, TRADACOMS, and certain ANSI X12 standards) define the composites.
	<p>An element is the smallest piece of information defined in a standard. An individual element can have different meanings, depending on the context. For this reason, elements usually do not have useful meaning until they are combined into segments.</p> <p>An element is the delimited EDI map component that you map (link) to a corresponding field on the opposite side of the map to show the input and the corresponding output when the data is translated.</p>

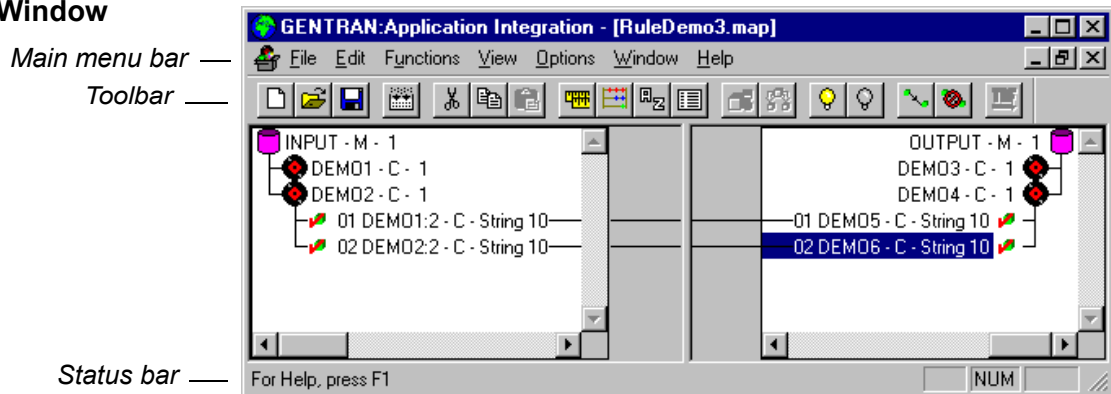

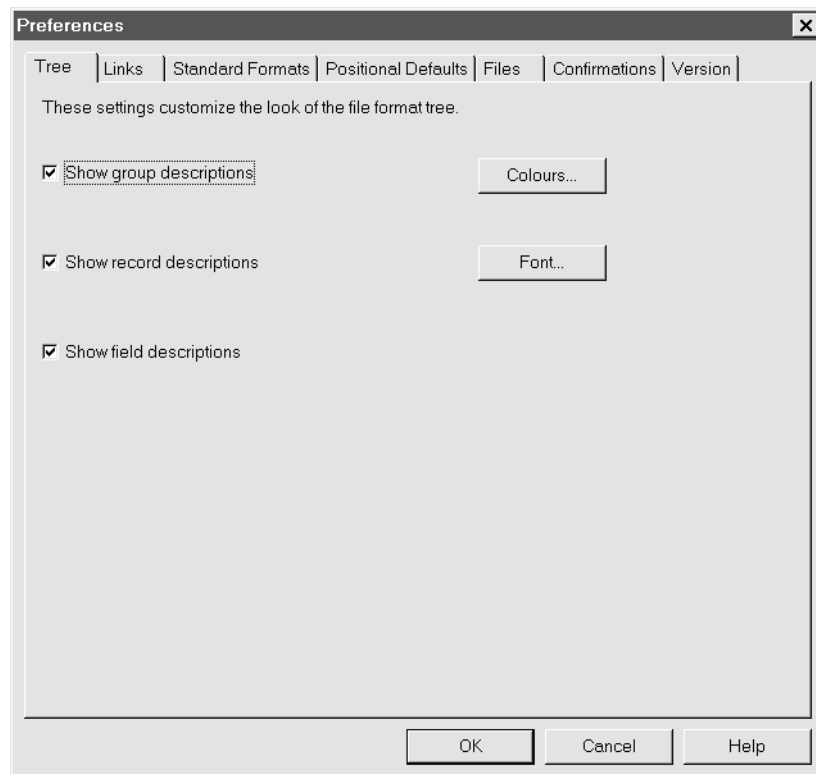

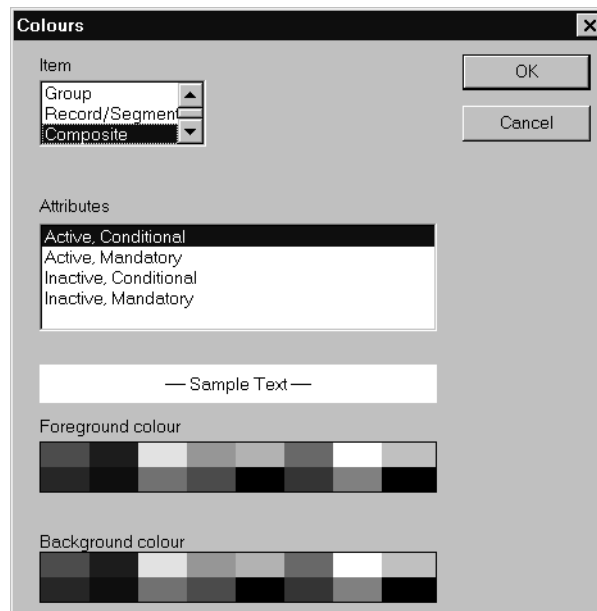

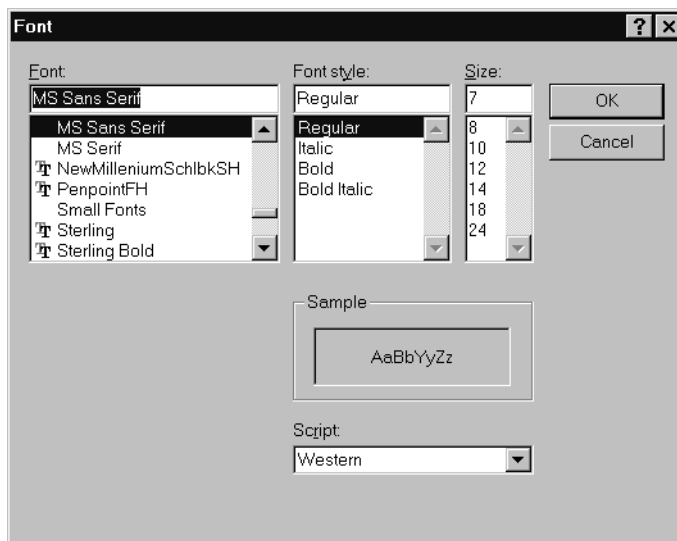

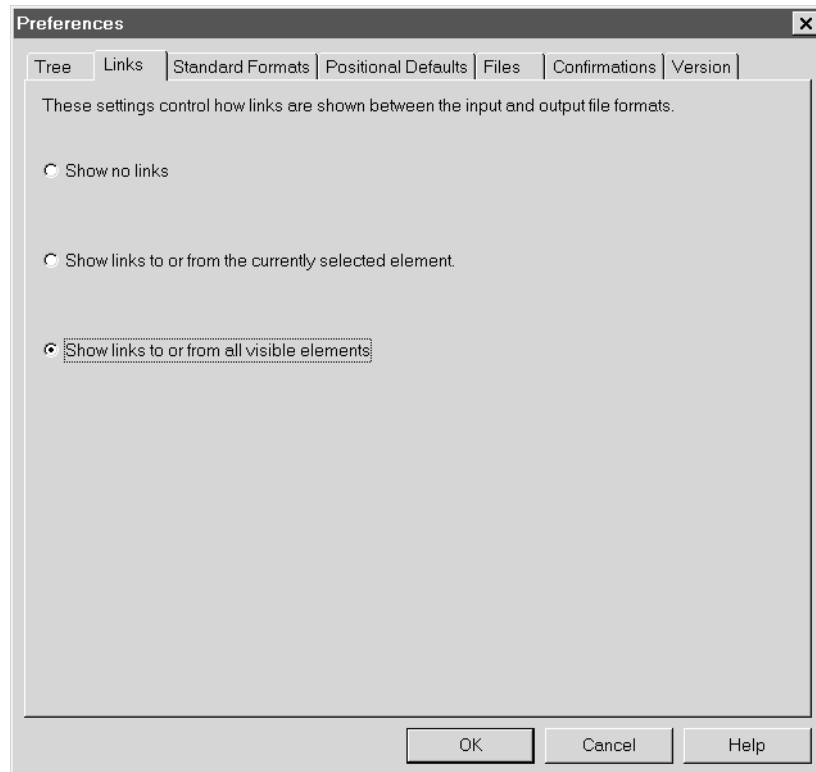

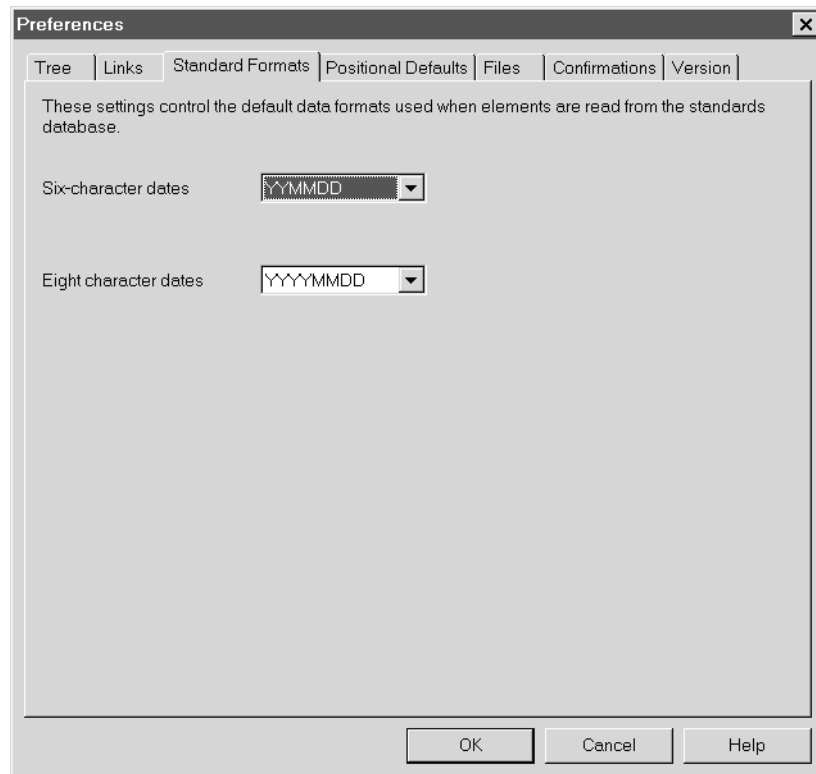

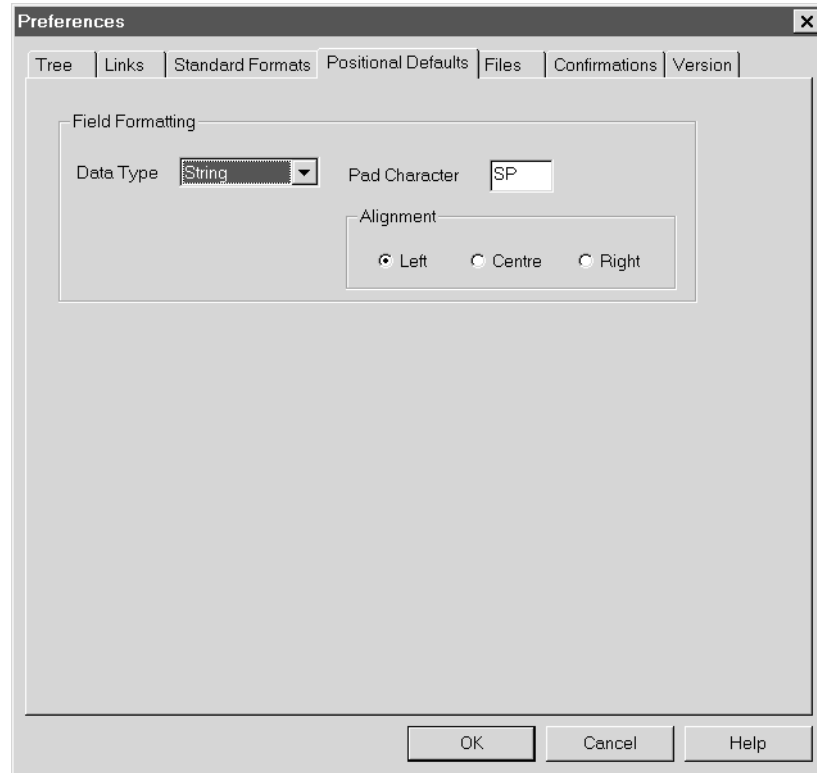

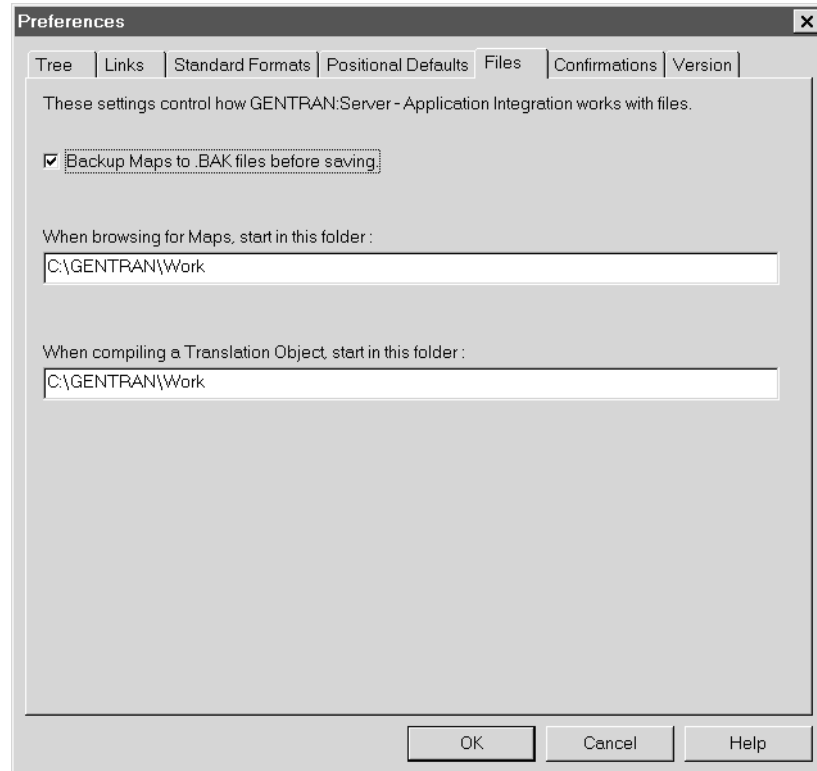

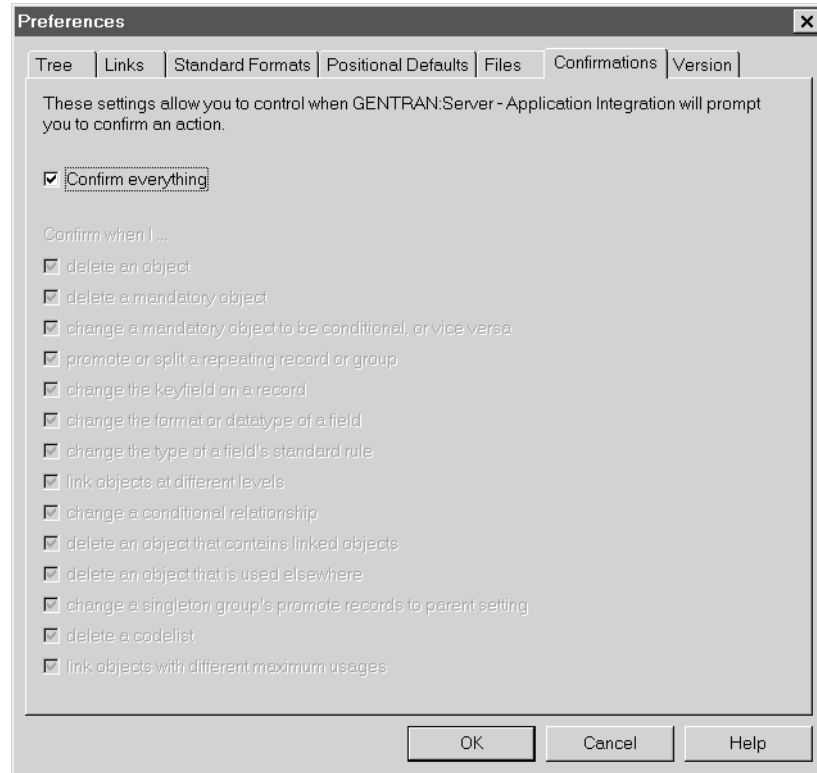

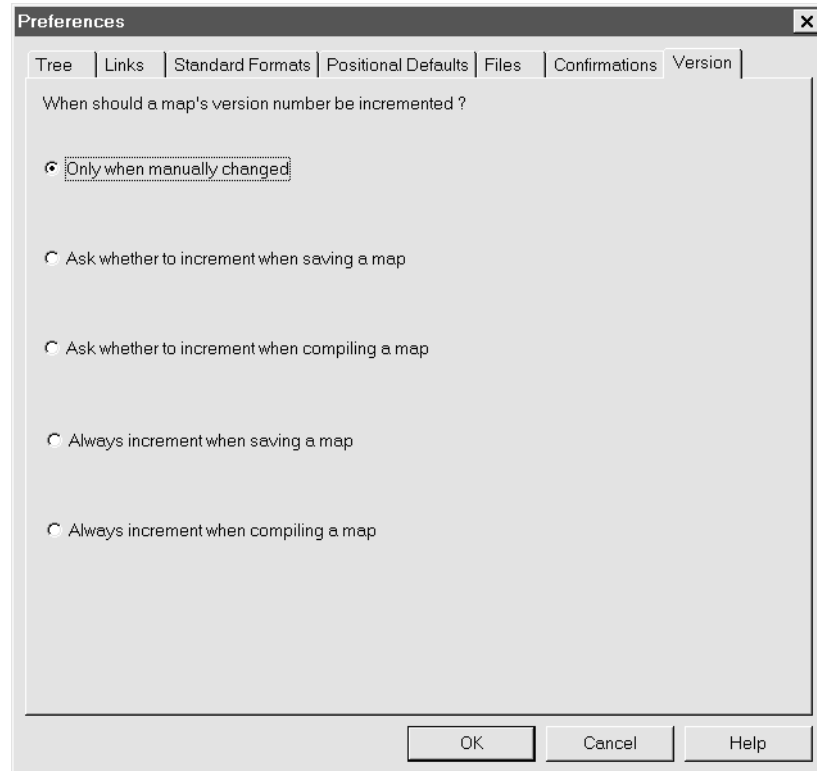

How to Customize Global Fonts

Introduction

The Font feature enables you to change the font that is used in the display of all maps. The default font that GENTRAN:Server uses is MS Sans Serif 9 point.

You can change the font type, style, and point size. This gives you the flexibility to shrink the font if you need to view more of the map on your monitor, enlarge the font, or change the type and style so that it is easier for you to read.



How to Customize the Auto-increment Map Version

Introduction You can configure Application Integration to automatically increment the version number of a map when you save or compile a map.

Options This list describes the available options for automatically incrementing the map version number.

- ▶ Only when manually changed
- ▶ Ask whether to increment when saving a map
- ▶ Ask whether to auto-increment when compiling a map
- ▶ Always auto-increment when saving a map
- ▶ Always auto-increment when compiling a map


Limitations The auto-increment function updates the minor (point) version number of the map on the Translation Object Details dialog box, from .1 up to .255. If the point version number exceeds .255, the system updates the point version number to zero and increases the major version number.

Example

The system increments version number 1.254 to 1.255 and increases 1.255 to 2.0.

How to Analyze the Standard File Format

5	List the map components that you need to activate. Note You must activate all segments that you expect to receive from a trading partner, even if the segments are not mandatory.

How to Correlate the Formats

Introduction After you have analyzed your input and output file formats, you must correlate the formats.

How to Manually Activate EDI Standard Map Components

Introduction

When GENTRAN:Server generates the EDI standard sides of the map, the system includes and activates all the groups, segments, composites, and elements that the standard agency defines as mandatory for the document version you specified. You cannot deactivate mandatory groups, segments, composites, and elements.

During translation, the system processes only the components that are activated. Therefore, you must activate the non-mandatory groups, segments, composites, and elements to use them in your map. **You must activate all segments that you expect to receive from your trading partner, even if the segments are not mandatory.**

Tip


As an alternative to activation, you can use the Auto Trim feature if you have a sample EDI standard file defined.

How to Automatically Activate Standard Map Components

Introduction

Instead of activating map components manually, you can use the Auto Trim feature to modify the EDI standard side of the map to match components in a sample EDI standard file that you select.

The Auto Trim feature examines the sample EDI standard file and then activates and deactivates map components on the EDI standard side of the map so that the two files match.

Before you begin

- ▶ You must create the sample EDI standard file and save it as a file definition (with a .DDF file name extension) before using Auto Trim.
- ▶ Make sure that the sample EDI standard file uses the same standard, version, and transaction set (message) as the map that you want to Auto Trim.
- ▶ In addition, make sure that the file does not contain envelope segments.

Caveats

To use Auto Trim, you must define the Segment and Element Delimiters. If you do not supply the Tag Delimiter, the system substitutes the Segment Delimiter. If you want to use composite elements, you must specify the Sub Element Delimiter. If you want to use release characters, you must specify the Release Character.



Defining a Fixed-Format Application File

Introduction

If a side of your map is an application format, you must either define your application format to GENTRAN:Server or load a saved file definition. Your application file format or definition must define all the information that you need to extract from your partner's document (if the translation is inbound) or send to your partner (if the translation is outbound).

Component organization

The system arranges each map component sequentially in the order that it is most logical for the system to process. Groups contain related records or subgroups. The records contain related fields.

You must create each level of your application file definition sequentially, so plan to create the groups, subgroups, and records before you create the subordinate fields in your fixed-format file definition.

WARNING

Do not map to the control numbers.



Trading Partnership code

If you want the system to look for the Trading Partnership code in the file, you have two options:



How to Create Fields

Introduction

Each record you create contains a group of logically-related application fields. These fields define the structure and content of the data to the system.

The easiest way to add application fields to a record is to use the Positional Field Editor, because it allows you to add multiple fields. Generally, you create the fields for the first record in the application file definition, and then proceed with each sequential record.

If you have only one field to add, you can use either the Create sub field or the Insert Field functions.

Recommendation

Do not define fields with the purpose of using the field to explicitly contain the record tag. This is because the system takes the tag that you define in the record into account when the automatic sequencing (Auto Position) feature is used. We recommend that you define the record tag on the Positional Record Properties dialog box.



Defining a Standard File Format or Variable-Length Application File

Overview

Introduction

The procedures for defining a standard file format and for defining a variable-length application file are similar. Both are based on a Delimited EDI syntax.

EDI standard format

When you create a map and specify that the input or output side is a standard format, GENTRAN:Server generates the EDI standard file format for you, based on the standard (agency), version, transaction set, and release you selected. The system includes all the groups, segments, composites, and elements that the standards agency defines for the version of the document you selected.

If you want to use a specialized version of a standard, you may have to define the EDI file to GENTRAN:Server. One way to define a proprietary standard is to customize a system-generated EDI standard file format. You can:

- ▶ change the properties of the map components
- ▶ use the Promote, Split, Copy, Cut, and Paste functions to define looping structures.

Variable-length application format

If the fields in your application format are variable-length rather than fixed-length, and you do not have a file definition, you must create a new data format, basing your application syntax on delimited EDI format.

When you create a new data format for your variable-length application file, you select **Delimited EDI** as the data format syntax and set the field separator (delimiter) in the map. The specific map components that you add use depend on the type of map you are creating.

How to Verify and Set Delimiters

Definition Delimiters are flags that you define to the system as separating specific variable-length application file components.

Note

Delimiters are also used to separate components in standards files. You set the delimiters for standards in the Trading Partnership record.

Why delimiters are used

You must use delimiters for all application file definitions with variable-length fields. This is because the system compresses the data, removing the leading zeroes and trailing blanks. Since the fields vary in length, the system needs a flag to determine where one element ends and another begins. An element delimiter marks the beginning of a new element.

Reason for verification

If you are using a variable-length application file definition that contains composite elements or subelements, you must verify that GENTRAN:Server is specifying the correct delimiters so that your data is processed correctly.

New lines vs. streamed format


The **Stream segments** option on the Delimiters tab of the File Properties dialog box controls the format of output segments.


If you do not select this option, each segment ends with the segment terminator followed by a carriage return or line feed. This is the expected format for non-EDI standard data, such as variable-length application files.

If you select this option, each segment follows another, without a carriage return or line feed to separate them. This is the expected format for EDI standard data. This is the default when you choose delimited EDI as the output format.



How to Modify Group Properties

Introduction A group contains related segments and/or groups that repeat in sequence until either the group data ends or the maximum number of times that the loop is allowed to repeat is exhausted. If you create a group that is subordinate to another group, this corresponds to a nested looping structure (a loop within a loop).

Procedure Use this procedure to modify the properties of a group.

Step	Action
1	<p>Right-click the group you want to modify and select Properties from the shortcut menu.</p> <p>System Response The system displays the Group Properties dialog box (Name tab displayed by default).</p> 
2	<p>If you want to modify the group name, in the first box on the Name tab, type the new name.</p> <p>Note Do not use spaces or dashes (-) in the group name. You can use the underscore (_) to separate words.</p> <p style="text-align: right; color: red;">(Continued on next page)</p>

(Contd) Step	Action
3	<p>Do you want to modify the group description?</p> <ul style="list-style-type: none"> ▶ If YES, type the new description in the second box on the Name tab. ▶ If NO, continue with the next step.


How to Modify Segment Properties

Introduction You can modify the properties of any segment, including the minimum and maximum number of times the segment can repeat, whether the segment is mandatory or conditional, and whether it is a loop start or loop end segment.

How to Use Loop Start and Loop End Segments

Introduction

Certain EDI standards use Loop Start (LS) and Loop End (LE) segments. LS and LE segments differentiate between two or more loops of the same type. If the transaction contains LS and LE segments and depending on whether your map is inbound or outbound, you need to define the LS and LE segments for the loops you are using in the map in one of two different ways.



Tip

You need to communicate with your trading partner to determine which loop identification code your partner sends you (for an inbound map), or expects to receive (for an outbound map).



How to Modify Composite Properties

Introduction A composite is a data element that contains two or more component data elements or subelements. You can modify the composite name and description, and whether or not it is mandatory.

Note

Composite elements are used only in EDI standard maps.

Procedure Use this procedure to modify the properties of a composite.

1	<p>Right-click the composite you want to modify and select Properties from the shortcut menu.</p> <p>System Response The system displays the Composite Properties dialog box.</p>  <p>(Continued on next page)</p>

2	<p>If you want to change the composite name, type the data element identification number in the first box on the Name tab.</p> <p>Note If a composite occurs more than once in a map it is identified by its name <ID>. The second and subsequent occurrences are identified by <ID>:n, where n is the number of the occurrence in the map.</p>
3	<p>If you want to change the composite description, type the new description in the second box on the Name tab.</p>
4	<p>Select the Validation tab if you want to specify that the composite is mandatory.</p>
5	<p>Select the check box on the Validation tab to indicate whether this composite must be present.</p>
6	<p>Click OK to save the changes to the composite.</p>


How to Modify Element Properties

Introduction

Each segment or composite contains a group of logically-related elements. These elements define the structure of the EDI standard data that your system needs to process the document.

Procedure: modifying element properties

The name is typically the element sequence number. ▶ If NO, continue with the next step. <p>Note If an element occurs more than once in a map, the system identifies the first occurrence by the element's name <ID>. The second and subsequent occurrences are identified by <ID>:n, where n is the number of the occurrence in the map.</p>
3	<p>Do you want to change the description of the element?</p> <ul style="list-style-type: none"> ▶ If YES, type the new description in the second box on the Name tab. ▶ If NO, continue with the next step. <p>Tip Use the description to provide a brief explanation of the element so that you can differentiate it from similar elements.</p>
4	<p>Do you want to change the validation options?</p> <ul style="list-style-type: none"> ▶ If YES, select the Validation tab and continue with the next step. ▶ If NO, GO TO Step 13.
5	<p>Do you want to designate the element as mandatory (must be present)?</p> <ul style="list-style-type: none"> ▶ If YES, select the first check box on the Validation tab. ▶ If NO, continue with the next step.

How to Define and Modify Relational Conditions

Introduction

You can use relational conditions to connect fields together for syntax or compliance reasons. For example, assume that Field A is invalid unless Field B is present. If you set up a condition that pairs Fields A and B, the system generates a compliance error if one of those fields is not present.

You can also view the conditional relationships between elements, as the standard provides.


Warning

Though the system allows you to edit EDI conditional relationships, it generates a compliance error when you do edit them. We recommend that you only view EDI conditions.

Procedure

Use this procedure to define, modify, and view field and element relational conditions.

Structuring Your Map

Overview

Introduction

This section describes how to structure your map by:

- mapping or linking components on the input side of a map to components on the output side
- creating repeating groups of related segments (loops).

In this section, you learn how to use the:

- Cut, copy, and paste functions to create a loop
- Promote function to extract one instance of a group or repeating record
- Split function to break a group or repeating record into two loops
- Equalize function to make the size of each map side the same.

Links

The Link function enables you to map a field from the input side of the map to a field on the output side of the map. The link between two map components (hereafter referred to as fields) is visually represented with a line connecting the two fields.

Loop

In many documents, related segments are grouped to convey a complete piece of information. For example, a company name, street address, city, state, zip code, and contact name form a complete business mailing address. If the group of related segments can be repeated, it is called a loop.

In a GENTRAN:Server map, a loop is a group of related records or subgroups that repeat in sequence until either the data ends or the maximum number of times that the loop is allowed to repeat is exhausted.

You can create loops in your input or output format to represent repeating units of data.

(Continued on next page)

Nested loop

A nested loop is a loop within another loop.

Example

When you create a group that is subordinate to another group, you create a nested looping structure (a loop within a loop).

How to Create Simple Links

Introduction The Link function is used to map a component on the input side of a map to a component on the output side of the map.

Notes


You must have at least one direct link to every record on the output side of the map, so the translator can create the record.

If you need to link two input fields to the same output field because of conditions established in your map, you must use an extended rule.

WARNING

Do not map to the control numbers.

Procedure Use this procedure to link two fields.

Step	Action
1	From the Functions menu, select Link .
2	Select a field on the input side of the map. System Response The cursor changes to a Link Arrow: 
3	Select the field on the output side of the map that the data from the field selected on the input side of the map is mapped to. System Response A line connects the two fields to visually represent the link. Note If a line does not appear when the two fields are linked, check the Preferences dialog box. Reference See How to Customize the Display of Links in the <i>GENTRAN:Server Getting Started Guide</i> for more information. On the Links tab of the Preferences dialog box, you should specify Show all links possible.

How to Copy, Cut, and Paste Components

Introduction The Copy, Cut, and Paste functions move information in the map. You can cut or copy a single map component (loop, record, or field) and paste it in another location in the map. You can also cut, copy, and paste a map component from one map to another.

Note

The map component you paste must be a valid component for the format. If you cut or copied an ODBC component, you can paste that component only into the ODBC side of a map. Conversely, if you cut or copied an application component, you can paste that component only into the application side of a map.

When to use Use these functions to create nested looping structures.

Information retained Copied map components retain all the information of the original map component. If the copied map component contains subordinate map components, such as subordinate fields, the system copies the subordinate map components, too.

Procedure Use this procedure to cut, copy, and paste a map component.

Step	Action
1	Select the map component that you want to cut or copy.
2	From the Edit menu, select Copy or Cut . System Response The Application Integration subsystem places the map component on the Clipboard.
3	Do you want to paste the component into another map? <ul style="list-style-type: none"> ▶ If YES, open the map you want to modify. ▶ If NO, continue with the next step. <p style="text-align: right; color: red;">(Continued on next page)</p>

(Contd) Step	Action	
4	Select the map component that you want the cut or copied selection pasted <i>after</i> . Note Make sure that the component you are pasting is valid for the side of the map. You can paste an ODBC component into the ODBC side of a map, but you cannot paste it into the application side of a map.	
5	Click Paste on the Main Toolbar to paste the map component from the Clipboard to the map. System Response	
	IF the map component is...	THEN the system...
	a group	prompts you to specify whether you want the contents of the Clipboard pasted as a child (subordinate) of the group or pasted at the same level as the group.
not a group	pastes the component into the map.	
6	Did you receive the prompt in Step 5? ▶ If YES, select the appropriate option and click OK . ▶ If NO, you are finished.	

How to Promote Groups and Repeating Records

Introduction The Promote function extracts one iteration (instance) of a group or repeating record. This enables you to map unique data from your application file definition or enter a specialized definition. GENTRAN:Server specifies that only one-to-one (no loops) or many-to-many (loop) mapping relationships are valid.

Promote vs. copy vs. split You can use the Copy, Cut and Paste functions to accomplish the same task. If you use Copy, Cut, and Paste, you must change the number in the **Maximum usage** box.

Depending on the circumstances, you can also use the Split function to extract one iteration.

Outbound Example

In this example, your application file definition contains:


- ▶ a Ship To record that groups all the shipping information, and
- ▶ a Bill To record that groups all the billing information.

Your Ship To and Bill To records both occur only once in the application. The EDI standard file contains a N1 group (for ANSI) or a NAD group (for EDIFACT) that repeats 200 times. If the Entity Identifier Code of the N1/NAD is BT, that means the N1/NAD group contains billing information. If the Entity Identifier Code is ST, the N1/NAD group contains shipping information.

Example Procedure

This procedure is an example of how to map unique data to your application file definition.

Step	Action
1	<p>Activate the N1/NAD loop and the appropriate segments and elements, if you have not already done so. If you already activated the N1/NAD group, just highlight it.</p> <p>Reference See How to Manually Activate EDI Standard Map Components for more information on activating.</p>
2	<p>Click Promote on the Main Toolbar to extract a single instance of the N1/NAD group.</p> <p style="text-align: right;">(Continued on next page)</p>

3	<p>From the Edit menu, select Properties.</p> <p>System Response The system displays the Group Properties dialog box with the Name tab displayed.</p> 
4	In the description box, type a specialized definition to identify this group as containing billing information.
5	<p>Click OK.</p> <p>System Response The system saves the change and exits the Group Properties dialog box.</p>
6	<p>Right-click the original N1/NAD group (that now repeats 199 times) again and from the Edit menu, select Properties.</p> <p>System Response The system displays the Group Properties dialog box with the Name tab displayed.</p>
7	<p>In the description box, type a specialized definition to identify this group as containing billing information.</p> <p style="text-align: right; color: red;">(Continued on next page)</p>

8	Click OK . System Response The system saves the change and exits the Group Properties dialog box.
9	Click the Deactivate button on the Main Toolbar and then click the original N1/NAD group (that now repeats 198 times), so the system does not process it.

How to Split Groups and Repeating Records

Introduction The Split function enables you to break a group or repeating record into two loops.

When to use Use this function when you need more than one instance of the same map component that still occurs multiple times.


Split vs. copy and paste

You can use the Copy and Paste functions (and change the number in the **Maximum usage** box) to accomplish the same task.

Note

The Split function is available only if you select a group or repeating record.

Procedure Use this procedure to split a group or repeating record.

Step	Action
1	Highlight the group or repeating record from which you want to extract one iteration.
2	Click Split on the Main Toolbar. System Response The system displays the Split dialog box.

(Contd) Step	Action
3	<p>In the First Loop Entries box, type the number that indicates the sequential number of iterations where you want the group or repeating record split.</p> <p>Example If the X loop repeats a maximum number of 5 times, and you type 2 in the First Loop Entries box, the resulting split generates one X loop that repeats a maximum of 2 times and a second X loop that repeats a maximum of 3 times.</p> <p>Note The number you enter in the First Loop Entries box must be greater than zero and less than the maximum number of iterations of the loop.</p>

In this example, your application file definition contains:


- an Allowance record that groups all the allowance information, and
- a Charge record that groups all the charge information.


Your Allowance and Charge records can repeat up to five times in the application file definition. The EDI standard file contains a ALC repeating segment that repeats 10 times. If you split the ALC segment in two, you can map allowance information directly to your Allowance application record and map charge information directly to your Charge application record.

Example: Creating a Nested Looping Structure


Introduction

In this example, you are defining an ANSI X12 Ship Notice/Manifest (856). When the system generates the 856 document, it contains one HL group. The HL group identifies dependencies between and the content of hierarchically-related groups of segments.

However, for your EDI standard file, you need to define additional levels of detail information. The details that you need to define include shipment, order, and line item information. To modify the structure of your EDI standard file to accommodate these requirements, you need to use the Copy and Paste functions to create a nested looping structure for the HL group.

Example procedure

This procedure is an example of how to create a nested looping structure.

1	Highlight the HL group and click Copy on the Main Toolbar.

How to Make the Two Sides of a Map Equal

Introduction When you open a map, the system displays the input and output sides of a map in equal dimensions. After manipulating a map and moving the center bar that divides the display of the input and output sides, you may want to make the two sides equal again.

The Equalize function enables you to reinstate the two sides of the map with focus in equal dimensions. The Equalize function is optional.

Procedure Use this procedure to make the two sides of a map equal in size.

Action
From the View menu, select Equalize .
System Response The system moves the center dividing bar between the two sides of the map with focus, so that the two sides of the map are equally proportioned.

How to Map Binary Segments

Introduction

Certain EDI standards use binary segments. GENTRAN:Server enables you to create and configure map components to process binary data.

When you load a EDI standard that contains binary segments from the Standards CD supplied with GENTRAN:Server, your system automatically creates the required elements.

If you need to manually create them, use the procedures in this topic.

Example

When you load the X12 275 transaction set into the output side of a map, you will notice that it contains a binary data segment with two elements--one for the length of the binary data and one for binary data. The default data type for the length element is "Number" and the maximum length is set to "15." The default data type for the binary data element is "String" and the default length is "760."

Required segments and elements

To handle binary data received for an inbound EDI segment, you must create or configure regular segments and elements on the input side of your map.

To generate an EDI segment containing binary data, you must create a binary data segment on the output side of your map. Then, you must create two elements in the binary segment for these data types:

- ▶ Bin_Len, which is for the length (in characters) of the binary segment
- ▶ Bin_Data, which is for the binary data

This table summarizes the input and output elements of your map for binary data

Number	Not Linked	Bin_Len
String	Linked	Bin_Data

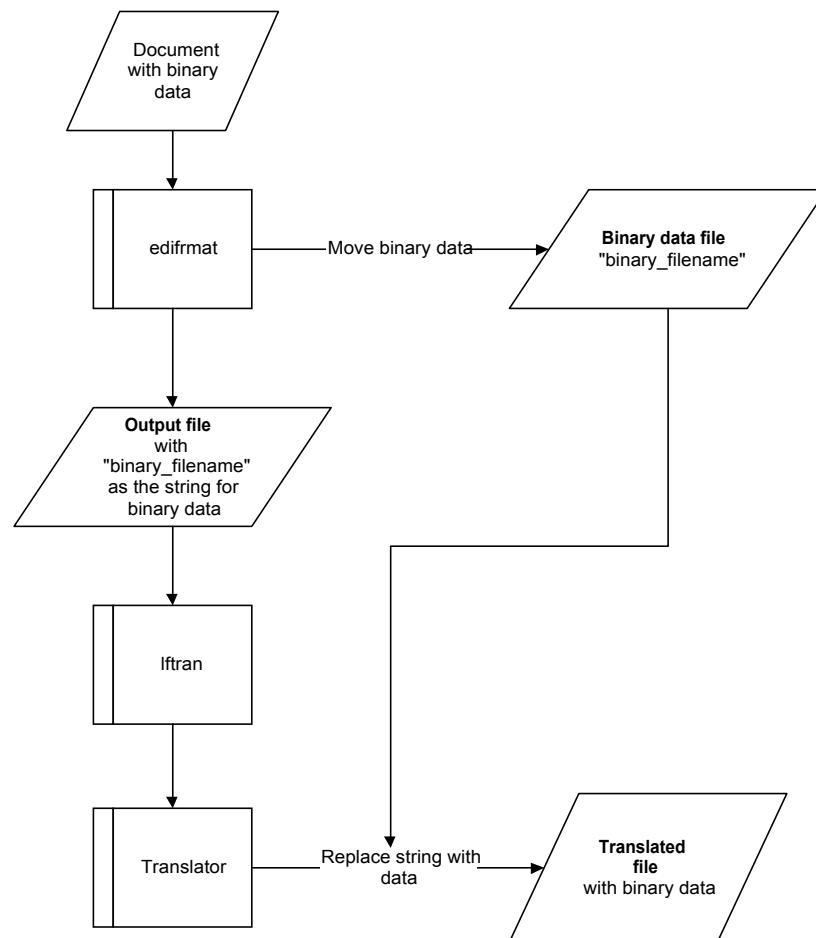

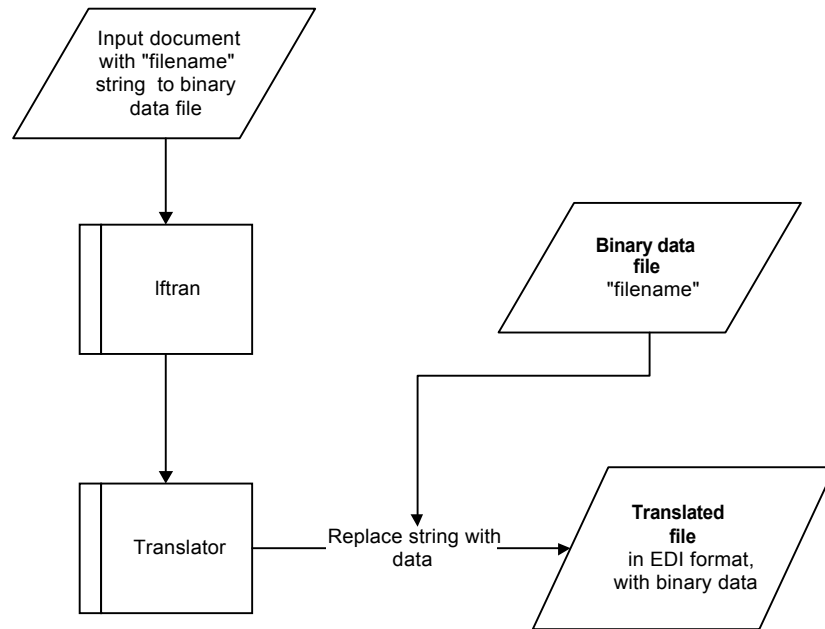

Formatting Your Data

Overview

Introduction

When you define or modify a field, you must specify the type and format. The options that are available for the format of the field depend on which type you select:

- ▶ String
- ▶ Number
- ▶ Date/Time.

String type

A string-type field contains one or more printable characters. If you specify that a field is a string type, you must designate the format by specifying a syntax token.

Number type

A number type field contains either an implied decimal or real number that can be mathematically manipulated.

If you specify that a field is a number type, you must designate the format by specifying a format of either N (implied decimal) or R (real) and the number of decimal places.

Date/Time type

A Date/Time type field contains a date or time. If you specify that a field is a Date/Time type, you must specify exactly how the date or time must be formatted.

Syntax Tokens

Definition A syntax token is a symbol or expression that defines ranges of characters and numbers that are allowed to be used for a string-type field.

Uses Syntax tokens enable you define ranges of characters and numbers valid for a string-type field. You use syntax tokens in the **Format** box of the Field Properties dialog box. This enables you to define the type of characters that you want the system to use when compliance checking each field.

Default syntax tokens The system creates default syntax tokens for each map. These default tokens are sufficient for most maps.

Single map When you set up a token, it applies only to that map. If you want to use the token in another map, you need to set it up for the second map as well.

Character ranges GENTRAN:Server uses the ANSI Character Set when determining the start-end range.

For Western European languages, consult the ANSI character chart (1252 Windows Latin 1). This chart also displays ranges so that you can enter appropriate ranges for the characters in your language.

If no chart is available, use the following guidelines:

- To include all the accented characters in the major languages of Western Europe, add the following ranges:

Start	End
0xC0	0xD6
0xD8	0xF6
0xF8	0xFC

2	Select a syntax token and click Change . System Response The system displays the Edit Syntax Tokens dialog box.

If you specify that a field is a string type, you must designate the format by specifying a syntax token. A syntax token defines ranges of characters or numbers that are valid for a string-type field.

How to Use the Number Type

Introduction

A number type field contains either an implied decimal or real number that can be mathematically manipulated. If you specify that a field is a number type, you must designate the format by specifying a format of either N (implied decimal) or R (real) and the number of decimal places.

Real or numeric

An N formatted number is a number that has an implied decimal point (e.g., 2.01 is formatted as 201). An R formatted number has an explicit decimal point (e.g., 2.01 is formatted as 2.01), and truncates trailing zeroes. Whether you use the N or R format depends on the requirements of your application. Regardless of whether you use the N or R format, you must also indicate the number of decimal places in the field.

This table lists the available real and numeric options.

R0	Explicit	No decimal places
R1	Explicit	Up to one decimal place
R2	Explicit	Up to two decimal places

Working with File Definitions

Introduction After you define a file format for the input or output side of your map, you can save it as a separate file so that you can use it in another map. This new file is called a file definition.

File definition name The system enables you to name the file definition. The file name extension for all file definitions is .DDF.

File format The system saves file definitions in XML format.

Location You should always save your file definitions in the drive and folder specified for File Definitions on the GENTRAN:Server Set Up Directories dialog box. Saving all file definitions in the same folder enables the Application Integration subsystem to list all the available file definitions when you choose to load one into a map.






Moving the translation object If you have GENTRAN:Server for UNIX, you must move the translation object from your client PC to the UNIX host so that you can use it to translate documents.

Generating a mapping report The Map Report option enables you to generate information about your map that can help you identify problems.

How to Compile a Map

Introduction The Compile function compiles the map and creates a translation object. The map that you create using GENTRAN:Server is a *source map*. When you compile the source map, the result is a *compiled translation object*. You use the Compile function after you complete and save the map.

Procedure Use this procedure to compile a map and generate a translation object.

Step	Action
1	<p>From the File menu, select Compile.</p> <p>System Response The system displays the Run-Time Translation Object Name dialog box.</p>  <p style="text-align: right; color: red;">(Continued on next page)</p>

3	<p>From the Save in list, change the drive or folder where the compiled translation object is stored, if necessary.</p> <p>Warning Do not store the compiled translation object in the directory that holds your source maps.</p>

5	<p>Verify that no errors occurred and click OK to exit the dialog box.</p> <p>Note The date that the translation object was compiled on is automatically loaded into the Compiled on box on the Translation Object Details dialog box.</p>
6	<p>From the File menu, select Save to save the source map with the Compiled on date.</p> <p style="text-align: right;">(Continued on next page)</p>

How to Copy a Translation Object to the Host

Introduction After you compile a new map to create a translation object, you can copy the translation object to the Host user directory for testing with the translator.



How to Print a Mapping Report

Editing Translation Object Details

Overview

Introduction You can edit the details of the translation object, including the description and version information.

You can also instruct the translator to use the pad character and alignment settings of each string field when reading an application file, to determine how to trim pad characters from the string data.

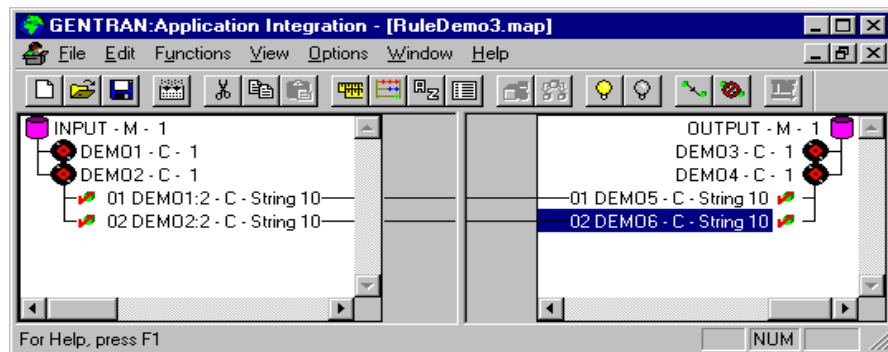
These options are available on the Translation Object Details dialog box.

Using rules The Translation Object Details dialog box also enables you to specify whether you want the translator to execute standard and extended rules.

If an output record or segment is linked to an input field in a record or segment that does not contain data but is at the same hierarchical level as an input record or segment that does contain data, the system will execute the standard and extended rules on the output field even though there is no data present.

Example

In the example diagram below, the system executes the extended rule on the DEMO5 field on the output side of the map even though there is no data for the field to which it is linked (DEMO1:2 on the input side of the map). The system executes the rule because there is data present for a field in the DEMO1 record on the input side of the map, and that record is at the same level as DEMO2.



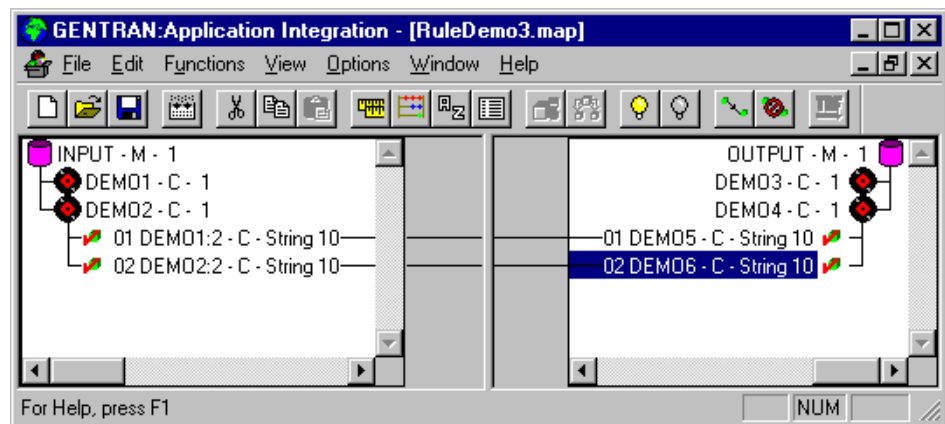

Rule execution

The system executes standard and extended rules for a record or segment on the output side of the map only if any of its links populate the output map component with data.

Example

In the example diagram below, the system does not execute the extended rule on the DEMO5 field on the output side of the map because there is no data for the field to which it is linked (DEMO1:2 on the input side of the map). The rule is *not* executed even though there is data present for a field in the DEMO1 record on the input side of the map, and that record is at the same level as DEMO2.

In this chapter

This chapter explains how to define rules for an application description or a file definition that you want GENTRAN:Server to use to determine the Trading Partnership Code in a data file.

How your system uses these rules

GENTRAN:Server uses this method to identify the Trading Partnership Code when the application description or file definition does not have a field marked as the Trading Partnership Code. The system also uses it when you run the **lftran** translation command with the A [] option.

Key terms

This table lists the key terms used in this chapter.

Term	Description
cross reference table	The table that associates identification strings with specific Trading Partnership Codes.
identification string	The value that results from applying a set of Trading Partnership rules to an application document.
Trading Partnership rule	An instruction that specifies the position of the information that you want GENTRAN:Server to extract from a particular field in an application document. A set of Trading Partnership rules derives an identification string from the document. GENTRAN:Server uses this string to determine the Trading Partnership Code

Configuration Process

Introduction You can configure your system to determine the Trading Partnership Code from multiple fields in the first record of an application file. This topic describes the stages in the configuration process.

Stage table This table describes the stages in the process.

Stage	Description
1	Create a set of Trading Partnership rules that will yield a unique identification string for a specific application description (*.app) or file definition (*.ddf). Reference See Defining Trading Partnership Rules for instructions.
2	Add the identification string to the TP Cross Reference table and link it to a Trading Partnership Code. Reference See Linking Rules to a Trading Partnership Code for instructions.

Defining Trading Partnership Rules

Overview

Introduction

The first stage in configuring your system to determine the Trading Partnership record from multiple fields is to create a set of Trading Partnership rules for a particular application description or file definition.

In this stage, you:

- ▶ Select the application description or file definition to which you want the rules to apply
- ▶ Build the rules.

Purpose of Trading Partnership rules

GENTRAN:Server uses the set of Trading Partnership rules to derive a unique identification string from an application document. Once the system has the identification string, it checks the cross reference table to find the Trading Partnership Code associated with the string.

Trading Partnership Rules

Definition Trading Partnership rules are instructions that specify the field names and positions in an application file that you want to extract from a document to build a unique identification string.

A Trading Partnership rule specifies the position of the information that you want GENTRAN:Server to extract from a field in an application document. A rule stipulates the:

- Field name
- Position of the characters to be extracted
- Place in the identification string that the extracted characters will occupy

Guidelines for building rules

These are the guidelines for Trading Partnership rules:

- The total number of characters that a set of rules extract to make an identification string cannot exceed 40.
- You can associate multiple string combinations to the same Trading Partner Code as long as each combination is unique.
- The characters extracted to make strings are case sensitive. For example, AyZ is NOT equal to AYZ.
- Leading and trailing spaces are retained. They are placeholders in the string.
- Substrings cannot overlap.

TP Rule table

The system stores the rules you define in a DISAM table named `aptptbl.dat/idx`. Each record in this table contains the:

- Name of the application description or file definition
- Record ID
- Field name and character-identification information for the rule.

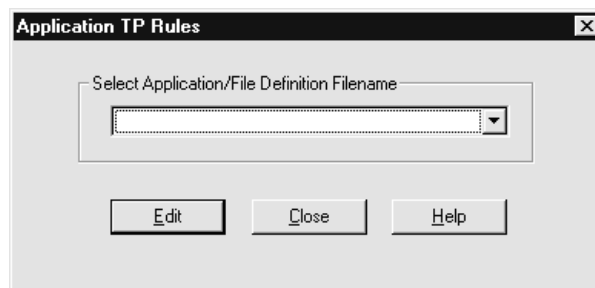

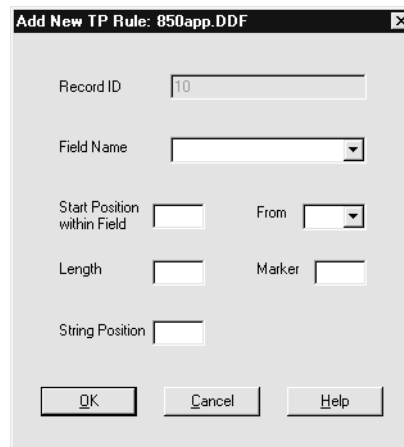

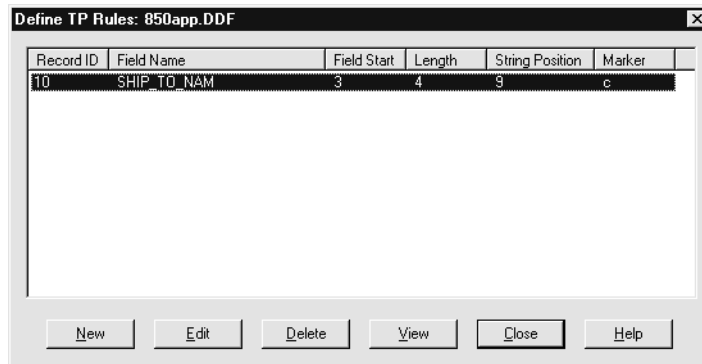

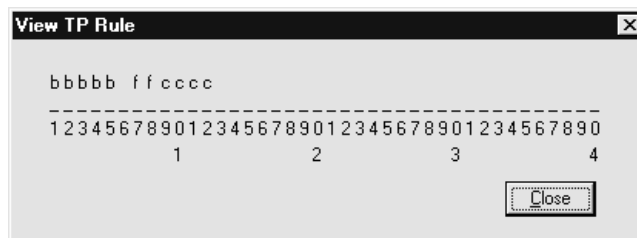

Linking Rules to a Trading Partnership Code

Overview

Introduction To enable GENTRAN:Server to determine a Trading Partnership Code from the identification string it extracts from an application file, you build a table that cross-references the string with a Trading Partnership Code.

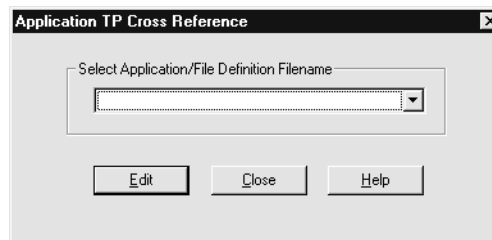
Guidelines These are the guidelines for linking strings to Trading Partnership Codes:

- ▶ Each identification string built from applying Trading Partnership rules must be unique. You cannot have the same combination of strings point to different Trading Partnership Codes.
- ▶ You can link two or more sets of strings to one Trading Partnership Code as long as each string is unique.
- ▶ Identification strings are case-sensitive. "AbC" does NOT equal "ABC."
- ▶ Leading and trailing spaces are place holders in the string.

Application TP Cross Reference Dialog Box

Introduction The Application TP Cross Reference dialog box is used to choose the name of the application description or file definition that describes the layout of the application documents to which the set of Trading Partnership rules apply.

Illustration This illustration shows the Application TP Cross Reference dialog box.



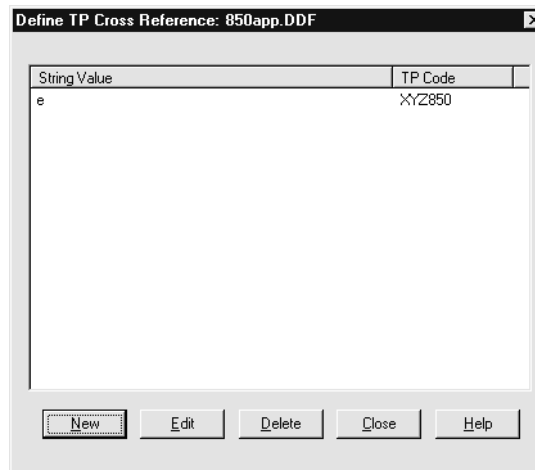

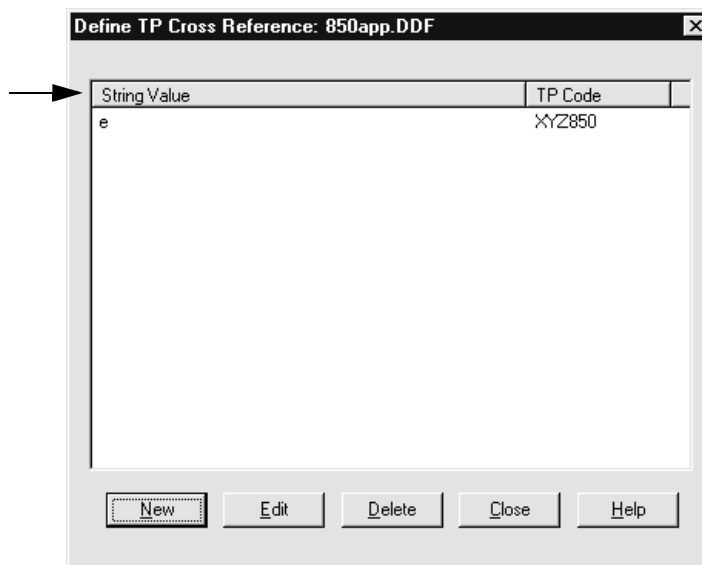

This illustration shows the location of the sorting toggle switches.





code list	A roster of code list tables that have been created or loaded in GENTRAN:Server.
code list table	A table that contains a list of valid codes for an element in an EDI standard.
standard rule	An Application Integration feature that enables you to apply basic or standard mapping operations to fields.

Standard Rules

Definition A standard rule is a feature that enables you to apply basic or standard mapping operations to fields. Standard rules give you access to functions that are more complex than simple linking, but less involved than extended rules.

Types of standard rules

This table describes the various types of standard rules.

Type	Description
Select	Maps entries you select from a table created in the GENTRAN:Server Partner Editor to a field or element in your map.
Select	Selects information from another source to one or more fields in the data.
Update	Updates the value of a field that was already read from the input file.
System Variable	Sets a variable that maps the current date and time to the selected element or field in your map.
Constant	Moves a literal constant value to a specified element or field to indicate a qualifying relationship with another element or field.
Use Accumulator	Performs numeric operations or calculations on the selected element or field. Enables you to map accumulated totals to count the occurrences of a specific field.
Loop Count	Counts the number of times a loop is repeated. Enables you to track the current loop or the outer loop in nested loops.
Use Code	Validates an element or field against a code list table to determine if the map component contains one of the values in the table.

One per field Each of the standard rules are mutually exclusive. Therefore, you can use only one on a particular field.

Related topics

Simple links enable you to match an element or field on the input side of your map with an element or field on the output side.

Extended rules enable you to use a GENTRAN:Server proprietary programming language to perform virtually any mapping operation you require in the translation process.

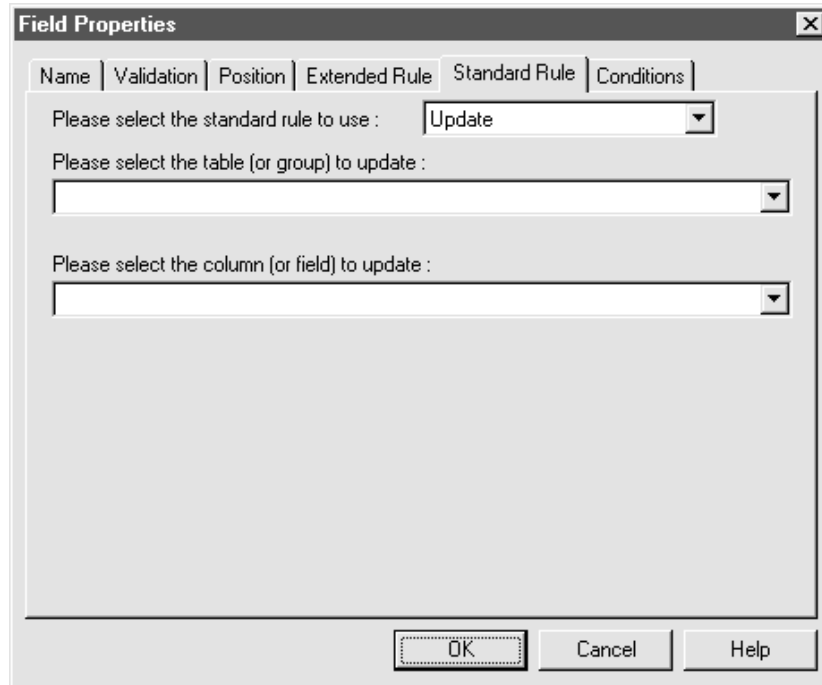

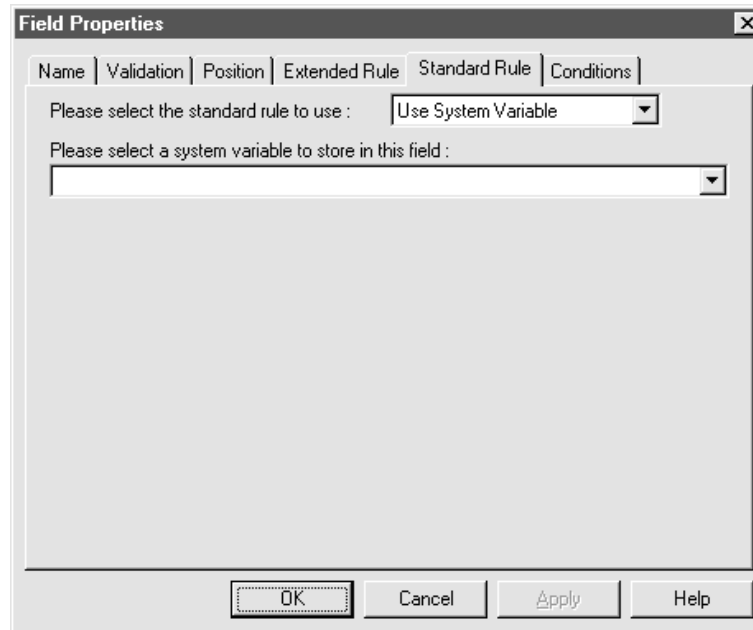

Why use literal constants?

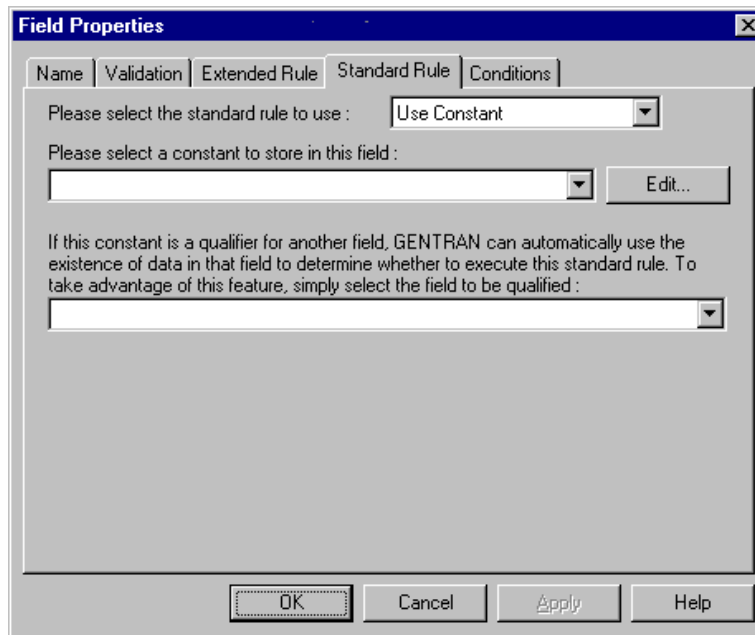
The system uses literal constants as repositories to store information that is used later in the map. You can create constants in maps to hold information that will be moved to an output field or used in a conditional statement.

You can also use literal constants to load common data into each application record on a map. Once you create the literal constant and name it, you can “hard code” (enter) a value that is loaded into the field that uses the constant.

To use the information stored in a constant, you need to use an standard rule.

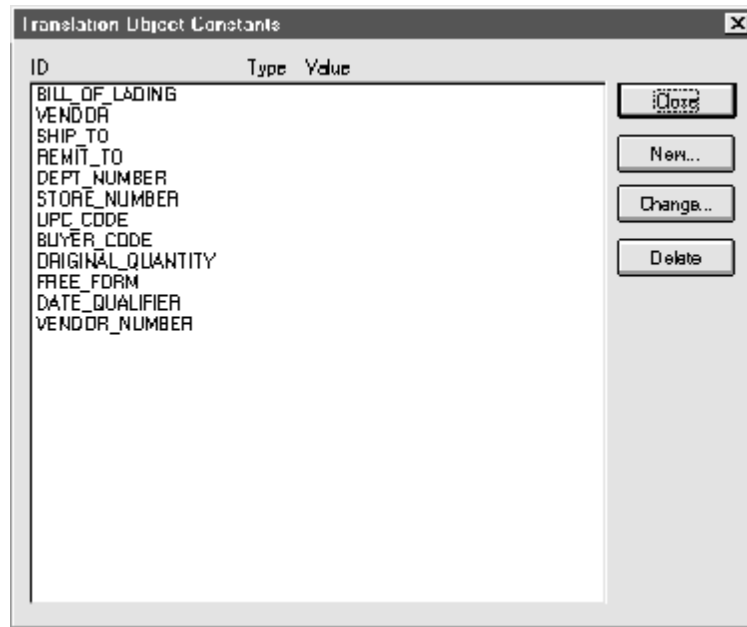

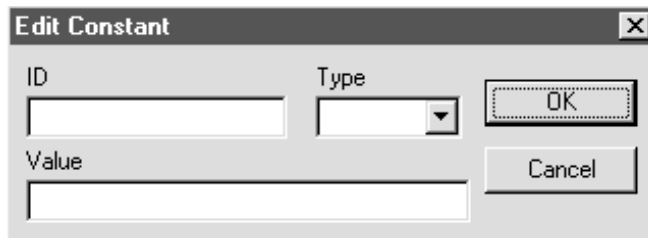

How to Define a Qualifying Relationship

Introduction The system uses literal constants as repositories to store information that is used at a later point in the map. Typically, you use constants in an outbound map to generate a qualifier.


What is a qualifier? A qualifier is an element that has a value expressed as a code that gives a specific meaning to the function of another element.

What is a qualifying relationship? A qualifying relationship is the interaction between an element or field and its qualifier. The function of the element changes depending on which code the qualifier contains.

Example procedure Use this procedure to define a qualifying relationship. In this example, you use a constant to define a qualifier for a Product/Service ID.

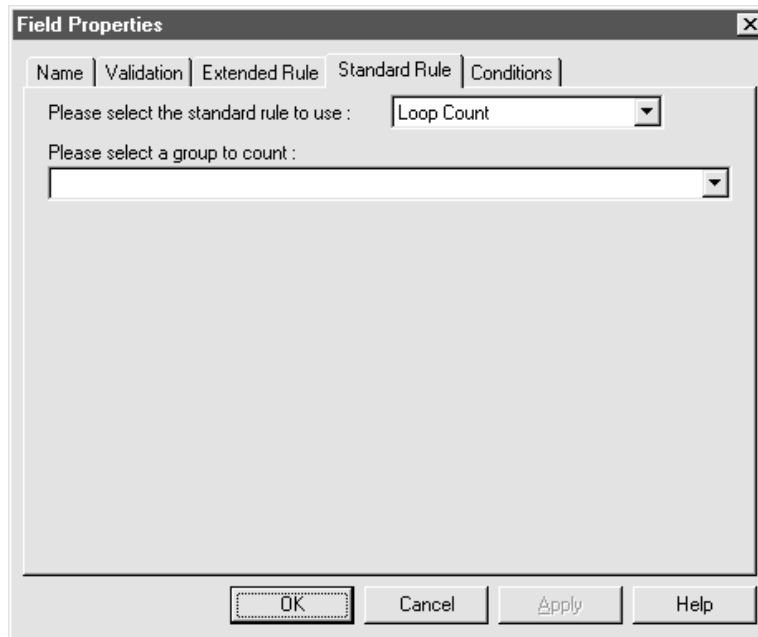

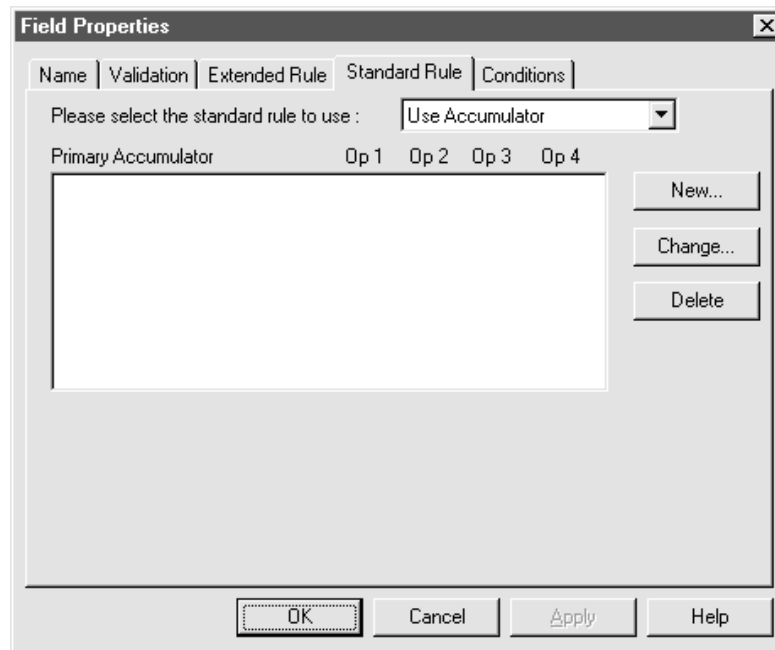
The Use Accumulator standard rule gives you access to a set of numeric variables. You can manipulate these variables with numeric operations and then transfer the results to and from fields.

This function enables you to:

- Add, change, or delete calculations for the field.
 - Use hash totals to accumulate numeric field values, such as quantity or price.
 - Map the accumulated total into a control total field, using accumulators to count the occurrences of a specific field
 - Map the accumulated total into a control total field, using accumulators to generate increasing or sequential record or line item numbers.

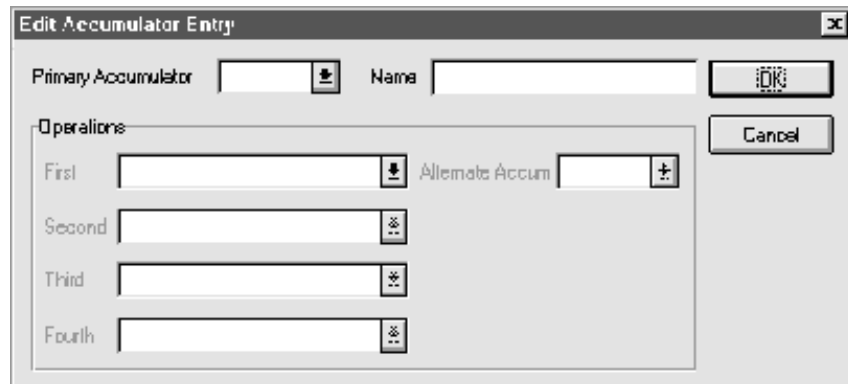

Using the Use Code Standard Rule

Overview

Introduction

The Use Code standard rule enables you to compare the value of an element or field to values in a predefined code table. You can apply a Use Code standard rule to an element or field to:

- ▶ Check the element's value against a code table.
- ▶ Select from the codes in a specified code table.
- ▶ Store a code's description in another element or field.

You can also specify whether or not the system generates an error if a validation against the code table fails.

Code tables

The GENTRAN:Server Application subsystem enables you to create code tables to use with the current map.

Note

While you can use Application Integration code tables for only the current map, you can create a code table in GENTRAN:Server that you can use globally for all maps.

Standard Code List tables

EDI standards use Code List Tables as repositories for lists of codes defined for elements.

Each EDI standard provides a code list table for each element that can be further defined with a code. GENTRAN:Server allows you to load code list tables from the standard. You can either load all the codes in the table, or you can select only one or more codes from the table.

Once you load a code list table, you can use a Use Code standard rule with an element or field to either look up a value from a code table or validate the contents of an element or field against the values in the code table.

Code List tables are versatile tools. You can import and export them and copy and paste them between maps.

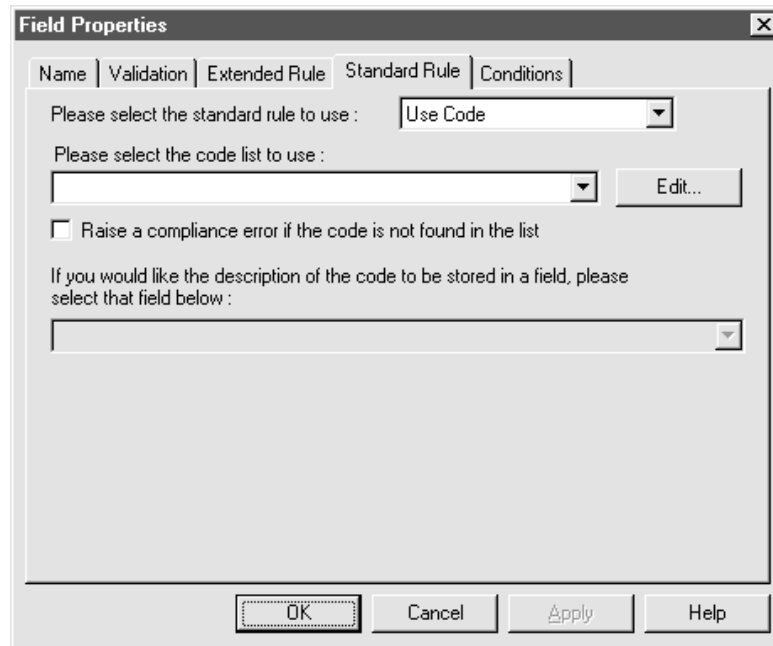
You can use the Use Codes standard rule to further qualify another element.

Example

If the XX element contains address information, you can further qualify that element by choosing the code SU from the 0222 table. In the 0222 table, the code SU is described as a supplier's address. Therefore, by using this code with the XX element, you are indicating that the XX element is not just address information, but address information for the supplier.

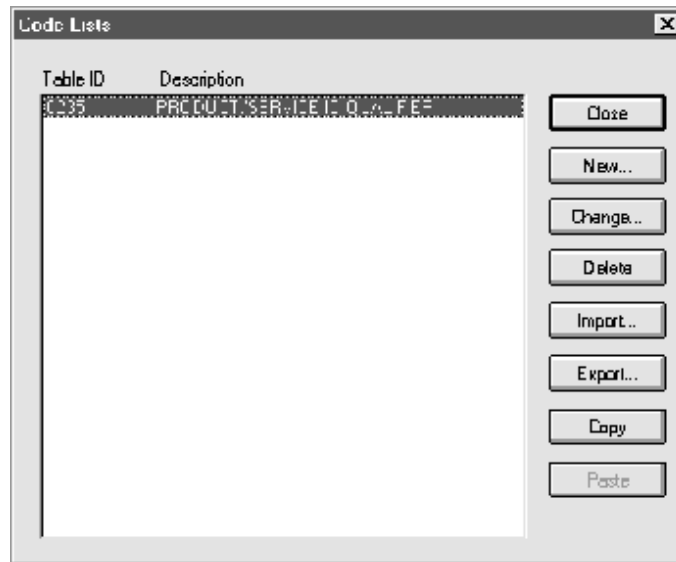

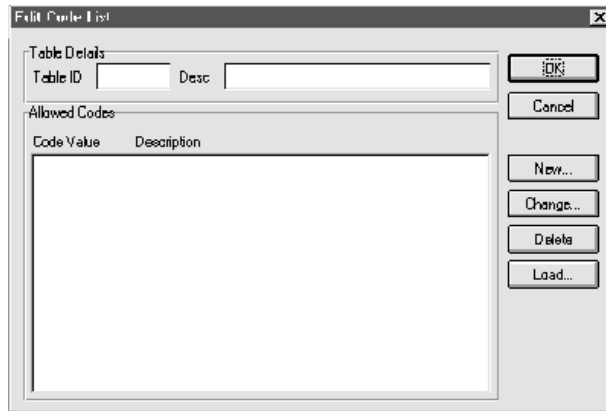

How to Validate Data Against a Code List Table

Introduction

This topic contains an example procedure. For this example, assume that you need to map the customer product code from the Product/Service ID to the customer product code field (CUSTPROCEDURE) on the application side of the map. To ensure that the data that is mapped from the Product/Service ID element is your trading partner's customer product code, you need to establish and use a code table with the Product Service ID *Qualifier*.

Procedure

Use this procedure to validate the data in the Product/Service ID field against a code list table.

Step	Action
1	<p>Load the code list table from the standard for the Product/Service ID Qualifier element.</p> <p>Reference See How to Load a Code List Table from the Standard for more information on loading a code table.</p> <p>Note The standards provide code list tables only for elements that use them. For example, in the TD4 segment, the TD401 (Special Handling Code) and TD403 (Hazardous Material Class Code) have code tables.</p>
2	<p>Define a code list table for the Product/Service ID Qualifier element that contains only the code value BP (Buyer's Part Number).</p> <p>Reference See How to Define and Modify a Code List for more information on defining a code table.</p>
3	<p>Double-click the element for which you need to validate data against a code table (Product/Service ID Qualifier).</p> <p>System Response The system displays the Element Properties dialog box.</p>
4	<p>Select the Standard Rule tab to access standard rule options.</p> <p style="text-align: right;">(Continued on next page)</p>

(Contd) Step	Action
5	From the standard rule list, select Use Code . System Response The system displays this prompt: "Are you sure you want to change the Standard Rule for this field?".
6	Click Yes to continue.
7	From the code list, select the code list table that the data in this field is validated against (0235).
8	If you need to specify that, for compliance reasons, the element <i>must</i> contain one of the codes from the specified table (nothing else is valid for that field), select the compliance error check box.
9	Click OK to add this standard rule to the field.

How to Define and Modify a Code List

Procedure Use this procedure to define or modify a code list table.

Step	Action
1	From the Edit menu, select Code Lists . System Response The system displays the Code Lists dialog box.
2	Do you want to create a new code list? <ul style="list-style-type: none"> ▶ If YES, click New. ▶ If NO (you want to edit a code list), select a code list and click Change. System Response The system displays the Edit Code List dialog box.
3	In the Table ID box, type the name of the field for which this code list table is used.
4	In the Description box, type the description of the field for which this code list table is used.
5	Do you want to create a new code? <ul style="list-style-type: none"> ▶ If YES, click New. ▶ If NO (you want to edit a code), select a code and click Change. System Response The system displays the Edit Code List Entry dialog box.
6	In the Value box, type the actual value of the code.
7	In the Description box, type a description of the code value.
8	Click OK to save the code list entry.
9	Repeat Steps 5 through 8 to add more code list entries to the code list table.
10	Click Close to save and exit the Edit Code List dialog box.
11	Click Close to exit the Code Lists dialog box.

How to Delete a Code List or Code List Entry

How to Import a Code List

Introduction The Code List Import function enables you to import code lists created for another map and share code lists with other users of GENTRAN:Server.

3	Select the location of the code list file. Note The default location is the folder where your Application Integration system is installed. The default file extension for code lists is .CDE. <p style="text-align: right; color: red;">(Continued on next page)</p>

4	Select the code list file from the list and click Open . System Response The system imports the code list and returns to the Code Lists dialog box. The imported code list is available for your use.
5	Click OK to exit the Code Lists dialog box.

How to Export a Code List

Introduction The Code List Export function enables you to export code lists to file. This enables you to define a code list for one map and use that code list in another map. This function also enables you to share code lists with other users of GENTRAN:Server.

Procedure Use this procedure to export a code list table.

1	From the Edit menu, select Code Lists . System Response The system displays the Code Lists dialog box.
2	Select a code list and click Export . System Response The system displays the Save As dialog box. <div data-bbox="716 1094 1362 1493" style="text-align: center;"> </div>
3	Do you want to change the name? <ul style="list-style-type: none"> ▶ If YES, type the name of the export file in the File name box. ▶ If NO, continue with the next step. <p>Note The file name defaults to the table ID with a .CDE file extension. The default location is the folder where your Application Integration system is installed.</p> <p style="text-align: right; color: red;">(Continued on next page)</p>

(Contd) Step	Action
4	Click Save . System Response The system exports the code list and returns to the Code Lists dialog box.
5	Click Close to exit the Code Lists dialog box.

How to Load a Code List Table from the Standard

7	Click OK to add this standard rule to the field.

Introducing Extended Rules

Extended Rule

Definition An extended rule is an Application Integration feature that enables you to apply complex mapping operations to fields. Extended rules give you access to functions that are more involved than standard rules.

You define extended rules with the GENTRAN:Server proprietary programming language. This is a full programming language that gives you access to the entire GENTRAN:Server internal storage area.

When to use extended rules Use extended rules when you need to define more complex translations than are available through the link function (simple mapping) and standard rules.

You can define an extended rule as:

- A session rule (pre-session or post-session)
- A rule for a map component

What comprises an extended rule? An extended rule can consist of two sections, a *declarations* section followed by a *statements* section.

Every extended rule must have a statements section. In the *statements* section, you define the actions that you want the rule to execute.

If you use additional variables, you must have a declarations section for the rule. You use this section to declare any variables that you use in a rule that are not already defined as part of the input or output specification of the map.

Reference

See [Declarations Section](#) for more information about the declarations section.

See [Statements Section](#) for more information about the statements section.

Declarations Section

Introduction The declarations section is used to declare the names and types of any variables you use either in the current rule or in any other rule that is within the scope of the current rule. The variables that you define in the declarations section store values.

Variables Variables consist of a name and a data type.

Rules for variable names

These are the rules for naming variables:

- ▶ Variable names can include alphanumeric characters and the colon and underscore characters.
- ▶ The first character in a variable's name can not be numeric.
- ▶ All variable names are case-sensitive.

Supported data types

These are the data types that extended rules support:

- ▶ Integer – is a whole number with no decimal component.
- ▶ Real – is a whole number that may have a decimal component.
- ▶ String – contains one or more printable characters.
- ▶ Datetime – contains a date or time.
- ▶ Array – defines a table of multiple occurrences of a single data type.

Terminating a declaration You must terminate a declaration with a semicolon (;). To improve readability, you can include a blank line in between the declaration and statement sections.

Statements Section

Introduction The statements section defines the actual work that an extended rule performs.

Statements and combinations A statement is a single operation that consists of a combination of expressions, keywords, commands, operators, and symbols.

A statement combination enables you to specify more complex operations.

What is an expression? An expression is a logical unit that the system evaluates. The statements section consists of a sensible combination of keywords, operators, and symbols.

Examples

A = B

A + B

Reference

See [Extended Rule Syntax](#) for a detailed explanation of these components.

Extended Rules Processing

Introduction

The system always processes field level extended rules after processing standard rules. After that, the point at which the system processes an extended rule depends on:

- Whether the rule is designated as pre- or post- session
- The scope of the extended rule
- The level of the map component that has the extended rule
- Whether the rule is attached to a component on the input side of the map or the output side.

Pre-session and post-session rules

You can specify that an extended rule is pre- or post-session on the Session Rules dialog box.

The system processes pre-session extended rules before processing the translation object. The variables in the extended rules are accessible for every extended rule defined in the translation object.

The system processes post-session rules after processing the translation object.

Levels of extended rules

You can attach extended rules to three different levels of map components:

- EDI standard file and application file groups, using the Loop Level Extended Rules dialog box.
- Groups, sub-groups, repeating records, and repeating segments, using the Loop Level Extended Rules dialog box.
- Fields and elements, using the Field Level Extended Rule dialog box.

Scope

The *scope* of an extended rule determines which variables are accessible from within a given extended rule. The scope depends on the current state of the map.

This list defines the scope of an extended rule.

- Pre-session extended rules (defined on the Session Rules dialog box) are in scope for every rule in the translation object.
- On Begin extended rules (defined on the Loop Level Extended Rules dialog box) are in scope until the conclusion of its companion On End rule (also defined on the Loop Level Extended Rules dialog box).
- Field level extended rules are in scope only for the duration of the field or element.

(Continued on next page)

Scope (contd)

The scope of an extended rule attached to the current map component depends on the type and state of the map component.

If a current group to which the rule is attached is subordinate to another group, then:

- ▶ The parent group is automatically in scope for the duration of the entire child group
- ▶ The current hierarchical structure is also in scope for the duration of the child by using an addressing method. This method is explained in the symbol syntax for [String constant](#).

An extended rule that is attached to a field or element is in scope only for the duration of the field or element. The system always processes field-level extended rules after processing standard rules.

A variable is considered to be “in scope” if it is:

- ▶ declared in the current rule,
- ▶ in the On Begin rule of a group that contains the current map component, or
- ▶ in the Pre-Session rule.

**Input side and
Output side of a
map**

The translator builds the data storage area for a map based on the structure of the input (source) side of the map. Therefore, extended rules address the map based on the hierarchy of the input side.

On the output side of a map, extended rules have access only to the current record and the entire input side of the map. However, from the input side of a map, you have access to the entire file structure. The translator does not write to the output file until it has read the entire input file. So, you can change the values output from any rule on the input side of a map or any rule on the output side until the time that the translator writes the output file.

Tip

When you use extended rules, always address the input side of the map so the translator can locate the map component that the rule accesses.

(Continued on next page)

Input rule processing

The translator processes the input side of the map first and then the output side. This table lists the sequence of how the translator processes rules on the Input side of a map.

Step	Action
1	Load the input definition.
2	Read the input file.
3	Determine if data is present for the first/next group. If it is present, run the group On_Begin rule, if the rule is present.
4	Load each field within the first/next record within the current group and then execute field level rules (for each field) in the following sequence: <ul style="list-style-type: none"> ▶ Standard rules ▶ Extended rules
5	At the end of the group, execute the On_End rule, if the rule is present.
6	Repeat steps 2 - 5 for each group in the input file.

Output rule processing

This table lists the sequence of how the translator processes rules on the output (destination) side of a map.

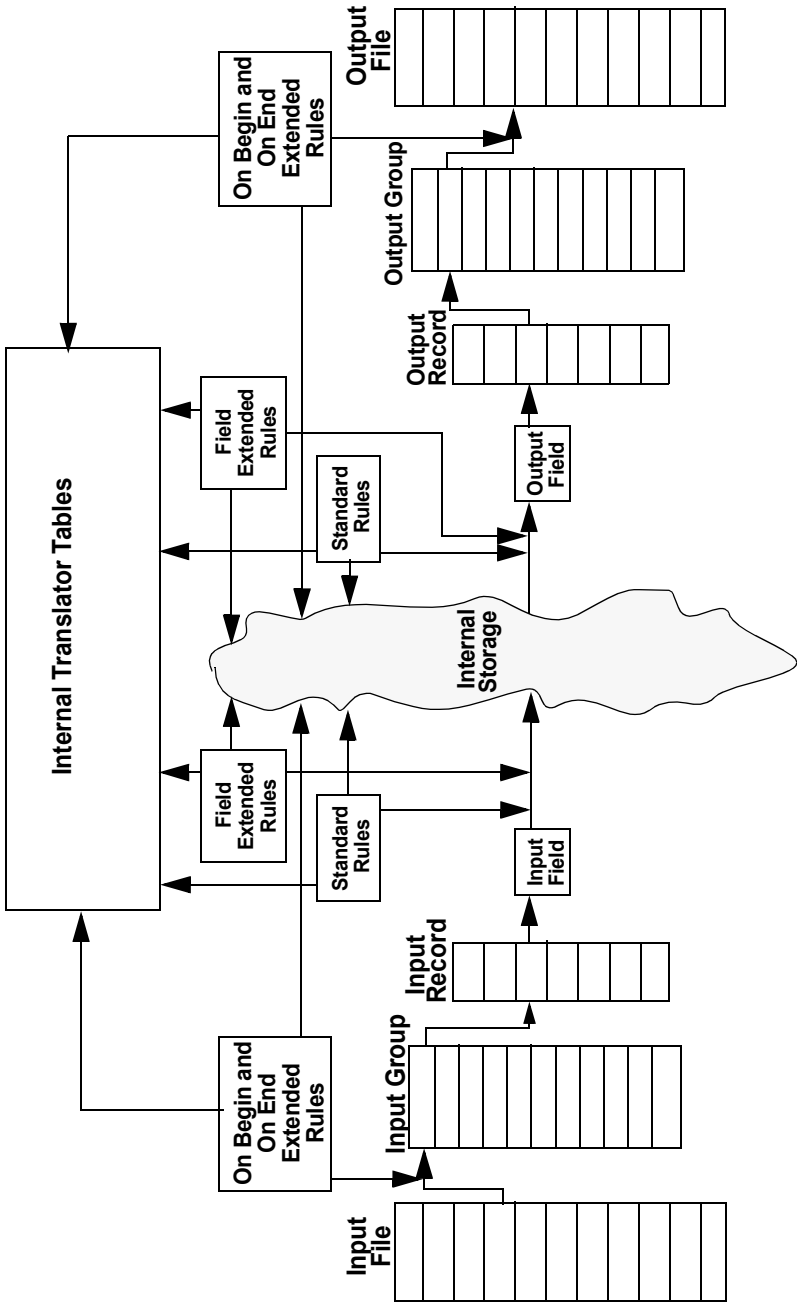
Step	Action
1	Verify whether or not data exists for the first/next record.
2	If the record is the first record of a group, run On_Begin rule, if the rule is present.
3	For each field in the record, execute field level rules (for each field) in the following sequence: <ul style="list-style-type: none"> ▶ Run standard rules ▶ Run extended rules
4	Format data according to specified field properties (see the Field Properties dialog box).
5	Write the record to the output file.

Defining Extended Rules

Overview

Introduction

Before you define an extended rule, you need to decide:

- ▶ what you want the scope of the rule to be
- ▶ when you want the rule to be executed

Levels

You can define extended rules to access components at these levels:

- ▶ the entire session (input and output sides of the map)
- ▶ looping map components (groups, segments, etc.)
- ▶ fields

The procedure you follow to define an extended rule varies slightly, depending on whether you are defining a session rule or a rule for a map component.

Session rules

A session rule applies to components on both the input and output sides of the map. There are two types of session rules:

- ▶ Pre-session
- ▶ Post-session

You can define both a pre-session and a post-session rule for a given session.

Pre-session

Pre-session rules define variables that must have global scope. Global scope means that the variable can be accessed from any other extended rule in the map. The system processes pre-session extended rules before processing the translation object, so variables in pre-session rules are in scope for every extended rule defined in the translation object.


Post-session

The system executes post-session rules after processing the translation object. Thus, post-session rules do not have permanent scope.

How to Define a Session Rule

Introduction This topic explains how to define a pre-session or a post-session extended rule.

Procedure Use this procedure to define a session rule.

1	<p>From the Edit menu, select Session Rules.</p> <p>System Response The system displays the Session Level Extended Rules dialog box.</p> 
2	<p>Do you want to define a pre-session rule?</p> <ul style="list-style-type: none"> ▶ If YES, click the Pre-session option. ▶ If NO (you want to define a Post-session rule), click the Post-session option.
3	<p>In the Editor list, type the extended rule.</p> <p style="text-align: right; color: red;">(Continued on next page)</p>



Overview

Introduction

The statements section of an extended rule consists of a sensible combination of keywords, operators, and symbols. This section explains the correct syntax for each of these components.

Basic syntax rules

Use spaces and operators to separate keywords and symbols.

Do not string two keywords together sequentially without an operator.

Keywords and Commands

Introduction A *keyword* is a fixed, defined use of a word that indicates how the programming language should be interpreted. There are two types of keywords:

- ▶ execution control
- ▶ command

Definition: execution control The execution control keyword controls the flow of execution of the defined rule. These keywords are used to evaluate conditions and perform looping operations.

Definition: command A command keyword performs actions on variables. Commands are responsible for moving data.

List of execution control keywords This is a list of GENTRAN:Server execution control keywords.

- ▶ ELSE
- ▶ BEGIN
- ▶ END
- ▶ WHILE
- ▶ DO

Symbols

Introduction Operations are performed on symbols.

The symbols that you can use in GENTRAN:Server extended rules are:

- ▶ variables
- ▶ constants
- ▶ map components/internal storage
- ▶ arrays
- ▶ accumulators.

Uses of symbols You can use symbols to address existing map components. You can also create additional instances of map components, as long as the map component is originally defined in internal storage.

Example

You can use this function to create extra line items when one line item field is already defined in internal storage.

Symbol syntax You must address each type of symbol in the proper syntax.

String constant

To address a string constant, you must enclose the constant value in quotes:

```
#fieldname = "HDR";
```

where HDR is the constant value

Addressing or creating a field in internal storage

To address a field or create a field in internal storage, within the scope of the current mapping action, use the syntax #FIELD_NAME

```
#field_1 = 2;
```

where 2 is a numeric constant value

Addressing or creating a field in a group

To address a field within a group or create a field within a group in internal storage within the scope of the current hierarchy, use the syntax \$GROUP.#FIELD_NAME

```
$N1.#0234
```

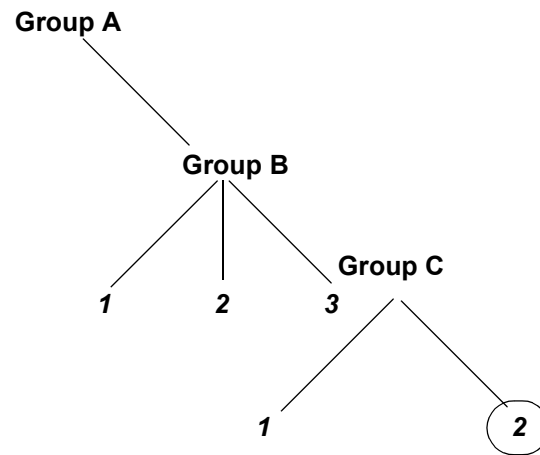

**Symbol syntax
(contd)****Addressing or creating a group in internal storage**

To fully address a group in the entire internal storage area, or to create a group in internal storage, use the syntax `$LOOP[index1][index2][index3]`, where the index entries indicate the hierarchical structure of the loop and enable you to address specific instances of a group:

`$Group_C[3][2].#Field_2`

where you are specifying the second instance of Group_C within the third instance of Group_B:

**Addressing an array**

To address an array (of any type), you address each element of the array individually. For example, if `array_1` is an array (of integers) and is declared:

`integer array_1[5]`

With variables 0 through 4, each element of the array is addressed individually as follows:

```
array_1[0]
array_1[1]
array_1[2]
array_1[3]
array_1[4]
```

Accessing an accumulator

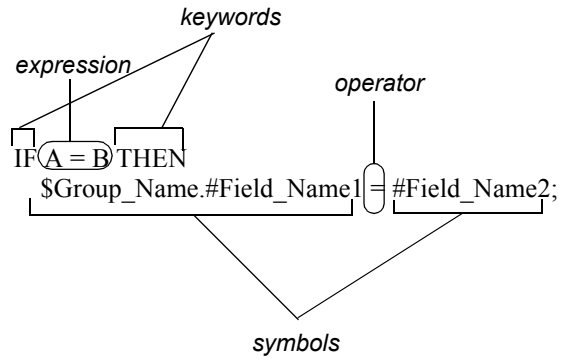
You can access an accumulator in the same manner as variables or internal storage. To address an accumulator, use the syntax `accum(n)` where “n” is the number (not the name) of the accumulator:

Assignment

Introduction

The assignment statement is the most powerful and most often used extended rule statement. In the most simple form, it is written as:

```
variable=expression
```

However, you can use this statement in more flexible and complex ways, defined as follows:

```
numeric_variable=numeric_expression  
numeric_field=numeric_expression  
string_variable=string_expression  
string_field=string_expression  
datetime_variable=datetime_expression  
datetime_field=datetime_expression
```

Numeric expression

A numeric expression can consist of numbers, numeric fields, numeric variables, and numeric functions combined with the standard arithmetic operators.

String expression

A string expression can consist of string constants, string fields, string variables, and string functions concatenated with the “+” operator.

Datetime expression

A datetime expression can consist of a datetime constant, datetime field or datetime variable.

Examples

Some examples of assignment expressions are as follows:

```
a = 5;  
a = b + c;  
s = "hello";  
s = s + "world";
```

Datetime Expressions

Introduction

Datetime expressions consist of a datetime variable and (optionally) datetime modifiers. You can write datetime expressions using datetime constants if you are using the standard syntax:

```
year/month/day
hour:minute:second
year/month/day/hour:minute:second
```

You can also write datetime expressions with datetime fields, variables, or by using *date* and *time* functions.

Date syntax

Write date functions as follows. Specify the month (January - December) as 1-12.

```
datetime d;

d = date(1995,4,6);
d = date(1995,4,6,12,0);
d = date("%y/%m/%d", "95/4/6");
```

The **d = date("%y/%m/%d", "95/4/6");** format enables you to convert any string format type into a datetime format type by indicating a format mask ("**%y/%m/%d**") along with the string ("**95/4/6**") you want to convert. Use this function if you are using non-standard syntax and need to specify the syntax you are using.

<< operator

You can use the << operator to modify your datetime variable by adding time increments (e.g., days, weeks, years). For example:

```
datetime d;
d=d <<weeks(2);
//This adds 2 weeks to d.
```

Time syntax

Write time functions as follows:

```
d = time(12,0);
d = time(12,0,59);
```

You can use the << operator to modify your datetime variable by adding time increments (e.g., seconds, minutes, years). For example:

```
datetime d;
d=d <<seconds(1);
//This adds 1 second to d.
```

(Continued on next page)

**Get and set
syntax**

The *get* and *set* functions enable you to access (get) or modify (set) individual components of a datetime type. Use these functions as follows:

```
integer a;  
datetime d;  
a = get days (d);  
a = get hours (d);  
set hours(d,a);  
set days (d,a);
```

Conditional Logic

Introduction GENTRAN:Server uses conditional logic to test conditions. Then, depending on the results of the test, GENTRAN:Server may perform different operations.

Nesting You can nest conditions to any level.

No terminating syntax Do not end conditions with a semicolon (;). The semicolon is necessary for terminating statements, but not conditions.

**IF...THEN...
ELSE** You can use the IF/THEN keywords to execute one or more statements conditionally. The condition is usually a comparison, but it can be any expression that concludes with a numeric value. GENTRAN:Server interprets the value as either *true* or *false*. The system interprets a zero value as false and a nonzero value as true.

BEGIN/END keywords

If you include more than one statement in the body of an IF/THEN loop, you must surround the statements with the BEGIN/END keywords. If you use only a single statement, you can omit the BEGIN and END.

IF/THEN execution

GENTRAN:Server evaluates the IF/THEN condition.

- If the condition is true, the system executes all the statements that follow the THEN keyword.
- If the condition is false, the system does not execute the statements following THEN.

(Continued on next page)

IF...THEN... ELSE

ELSE keyword execution

You can use the ELSE keyword in conjunction with IF/THEN to define several blocks of statements, one of which is executed.

GENTRAN:Server tests the first IF/THEN condition.

- ▶ If the condition is false, the system proceeds to test each sequential condition until it finds one that is true.
- ▶ The system executes the corresponding block of statements for the true condition.
- ▶ If none of the IF/THEN conditions are true, the system executes the statements following the ELSE keyword.

Syntax

```
IF condition THEN
BEGIN
    statement1;
    statement2;
END
ELSE
BEGIN
    statement3;
    statement4;
END
```

Example of conditional logic

Assume that you need to evaluate whether an N1 or NAD group contains billing or shipping information (this depends on the qualifier that a field in the group contains). Then you will map that information to the appropriate application fields.

For this example, you need to add an On End extended rule to the N1/NAD. The system executes the rule when the group terminates. This is an example of the syntax of the rule:

```
IF #0098 = "BT" THEN
BEGIN
    $Group_Name.#BILLTONAME = #0093;
    $Group_Name.#BILLTOADDR1 = #0166;
    $Group_Name.#BILLTOADDR2 = #0166:2;
    $Group_Name.#BILLTOCITY = #0019;
    $Group_Name.#BILLTOSTATE = #0156;
    $Group_Name.#BILLTOPCODE = #0116;
END
IF #0098 = "ST" THEN
BEGIN
    $Group_Name.#SHIPTONAME = #0093;
    $Group_Name.#SHIPTOADDR1 = #0166;
    $Group_Name.#SHIPTOADDR2 = #0166:2;
    $Group_Name.#SHIPTOCITY = #0019;
    $Group_Name.#SHIPTOSTATE = #0156;
    $Group_Name.#SHIPTOPCODE = #0116;
END
```

String Conditions and Functions

Introduction

You can use string conditions in IF/THEN and IF/THEN/ELSE statements to perform comparisons between strings. Here are some examples of the syntax:

```
IF s1 = s2 THEN
IF s1 < s2 THEN
IF s1 > s2 THEN
```

The following string functions are also available for you to use:

- ▶ left
- ▶ right
- ▶ mid
- ▶ strdate
- ▶ concat
- ▶ strstr

Left, right, mid syntax

The *left*, *right*, and *mid* functions enable you to extract substrings from a string.

- ▶ The left function extracts a specified number of characters from the left of the string variable or field and returns the result as a string.
- ▶ The right function extracts a specified number of characters from the right of the string variable and returns the result as a string.
- ▶ The mid functions extracts from a specified position in the string to the right, for a specified number of characters.

This is an example of how the statements are used.

```
string[10] s;
string[3] s1;
string[3] s2;
string[4] s3;
string[7] s4;

s = "abcdefghij";
s1 = left(s,3);
s2 = right(s,3);
s3 = mid(s,3,4);
```

(Continued on next page)

Strdate syntax

The *strdate* function converts a datetime type into a string using a format that you specify. This function enables you to include static characters such as a slash (/), which gives you access to full date support.

Syntax

```
datetime d;  
string[8] s;  
  
strdate(d, "%y/%m/%d", s);
```

Concat syntax

The *concat* function concatenates a specified number of characters from one string onto the end of another string. This example demonstrates the syntax to concatenate five characters from string "s2" onto the end of string "s1":

```
string[10] s1,s2;  
concat(s1,s2,5);
```

Strstr syntax

The *strstr* function finds a substring inside a string. This function returns the position of the first instance of the designated substring. If this function does not find the specified substring inside the string, it returns a value of -1.

Syntax

```
integer d;  
  
d = strstr("hello", "el");
```

Numerical Functions

Introduction

The numerical functions enable you to convert one data type to another. These are the numerical functions that you can use:

- `len`
- `atoi`
- `atof`
- `ntoa`

Len syntax

The `len` function counts and returns the number of characters in a string.

Example

```
integer a;  
a = len("hello");
```

Atoi, atof, ntoa syntax

The `atoi` function converts strings into integers.

The `atof` function converts string into real numbers.

The `ntoa` function converts both integers and real numbers into strings.

Example

```
integer a;  
real b;  
string[8] s;  
a = atoi("5");  
b = atof("5.5");  
ntoa(5.5, s);
```

Raise Compliance Error Function (CERROR)

Introduction The *cerror* function raises a compliance error.

Syntax `cerror(100,$ILD[0][1][1].#VATC);`

The above example raises compliance error 100 on the VATC element of the specified instance of the ILD group. You typically specify this function as a action to be performed if a condition is false. This function is valid on either side of a map.

Remove Field Value Function (EMPTY)

Introduction The *empty* function sets the value of a field in internal storage to null. This function is not the same as setting the value of a field to a zero length string (" ") or to zero. This function is typically used to prevent an output value.

Syntax `empty($ILD[0][1][1].#VATC);`

The above example sets the value of the specified instance of the VATC element to null.

Note that you cannot use EMPTY as part of an expression because it does not return a value.

Existence of Data Function (EXIST)

Introduction The exist function returns a non-zero (true) value if there is data in a specified field in internal storage. If there is no data in the specified field, this function returns a zero (false) value. This function is typically used as a part of a condition.

Syntax `IF exist($ILD[0][1][1].#VATC) THEN`

The above example returns a non-zero value if the condition is true (data is present in the specified instance of the VATC element). A zero value is returned if the condition is false (no data is present in the specified instance of the VATC element).

Count Function (COUNT)

Introduction The *count* function returns the total number of times a group (or repeating record) has iterated.

Syntax `count (GROUPNAME [3] [*]) ;`

The above example returns the total iterations of the GROUPNAME group within the third iteration of the parent group.

Delete Function (DELETE)

Introduction The *delete* function deletes the specified iteration of a repeating record or group.

Syntax `delete(GROUPNAME[iteration]);`

File Pointer Functions (FSEEK, FTELL)

Introduction

The *fseek* function moves the file pointer to a new location which is a specified number of bytes (offset) from the beginning of the file, end of the file, or relative to the current position (origin). To invoke the *fseek* function against the input file, the value for *current_file* is "0." To invoke the *fseek* function against the output file, the value for *current_file* is "1." The *fseek* function is typically used in conjunction with only the *ftell*, *readblock*, and *writeblock* functions.

The *ftell* function obtains the current position of the file pointer and returns it as an integer. To invoke the *ftell* function against the input file, the value for *current_file* is "0." To invoke the *ftell* function against the output file, the value for *current_file* is "1." The *fseek* function is typically used in conjunction with only the *fseek*, *readblock*, and *writeblock* functions.

Syntax

```
fseek(current_file,offset,origin);  
numeric_variable = ftell(current_file);
```

Block of Data Functions (READBLOCK, WRITEBLOCK)

Introduction

The *readblock* function reads a block of data (segment or record) from the input file and places it into the argument of a string variable. The *writeblock* function writes the data contained in the argument of a string variable to the output file.

The *readblock* and *writeblock* functions are used in conjunction with each other to pass a block of data from the input file to the output file without compliance checking or testing for proper EDI syntax. Together these functions provide a more efficient alternative of using wildcard segments.

Syntax

```
readblock(string_variable);  
writeblock(string_variable);
```

User Exit Function (EXEC)

What is a user exit?

A user exit is an extended rule that enables the map to temporarily exit translation and then:

- ▶ Run a shell script, retrieve the results, return to translation, and use the results of the shell script in translation. In GENTRAN:Server for UNIX, the exec extended rule has this function.

Placing the extended rule

You can use the exec function in an extended rule for a map component at any hierarchical level, including field level extended rules, if appropriate.

Note

When you apply a user exit to a map component, subordinate map components may also be able to execute the same user exit.

Allowable data types

This table lists the extended rule data types that you can use with exec:

- ▶ INTEGER
- ▶ REAL
- ▶ STRING

Note

You cannot use date and time data unless you process it as a string.

Introduction The **aton** function is a numerical function that converts strings into real numbers. The numerical functions enable you to convert one data type to another.

Syntax `real = aton(string);`

where: `real`=real number variable
`string`=string variable

Example

```
real b;  
string[20] s;  
s = "5.5";  
a = aton(s);  
// "a" contains the value 5.5
```

begin

Introduction

The **begin** and **end** keywords are used in conjunction with **if/then** loops. You can nest the conditions in an **if/then** loop to any level. If you include more than one statement in the body of an **if/then** loop, you must surround the statements with the **begin/end** keywords. If you use only a single statement, you can omit the **begin** and **end**.

Note

Do not end conditions with a semicolon (;). This terminating syntax is necessary for statements *only*.

Syntax

```
if condition then
begin
    statement1;
    statement2;
end
```

break

Introduction The **break** function terminates the execution of the nearest enclosing **while** loop and passes control to the statement that follows the **end** keyword. The **break** keyword can be used in complex loops to terminate a loop before several statements have been executed.

Example

```
integer i
integer j;

i = j = 0;
while i<10 do
begin
    if (i = 8) then
        continue;
    if (i = 9) then
        break;
end
//As long as "i" has a value less than "10" the loop repeats. If "i"
//has
//a value of "i", the loop continues. If "i" has a value
//of "9" the loop terminates.
```

cerror

Introduction The *cerror* function raises a compliance error. You can specify this function as an action to be performed if a condition is false.

Syntax `cerror(error_number,$GROUP_NAME[index][index][index].
^#FIELD_NAME);`

Example

```
cerror(100,$ILD[0][1][1].#VATC);
//This raises compliance error 100 on the VATC element of the
//specified instance of the ILD group
```

Introduction The **concat** function concatenates a specified number of characters from one string onto the end of another string.

Syntax `concat(string,string,num_char);`

where: string=string variable
num_char=number of characters from the second string onto the end of the first string

Example

```
string[10] s1,s2;  
concat(s1,s2,5);  
//Concatenate five characters from string "s2" onto the end of  
//string "s1"
```

continue

Introduction The **continue** function continues the execution of the innermost loop without processing the statements in the loop that follow the **continue** statement.

Example

```
integer i
integer j;
i = j = 0;
while i<10 do
begin
    if (i = 8) then
        continue;
    if (i = 9) then
        break;
end
//As long as "i" has a value of "8" the innermost loop repeats. If
//"i"
//does not have a value of "8" the next statement (break statement)
//is processed.
```

count

Introduction The **count** function counts and returns the number of iterations of a group.

Example This is an example of the count function:

```
integer i;  
i = count($N1[*]);  
//The [*] is a wildcard that counts the number of iterations of the  
//N1 group.
```

delete

Introduction The **delete** function deletes a specified occurrence of a group.

Syntax `delete($GROUP_NAME[N]);`
where [n] is the occurrence of the group that you want to delete.

Example `delete($ILD[2]);`
`//Deletes the second occurrence of the ILD group.`

empty

Introduction The **empty** function sets the value of a field in internal storage to null. This function is not the same as setting the value of a field to a zero length string (" ") or to zero.

Syntax `empty($GROUP_NAME[index][index][index]. #FIELD_NAME)`

Example

```
empty($ILD[0][1][1].#VATC);  
//Set the value of the specified instance of the VATC element  
//to null

If you include more than one statement in the body of an **if/then** loop, you must surround the statements with the **begin/end** keywords. If you use only a single statement, you can omit the **begin** and **end**.

Note

Do not end conditions with a semicolon (;). This terminating syntax is necessary for statements *only*.

Syntax

```
if condition then
begin
    statement1;
    statement2;
end
```

exec

Introduction The exec function invokes the execution of a shell script. The translator waits until the script finishes before continuing with translation.

After the script runs and returns a numeric return code, the exec function:

- Retrieves the return code
- Returns to translation
- Uses the return code in translation.

Note

You must set an integer value equal to the return value of the exec (...) call for the rule to compile.

Syntax nReturn = exec(string)

where:

nReturn = return value

string = string variable or literal value that represents the shell script

Example

```
integer nReturn;  
nReturn = 0;  
nReturn = exec ("c:\addrunm.sh");
```

exist

Introduction **Exist** tests for empty fields (containing null). The **exist** function returns a non-zero (true) value if there is data in a specified field in internal storage. If there is no data in the specified field, this function returns a zero (false) value. This function is typically used as a part of a condition.

Syntax if exist(\$GROUP_NAME[index][index][index]. #FIELD_NAME) then

Example

```
if exist($ILD[0][1][1].#VATC) then
//Return a non-zero value if the condition is true (data is present
//in the
//specified instance of the VATC element). A zero value is returned
//if the condition is false (no data is present in the specified
//instance of
//the VATC element).
```

fseek

Introduction

The **fseek** function moves the file pointer to a new location, which is a specified number of bytes (offset) from the beginning of the file, end of the file, or relative to the current position (origin). To invoke the **fseek** function against the input file, the value for `current_file` is "0." To invoke the **fseek** function against the output file, the value for `current_file` is "1." The **fseek** function is typically used in conjunction with only the `ftell`, `readblock`, and `writeblock` functions.

Syntax

```
fseek(current_file,offset,origin);
```

where:

current_file	0 indicates the input file; 1 indicates the output file
offset	The position to which the file pointer is moved relative to the origin.
origin	Use begin to offset the file pointer from the beginning of the file, end to offset from the end of the file, or current to offset from the pointer's current position in the file.

Example

```
string[1024]temp_buffer;
Integer Position;
Position = ftell(0)
while readblock(temp_buffer) do
begin
  if left(tem_buffer,3) = "IEA" then
  begin
    fseek(0,Position,begin);
    break;
  end

ftell

Introduction The **ftell** function obtains the current position of the file pointer and returns the position as an integer. To invoke the **ftell** function against the input file, the value for **current_file** is "0." To invoke the **ftell** function against the output file, the value for **current_file** is "1." The **fseek** function is typically used in conjunction with only the **fseek**, **readblock**, and **writeblock** functions.

Syntax `numeric_variable = ftell(current_file);`

Example

```
string[1024]temp_buffer;
Integer Position;
Position = ftell(0)
while readblock(temp_buffer) do
begin
    if left(temp_buffer,3) = "IEA" then
        begin
            fseek(0,Position,begin);
            break;
        end
    writeblock(temp_buffer);
    Position = ftell(0);
end
//Read segment from input file and place in temp_buffer. Look for
//"IEA" segment tag. If found, reset file pointer to where it was
//before the "IEA" segment was read. Write contents of temp_buffer

get

Introduction The **get** function enables you to access individual components of a datetime variable.

Syntax `integer_variable = get datetime_component (datetime_variable);`

where: integer_variable=integer variable
datetime_component=individual component of the datetime variable
datetime_variable=datetime variable of which you want to access a component part

Example

```
integer a;  
integer b;  
datetime d;  
a = get days (d);  
b = get hours (d);  
//Accesses the days from the datetime variable "d" and loads into  
//variable "a". Accesses the hours from the datetime variable "d"  
//and loads into variable "b".
```

if...then...else

Introduction You can use the **if**, **then**, and **else** keywords to apply conditional logic. Use conditional logic to have GENTRAN:Server test conditions and then, depending on the results of the test, perform different operations.

Note

Do not end conditions with a semicolon (;). This terminating syntax is necessary for statements *only*.

if/then You can use the **if/then** keywords to execute one or more statements conditionally. The condition is typically a comparison, but it can be any expression that concludes with a numeric value. GENTRAN:Server interprets the value as either *true* or *false*. A zero value is false and a nonzero value is true.

GENTRAN:Server evaluates the **if/then** condition, and if it is true, the system executes all the statements that follow the **then** keyword. If the condition is false, none of the statements following **then** are executed.

else You can use the **else** keyword in conjunction with **if/then** to define several blocks of statements, one of which is executed. GENTRAN:Server tests the first **if/then** condition. If the condition is false, the system proceeds to test each sequential condition until it finds one that is true. The system executes the corresponding block of statements for the true condition. If none of the **if/then** conditions are true, the system executes the statements that follow the **else** keyword.

Nesting conditions You can nest conditions to any level.

Example

```
if condition then
begin
    statement1;
    statement2;
end
else
begin
    statement3;
    statement4;
end
```

index




Introduction The **index** function enables you to determine which instance of a particular loop the translator is currently accessing.

Syntax `index(integer_variable);`

where: `integer_variable`=integer variable that indicates the hierarchical level for which you want to determine the loop count

Example

```
index(1)
//This extended rule is located on the ILD group in the diagram
//below. This determines the current loop count for the first level
//(ODD) in the hierarchical structure.
```

```
INVOIC -M- INVOICE DETAILS 
  ODD -M- 999999 
    ILD -M- 999999 
```


left

Introduction The **left** function extracts a specified number of characters from the left side of a string variable or field and returns the result as a string.

Syntax The syntax is as follows:

```
string_variable = left(string_variable,num_char)
```

```
where:num_char=integer variable
```

Example

```
string [25]name;  
string [5]temp_variable;  
name = "Acme Shipping Company"  
temp_variable = left(name,4);  
// "temp_variable" would contain "Acme"
```

len

Introduction The **len** function is a numerical function that counts and returns the number of characters in a string. The numerical functions enable you to convert one data type to another.

Syntax `number_char = len(string);`
where: num_char=integer variable

Example

```
integer a;  
a = len("hello");  
// "a" contains the value 5
```

messagebox

Introduction The **messagebox** function enables you to display on the monitor a message box for which you have designated the format and content. You can specify the number and type of buttons on the message box, the message icon (for example, hand, question mark, exclamation point, or asterisk), and the message displayed. You can also issue a return value based on the chosen action, such as a Yes or No response from the user. This function is useful for debugging maps.

Syntax `messagebox("message",defined_number)`

where:message=message string
 defined_number=defined number of the desired buttons plus the defined number of the desired icon (if used)

Example

```
if messagebox("Do you really want to delete this object?",36) = 6
begin
.
.
.
end

//Displays a message box with the given string as the message, Yes
//and No buttons (4) and a question mark icon (32). The number and
//type of buttons (4) plus the icon (32) equals the defined_number
//(36). If the user clicks the Yes button (return value "6"), the

Introduction The **mid** function extracts characters from a specified position in a string, either to the end of the string or for a specified number of characters, and returns the resultant string. This function is zero-based.

Syntax `string_variable = mid(string_variable,start_pos,num_char)`

where:start_pos =integer variable
num_char=integer variable

Example

```
string [25]name;  
string [10]temp_variable;  
name = "Acme Shipping Company"  
temp_variable = mid(name,6,8);  
// "temp_variable" will contain "Shipping"
```

ntoa

Introduction The **ntoa** function is a numerical function that converts real numbers into strings. The numerical functions enable you to convert one data type to another.

Syntax string = ntoa(real,string);

where:real=real number variable
string=string variable

Example

```
real b;  
string[8] s;  
b = 5.5;  
ntoa(5.5, s);  
//The variable "s" contains the string "5.5".
```

param

Introduction The **param** function is used to read the value of the PARAM(n) variable. This extended rule enables you to pass data strings between the core translator and the lftran translator program. You can run this rule from any scope (pre-session, post-session, group onbegin, field, and so on).

Syntax param(integer_PARAM_number);

where: interger_PARAM_number = the number of the pre-defined variable

Example

```
//populate field #0351 with value of Param2
#0351 = param(2)
```

readblock

Introduction

The **readblock** function reads a block of data (segment or record) from the input file and places it into the argument of a string variable. The **readblock** and **writeblock** functions are used in conjunction with each other to pass a block of data from the input file to the output file without compliance checking or testing for proper EDI syntax. Used together, these functions provide a more efficient alternative to using wildcard segments.

Syntax

`readblock(string_variable);`

Example

```
while readblock(temp_buffer) do
begin
  if left(temp_buffer,3) = "IEA" then
  begin
    fseek(0,Position,begin);
    break;
  end
  writeblock(temp_buffer);
  Position = ftell(0);
end
//Read segment from input file and place in temp_buffer. Look for
//"IEA" segment tag. If found, reset file pointer to where it was
//before the "IEA" segment was read. Write contents of temp_buffer
//to output file. Set "Position" = the current file pointer
//position.
```

readbytes

Introduction

The **readbytes** function reads a number of bytes from the input file. This function is used in conjunction with the **writebytes** function. Together, the **readbytes** and **writebytes** function provide an efficient method to pass data through a map if the data does not need to be compliance checked or altered in any way.

Readbytes is similar to the **readblock** function. However, **readblock** works with entire blocks only, such as an entire segment or record. **Readbytes** works with any quantity of data, whether it is smaller or larger than a block.

The **readbytes** function uses two parameters:

- ▶ The string variable into which the data being read will be stored
- ▶ The number of bytes to read

Syntax

```
readbytes(read_from_buffer, num_bytes);
```

where: **read_from_buffer**=string variable into which the data being read will be stored

num_bytes=integer value representing the number of bytes to read from the input file.

Note

Readbytes returns the number of bytes it was actually able to read.

Example

```
string [1024] tempBuffer;
while readbytes(tempBuffer,1024) do
begin
writebytes(tempBuffer,1024);
End
//Read 1024 bytes from input file and place in string variable
//named tempBuffer.

writebytes("^0D^0A",2);
//Appends a CRLF to the end of the output file.
```

right

Introduction The **right** function extracts a specified number of characters from the right side of a string variable or field.

Syntax `string_variable = right(string_variable,num_char)`
where: num_char=integer variable

Example

```
string [25]name;  
string [10]temp_variable;  
name = "Acme Shipping Company"  
temp_variable = right(name,7);  
// "temp_variable" would contain "Company"
```

set

Introduction The **set** function enables you to define individual components of a datetime variable.

Syntax `set datetime_component (datetime_variable, integer_variable);`

where: `datetime_component`=individual component of the datetime variable
`datetime_variable`=datetime variable of which you want to access a component part
`integer_variable`=integer variable

Example

```
integer a;  
integer b;  
datetime d;  
set days (d,a);  
set hours (d,a);  
//Defines the days of the datetime variable "d" from variable "a".  
//Defines the hours of the datetime variable "d" from variable "b".
```

setparam

Introduction The **setparam** function writes a value to a PARAM(n) variable. This enables you to pass data strings between the core translator and the outer translator program (lftran). You can run this rule from any scope (pre-session, post-session, group onbegin, field, and so on).

Use in audit record In GENTRAN:Server for UNIX, PARAM(0) is used exclusively to store a mapped value in the audit record. After translation, the translator copies the content of PARAM(0) into the User Buffer field of the EDI audit record, edihist.dat/.idx. If the contents of PARAM(0) exceed 53 characters, the translator copies only the first 53 characters.

Reference

See the [edistat.i/o, edihist.dat/idx](#) topic of the [File Record Layouts](#) chapter in the *GENTRAN:Server Technical Reference Guide* for the layout of the audit record.

Syntax setparam(integer_PARAM_number, string_data);

where: interger_PARAM_number = the number of the pre-defined variable,
string_data = the value of the data assigned to the parameter

Example In the following example, #0324 is a field in the map. If the content of field #0324 is a PO number, such as PO152893, then parm 0 contains the string "The PO for this order is: PO152893."

strMsg = strMsg + #0324;

strdate

Introduction The **strdate** function converts a datetime type into a string using a format that you specify. This function allows you to include static characters such as a slash (/), which gives you access to full date support.

Syntax `strdate(datetime,"format",string);`

where:datetime=datetime variable (month specified as 0-11)
 format=desired date format
 string=string variable

Example

```
datetime d;
string[8] s;

strdate(d,"%y/%m%d",s);

//Converts a datetime variable into an eight character string in
//the format "year/month/day".
```

Introduction The **strstr** function finds a substring inside a string. This function returns the position of the first instance of the designated substring within the specified string. If this function does not find the specified substring in the string, it returns a value of "-1". This function is zero-based.

Syntax `integer = strstr("string","substring");`

where:integer=integer variable
string=string
substring=part of the string

Example

```
integer d;  
  
d = strstr("mississippi","is");  
  
//Finds the first instance of the substring "is" inside the string  
//"mississippi" and returns the position of that first substring.
```

unreadblock

Introduction

The **unreadblock** function moves the input file-pointer back one block. (A block of data is equivalent to one EDI standard segment or one positional record.) Unreadblock is used with the readblock function to “unread” the block of data that readblock just processed. The unreadblock function unreads only the most recent block of data processed.

Note

Use unreadblock in conjunction with the readblock function only.

Unreadblock is an alternative to using the fseek and ftell functions, and is the preferred method of moving the file pointer back one block of data. Unreadblock allows the translator to correctly track the number of bytes read and number of segments read during the translation process by moving the file-pointer back and decrementing the segment and bytes counts accordingly.

Syntax

```
unreadblock();
```

Example

```
string[1024] tempBuffer;

while readblock(tempBuffer) do
begin
if left(tempBuffer,3) = "IEA" then
begin
unreadblock();
break;
end
writeblock(tempBuffer);
end

//Read segment from input file and place in tempBuffer variable.
//Look for the "IEA" segment tag and, if found, reset the file-
//pointer to where it was located before the "IEA" segment was
//read. Write contents of tempBuffer to output file.
```

while...do

Introduction

The **while...do** function executes a statement repeatedly until the specified termination condition evaluates to zero. The system tests the terminating condition *before* each iteration of the loop, so a **while** loop executes zero or more times depending on the value of the termination expression.

Note

Do not end conditions with a semicolon (;). This terminating syntax is necessary for statements *only*.

Example

```
integer i;

while i < 10 do
begin
    if (i = 8) then
        continue;
    if (i = 9) then
        break;
end
//While "i" is less than ten, execute the loop. If "i" is equal to
//or greater than ten, terminate the loop.
```

writeblock

Introduction

The **writeblock** function writes the data contained in the argument of a string variable to the output file. The **readblock** and **writeblock** functions are used in conjunction with each other to pass a block of data from the input file to the output file without compliance checking or testing for proper EDI syntax. Together these functions provide a more efficient alternative of using wildcard segments.

Syntax

```
writeblock(string_variable);
```

Example

```
while readblock(temp_buffer) do
begin
  if left(tem_buffer,3) = "IEA" then
  begin
    fseek(0,Position,begin);
    break;
  end
  writeblock(tem_butffer);
  Position = ftell(0);
end
//Read segment from input file and place in temp_buffer. Look for
//"IEA" segment tag. If found, reset file pointer to where it was
//before the "IEA" segment was read. Write contents of temp_buffer
//to output file. Set "Position" = the current file pointer
//position.
```

writebytes

Introduction

The **writebytes** function writes a specified number of bytes to the output file. You use this function in conjunction with the **readbytes** function. Used together, the **readbytes** and **writebytes** function provide an efficient method of passing data through a map if the data does not need to be compliance checked or altered.

Note

The system does not append a segment terminator to the end of the string value written to the output file.

Writebytes is similar to the **writeblock** function. However, **writeblock** works only with entire blocks, such as an entire segment or record. **Writebytes** works with any quantity of data, whether it is smaller or larger than a block.

The **writebytes** function uses two parameters:

- The string variable containing the data to be written to the output file
- The number of bytes to write

Syntax

```
writebytes(write_to_buffer, num_bytes);
```

where: **write_to_buffer**=string variable containing the data to be written to the output file

num_bytes=integer value representing the number of bytes to read from the **write_to_buffer** variable and write to the output file

Note

If hex values are used in constants, use `\0x` instead of `^`.

Example

```
string [1024] tempBuffer;
while readbytes(tempBuffer,1024) do
begin
writebytes(tempBuffer,1024);
End
//Read 1024 bytes from input file and place in string variable
//named tempBuffer.

writebytes("^0D^0A",2);
//Appends a CRLF to the end of the output file.
```

Reconciliation ID record	A record containing a set of interchange and group IDs used with functional acknowledgments.

TRADACOMS record	A record containing all of the supplementary Trading Partnership information for use with TRADACOMS standards.

Trading Partnership Records

Introduction

Trading Partnership records hold information about your trading partner. GENTRAN:Server uses the information you define in the Trading Partnership records every time it processes your data. During translation, GENTRAN:Server inserts the information defined in the Trading Partnership records into the stream of data that you are sending your trading partner. Specifically, GENTRAN:Server uses this information when building the Interchange envelope, the Group envelope, and the transaction set envelopes.

This section describes all Trading Partnership records and examines the relationships among them.

Understanding Trading Partnership records

Trading Partnership records are those records you maintain with the Trading Partnership Editor. The following records define a trading Partnership:

- ▶ Interchange Organization record
- ▶ Group Organization record
- ▶ Trading Partnership record
- ▶ Category record
- ▶ Reconciliation ID record
- ▶ Contact record

The system hierarchically defines the Trading Partner records. At the highest level is the Interchange Organization record. Below the interchange level is the Group Organization record. At the lowest level is the Trading Partnership record.

To translate data in GENTRAN:Server, you must define each of the following for every document that you want to process:

- ▶ One Interchange Organization record
- ▶ One Group Organization record
- ▶ One Trading Partnership record.

Depending on your organization's needs, you may also define the Category, Reconciliation ID, and Contact for the Trading Partnership.

(Continued on next page)

Interchange Organization record

The Interchange Organization record contains information that is used when GENTRAN:Server creates the interchange envelope around your EDI data. Interchange Organization records must be unique for each interchange-level organization. In other words, you must have a separate Interchange Organization record for each interchange-level organization.

Group Organization record

The Group Organization record contains information that GENTRAN:Server uses when creating the group envelope around your EDI data. You may create multiple group records for a single interchange record.

Group Organization records must be unique for each group-level organization. In other words, there must be a separate Group Organization record for each group-level organization.

Trading Partnership record

The Trading Partnership record contains basic Trading Partnership information such as the Trading Partnership Code, the compiled map (translation object) GENTRAN:Server will use when translating business documents for this partner, and whether the system will generate an acknowledgment.

Trading Partnership records need not be unique for each Trading Partnership. In other words, two or more trading partnerships can use the same Trading Partnership record.

Category record

The Category record is a record you create that allows you to group trading partnerships according to similarities of interest. You may create up to five category types for use with your trading partnerships.

Reconciliation ID record

The Reconciliation ID record contains Reconciliation IDs for use in functional acknowledgments and CONTRLs. If the Interchange IDs and Group or Application IDs in your functional acknowledgments or CONTRLs are different than those used in the document being acknowledged, you must have a Reconciliation ID record in addition to a Trading Partnership record for each Trading Partnership.

Reconciliation ID records must be unique for each Trading Partnership.

Contact record

You use contact records to store the name, address, and telephone number of a contact at your trading partner's place of business. You can create separate Contact records at the interchange, group, and trading partner level.

Contact records must be unique for each individual with whom you communicate in your trading partner's organization.

Trading Partnership Administration

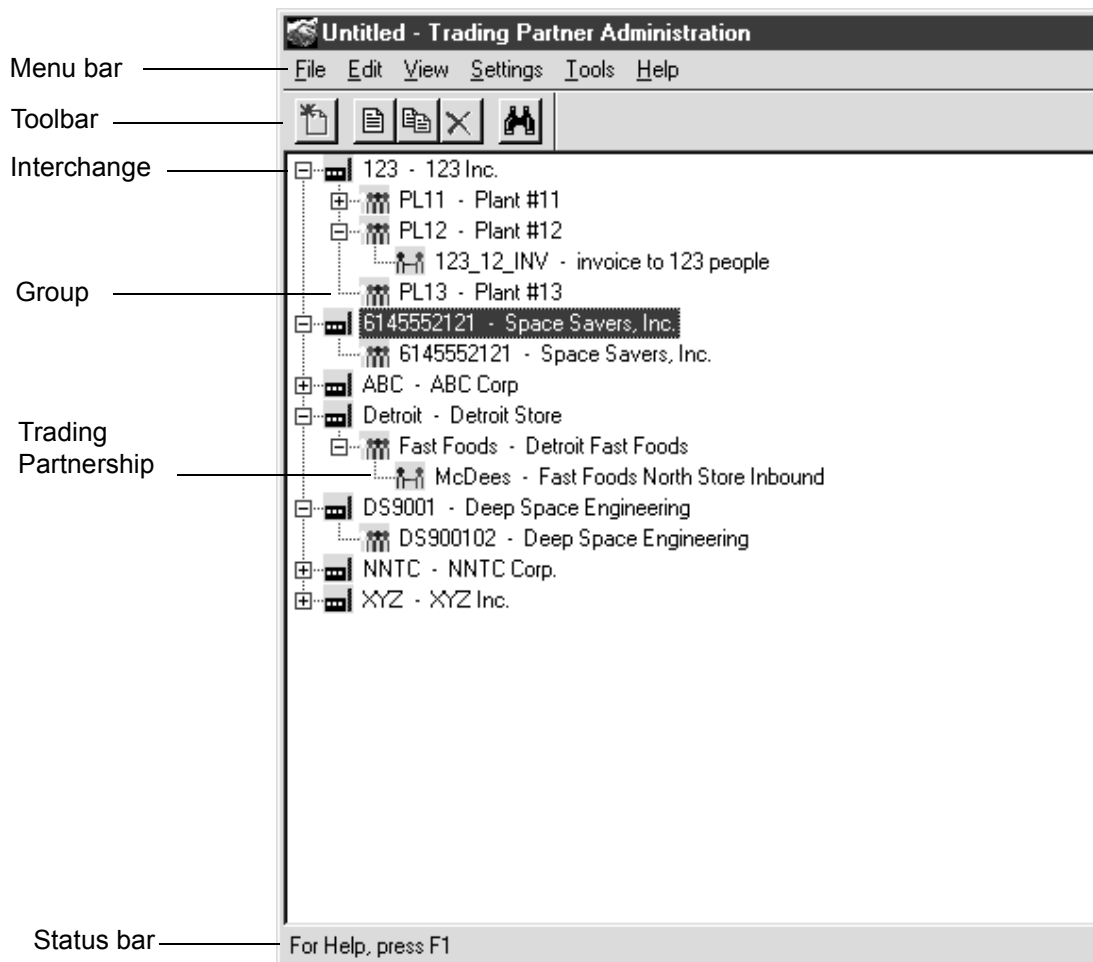

Trading Partner Administration explorer fields and functions

Field	Function
Menu bar	Opens menus to display commands.
Toolbar	Starts another function, such as the Save or Delete function.
Interchange	Identifies an Interchange Organization record, which contains all information specific to a single company
Group	Identifies a Group Organization record, which contains all information specific to a single division or department in your trading partner's organization.
Trading Partnership	Identifies a Trading Partnership record, which contains information about one of the trading partnerships you have established.
Status bar	Displays a status message, prompt, or toolbar button description.

Viewing options

The Trading Partnership Administration window has four viewing options:

- No tree
- Trading Partnership records only
- Organization records only
- Entire tree

How to Select a Trading Partner View

Overview This section explains the four views available in Trading Partnership Administration.

Introduction You choose a view in Trading Partnership Administration based on these criteria:

- The number of Trading Partnership records you want to display.
- The number of records you maintain.
- Whether you have assigned Interchange and Group Organization codes to your Trading Partnership records.

Four viewing options

This table lists the available views and their functions.

View...	Description...
No Tree	An empty dialog box.
TP Only	A list of Trading Partnership records.
Org Only	A list of all Organization codes. Use when you have a large number of records.
Entire Tree	A complete tree view that includes a list of all Organization and Trading Partner records. Includes records that are not defined for any Organization code.

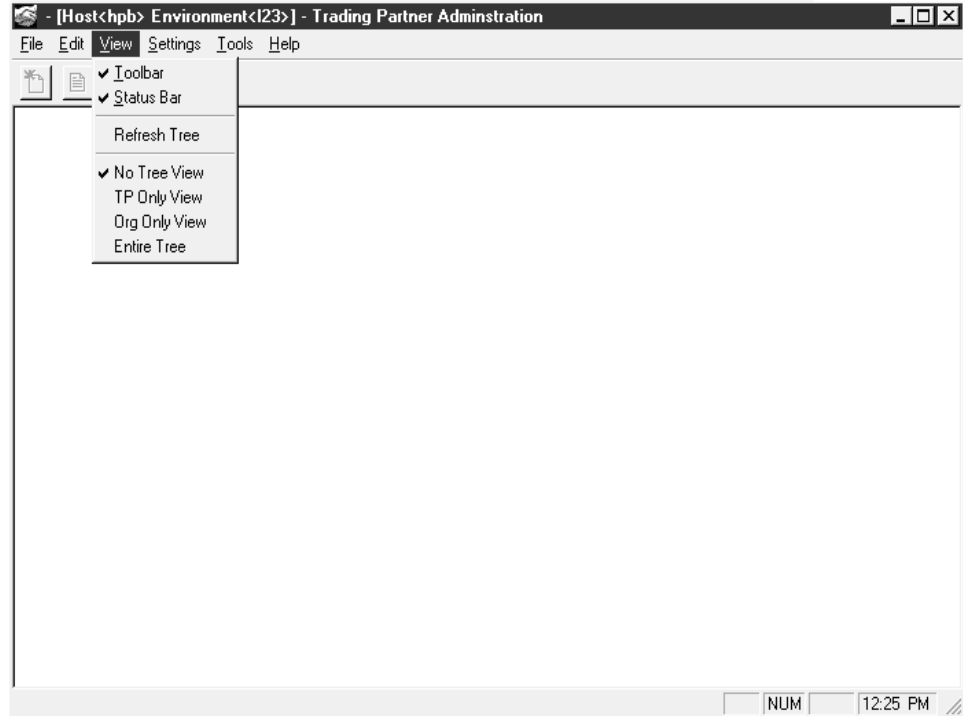
No Tree When you select **No Tree** view, the system displays a blank screen.

Use this view for these tasks:

- Searching for and editing a single Trading Partnership Record.
- Creating new Interchange Organizations, Group Organizations, and Trading Partnership records.
- Performing all functions quickly.

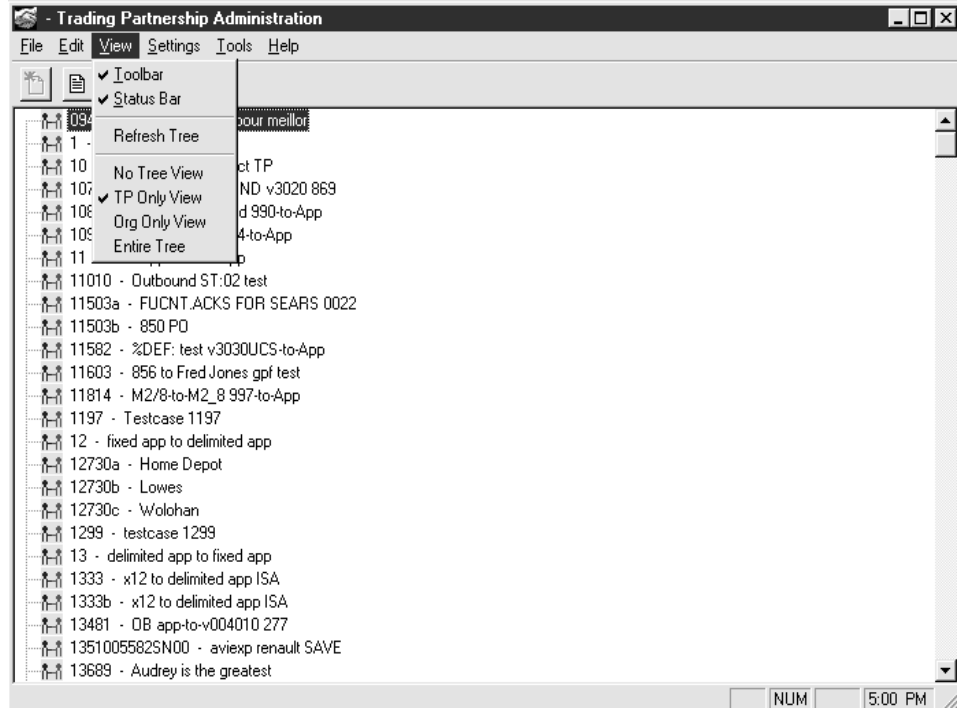
TP Only When you select **TP Only** view, the system displays a list of all Trading Partnership records.

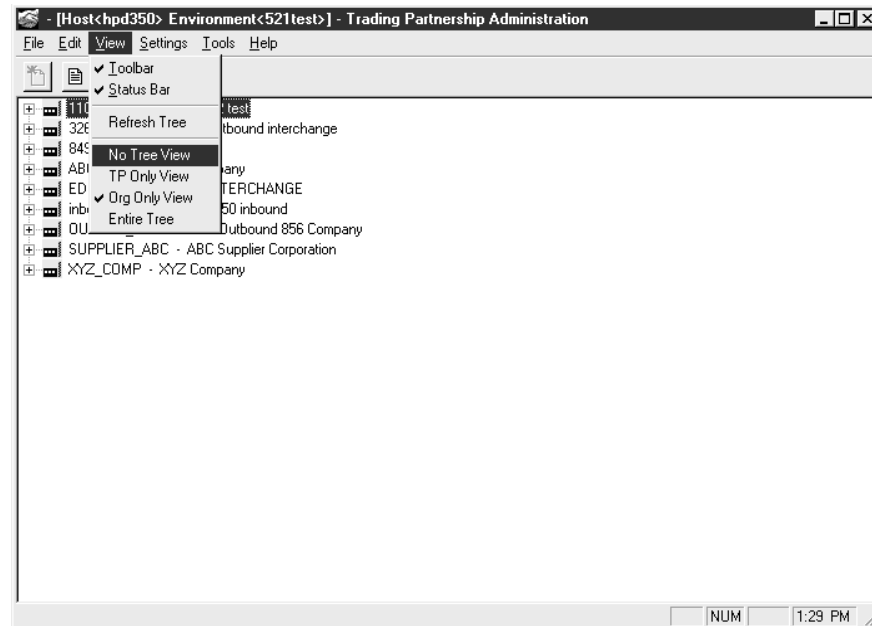

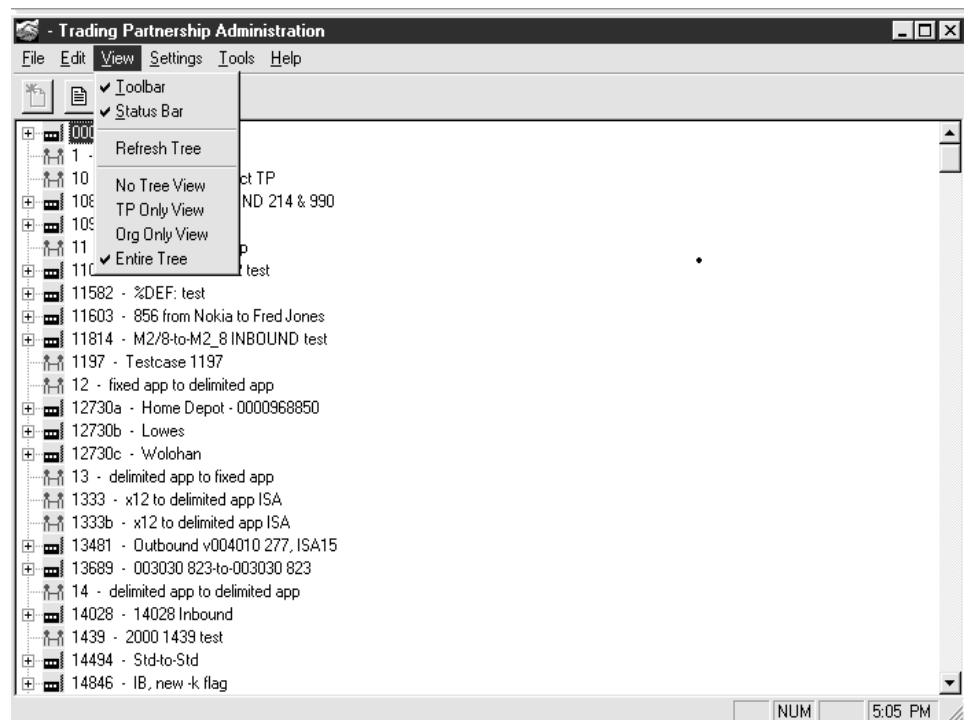
When you select the **Entire Tree** view, the system displays all Interchange and Group Organization codes and all Trading Partnership records.

This illustration shows the Trading Partnership Administration using the **Entire Tree** view.



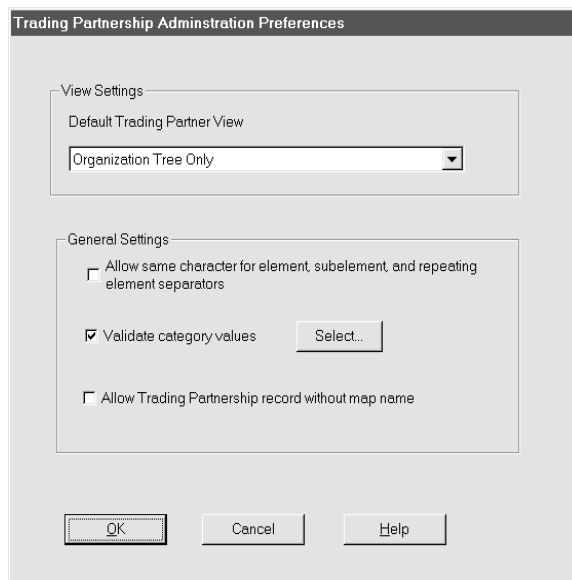
How to Set TP Administration Preferences

Overview The default view of the Trading Partnership Administration window is initially set to **Build Entire Tree**.

Note

You can select another view as the default using the Trading Partnership Administration Preference dialog box by clicking **Preferences** on the **Settings** menu. However, if you are using GENTRAN:Server for UNIX, the Security Administrator must grant you the authority to change the setting.




You need to define the General Settings prior to creating and editing the Trading Partnership Record.

Field	Function
Allow same character for element, subelement, and repeating element separators	Disables the warning prompt displayed when the same character is used for element, subelement, and repeating element separators. Also allows the same values.
Validate category values	<p>Validates the selected category against the database.</p> <p>Note Check the Validate category values and choose SELECT to display five categories. You can verify up to five categories in every Trading Partnership Record.</p> 
Allow Trading Partnership record without map name	<p>Disables the warning displayed whenever you create a Trading Partnership record without assigning a map name to it, allowing you to create a Trading Partnership record without assigning a map name.</p> <p>Note If you try to create a Trading Partnership record without assigning it a map name and this option is not selected, the system displays an error message.</p>

How to Set Default Translation Selections

Introduction You can set default (automatically assigned) translation selections for the Trading Partnership records you create. You set these choices for the type of translation (application-to-standard, application-to-application, etc.).


How the system uses the selections Once you set default translation selections, GENTRAN:Server applies these selections to each subsequent Trading Partnership record you create that has the specified translation type. If you do not want a Trading Partnership to use the default settings, you can set them at the Trading Partnership level to override the default selections.



How to Search for a Trading Partnership Record

Overview

This topic explains how to search for a Trading Partnership record. You can search for Trading Partnership records by ranges of values in various fields. You can also search for specific values such as:

- Interchange or Group IDs
- Organization codes
- Trading Partnership Codes
- Standard versions
- Set IDs, categories, and name.

You enter the search criteria on the Trading Partner Search dialog box. You can run Trading Partner Search on all views except Trading Partner Only view.

Target EDI interchange and/or group IDs	Searches for Trading Partnerships with the interchange or group IDs you specify. Note The Trading Partnership Editor accepts a dollar sign (\$) as a wildcard indicator for this field.
Target a specific standard version	Searches for Trading Partnerships using a specific EDI standard version. Note The Trading Partnership Editor accepts a dollar sign (\$) as a wildcard indicator for this field.
Target message/transaction set ID	Searches for Trading Partnerships with documents that have message or set ID you specify. Note The Trading Partnership Editor accepts a dollar sign (\$) as a wildcard indicator for this field.
Target one or more trading partnership categories	Searches for Trading Partnerships based on a category you have defined.
Target a specific translation mapping table	Searches for Trading Partnerships using a specific compiled map or translation object (TPL table).
Specify the trading partnership name/description	Searches for a Trading Partnership by name.
Target a specific translation type	Searches for Trading Partnerships using one of the valid translation types. The Edit button displays a list of choices.

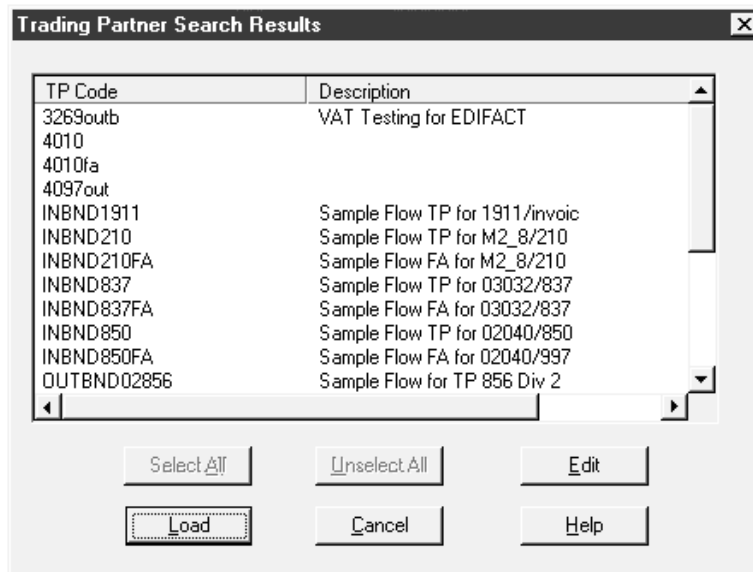

You can select multiple fields when searching for Trading Partnership records. Each field that you select narrows the search and enables you to focus on a specific Trading Partnership.



Introduction

You use the Trading Partnership Editor to create and maintain your Trading Partnership records. When you create a new Trading Partnership record, the Trading Partnership Editor guides you through the information that you need to define for the type of translation you select. You also use the Trading Partnership Editor to alter and update Trading Partnership information in existing records.

Accessing the Trading Partnership Editor dialog box

Use this procedure to open the **Trading Partnership Editor**.

Step	Action
1	Open the Trading Partnership Administration window.
2	Right-click on the Trading Partnership record you want to edit. System Response The system displays a menu of available functions.
3	Click Edit . System Response The system displays the Trading Partnership Editor dialog box.

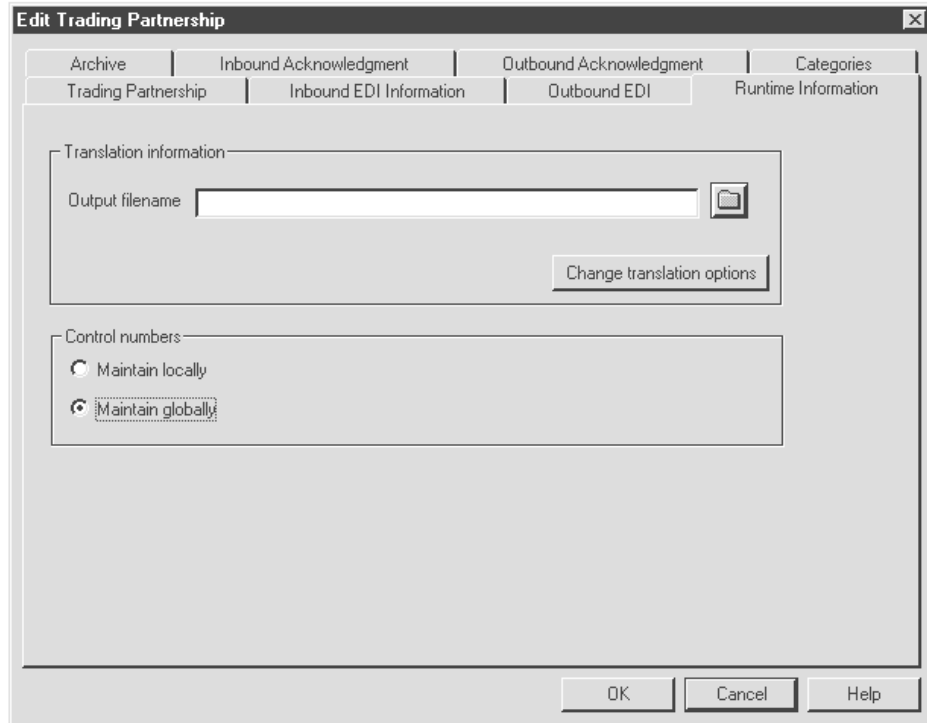

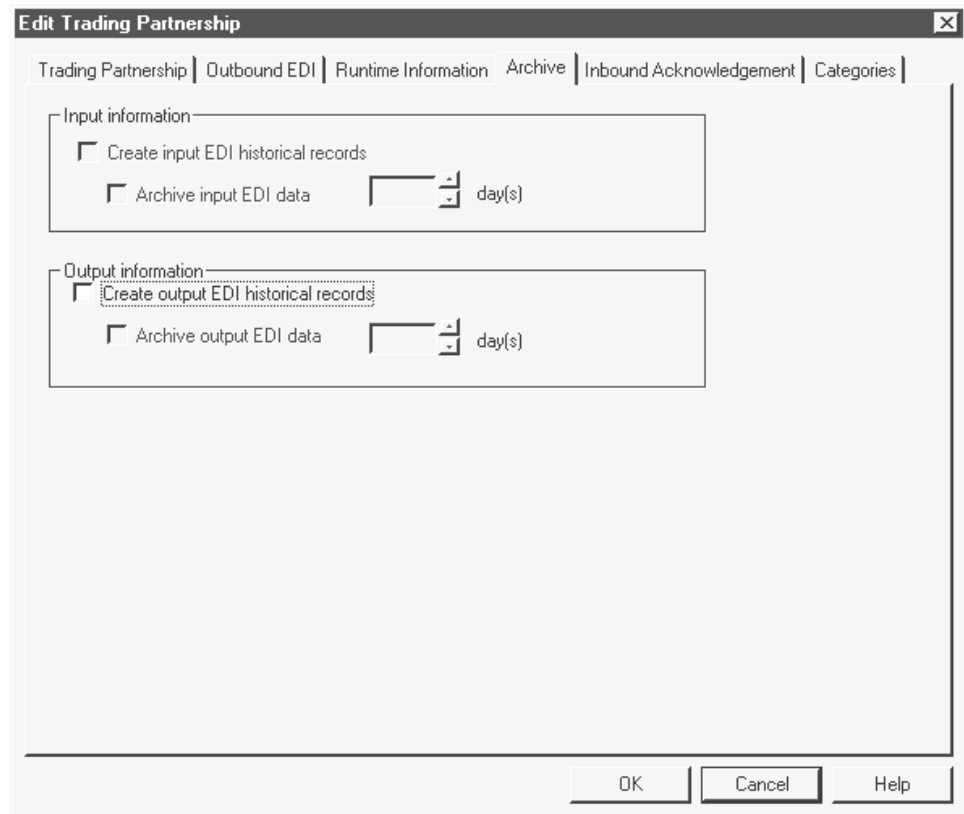

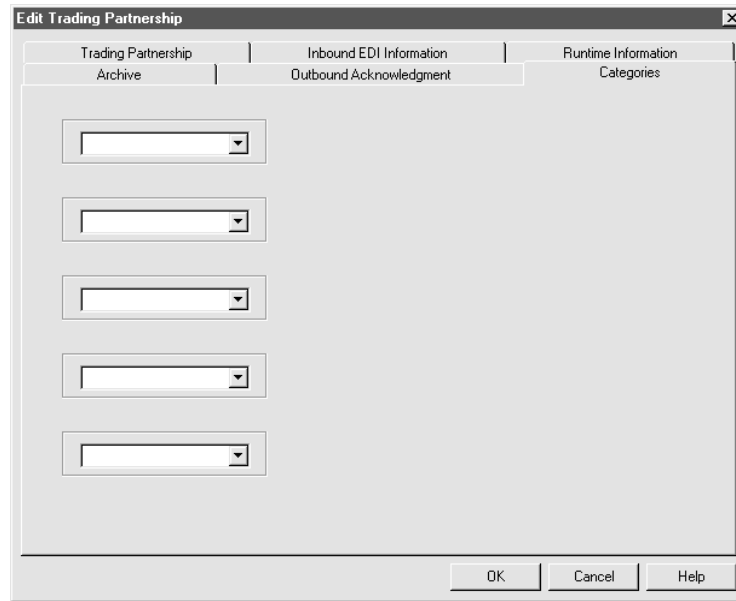

Using wildcard characters

Using Standard Cross Reference Tables

Overview

Introduction

Some GENTRAN:Server components, such as the translator, look in the Trading Partnership record to determine which compiled map (translation object) to use for translation. To find the correct Trading Partnership record, GENTRAN:Server examines each inbound file to determine the six key pieces of information needed to find the Trading Partnership record. These are the six key fields:

- ▶ Your Interchange ID
- ▶ Trading Partner's Interchange ID
- ▶ Your Group ID
- ▶ Trading Partner's Group ID
- ▶ Document (Set) ID
- ▶ Standard Version

Standard version as key field

If the files that a trading partner sends you contain values in the standard version field that GENTRAN:Server does not recognize, the system cannot find the Trading Partnership record.

Note

GENTRAN:Server may find the Trading Partnership record if you used a dollar sign (\$) as a wildcard indicator for the Standard version field on the Inbound EDI tab of the Trading Partnership record.

Purpose of the Standard Cross Reference Table

The Standard Cross Reference Table is a GENTRAN:Server feature that enables you to specify the standard version that you want GENTRAN:Server to use when it finds certain values in the inbound document's standard version fields.

GENTRAN:Server then uses the standard version reference in the table and the other key fields to find the Trading Partnership record.

(Continued on next page)

Example

Your trading partner uses an older version of the EDIFACT standards. The inbound documents this trading partner sends you have 0 in the message release number field and 0 in the release number field. (These are the fields GENTRAN:Server uses to determine the standard version.) When the translator checks these fields for the standard version, it will try to find a Trading Partnership record for standard version 00000 for the trading partner's Interchange and Group IDs.

You create an entry in the Standard Cross Reference Table. The entry cross references the message release number "0" and release number "0" with standard version 001911. This entry directs the translator to use standard version 001911 in a subsequent search if it cannot find a Trading Partnership record for standard version 00000 in its first search.

Translation types

You can use the Standard Cross Reference Table to locate Trading Partnership records that are based on these translation types:

- ▶ Standard-to-application
- ▶ Standard-to-standard
- ▶ Standard-to-XML (if you have the XML translation option)

Standard Cross Reference Table files

The GENTRAN:Server installation process installs an empty Standard Cross Reference Table automatically. The files are DISAM files named *xtable.dat* and *xtable.idx*. GENTRAN:Server stores the files in the directory that holds your Trading Partner files.

GENTRAN:Server provides load and unload utilities to move the *xtable.dat* and *xtable.idx* files.

Standard Cross Reference Table entry

You access the table from the Inbound EDI tab of the Trading Partnership record. Each entry you make to the table is unique to the Interchange ID and Group ID of your trading partner. When GENTRAN:Server checks the table, first it looks for the Interchange ID and Group ID and then for the standard version cross-reference under these IDs.

- ▶ A valid standard version. This is the standard version that you want GENTRAN:Server to use as one of the six key fields it uses to find the Trading Partnership record for the interchange and group ID.



Creating Optional Records

Overview

Introduction Contact records and Category records are optional Trading Partnership records.

Contact records Contact records are used to hold names, addresses, and phone numbers of the people you communicate with in your trading partner's organization.

Category records The category feature enables you to group your Trading Partner records by common category. It is a flexible feature that you can use organize your Trading Partner records in your own way.

How to Create Categories

Introduction

It is often useful to group Trading Partner records by common category. After you define categories, you can use them as selection criteria for viewing, changing, or deleting Trading Partnership records.

You define the categories according to similarities of interest. You may define up to five category types. After you define categories, the category types appear on the Trading Partnership editor's Categories tab.

Example

You create a category called INDUSTRY so that you can group trading partners by industry. Next, you create values for different types of industries, such as retail, manufacturing, or warehousing. You then use these values to locate relevant records when you need to search for a particular group of Trading Partnerships.

About file locking in UNIX version

In GENTRAN:Server for UNIX, the Security subsystem locks Trading Partnership records when you open them for editing. When a file is locked, GENTRAN:Server:

- Prevents you from opening it in another session when you run multiple sessions on your desktop.
- Stops another user from opening the file for editing and displays a message to let the user know that the file is not available for editing, but does allow the user to view the file.

GENTRAN:Server locks these Trading Partnership files:

- Trading Partner record
- Group Organization record
- Interchange Organization record

GENTRAN:Server does not lock these files; so, you must take care not to edit the same file in a parallel session or on another desktop.

- Files edited in the File Browser
- Trading Partnership Category files
- Trading Partnership Contact files.

Note

If the same file is edited in two different parallel sessions, the last changes saved overwrite earlier changes from another session.

Standards compliance

The elements in the interchange and group envelope segments depend on the standard, the standard version, or (for EDIFACT) the syntax level. GENTRAN:Server bases the options it displays for the elements on the information you specify.

Example 1

If you specify X12/ANSI standard version 4020 and later, GENTRAN:Server displays "Repeating Element Separator" and a drop-down list of valid values for element ISA11 on the Interchange Information dialog box. For standard versions prior to 4020, GENTRAN:Server displays "Interchange Standards ID" in the ISA11 element field.



If you specify UN/EDIFACT Syntax Version 4 for UNB element 0002 on the Interchange Header Information dialog box, GENTRAN:Server shows an 8-digit format (for example, 19991129) for element 0017, Date of Preparation, on the UNB and UNG dialog boxes.



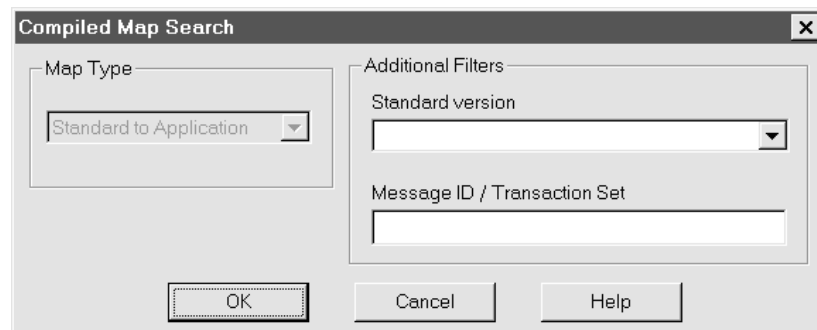

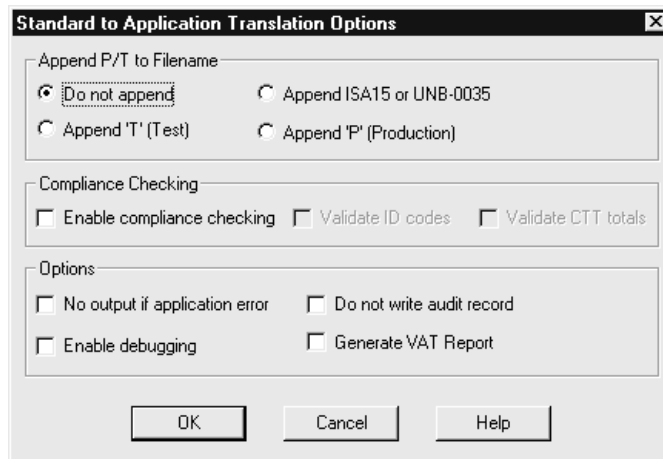

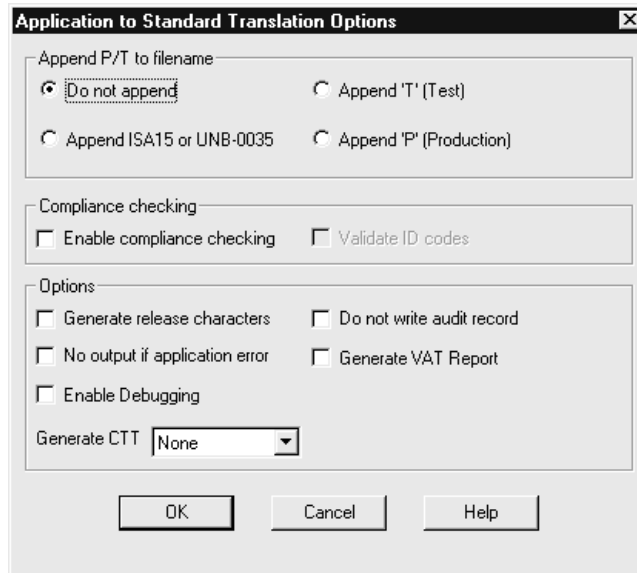

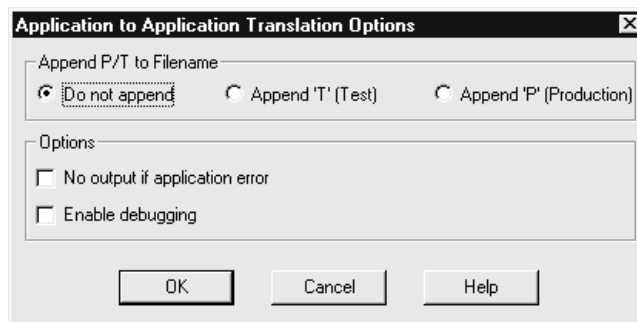

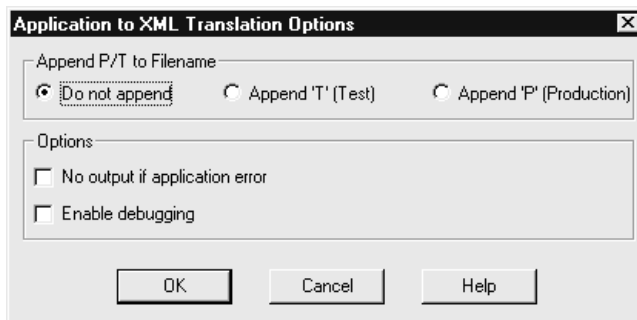

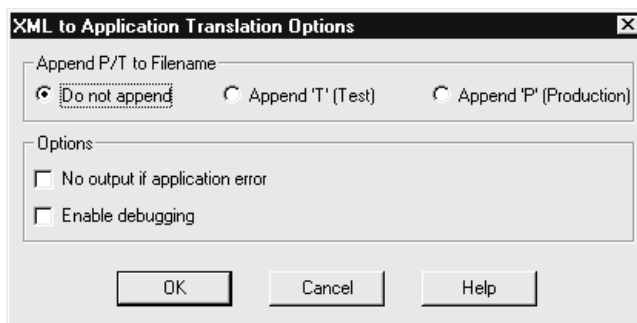

XML to Application Translation Options dialog box

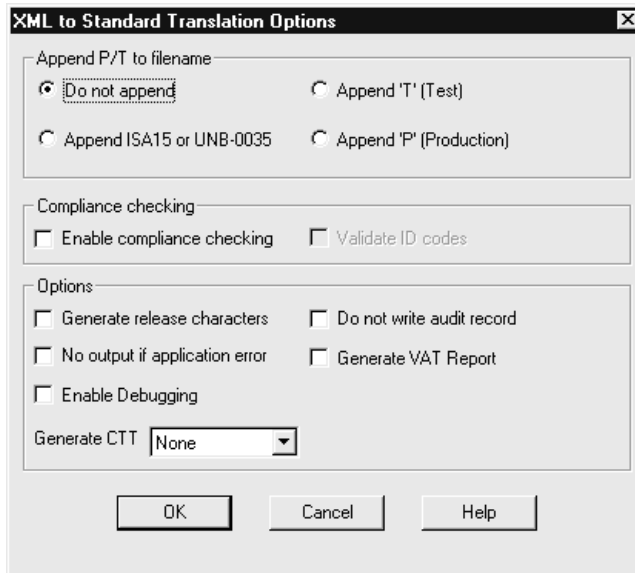

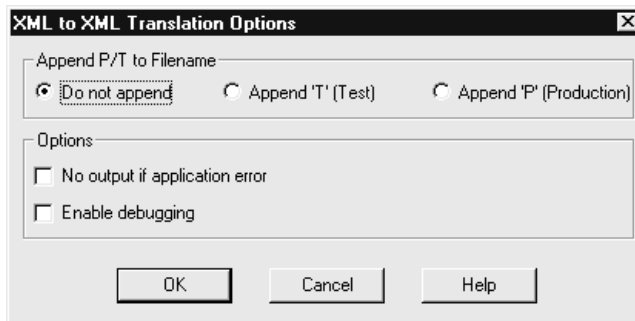

Overview

Introduction

Running translation from a script or batch file

To run translation automatically, include the lfrtran command in a batch file or script.

To run translations on a schedule, enter the lfrtran translation command and the appropriate parameters into a batch file or script, and then run the batch file or script in an unattended mode via the Task Scheduler.

For information about the lfrtran command, see the chapter [Command Reference](#) in the *GENTRAN:Server Technical Reference Guide*.

About translation

Data translation is the primary function of GENTRAN:Server. Data translation takes business data in one computer-readable form and transforms it into another form.

During translation GENTRAN:Server executes the instructions defined in the:

- Translation object or compiled map
- Trading Partnership record
- Translation batch file, script, or translation dialog boxes.

Setting translation options

You can set translation options in several ways:

- ▶ Set default translation options for a particular type of translation in Trading Partnership Administration
- ▶ Set specific translation options for a particular Trading Partnership record. These override any default settings.
- ▶ Set options for a specific input file when you run translation from the Translate menu. These override any other settings.

Key terms

This table describes key terms used in this chapter.

Term	Description
archive	The process of copying and saving EDI data that has been processed.
audit record	A temporary audit file named <i>edistat.i</i> or <i>edistat.o</i> , created during translation, which contains the directory path and file name for the EDI data received or generated. The record does not contain the actual EDI data.
data file	The file that contains the inbound or outbound data.
envelope	The process of combining like interchanges.
functional acknowledgment (FA)	The standard transaction set used to acknowledge receipt of a transmission. The functional acknowledgment tells you if a document was received and processed by your trading partner and whether it contained EDI standard compliance errors. Likewise, the functional acknowledgment you send to your trading partner relays the same information to them.
historical record	The index files named <i>edihist.dat</i> and <i>edihist.idx</i> that store the location of the archived EDI data. The files are built from the audit records that translation produces. Together, they are the permanent audit file.
history audit directory	The EDI History Audit (<i>hisaud</i>) directory used to store permanent history files.

inbound translation	<p>A translation in which the input format of the source document is either an EDI standard format or an XML format that you use to exchange documents with a trading partner.</p> <p>Note Inbound translation using an XML format is available only if you have the XML translation option.</p>
outbound translation	<p>A translation in which the input format of your source document is either an application format or an XML format that you defined for your internal application documents.</p> <p>Note Inbound translation using an XML format is available only if you have the XML translation option.</p>
reconciliation	<p>The process of viewing functional acknowledgments, viewing data with the status of Errors, and correcting the EDI data.</p>
status audit directory	<p>The EDI Status Audit directory (<i>stataud</i>) used to store temporary audit files (<i>edistat.i</i> and <i>edistat.o</i>) and the history audit data.</p>
Trading Partnership Code	<p>A user-defined code that uniquely identifies a Trading Partnership record.</p>
translation	<p>The conversion of data from one format to another.</p>

Inbound and Outbound Translation

Introduction Translation is either inbound or outbound. The dialog boxes, translation objects, and options you use during translation differ for each type of translation.

Inbound translation In an inbound translation, the source or input document is in a data transmission format. The data transmission format can either be an EDI standard or, if you have the XML translation option, an XML format that your trading partner uses to send you documents. These are the types of maps normally used in inbound translation:

- ▶ Standard-to-standard
- ▶ Standard-to-application

XML translation option

If your trading partner sends you files in XML format and you have the XML translation option, you can also run these types of inbound translation.

- ▶ Standard-to-XML (if you have the XML translation option)
- ▶ XML-to-application (if you receive the XML input documents from your trading partner)
- ▶ XML-to-XML (if you receive the XML input documents from your trading partner)
- ▶ XML-to-standard (if you receive the XML input documents from your trading partner)

ODBC translation option

If you have the ODBC translation option, you can define the output application file as an ODBC database format.

For example:

- ▶ Standard-to-application (ODBC)

Outbound translation

In an outbound translation, the source or input document is in a data format that you use for your internal applications. The input format of the source documents is either an application format or, if you have the XML translation option, an XML format that you defined for your internal application documents. These are the types of maps normally used in outbound translation:

- ▶ Application-to-application
- ▶ Application-to-standard

XML translation option

If you have the XML translation option, you can also run these types of outbound translations

- ▶ Application-to-XML
- ▶ XML-to-standard (if you send the output documents to your trading partner)
- ▶ XML-to-XML (if you send the output documents to your trading partner)

ODBC translation option

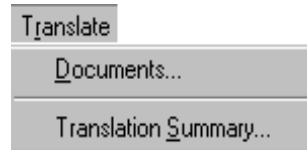
If you have the ODBC translation option, you can define the input application file as an ODBC database format.

For example:

- ▶ Application (ODBC)-to-standard
 - ▶ Application (ODBC)-to-XML

Translation menu options and functions

This table describes the options of the **Translate** menu and their functions.

Option	Function
Documents	<p>Translates both input data files that are coming in to your system and input files that are leaving your system.</p> <p>Inbound data files are in a standard format and are usually translated to your application format. Outbound data files are usually in your application format and are usually translated into an EDI standard format.</p> <p>Note If you have the XML translation option, then your inbound data files can also be in XML format and translated into an XML format.</p>
Translation Summary	Displays selected information about translations.

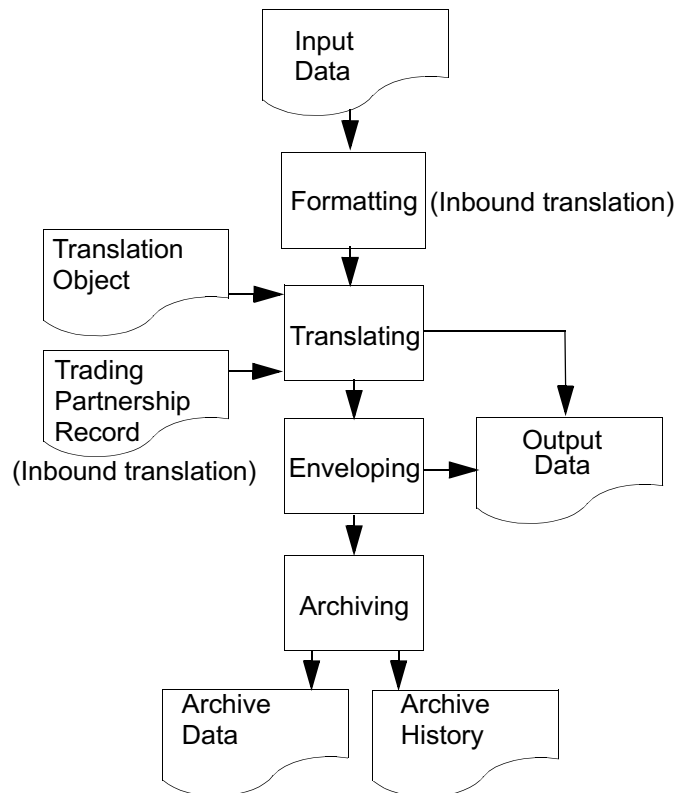

This example describes the typical stages in the default inbound translation process for X12 data that is being translated to application data.

Stage	Description
1	GENTRAN:Server determines the Trading Partnership Code.
2	GENTRAN:Server reads the Trading Partnership record.
3	GENTRAN:Server determines whether outbound acknowledgments are required. <ul style="list-style-type: none"> ▶ If YES, the system generates a Trading Partnership enveloping signature that includes an ACK component for each transaction set and then continues with Stage 4. ▶ If NO, the system continues with Stage 4.

1	GENTRAN:Server determines the Trading Partnership Code.

3	GENTRAN:Server generates a Trading Partnership enveloping signature for the transaction set.
4	GENTRAN:Server translates the set and generates the output data, which includes the enveloping signature.
5	Are there more sets to process? <ul style="list-style-type: none"> ▶ If YES, repeat Stages 1 through 4. ▶ If NO, continue with Stage 6.
6	GENTRAN:Server uses the Trading Partnership enveloping signature to find and lock the Trading Partnership records.

Enveloping Outbound Data

EDI Envelopes

Envelope segments

The EDI transaction sets and functional acknowledgments that you send to a trading partner must include envelope segments. The purpose of an envelope is to ensure that the sender and receiver of the transactions are properly identified and routed properly.

Each envelope level contains two data segments:

- ▶ A header segment to identify the beginning of the envelope
- ▶ A trailer segment to signal its end.

Levels

There are three possible levels of envelopes:

- ▶ Interchange envelope
- ▶ Group envelope
- ▶ Transaction set envelope

The interchange and transaction set envelopes are mandatory for all standards. The group envelope is optional (or not used at all) for many EDI standards.

One interchange envelope can contain multiple groups. One group can contain multiple transaction sets of the same type.

Interchange envelope

The interchange envelope is the outer envelope. The header segment usually contains data elements that specify who the sending party is and the final destination.

Example

The ISA segment is an interchange envelope segment for the ASC X12 standard.

Group envelope

The group envelope is the second-level envelope.

The group header segment begins a group. Within the group segments are data fields that identify the type of transactions contained in the group, the sender and receiver's application IDs, the transmission date, control number, and other standard reference data.

Example

The GS segment is the functional group envelope segment for the ASC X12 standard.

Transaction set envelope

Each transaction is surrounded by a transaction envelope. All detail segments are stored in between the transaction set header and trailer segments.

Example

The ST segment is the transaction envelope for ASC X12 standard.

Location of Enveloping Information

Introduction

GENTRAN:Server builds the interchange, group, and transaction set envelopes from information defined in specific Trading Partnership records. During the enveloping process, GENTRAN:Server inserts the envelope information into the stream of data that you are sending your trading partner.

Record/envelope information table

This table shows the records that GENTRAN:Server uses to envelope outbound EDI data and lists the type of enveloping information each record contains.

Record	Enveloping Information
Interchange Organization record	<ul style="list-style-type: none"> ▶ Your unique interchange identifiers, which are inserted into the Interchange envelope. ▶ Your trading partner's unique interchange identifiers, which are inserted into the Interchange envelope. ▶ The counter used for control numbers for your outbound business documents. ▶ The counter used for control numbers for inbound business documents that you receive from this trading partner.
Group Organization record	<ul style="list-style-type: none"> ▶ A unique Group Organization code that is inserted into the Functional Group envelope. ▶ Your unique group identifier that is inserted into the Functional Group envelope. ▶ Your trading partner's unique Group identifier that is inserted into the Group envelope. ▶ The counter used for control numbers for your business documents. ▶ The counter used for control numbers for inbound business documents that you receive from this trading partner. <p style="text-align: right; color: red;">(Continued on next page)</p>

Outbound EDI tab of the Trading Partnership record	<ul style="list-style-type: none">▶ The type of header segment used for the Interchange envelope.▶ The type of group segment used for the Functional Group envelope.

Introduction

You have two options for enveloping your outbound EDI data:

- ▶ Envelope transactions as part of the translation process
- ▶ Collect output transactions and delay enveloping until a later time

Setting enveloping options

You set enveloping options in the **lftran** command:

- ▶ In a translation script or batch file, or
- ▶ From the Translation Options dialog box if you run translation in attended mode from the Translate menu

4	<p>If lftran is unable to lock the Trading Partnership records, it produces a lock file.</p> <ul style="list-style-type: none"> ▶ If the translation output does not include functional acknowledgments, the sets that were not enveloped are written to boxout.lock in the temp directory. ▶ If the translation output includes functional acknowledgments, the sets and functional acknowledgments that were not enveloped are written to sigout.lock in the temp directory. <p style="text-align: right;">(Continued on next page)</p>

Delayed enveloping

This table shows the stages in the delayed enveloping process.

1	The translator determines that the translation output will be in an EDI standard format.
2	The Iftran program runs with the H0 option to add a delayed envelope signature line to the beginning of each set in the output data. The program does not add envelope segments to the output data. Note The Iftran program can run many times throughout the day.
3	The system collects the output data.
4	The Iftran program runs with the H1 option at a later time, usually according to a schedule. The program processes the collected output data, using the envelope signature lines to locate and lock the appropriate Trading Partnerships records.
5	If Iftran is unable to lock the Trading Partnership records, it produces a lock file. The system writes the sets and functional acknowledgments that were not enveloped to sigout.lock in the temp directory.
6	The Iftran program uses the envelope signature and the information in the Trading Partnership records to generate interchange, group, and set header segments.

Setting Enveloping Options in a Script or Batch File

Introduction

In production mode, you will probably run the **lftran** command with translation and enveloping options in a script or batch file.

Settings for the translation script

This table describes the **lftran** option you must set in your script or batch file.

IF you want to...	THEN...
Envelope the EDI transaction sets during translation	Do not set an enveloping option in lftran , because this is the default enveloping action.
Collect translated files to envelope later (delay enveloping)	Configure your system to run the lftran program twice: <ul style="list-style-type: none"> ▶ First with the H0 option to generate the output file with the signature lines. You can run this option throughout the day. ▶ Later with the H1 option to lock the Trading Partnership records, generate the envelope segments from the signature lines in the collected output files, and then envelope all the collected data.

Handling the lftran output

The translation scripts supplied with GENTRAN:Server produce a boxout.lok file. If you want to reprocess the sets in this file, you must modify the translation script to re-route the file through the translation and enveloping process.

For solutions on processing the sigout.lok file, see the readme file and supplementary white papers for this release of GENTRAN:Server.

Combining like interchange envelopes

If you want to combine like interchange envelope segments into one interchange envelope segment after translation, you must include the **envelope** command in a batch file or script. However, if you are translating with the H1 option and the input files are organized by Trading Partnership code, you can omit the **envelope** command.





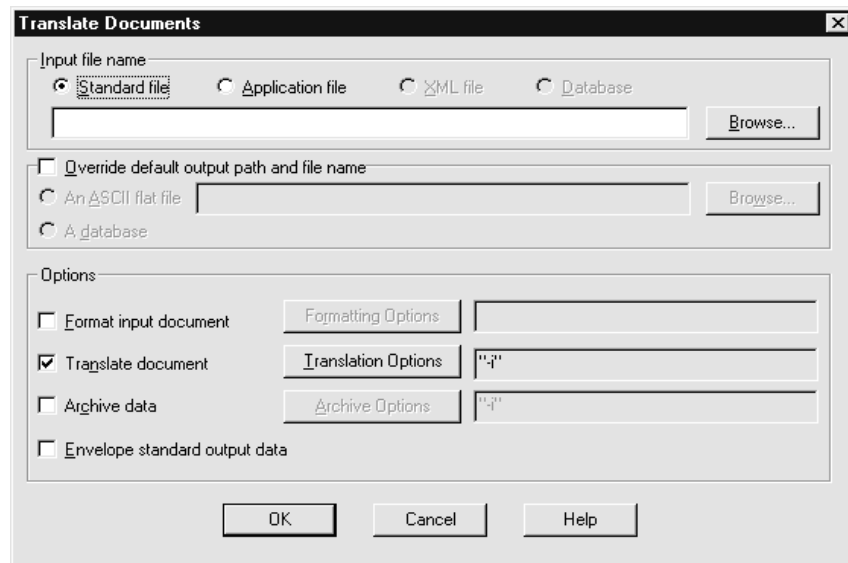

- ▶ Enable enveloping when the output file is in a standard format.

Fields and functions

This table describes the Translate Documents dialog box and their functions. The available options depend upon the type of input file selected.

Field	Function
Input file name	
Standard file	Specifies that the input file is in an EDI standard file format (inbound).
Application file	Specifies that the input file is in an application file format (outbound).
XML File	Specifies that the input file is in XML file format. Note This option is enabled only if you have the GENTRAN:Server XML translation option.
Database	Specifies that the input file is in a database format.
Input file name box	Used to enter the path and name of the file you want to translate. Notes Do not enter environmental variables in this field. You can use the Browse button to locate the file.
Browse	Opens a search dialog box, which enables you to browse the folders to locate the input file name.
Override default output path and file name	Overrides the default location to store the translated data. The default location is specified in the Trading Partnership record. Note You should not enter environmental variables in this field.

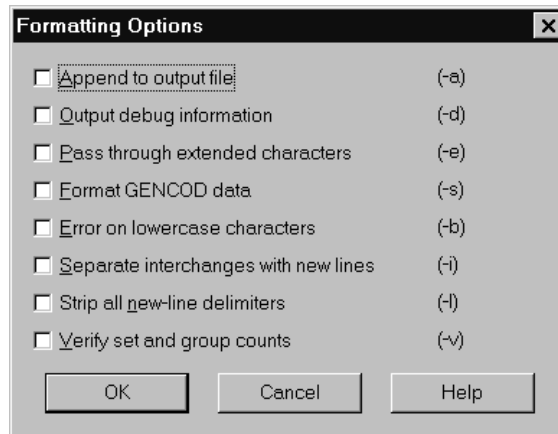

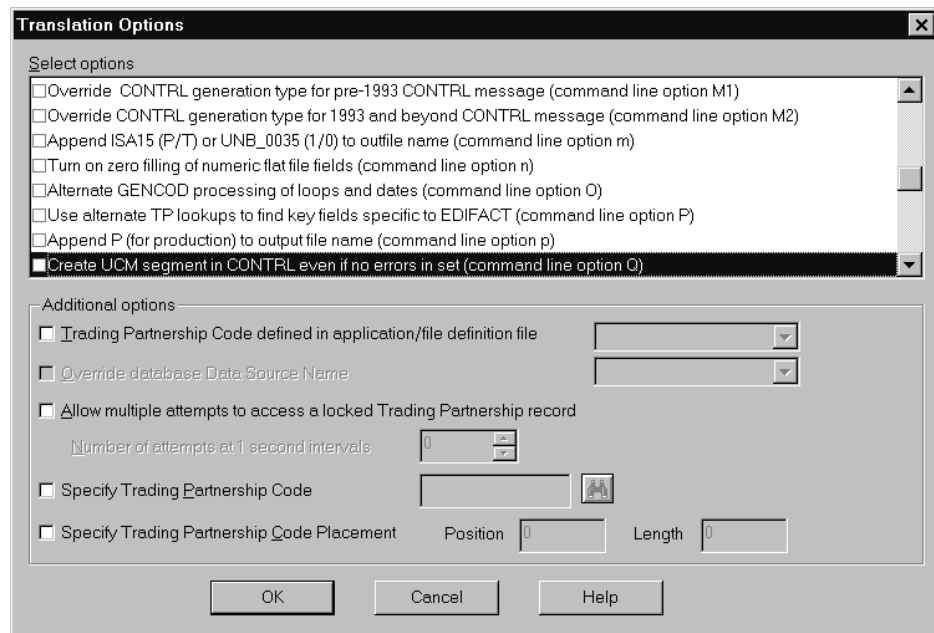

If you want to use different translation options for some Trading Partnerships, set up translation options in the Trading Partnership record. (See [Working with Trading Partnerships](#) in this guide.) If you set translation options in both places, the program uses both sets of options unless they conflict. If some options conflict, GENTRAN:Server uses those set in the Translation Options dialog box.

Note

GENTRAN:Server saves the options from the last run. You do not have to enter them again for subsequent runs unless you want to make additional changes.

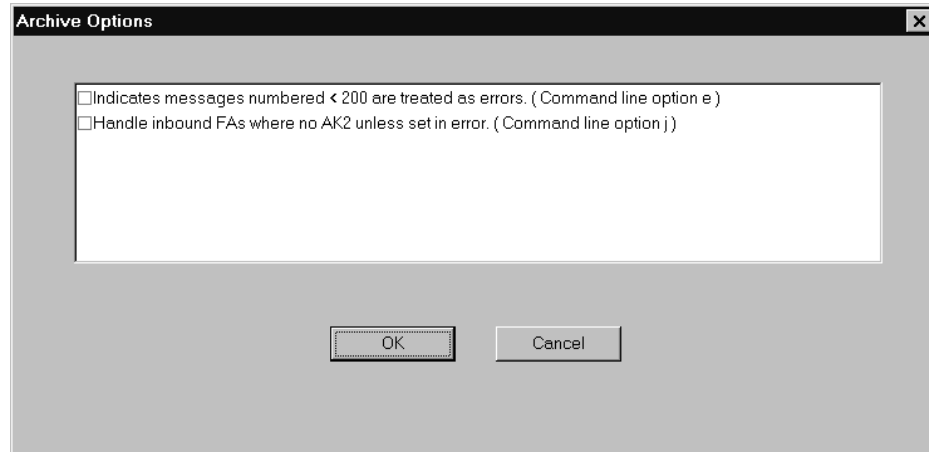

How to Modify the Outbound Envelope Segments

Introduction You can modify the values of the elements in the interchange and group envelope segments that GENTRAN:Server inserts in the envelope segments of a Trading Partnership's:

- ▶ Outbound EDI documents
- ▶ Outbound Functional Acknowledgments.

Standards compliance

The elements in the interchange and group envelope segments depend on the standard, the standard version, or (for EDIFACT) the syntax level. GENTRAN:Server bases the options it displays for the elements on the information you specify.

Example 1

If you specify X12/ANSI standard version 4020 and later, GENTRAN:Server displays "Repeating Element Separator" and a drop-down list of valid values for element ISA11 on the Interchange Information dialog box. For standard versions prior to 4020, GENTRAN:Server displays "Interchange Standards ID" in the ISA11 element field.



If you specify UN/EDIFACT Syntax Version 4 for UNB element 0002 on the Interchange Header Information dialog box, GENTRAN:Server shows an 8-digit format (for example, 19991129) for element 0017, Date of Preparation, on the UNB and UNG dialog boxes.



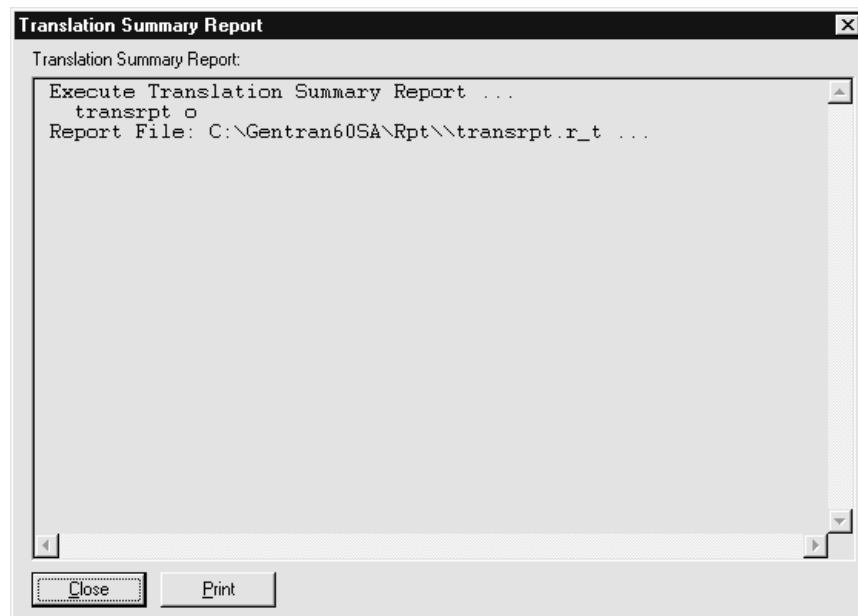

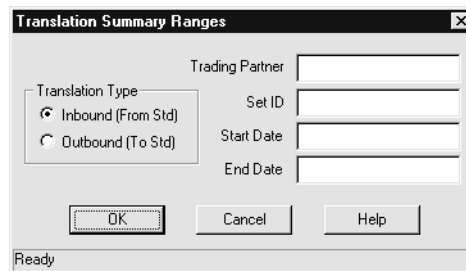

Introduction

About archiving

The GENTRAN:Server archiving feature for EDI translation enables you to store a copy of inbound and outbound EDI document status information that is created during translation, and the actual EDI documents. Through the archive setup windows, you choose the types of records to be archived.

Once data is archived, you can:

- Examine archived inbound and outbound data
- Edit the archived outbound data
- Extract archived outbound data and prepare it to resend it to the trading partner
- Reconcile functional acknowledgments
- Move data to media or to another machine.

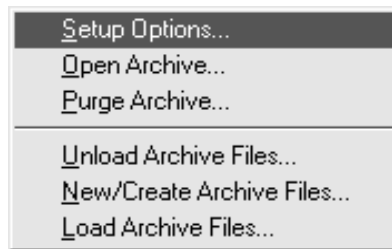

EDI Status Audit directory	The directory used to store temporary translation audit files (<i>edistat.i</i> and <i>edistat.o</i>).
ediarc	The GENTRAN:Server program that controls archiving.
functional acknowledgment (FA)	The standard transaction set used to acknowledge receipt of a transmission. The functional acknowledgment tells you if a document you sent was received and processed by your trading partner. It also can tell you if your document contained EDI standards compliance errors.
historical record	The index files named <i>edihist.dat</i> and <i>edihist.idx</i> that store the location of the archived data. The files are built from the temporary translation audit files. Together, they form the permanent audit file.
reconciliation	The process of viewing functional acknowledgments, viewing data with certain statuses, such as Error, Late, or Waiting, and correcting the EDI data.
status record	A temporary audit file named <i>edistat.i</i> or <i>edistat.o</i> , created during translation, which includes the directory path and file name for the EDI data received or generated. The record does not contain the actual EDI data.

New/Create Archive Files	Creates two historical files named <i>eidhist.dat</i> and <i>edihist.idx</i> . These files are used to prepare for moving archived data from another machine or from media. You populate these files by archiving EDI data or by loading an ASCII file created from the contents of an Archive historical file.
Load Archive Files	Loads the EDI historical files (<i>edihist.dat/.idx</i>) from ASCII file data (<i>edihist.unl</i>).

The Archive Process

Introduction The **ediarc** program controls archiving for EDI translation data. Archiving begins when the translation process produces status records. The subsequent stages in the process depend on how you set up archiving for your system.

Archiving process This table describes the archive process when all archiving options are activated.

Stage	Description
1	<p>During translation, GENTRAN:Server creates temporary audit files named <i>edistat.i</i> (inbound) and <i>edistat.o</i> (outbound) and places them in the EDI Status Audit directory.</p> <p>For each set translated, these audit files include pointers to the directory path and file name for the EDI data received or generated.</p>
2	<p>If you configure your archiving system to save historical records, ediarc posts the status records to the historical files, <i>edihist.dat</i> and <i>edihist.idx</i>, which reside in the EDI History Audit directory.</p>
3	<p>If you configure your archiving system to save EDI data files, ediarc checks the archive switches in the Trading Partnership record to determine which sets to archive and their purge dates. ediarc then copies the EDI data files into a directory hierarchy in the EDI History Audit directory.</p> <p>Reference See the topic How archived files are named in this chapter.</p>
4	<p>If functional acknowledgments were created during the translation, ediarc posts their status to the <i>edihist.idx</i> and <i>edihist.dat</i> files and copies the EDI data file to the EDI History Audit directory.</p>
5	<p>If the data was archived successfully, GENTRAN:Server deletes the temporary status records <i>edistat.i</i> and <i>edistat.o</i>. If an error occurred during archiving, the temporary files are kept for debugging under the names <i>edistat.irr</i> and <i>edistat.orr</i>.</p>
6	<p>GENTRAN:Server writes error messages to the file <i>xlcntl.err</i>, which is in the wrktemp subdirectory under the directory specified for User Files.</p>

How archived files are named

The file name format for archived files is as follows:

`edihist\yyyy\mm\dd\hh\nnnnnnnn.ext`

Where:

- ▶ “edihist” represents the name of the EDI History directory.
- ▶ “yyyy\mm\dd\hh” represents the year, month, day, and hour the data was translated.
- ▶ “nnnnnnnn” is the system-generated 8-character file name.
- ▶ “.ext” represents the file name extension.
 - If you do not select a data compression utility during setup, the extension is *.arc*.
 - If you select a data compression utility during setup, the extension is determined by the compression utility. (*.zip* for Pkzip files, *.z* for packed, and *.Z* for compressed.)

Example

Assume that the EDI History Audit directory is named *edihist*. The data file was translated on January 3, 1997, at 11 a.m. and compressed with Pkzip.

Ediarc copies the file and names it:

`edihist\1997\01\03\11\0000001.zip`

Before you begin

To ensure the accuracy of archiving and functional acknowledgment reconciliation, you must have unique control numbers across all documents for a trading partner. This is because the archiving program does not archive duplicate records; if two different records have the same control numbers, the archiving program rejects the second as a duplicate.

The best way to ensure unique control numbers is to use Organization records and maintain control numbers globally. This causes GENTRAN:Server to automatically assign unique, sequential control numbers to all documents for a single trading partner.

WARNING

If you do not use Organization records and maintain control numbers globally, you must check each Trading Partnership record with the same Interchange IDs and edit the control numbers. Add a unique, sequential prefix (for example, 1, 2, 3, ..., *n*) to each control number so the control numbers are unique.

How to Specify the Translation Audit Directories

Introduction

How your organization specifies the EDI translation audit directories depends on whether you are running GENTRAN:Server for UNIX (client/server) or the GENTRAN:Server Workstation version.

Decision table for Creating Audit Directories

Use this decision table to determine the number and types of audit directories you need to create for the different versions of GENTRAN:Server.

IF you work in a...	THEN create...
Single-user environment in which one user runs translation and archives data	One audit directory that serves as both the EDI Status Audit directory and the EDI History Audit directory.
Multi-user environment in which several users create maps, but only one user runs translation and archives data	One audit directory that serves as both the EDI Status Audit directory and the EDI History Audit directory.
Multi-user environment in which several users run translation and archive data	One EDI History Audit directory that is the same for all users. A private EDI Status Audit directory for each user.

Audit directories for the UNIX version

If you are running GENTRAN:Server for UNIX, your system Security Administrator specified the EDI Status and EDI History Audit directories on the host when your security file was established. Check with your Security Administrator to make sure these directory paths are in place before you run **ediarc**.

The EDI Status Audit directory is your working directory. The EDI History Audit directory stores the path and file name to every archived file.

You can view the paths to these directories by selecting Setup Directories from the Settings menu, but you cannot change the paths. The Security Administrator can change the paths with the Security Administration software installed on the UNIX host.

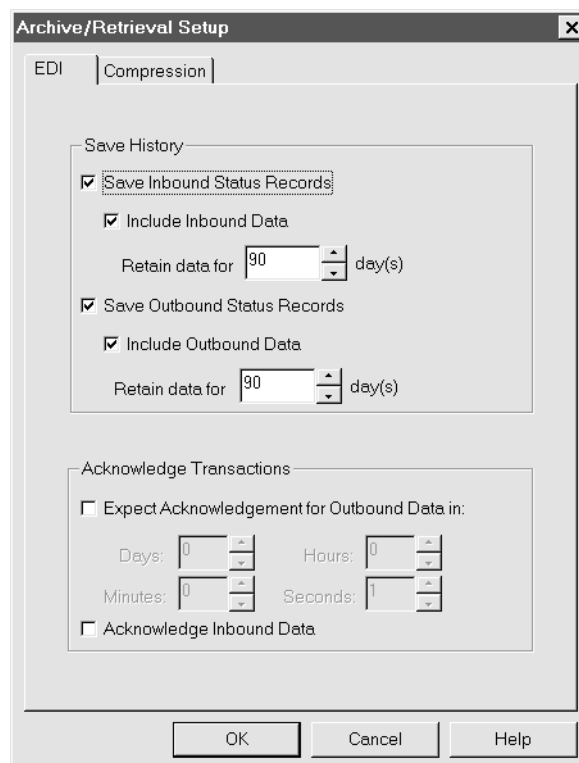

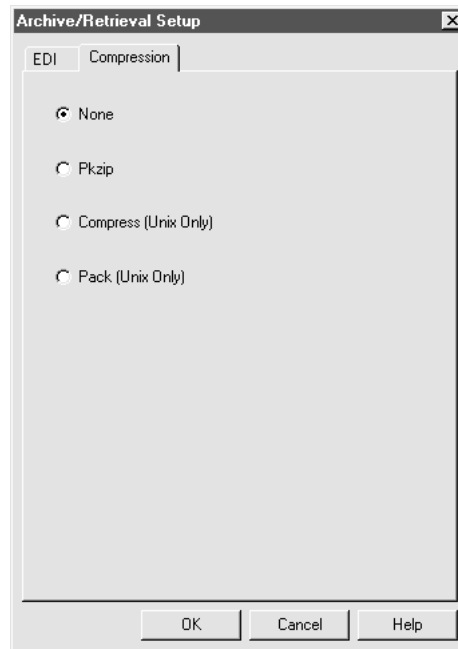

How to Set EDI Translation Archiving Options

Introduction To set up EDI translation archiving and retrieval options to fit your business needs, you begin by selecting **Setup Options** from the **Archive** menu to display the Archive/Retrieval window. You use the EDI tab on this window to choose the records you want the system to archive.

Archiving options On the EDI tab, you choose to have the system perform one or more of the following tasks:

- ▶ Create status records (*edistat.i* and *edistat.o*)
- ▶ Archive inbound status records, outbound status records, or both (create the *edihist.dat* and *edihist.idx* files from the *edistat.i* and *edistat.o* records)
- ▶ Archive inbound data files, outbound data files, or both
- ▶ Keep data files for a specified number of days
- ▶ Look for functional acknowledgments for outbound data in a specified number of days, hours, minutes, and seconds
- ▶ Acknowledge inbound data files.

Option dependencies Archiving starts with the creation of status records, *edistat.o* and *edistat.i*, during translation. These status records are eventually posted to *edihist.dat* and *edihist.idx*, the historical records. The historical records store the location of the archived data. Therefore, to archive and retrieve data files, you must activate both the status record and historical record option.

Where default settings are stored The Archive/Retrieval system default settings for EDI translation are stored in the configuration file *arcopt.cfg*. This file is in the *edihist* directory of each environment.

Relationship to Trading Partnership record

GENTRAN:Server uses the EDI Archiving settings as default settings when you set up a new Trading Partnership record, but enables you to override them for any Trading Partnership record.

To determine which records to archive during processing, GENTRAN:Server checks the archive options of the Trading Partnership record.

How to Select a Data Compression Utility

Introduction Archived data can consume large amounts of disk space. To help control disk space, you may use a compression utility to reduce the size of your archived documents.

Before you begin GENTRAN:Server does not include compression utilities. If you want to compress your archived data, you must have installed one of the compression utilities that GENTRAN:Server supports:

- ▶ Pkzip
- ▶ Compress
- ▶ Pack

Important note

After the utility is installed, you must add the utility to your user path.

**How

works**

When you select a compression utility, GENTRAN:Server records your selection in a configuration file. During archiving, GENTRAN:Server checks this file to determine which compression utility to use and then starts the compression utility.

How to Run the Archive Program

Introduction

You can start **ediarc**, the program that controls EDI translation archiving, from:

- ▶ The command line
- ▶ A batch file or script you run from the Task Scheduler
- ▶ The **Archive Data** option on the Translate Outbound Documents and Translate Inbound Documents dialog boxes.

When to archive data

The best time to archive EDI translation data is immediately after all inbound and outbound translations, before the data file is purged or moved.

WARNING

To prevent loss of data, make sure that you run the archive program before you delete or move a data file.

Starting ediarc from a batch file or script

You may run **ediarc** from a UNIX or DOS batch file and use the Task Scheduler to run **ediarc** on a schedule.

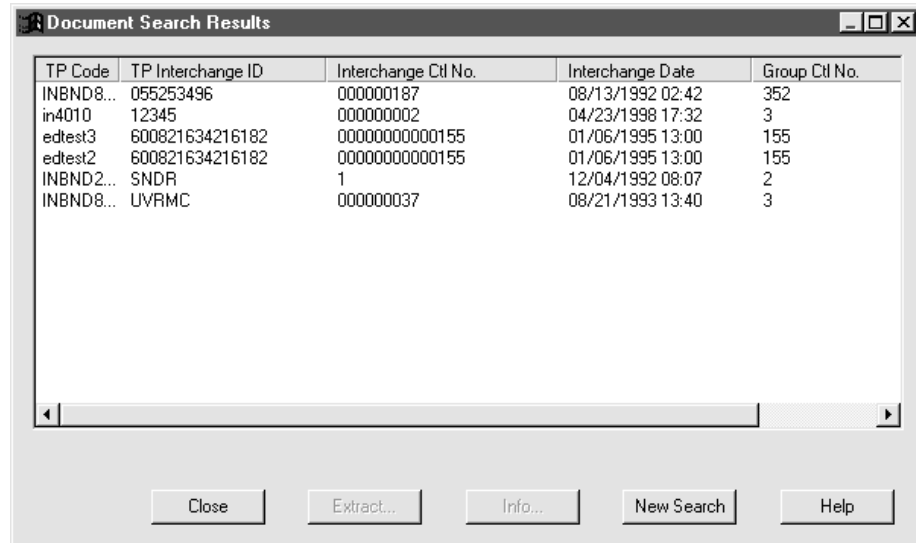



Reconciling Functional Acknowledgments (FAs)

Overview

Definitions A **functional acknowledgment** (FA) that you receive is an inbound document that contains the status of outbound data you sent to a trading partner.

A **functional acknowledgment** that you send is an outbound document in response to a document you received from a trading partner.

Purpose The purpose of functional acknowledgments is to provide you with:

- The status of a sent or received document (rejected, accepted, or accepted with errors).
- The information necessary to reconcile the historical records maintained in *edihist.dat*.
- Error information related to a sent or received document.

Types of functional acknowledgments

This table lists the types of functional acknowledgments and describes each type.

- The receiving company uses one of these functional acknowledgment transaction sets to communicate the results of a transmission back to the sending company.
- For each functional group sent, the acknowledgment details what transactions were received and if there were any segment or data element syntax errors according to the related standard.

Type	Description
997	The X12 functional acknowledgment transaction set.
999	The UCS functional acknowledgment transaction set.
CONTRL	The Edifact and Odette functional acknowledgment transaction set.

Type	Description
Network	For TRADACOMS-formatted messages only, GENTRAN:Server can receive and reconcile both IBM® and INS® network acknowledgments.

Functional acknowledgment levels

Functional acknowledgments are always associated with a transaction group (a collection of transactions).

The functional acknowledgments that GENTRAN:Server handles have three different levels of detail:

- ▶ **Group**, which indicates if a group of like documents contained errors
- ▶ **Set**, which indicates if an individual transaction set contained errors
- ▶ **Segment/Element**, which indicates the exact segment and element containing an error.

Control numbers in a functional acknowledgment

The archiving program does not archive duplicate records, so if two different records have the same control numbers, the archiving program rejects the second as a duplicate. See the [Before you begin](#) topic.

Reconciliation

If you send or receive functional acknowledgments, you need to reconcile errors regularly.

The process of reconciling functional acknowledgments is similar to the process of reconciling your bank statement: you review the status of documents that you have sent and received, and then resolve any discrepancies.

You must archive EDI data (including any functional acknowledgments) after each translation to use the functional acknowledgment reconciliation feature.

Setting Up Your System to Handle Functional Acknowledgments

Introduction

You must request functional acknowledgments from your trading partner before sending EDI data. If you receive documents from a trading partner, you should ask if they want functional acknowledgments from you and at what level they want to receive them.

Configuring your system

To configure your system to send acknowledgments to all trading partners when you receive inbound data, select the **Acknowledge Inbound Data** option on the EDI tab of the Archive/Retrieval window.

To configure your system to expect acknowledgments from all trading partners for outbound data, complete the **Expect Ack for Outbound Data in** option on the EDI tab of the Archive/Retrieval window.

Configuring a Trading Partnership record

You can configure the functional acknowledgment settings at the Trading Partnership level. These settings override your system settings for the individual trading partner.

To configure your system to send acknowledgments to a specific trading partner when you receive inbound data from that trading partner, select the **Create acknowledgment for inbound document** option from the Outbound Acknowledgment tab of the Edit Trading Partnership dialog box.

To configure your system to expect acknowledgments from a specific trading partner for outbound data, complete the **Expect acknowledgment for outbound document in** option on the Inbound Acknowledgment tab of the Edit Trading Partnership dialog box.

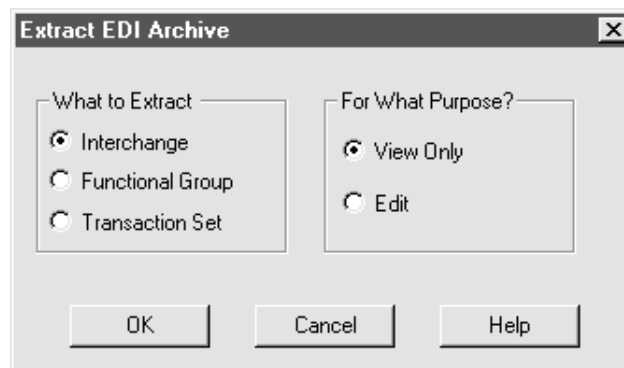

How to Prepare Documents to Resend

Introduction

The resend program repackages archived outbound or inbound data so that you can send it. The program replaces new lines with character terminators and increments the control numbers to those you specify.

Resending Outbound Data

You can edit archived outbound data that contains errors and then send the corrected data to your trading partner. In this case, you want to increment the control numbers so that the archiving program does not reject the document as a duplicate.

You may also resend archived outbound data that your trading partner never received. In this case, you may use the same control numbers as the original document.

Resending Inbound Data

You may also resend inbound data. This data is saved as a newline-terminated file. The **Override Control Numbers** option is unavailable when you are resending inbound data.

When resending inbound data, you must use the File Browser to edit the control numbers before saving the file. This prevents the duplication of audit records in the archive when you retranslate the file inbound.





How to Purge Data

Introduction

Leaving large amounts of data in the archive files slows down the retrieval process when you view or edit data. You should remove the stored data from the audit/archive directory regularly. Determine the interval based on management of your disk space and your company's policies.

Running the purge program

The purge program enables you to purge data based on criteria you select. You may start the purge program from:

- ▶ The archive menu
- ▶ The command line
- ▶ A batch file or script through the Task Scheduler.

In this section, you learn to run the purge program from the **Archive** menu.

Comment

The data purge process may require a long time to run. You may want to run it from a batch file or script during off hours through the Task Scheduler.

When you schedule **edipurge** to run during the off hours, you must verify that the system will not be running **ediarc** at the same time.

To select data for purging with a command line program, use the **edipurge** command. See the *GENTRAN:Server Technical Reference Guide* for more information about **edipurge**.

Overview

Task Scheduler Basics

Introduction

You can use GENTRAN:Server's Task Scheduler to run tasks (DOS batch files or UNIX scripts) automatically on a schedule you specify.

You may find it convenient to run translations and other GENTRAN:Server functions from a batch file or script. You can schedule batch files or scripts to perform functions unattended during off-hours.

The Task Scheduler is available in both the GENTRAN:Server for UNIX (client/server) version and the Workstation version. However, each version handles a scheduled file differently.

Task Scheduler example

You might create a batch file or script to run outbound translation, and then use the Task Scheduler to run it every night at 11:00 p.m.

GENTRAN:Server for UNIX version

If you are running GENTRAN:Server for UNIX, the Task Scheduler sends the scheduled files to the host and executes the UNIX **crontab** command. The UNIX **crontab** command adds the file to the **cron** spool area. The UNIX **cron** program activates the timer.

The location of **crontab** and the UNIX program **cron** varies among the types and version of the UNIX operating system.

Example

Here is a sample path:

```
/var/spool/cron/crontab/muser
```

Note

The *muser* file, which represents the server where **cron** runs, needs permission to run **cron**.

Workstation version

The Workstation version of GENTRAN:Server has its own timer, **mtimer**. You may activate this executable file by:

- ▶ Clicking **Run Task Scheduler** on the **Tools** menu
- ▶ Configuring *mtimer.exe* to start when your computer starts.

When you use the Task Scheduler to schedule a file, the Task Scheduler saves the file to *crontab.dat*. Then, when you activate **mtimer**, **mtimer** reads the *crontab.dat* file and processes the files based on the schedule you established in the Task Scheduler.

In this chapter

This chapter contains relevant points about creating batch files or scripts containing the GENTRAN:Server command-line and operating-system commands you want to perform. You will also learn how to use the Task Scheduler to specify the date and time you want the batch file or script to run and important points about running the batch files and scripts.

The Flow of Work

DOS Batch Files and UNIX Script Files

Introduction

For use with GENTRAN:Server, DOS batch files or UNIX scripts generally contain a combination of operating-system commands and GENTRAN:Server command-line commands. When you create a batch file or script, you enter the commands in the order you want to execute them.

Reference

See the chapter [Command Reference](#) in the *GENTRAN:Server Technical Guide* for information on command syntax and options.

Used for unattended translation

Perhaps one of the most common uses for batch files or scripts within GENTRAN:Server is for unattended inbound and outbound translation.

About unattended inbound translations

To run inbound translations unattended, you create a batch file or script that includes commands to do some or all of the following:

- ▶ Delete files created in the previous translation (mandatory unless you want GENTRAN:Server to append these results to the results of the previous translation).
- ▶ Remove non-EDI data from the input file (mandatory; this is the **edifrm** utility).
- ▶ Translate the EDI data (mandatory).
- ▶ Envelope the outbound functional acknowledgment or CONTRL (optional).
- ▶ Archive the EDI data exactly as it was received (optional).
- ▶ Archive the outbound functional acknowledgments (optional).
- ▶ Create and print a Translation Summary Report (optional).
- ▶ Delete or rename intermediate files created in this run (mandatory).

**About
unattended
outbound
translations**

To run outbound translations unattended, you create a batch file or script that includes commands to do some or all of the following:

- ▶ Delete files created in the previous translation (mandatory unless you want GENTRAN:Server to append these results to the results of the previous translation).
- ▶ Translate the data into EDI or XML data (mandatory).

Note

If you have the XML translation option, then the data can also be translated into XML.

- ▶ Combine like interchanges for EDI data (optional; this is the envelope utility).
 - ▶ Archive the EDI data exactly as it was sent (optional).
 - ▶ Create and print a Translation Summary Report (optional).
 - ▶ Delete or rename intermediate files created in this run (mandatory).

Sample GENTRAN:Server Batch Files (Workstation Version)

Introduction

If you are running the Workstation version of GENTRAN:Server, GENTRAN:Server batch files run from the Task Scheduler and **mtimer**.

How GENTRAN:Server batch files differ from DOS files

GENTRAN:Server batch files differ from DOS files in the following ways:

- ▶ GENTRAN:Server batch files can execute only GENTRAN:Server and DOS command-line commands, working from the top of the file to the end.
- ▶ GENTRAN:Server batch files cannot contain conditions or pointers (for example, **GOTO**). However, you can nest DOS batch files in GENTRAN:Server batch files. Nested DOS batch files execute properly, including conditions and pointers. You cannot, however, include Windows GENTRAN:Server commands (**lfran** and **mtimer**) in DOS batch files that are nested in GENTRAN:Server batch files.
- ▶ To adhere to the syntax of the **mtimer** scripting language, for the Workstation version you must precede each DOS command in unnested or top-level batch files with 'DOS'.

About these samples

The following batch files are intended as examples only. File names used here suggest possible naming conventions. In your work, select one file naming convention and use it consistently.

Keep in mind that you can create one batch file to perform multiple tasks or handle multiple standard types.

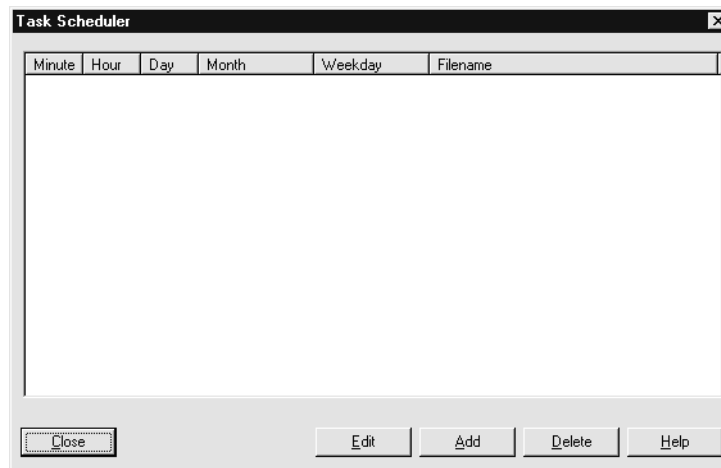

About scheduling tasks in the GENTRAN:Server for UNIX version

When you close the Task Scheduler after scheduling tasks, GENTRAN:Server sends the file to the host and executes the UNIX crontab command. This adds the file to the cron spool area. This UNIX operating system **cron** program activates the timer.

CAUTION

Closing the Task Scheduler overwrites any existing *crontab* file and deletes tasks previously scheduled outside of GENTRAN:Server. You should check for previously scheduled tasks and, if necessary, schedule GENTRAN:Server tasks outside of GENTRAN:Server.

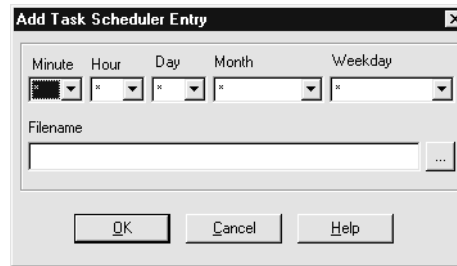

How to Run Scripts (UNIX Version)

Your system administrator can prohibit a scheduled script from running.

Using crontab to check scheduled tasks

To check the tasks you currently have scheduled outside of GENTRAN:Server, enter the following command at a UNIX prompt from any directory:

```
crontab -l
```

MTimer and Workstation Batch Files

About mtimer For Windows platforms, you must have **mtimer** running at the time you want to run the unattended processes specified in the Task Scheduler.

Example

To run batch files daily, you must either activate **mtimer** daily or leave it on. You can leave **mtimer** on only if you leave your computer on with Windows running. You can close GENTRAN:Server without affecting **mtimer**.

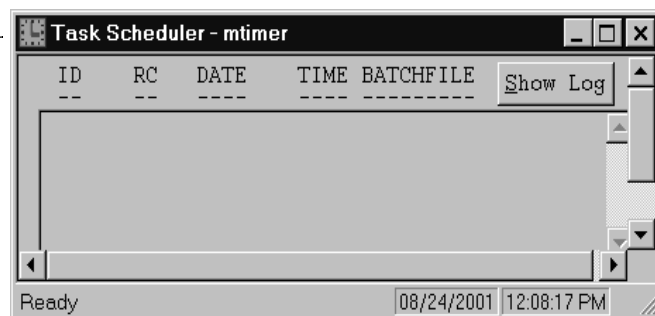

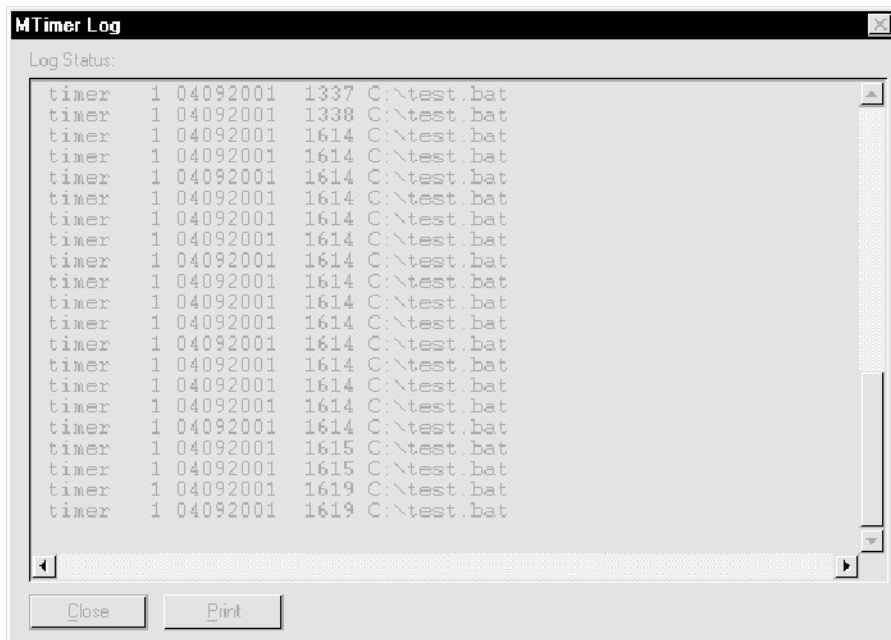
About mtimer files

When you activate **mtimer**, GENTRAN:Server creates three files. This table describes the files.

File	Description
unop.ran	Contains a list of tasks completed during this active session. Unless you elect to suspend processing, GENTRAN:Server deletes this file when you stop mtimer .
unop.log	Contains the list of completed tasks. GENTRAN:Server appends to this file with each new mtimer session, instead of deleting or overwriting it. This means it can grow very large. You should watch its size and periodically delete this log file manually. You can view this log on the MTimer Log dialog box while mtimer is running.
unop.err	Contains operating-system error messages in response to errors in the DOS commands included in your batch file.





At any time during processing, you can either stop **mtimer** or suspend job processing.


If you suspend job processing, GENTRAN:Server retains a list of the completed tasks. You have the option of resuming **mtimer** at any time in the future. When you resume **mtimer**, processing begins where it left off.

Stopping or suspending mtimer





Overview

Introduction

The GENTRAN:Server error messages and other informational messages are noted in the Compile Errors dialog box when you compile the translation object or in the Error section of the Extended Rules dialog boxes when you compile an extended rule containing errors prior to compiling the translation object, and when you commit an erroneous action in GENTRAN:Server.

The informational messages are dependent on the context of the program, and are intended to be self-explanatory. The error messages are described in the topics accessed below, along with the actions you can take to correct the problem.

In this appendix

This appendix explains how to determine the action you should take when you receive an error message.

Map Editor Messages

Introduction GENTRAN:Server errors can occur when you are creating a map. The system uses pop ups to notify you of an error, such as invalid or missing data.

Messages The GENTRAN: Server error messages are listed below in alphabetical order by the first letter of the error message text. The table also includes an explanation of the error and an action you can take to correct the error.

When the system displays an error message, acknowledge the message by clicking **OK** and then take the appropriate action.

Message Text	Explanation/Your Action
A code list entry must have a code value	Explanation You attempted to add a code without an associated code value.
A code list must have an element id	Explanation You attempted to create a code list without an element ID.
A code list for this element already exists. You must use another element id or delete the original code list first	Explanation You attempted to create a code list with the same element ID as an already existing code list. Your action Either change the element ID or delete the original code list.
A condition field is required	Explanation You established a conditional relationship that requires a condition field, but did not specify a condition field.

Translator Report Error Messages

Introduction The translator report error messages can occur when the translator cannot translate a document, read input data, or write output data.

NCPDP Messages NCPDP messages can occur when the translator cannot translate a document that is in an NCPDP format.

Output error messages

Output error messages can also occur when the translator tries to write to the output file. Many times the error results because the Batch File string is missing a portion of the Batch File or a value in the string is incorrect.

To prevent errors from occurring verify that the Batch File string follows the detail data record (DDR) format:

<separator>filename<separator>StartOffset<separator>EndOffset<separator>.

acknowledgment	The ANSI 997 functional acknowledgement, the EDIA 999 acceptance/rejection advice, and the EDIFACT CNTRL document.
activation	The process of turning on groups, segments, composites, and elements that a standard does not define as mandatory, but that you have determined that you need to use in a map.
application file	A <i>fixed-format, variable-length file</i> , or a <i>positional file</i> that contains all the information that you need to extract from your partner's document or send to your partner so that your system can accurately process the data.
Application Integration subsystem	<p>The GENTRAN:Server for UNIX mapping software that enables you to create maps that translate:</p> <ul style="list-style-type: none">▶ your application files to EDI standard formats for documents you send to your trading partners (outbound mapping), and▶ EDI standard formats to your application format for documents that you receive from your trading partners (inbound mapping). <p>Note If you are using the XML or ODBC translation options, then you can also create maps that translate XML and ODBC data.</p>
application system	Computer systems, outside of EDI, designed to fulfill specific business functions. These include accounting, purchasing, materials control, human resources, shipping, and other systems.
Application-to-application map	A map that describes how to translate an application document to another application format.

Application-to-EDI map	A map that describes how to translate your application document to an EDI document destined for your trading partner.
Application-to-XML map	A map that describes how to translate your application document to an XML document destined for your trading partner.
archive	The process of copying and saving EDI standard data that has been processed.
Auto trim	The Application Integration feature that enables you to automatically activate and deactivate map components on the EDI side of a map by using a sample EDI file as a model.
batch file	A file that contains command-line commands and DOS commands.
category	A user-definable record that enables you to group Trading Partnerships.
code list	A roster of code list tables that have been created or loaded in GENTRAN:Server.
code list tables	A table that contains a list of valid codes for an element in an EDI standard.
colours	The Application Integration feature that enables you to select foreground and background colours to visually define the various map components.
command	A keyword that performs actions on variables. Commands are responsible for moving data.
compile	The process used to convert a map into a translation object.

component data element	A data element that belongs to a composite data element. Component data elements are also called sub-elements.
composite	A data element that contains two or more component data elements or sub-elements.
composite data element	A data element that contains two or more component data elements or sub-elements. Composites are defined by the EDI standards that use them (EDIFACT, TRADACOMS, and certain ANSI X12 standards).
conditions	See <i>relational conditions</i> .
constant standard rule	A standard rule that enables you to move a literal constant value to a specified field or generate qualifiers to indicate a qualifying relationship with another field.
contact record	A record containing the name, address, and telephone numbers of an individual at your trading partner's business.
cron	A UNIX operating-system utility that runs commands and scripts according to a preset schedule. This is the executable file that activates the timer in GENTRAN:Server for UNIX.
cross reference table	A table that associates strings with specific Trading Partnerships.
data file	The file that contains the inbound or outbound data.
data definition format	A file that defines a file format used in a map. It includes the hierarchical and looping structure of the data, the map objects, and the attributes of the objects.

date/time type	A type of field that contains a date or time. If you specify that a field is a date/time type, you must specify exactly how the date or time must be formatted.
deactivation	The mapping function that enables you to make non-mandatory map components unavailable for use by the system.
default	A predefined value. Programs use these built-in values <i>unless</i> you specifically override them.
delimiters	Flags that you define to the system as separators for specific EDI components.
document	<p>One transaction set containing actual data and treated as a single entity. The amount of data does not affect whether something is a document or not, only the fact that it is treated as a single entity. For example, regardless of whether a purchase order contains one item or ten thousand, if it is one purchase order, it is one document.</p> <p>If a trading partner sends you a communication containing 10 purchase orders, you have received 10 documents. If the communication contained 15 invoices, you have received 15 documents.</p> <p>See also transaction set.</p>
EDI	Electronic Data Interchange (EDI). The process by which companies can exchange business documents directly from application to application by computer without paper documents being produced.
EDI History Audit directory	The directory used to store permanent history files and EDI data.
EDI standard	The rules for turning a business document into an EDI document.

EDI Status Audit directory	The directory used to store temporary translation audit files (<i>edistat.i</i> and <i>edistat.o</i>).
EDI-to-Application map	A map that defines how to move data from the EDI standard-formatted documents that your partners send you to your application file.
EDI-to-EDI map	A map that defines how to translate data that is in an EDI standard format into another EDI standard format.
EDI-to-XML map	A map that defines how to translate data that is in an EDI standard format into XML format.
ediarc	The GENTRAN:Server program that controls archiving.
edifrmat	The utility that removes segment terminator and replaces it with a new-line terminator.
element	<p>The smallest piece of usable information defined by the standards. An element is the EDI map component that is mapped (linked) to a corresponding application field to move data to and from the EDI file. Examples might include a quantity, unit price, or description. An individual element can have somewhat different meanings depending on context. Therefore, elements are normally not considered to have useful meaning until they are combined into segments.</p> <p>See composite data element and component data element.</p>

envelope A way of separating information in transmissions for ease of processing. Each envelope contains a header segment and a trailer segment, which separate the envelope from other envelopes and provide information about the contents of the envelope.

There are three levels of envelopes, as follows:

- **Transaction Set**
Each transaction set (business document) is contained within a transaction set envelope.
- **Functional Group**
An envelope containing related business documents. The standards define which transaction sets should be placed together into a functional group envelope.
- **Interchange Envelope**
All material being sent to one trading partner in one communication. The term Interchange Envelope is the term used by ANSI. EDIA uses the term Transmission Envelope to refer to this level of envelope. Since we use the term transmission for other uses, we refer to Interchange Envelope only.

equalize The mapping function that enables you to reinstate the two sides of the map with focus in equal dimensions.

expression A logical unit of information that the system evaluates.

extended rules The Application Integration feature that enables you to apply complex mapping operations to fields. These rules give you access to the GENTRAN:Server proprietary programming language.

field The smallest piece of information defined in an application file. A field is the application map component that is mapped (linked) to a corresponding EDI element to move data to and from your application file.

file format definition A file that defines how fixed-format data needs to be formatted for an application to process it. These files have a .DDF extension.

File format definition files contain a layout of the records, fields, and groups in an application file.

fixed-format file	See application file .
Font feature	The mapping feature that enables you to globally change the font type, style, and point size that is used in the display of all maps.
functional acknowledgment (FA)	The standard transaction set used to acknowledge receipt of a transmission. The functional acknowledgment tells you if a document you sent was received and processed by your trading partner. It also can tell you if your document contained EDI standards compliance errors. Likewise, the functional acknowledgment you send to your trading partner relays the same information.
functional group	A group of transaction sets that the standards-setting body (such as ANSI) has defined as fitting together with other related transaction sets. An example might be a Functional Group defined as containing all purchasing transaction sets.
global scope	A variable in an extended rule that can be accessed from any other extended rule in the map.
group	A looping structure that contains related records/segments and/or groups that repeat in sequence until either the group data ends or the maximum number of times that the loop is allowed to repeat is exhausted.
Group Organization record	A record containing all information specific to a single division or department in your trading partner's organization.
historical record	The index files named <i>edihist.dat</i> and <i>edihist.idx</i> that store the location of the archived data. The files are built from the status records that translation produces. Together they form the permanent audit file.
history audit directory	The EDI History Audit (<i>hisaud</i>) directory used to store permanent history files.

identification string

The value that results from applying a set of Trading Partnership rules to an application or XML document.

inbound mapping

The process of creating a map that defines:

- The EDI standard format in which your trading partner sends documents to you
- Your application file format (how the data needs to be formatted for your application to process it).

Note

If you have the XML or ODBC translation option, then the process of creating maps also defines:

- The XML format in which your trading partner sends documents to you
- The ODBC format in which your trading partner sends documents to you

inbound translation

A translation in which the input format of the source document is either an EDI standard format or an XML format that you use to exchange documents with a trading partner.

Note

Inbound translation using the XML format is available only if you have the XML translation option.

integer

A number that can have an implied decimal point (e.g., “2.01” is formatted as “201”).

interchange

All the functional groups of documents (transaction sets) sent from one sender to one receiver in the same transmission.

Interchange Organization record

A record containing all information specific to a single company.

Interchanges browser	The GENTRAN:Server browser that enables you to view a hierarchical list of all the interchanges that were sent or received. It contains status information about the interchanges, (e.g., whether or not a functional acknowledgement was received and the status of that acknowledgement). This browser also enables you to access the documents within the interchanges. The Interchanges browser can always be accessed.
keyword	A fixed defined use of a word that indicates how the programming language should be interpreted.
link	The function that connects or maps a field from the Input side of the map to a field on the Output side of the map. The link between two map components is visually represented with a line connecting the two fields.
literal constant	A constant that the system uses as a repository to store information that is used at a later point in the map. Typically, constants are used in an outbound map to generate a qualifier.
loop	A mapping structure in which the records or groups repeat in a sequence until either the group data ends or the maximum number of times that the loop is allowed to repeat is exhausted.
loop count standard rule	The function that enables you to track the number of times a loop is repeated. If the field is part of a loop. If the loop is a nested loop, you can track the current loop or the outer loop. For example, if the Y loop is nested within the X loop, and the Y loop has cycled through 15 iterations and the X loop has cycled through 3 iterations, you can choose to count either the "15" (Y loop) or the "3" (X loop).
loop start/loop end segments	Loop Start (LS) and Loop End (LE) Segments, used by certain EDI standards, differentiate between two or more loops of the same type.
many-to-many mapping relationships	A mapping relationship that has a looping structure.

map A set of instructions that indicates the corresponding relationship between your application file input and output, and defines how the system should translate data.

map object A component object of a map. For example:

- ▶ Positional or Delimited EDI file
- ▶ group
- ▶ segment
- ▶ record
- ▶ element

Note

If your company purchased the XML translation, other map objects include:

- ▶ pcddata
- ▶ attribute
- ▶ attribute container
- ▶ content particle

mtimer A feature you can use to start, stop, or resume unattended processes in the Workstation version of GENTRAN:Server.

nested looping structure A mapping structure that has a loop within another loop.

number type A type of field that contains either an integer or real number. If you specify that a field is a number type, you must designate the format by specifying a format of either “N” (integer) or “R” (real) and the number of decimal places.

one-to-one mapping relationship A mapping relationship without a looping structure.

outbound mapping	<p>The process of creating a map that translates your application file format to EDI standard formats, so you can send documents to your trading partners.</p> <p>Note If you have the XML translation option, you can create a map that translates your application file to an XML format to send to your trading partners.</p>
outbound translation	<p>A translation in which the input format of your source document is either an application format or an XML format that you defined for your internal application documents.</p> <p>Note Outbound translation using an XML format is available only if your company purchased the XML translation option.</p>
partner key	<p>A set of values that the translator uses to find the partner relationship.</p>
positional file	<p>See application file.</p>
post-session rule	<p>An extended rule that the system processes after it processes the translation object.</p>
predefined	<p>On a data entry translation object, a default value for a particular field.</p>
pre-session rule	<p>An extended rule that the system processes before it processes the translation object.</p>
promote	<p>To extract one iteration (instance) of a group or repeating record from a loop.</p>
qualifier	<p>A field that has a value expressed as a code that gives a specific meaning to the function of another field. A qualifying relationship is the interaction between a field and its qualifier. The function of the field changes depending on which code the qualifier contains.</p>

real number	A number that has an explicit decimal point (e.g., “2.01” is formatted as “2.01”), and truncates trailing zeroes.
reconciliation	The process of viewing functional acknowledgments, viewing data with certain statuses, such as Error, Late, or Waiting, and correcting the EDI data.
Reconciliation ID record	A record containing a set of interchange and group IDs used with functional acknowledgments.
record	A map item that contains a group of related fields. A record can occur once or can repeat multiple times.
relational condition	A mapping function used to connect fields together for syntax or compliance reasons. For example, Field A is invalid unless Field B is present. Therefore, if you set up a condition that pairs Fields A and B, the system generates a compliance error if one of those fields is not present.
scope	The range of an extended rule. The scope determines which variables in the rule are accessible from other extended rules. The scope depends on the current state of the map.
script file	A file that contains command-line commands and UNIX commands.
segment	A group of related elements or composite data elements that combine to communicate useful data. Segments are defined by the EDI standards. A segment can occur once or can repeat multiple times. For example, a catalog price segment might consist of elements for item description, volume, price, lead time, etc. By themselves, none of these elements would communicate useful information. Together, they provide the information necessary for someone to tell if the item is what is desired, whether the price is reasonable, etc. A number of segments together form a transaction set.

select standard rule	A mapping function that enables you to map definition and table information from the GENTRAN:Server Partner Editor to a selected element or field in a map. This standard rule enables you to select entries from the parent group on the current side of the map. You can then map the fields in those tables to one or more fields in the data. The Select function uses the value of the current field to perform the selection.
simple mapping	See <i>link</i> .
split (map component)	A function used to split (break) a group or repeating record into two loops. You typically use this function when you need more than one instance of the same map component that still occurs multiple times.
split (XML file)	A configuration process that enables the system to break an XML file into smaller documents or sets.
Standard Cross-Reference Table	The GENTRAN:Server feature that enables you to build a table of standard values. GENTRAN:Server can use these values to find the Trading Partner record for certain inbound documents.
standard rules	An Application Integration feature that enables you to apply basic or standard mapping operations to fields. These rules give you access to mapping operations that are more complex than simple linking, but less involved than extended rules. Each of the standard rules are mutually exclusive (you can use only one on a particular field).
status audit directory	The EDI Status Audit directory (<i>stataud</i>) used to store temporary audit files (<i>edistat.i</i> and <i>edistat.o</i>) and EDI data.
status record	A temporary audit file named <i>edistat.i</i> or <i>edistat.o</i> , created during translation, which includes the directory path and file name for the EDI data received or generated. The record does not contain the actual EDI data.

string	A type of field or element that contains one or more printable characters. If you specify that a field is a string type, you must designate the format by specifying a syntax token.
sub-element	See <i>component data element</i> .
syntax token	<p>A symbol or expression that defines ranges of characters and numbers that are allowed to be used for a string-type field.</p> <p>You use the syntax tokens in the Format field of the Field Properties dialog to define what type of characters the system uses while compliance checking each field.</p>
system variable standard rule	A function that enables you to set a variable that maps the current date and time to the selected field.
TRADACOMS record	A record containing all of the supplementary Trading Partnership information for use with TRADACOMS standards.
TDF	Transaction Data File. A flat file representation of the EDI standard document. This file serves as a filter between your document files and the GENTRAN:Server translator. For outbound processing, data is imported from a TDF file and translated to EDI format using a TDF Import translation object. The data is then ready to be posted and sent to your trading partner. For inbound processing, EDI documents that are received by GENTRAN:Server can be exported to a TDF-formatted file using a TDF Export translation object. This data file is then ready to be processed or converted to your internal application files.
trading partner	Another firm with which your company trades documents.
Trading Partner Administration	The GENTRAN:Server subsystem that enables you to define, edit, and delete all partner information for your company and all of your trading partners.

Trading Partner record	<p>One of the records maintained in trading partner files:</p> <ul style="list-style-type: none">• Interchange Organization record• Group Organization record• Trading Partnership record• Contact record• Reconciliation ID record• Category record• TRADACOMS record.
Trading Partnership	<p>An arrangement with a specific trading partner to exchange information in a specific document type and using a particular standard version.</p>
Trading Partnership code	<p>A user-defined code that uniquely identifies a Trading Partnership record. Normally, the Trading Partnership record describes a unique trading partner and document combination. The Trading Partnership Code must contain from 1-15 alphanumeric characters. Spaces and special characters are NOT allowed.</p>
Trading Partnership record	<p>A record containing information about one of the Trading Partnerships you have established.</p>
transaction set	<p>A business form as defined by the standards. The standards define each transaction set in terms of the segments and elements that make up the form, the order in which they appear, and the relationships among them. Examples include an ANSI 850 purchase order or an UCS 880 invoice. Transaction sets are also known as messages and documents.</p>
translation	<p>The conversion of data from one format to another.</p>
translation object	<p>A compiled map file containing information that instructs the translator how to convert a file from one format to another.</p>

translator	The GENTRAN:Server subsystem that translates data from one format to another.
update standard rule	A standard rule that enables you to update a specific field on the current side of the map with the contents of a field.
use accumulator standard rule	A standard rule that gives you access to a set of numeric variables that you can manipulate via numeric operations, and then transfer to and from fields. Accumulators are used generally for counting the occurrences of a specific field or generating increasing or sequential record or line item numbers.
use code standard rule	A standard rule that enables you to match a field against a predefined code table, specify whether or not a compliance error is generated if the field does or does not contain one of the values in the code table, and store a code's description in another field.
user exit	An extended rule that enables the map to temporarily exit translation, run a shell script, return to translation, and use the results of the shell script in translation.
user translation object	A translation object that controls data entry, Application-to-EDI processing, EDI-to-Application processing, EDI-to-EDI processing, and the creation of printed reports. The Application Integration subsystem enables you to generate user translation objects.
variable	An item that you define in the declarations section of an extended rule to store values. Variables consist of a name and a data type.
workspace	The system's working area for an import file.
