  - The Gentran:Server OFTP Plus Module
- The SAP Extension feature has changed in this release:
  - SAP Extension back-end DB has changed to use DISAM from MySQL.
  - ODBC Drivers are no longer required because of the use of DISAM.
  - New SAP Extension DISAM files are located in the \$EDI\_ROOT/tp directory.
