

# Connect:Direct for i5/OS Version 3.6.00 Release Notes

The *Connect:Direct for i5/OS Version 3.6.00 Release Notes* document supplements Connect:Direct for i5/OS version 3.6 and Connect:Direct Secure+ Option version 3.6.00 documentation. Release notes are updated with each release of the product and contain last-minute changes and product requirements, as well as other information pertinent to installing and implementing Connect:Direct for i5/OS. Read the document in its entirety before installation.

The Connect:Direct for i5/OS package consists of the distribution media, a product key, and product publications. The Connect:Direct for i5/OS application is distributed as follows:

- ◆ CD-ROM
- ◆ File downloaded from the Sterling Commerce Electronic Software Distribution Portal

See Installing Connect: Direct for i5/OS from the ESD Portal on page 12 for instructions.

The product CD-ROM is identified with an external label showing the product name and release level.

# **Product Requirements**

Connect:Direct for i5/OS has the following requirements:

#### **Hardware and Software**

Connect:Direct for i5/OS requires the following hardware and software:

	Disk storage required for Connect:Direct for i5/OS is 100 MB. However, the actual size depends on the size of a statistics file and others.
	The minimum memory requirement is 32 MB. However, main storage depends upon the number of users and sessions.
	Note: To verify the storage available on your system, use the WRKSYSSTS command. Check the amount of total system storage and the percentage of storage used. If the total amount needed for Connect:Direct is more than the amount of storage available on your system, you must free some system storage before proceeding.

# License Key File

The license key file identifies the product features that are available at a site. When you purchase the Connect:Direct for i5/OS application, a temporary key file is sent to you that enables operation of Connect:Direct for i5/OS for a limited time. You must replace the temporary key with a permanent key to continue running Connect:Direct for i5/OS.

**Note:** If you are using an earlier version of Connect:Direct Secure+ Option i5/OS or if you purchase Connect:Direct Secure+ Option for i5/OS version 3.6 after the initial purchase of Connect:Direct for i5/OS version 3.6, obtain a new license key file.

The temporary and permanent key files are supplied as text files named *nnnnn*.txt, where *nnnnn* is a number assigned by Sterling Commerce. Each key file is sent to you as an attachment to an e-mail. The temporary and permanent license key file must be applied on the computer where Connect:Direct for i5/OS is installed.

### Obtaining the Permanent License Key File

Request the permanent license key file using one of the following methods:

- Reply to the Sterling Commerce e-mail containing your temporary license key file and include the serial and model numbers of the computer where Connect:Direct for i5/OS is installed.
  - a. To find the serial number, type the following command at a command prompt and press **Enter**:

dspsysval gsrlnbr

b. To find the model number, type the following command at a command prompt and press **Enter**:

dspsysval qmodel

- Request the license key file from Support On Demand:
  - a. Log in to the Sterling Commerce Support On Demand Web site. If you do not have a Support On Demand user name and password, follow the instructions in *Getting Support for Sterling Commerce Products* on page 18.
  - b. Under Product Family Support, highlight **Connect** and click **Key Request**. The Connect Product Key Request page is displayed.
  - Type the information in the required fields and click **Submit**.
     You will receive the permanent license key file through e-mail in approximately 24 to 48 hours.

### Uploading the License Key File

To upload the temporary or permanent license key file:

- 1. Create a **c:\temp** directory on your PC.
- 2. Save the license key file from the E-mail attachment to c:\temp, renaming the file to apkeyf.txt, the default key file name specified in the Connect:Direct initialization parameters.
- 3. Verify the name and location of the current key file:
  - a. Log on to the i5/OS system using the administrator profile, CDADMIN.
  - b. Type the following command and press **Enter** until the Change C:D parms (CHGCDPARM) screen is displayed:

WRKCDPARM

c. Press **Page Down** until the Change C:D parms (CHGCDPARM) screen, which shows the Asset protection key file parameter, is displayed. Write down the location of this file

because you will need this information later in this procedure. This parameter value is the current location of the asset protection key file.

**Note:** If this installation is an upgrade and you are replacing the currently installed license key file, back up or rename the existing license key file if you do not want to overwrite it.

4. On your PC, click Start and select Run.

You do not have to stop Connect: Direct on the i5/OS system to complete the remaining steps.

5. In the **Open** field, type the following and press **Enter**:

COMMAND

An MS-DOS window is displayed.

6. At the c:\WINDOWS prompt, type the following command and press **Enter** to change the working directory:

cd c:\temp

**Note:** If you changed the name of the default license key file in the Connect:Direct initialization parameters, substitute that name for apkeyf in the remaining steps.

7. At the c:\temp prompt, type the following command and press **Enter** to ensure that the license key is listed in the temp directory.

dir apkeyf\*

If the key file is listed, continue with step 8. If the file is not listed, repeat steps 1–7.

8. Type the following command and press **Enter** to establish an FTP session with your system:

c:\windows\ftp <your system name or IP address>

- 9. When you are prompted for a user name and password, type the CDADMIN user profile and password used during the installation.
- 10. Verify that the working directory is <cdlib> by typing the following and pressing **Enter**:

pwd

where <cdlib> is the location of the license key file displayed in step 3 on page 7.

11. If <cdlib> is not listed as your working directory, type the following command and press **Enter**:

cd <cdlib>

12. Transfer the key file by typing the following command and pressing **Enter**:

put apkeyf.txt apkeyf

**Caution:** Transfer the temporary or permanent license key file to your i5/OS system in TEXT format. Do not perform a binary transfer.

A message is displayed notifying you that the file was transferred successfully.

13. Verify the contents of the transferred key file by comparing it to the original key file. To view the contents of the original key file, open it in a text viewer. After you have opened the original key file, view and verify the contents of the transferred key file by typing the following command and pressing **Enter**:

dsppfm <cdlib>/apkeyf

The contents of the transferred file should match the contents of the original key file.

*Caution:* Do not edit the *nnnnn*.txt file or the license.key file. Text editors may insert a carriage return or truncate lines, which will invalidate the key file.

14. If the files match, type the following command in the FTP window to end the session:

ftp> quit

15. At the prompt, type the following command and press **Enter**:

c:\temp> exit

### Validating the License Key

Install Connect:Direct for i5/OS before validating the license key. After you transfer the license key file to the i5/OS system, verify the license key specified in the Connect:Direct initialization parameters. To validate the temporary or permanent key file, use the following procedure:

- 1. Log on to the i5/OS system using the administrator profile, CDADMIN.
- 2. Replace the key file in one of the following ways:

• If Connect:Direct is running, type the following command and press **Enter**:

WRKCDSTS

Press **PF9** to reload the key file. The following message is displayed:

Your request has been submitted to the processq

• If Connect:Direct is not running, start Connect:Direct using the following command:

STRCD

3. To view the start-up messages issued, type the following command:

DSPMSG

If no error messages are displayed, the key validation is successful. If key validation fails, use the Sterling Commerce Customer Support Web site at <a href="https://www.sterlingcommerce.com">www.sterlingcommerce.com</a> to search the knowledge base.

# **Features and Enhancements**

Connect:Direct for i5/OS version 3.6.00 has the following features and enhancements.

**Note:** For documentation updates associated with the maintenance, go to Support on Demand to download the maintenance and related documentation updates. Documentation updates for the maintenance are also available on the Sterling Commerce Support on Demand Documentation library.

Connect:Direct for i5/OS version 3.6.00	Supports Sterling Secure Proxy, which enhances security when transferring data between trading partners.
	Provides support for specifying a network interface from the server to an adjacent node. Provides convenience by enabling you to define an NIC for output traffic in the netmap.
	Supports OS versions V5R4 and later.
	Supports IPv6 internet protocol, enabling you to:  • Specify a much larger address range than IPv4 in configurable fields.  • Listen for incoming client and server connections on either an IPv4 or IPv6 address.
	Provides for more secure encryption of data through new ciphers added to the Connect:Direct Secure+ Option cipher suites list. Obsolete ciphers suites are removed from the list.

# **Special Considerations**

Special considerations for Connect:Direct for i5/OS and Connect:Direct Secure+ Option for i5/OS applications follow:

- ◆ To establish an SSL connection between Connect:Direct for i5/OS and Sterling Secure Proxy (SSP), use SSP Version 2.0 with Patch 5. TLS and non-secure connections between Connect:Direct for i5/OS and SSP are supported without the SSP patch.
- ◆ For compatibility with Gentran Integration Suite (GIS) Connect:Direct Server Adapter, use GIS Version 4.3.00 with Patch 4305 or later.

### **Installation Notes**

When you purchase Connect:Direct for i5/OS, Connect:Direct Secure+ Option for i5/OS is installed but unavailable unless you have also licensed this option. Before you install Connect:Direct for i5/OS, read all the information in this section and follow the guidelines.

- ◆ The Connect:Direct administrator who installs Connect:Direct for i5/OS must also start the product.
- ♦ If this is a new installation, review *Connect:Direct for i5/OS Release Notes* and *Connect:Direct for i5/OS Installation and Administration Guide* for last-minute product information and pre-installation tasks.
  - If you are upgrading from a previous version of Connect:Direct for i5/OS, review *Upgrading Connect:Direct for i5/OS*.
- ◆ Complete any worksheets before installing Connect:Direct for i5/OS.
- Review your security configuration to ensure compatibility with the following products:
  - Connect:Direct for i5/OS. Refer to the *Connect:Direct for i5/OS Installation and Administration Guide* for security options.
  - Connect:Direct Secure+ Option for i5/OS. Refer to the *Connect:Direct Secure+ Option* for i5/OS Implementation Guide for security options.
- ◆ Verify that you have the current updates for Connect:Direct for i5/OS. Access current update information, including instructions for applying updates containing product fixes and enhancements, from the Connect product support Web site at www.sterlingcommerce.com. See *Getting Support for Sterling Commerce Products* on page 18 for instructions.
- ♦ If you purchase Connect:Direct Secure+ Option for i5/OS after you purchase Connect:Direct for i5/OS, you must obtain a new license key. See *License Key File* on page 6 for instructions.

# **Upgrading to Connect:Direct for i5/OS Version 3.6.00**

If you are upgrading from an existing version of Connect:Direct for i5/OS, review *Upgrading Connect:Direct for i5/OS*, which is a separate document in the Connect:Direct for i5/OS documentation library.

In addition, if you are upgrading from an existing version of the Connect:Direct Secure+ Option for i5/OS application, observe the following guidelines:

- ♦ You can continue to use the parameters file that was defined in an earlier version of the product. It is not necessary to reconfigure trading partner definitions, if the trading partner will continue to use the same protocol.
- ♦ If the previous version was the Export version, the STS authentication keys and signature keys will not work with this version. You must regenerate the keys. Refer to *Installing and Setting Up Secure+ Option, in Connect:Direct Secure+ Option Implementation Guide* to regenerate the keys.

# Installing Connect:Direct for i5/OS from the ESD Portal

These instructions contain procedures for downloading, unpacking, and uploading the Connect:Direct for i5/OS version 3.6.00 release, including documentation. The file you download from the Electronic Software Distribution (ESD) Portal is named CD3600savf.zip.

# Downloading the Application File to your PC or Workstation

This procedure assumes that you are downloading the file to a PC or workstation and then uploading it to your i5/OS system.

To download the CD3600savf.zip file:

- 1. Click the link to the Electronic Software Distribution Download Area in the e-mail from Sterling Commerce.
- 2. In the **Security Alert** dialog box, click **Yes**.
- 3. On the Login page, type the following information included in the e-mail:
  - Sterling order number
  - Company name
  - Customer ID
- 4. Click **Login**. The Download Area is displayed.
- 5. Find Connect: Direct for i5/OS, version 3.6.00 and click **Download**.
- 6. In the **File Download** dialog box, click **Save**.
- 7. When the **Save As** dialog box opens, save the CD3600savf.zip file to the C:\ drive.

**Note:** If Internet Explorer adds a number in brackets to the name of the downloaded file (for example, CD[1].*platformoruniqueproductname.version*), rename the file on the Windows system before you transfer it to the system where it will be installed.

# Uploading the Application File to your i5/OS Computer

To upload Connect:Direct for i5/OS from your PC or workstation to your i5/OS computer:

- 1. Right-click the CD3600savf.zip icon, and extract the CD3600SAVF.SAVF file to your C:\ drive.
- 2. From your PC or workstation, start an FTP session to the i5/OS computer and log on to the system:

```
>ftp ip address of the i5/OS computer
>User-id youruserid
>password yourpass
quote site nam 1
bin
cd /qsys.lib/qgpl.lib (or library of your choice)
```

3. Copy the CD3600SAVF.SAVF file to the CD3600SAVF save file on your i5/OS system:

```
PUT CD3600SAVF.SAVF CD3600SAVF.SAVF
```

- 4. Take one of the following actions:
  - a. If this is an initial installation, go to the *Installing from the SAVF file* section from the *Installing Connect:Direct* chapter of the *Connect:Direct for i5/OS Installation and Administration Guide*.
  - b. If this is an upgrade from a previous version, go to the *Installing from the SAVF file* section from the *Connect:Direct for i5/OS Upgrading Guide*.

# **Maintenance Updates**

Connect:Direct for i5/OS Version 3.6 contains all maintenance fixes applied to previous versions. Issues resolved for Version 3.6 follow.

SR Number	Explanation
1281867	Request to add check for CRYP=0 inbound FMH68 to mean not Secure+.
1282336	Permanent Session Manager receives a MCH3402 error after sitting idle for awhile and a new process starts.
1301273	Request to add CDPlex z/OS support to Connect:Direct for i5/OS.
1301628	When error occurs on Process, messages repeat in CDLOG and Statistics.
1306167	An inbound LU0 connection from HP NonStop produces a MCH3601 error because CRC checking is not valid on LU0.
1298494	An inbound process from HP NonStop to IFS ASCII file produces a MCH1211 error.

SR Number	Explanation
1304197	File error SVSJ013I on z/OS from CDSND is not reporting error back to the CL program.
1309788	In DBCS, you cannot specify DEFAULT=A140, or DEFAULT=4040 instead of DEFAULT=0000 in the source member when using XTRAN()
1316195	The SPADMIN export of the STS key creates a file that causes an abnormal termination of the software on the mainframe when importing the file.
1316195	Connect:Direct for i5/OS SPADMIN creates the EXPORT file incorrectly on the STS option.
1306167	A pointer error on a LU0 inbound process occurs when i5/OS tries to verify Cyclic Redundancy Check.
1298494	HP NonStop sending to i5/OS produces an MCH1211 error.
1338491	Windows sending multiple processes in one connection causes an APXS002I error.
1338467	Sending an empty file with Secure+ SSL/TLS active causes an MCH3601 error.
1338493	Request for support of Control Center 3.0 monitoring.
1338944	CDSPLMON does not start. MCH3401 error splmon_init stmt 103 is produced.
1338986	Inbound Secure+ starts two Session Managers on a Secure connection and transmits a file successfully, but produces error messages.
1339735	Inbound SSL connections from Windows or UNIX to i5/OS fail and produce a CSPA202E -6996 error on the PNODE if the client authentication is enabled at i5/OS
1340174	Inbound from UNIX on UNIX fails to create MSGI information in statistics.
1340195	Problems occur with Secure+ STS when using *LCLNODE Secure Enabled = Y and Secure Enabled = N on remote netmap records.
1316172	Allow TEXTFILE in IFS to use something other than CRLF for record terminators.
1297537	Parameters to control the coded character set ID for IFS creates files instead of defaulting to the system CCSID.
1340432	Connect:Direct OS/400 3.5.00 dependent LU62 connections to a remote z/OS fails.
1341455	A CDSND to a z/OS HFS file results in a SDAA048I syntax error on z/OS.
1179458	Allow Connect:Direct to handle DB2 files with fields for NULLS. Keyword ALWNULL.
1342676	Permanent Sessions Managers cause Secure+ failures using STS.
1342895	A RMTSYSTEM job produces an error QLICHGLL failed with CPF2184.
1342902	CDRCV to UNIX on UNIX does not create the MSGI information in statistics. It leaves Process in WAIT WS state on UNIX.
1342167	Some Secure+ transfers fail between UNIX and i5/OS outbound. The i5/OS transfer shows an CSPA203E error.
1342167	Transfers run slower after applying 504A.
1341517	CDSND COMPRESS(*EXT) sending from some IFS files using TEXTFILE(*YES) produces error ACOP252I.

SR Number	Explanation
1341715	Sending some IFS files using TEXTFILE(*YES) causes error AFLH803I - File I/O error occurred.
1135543	Request support for larger DSN beyond 64 characters.
1344707	Request to increase the maximum time allowed for RUNTASK Max Time to Wait [RUNTASKTIM] in the INITPARMS.
1345763	The SCPA000I message is repeated in the CDLOG and statistics.
1346471	Process from UNIX with a PNAME greater then 22 characters causes a loop after FMH75.
1346592	CDPMGR ends abnormally and produces a MCH2602 RmsILockMiObject Lock request not given error message, but Connect:Direct remains running.
1347240	z/OS reports statistics incorrectly for RECFM=FB when sending to i5/OS.
1348212	Error CSPA084E results when sending a IFS file with blank lines in text mode when Secure+ STS is used with digital signature.
1349579	When transferring a 0 byte file from CD HP NonStop to i5/OS, the I/O Recs report information incorrectly.
1349257	Record count is incorrect in z/OS to i5/OS copy in z/OS statistics. The actual data is correct.
1350167	z/OS pulls from the IFS file causing a MCH error when DBLK=0 is sent in FMH71 from z/OS.
1351278	Large multiple gigabyte transfers cause the pointer error Secure+ SSL/TLS is in use.
1353671	Intermittent SSL handshake error CSPA003E occurs during file transmission between Mainframe (PNODE) and iSeries.
1352803	The feedback code from UNIX/Windows is not displayed in Statistics.
1346841	When SSL/TLS is in use and a network connection is lost, restarting fails and produces a APSM007E error.
1338491	Windows sending multiple Processes in one connection to i5/OS causes an ASMT015I error on the second process.
1355179	When SNDFFD(*YES) is used and the file field description is beyond the 12K limit an error message is not received.
1355528	After an upgrade, the Spool Monitor fails when sending a spool file to a GDG on z/OS and produces the error AFLH002I.
1353671	The error ASMT806I-Unknown sense code is received from an SSL connection on the SNODE.
1358560	Pulling a file from i5/OS sends back 3101 instead of SDE0210I.
1361490	After 608A is installed, Processes fail with ASMT015I and CPD0071 errors. The variable status.sec_xsys_init is in the wrong state.
1362459	Allow Connect:Direct for i5/OS to use user profiles with JOBDs containing more than 25 library entries.

SR Number	Explanation
1363442	Unwanted CSL* user spaces remain when running CDCLEANUP.
1363512	The CDTCPL loops if the listen port is removed manually from NETSTAT *CNN.
1363763	The SPADMIN adds remote nodes as type 'L' (local) when a sync-add <f7> is used.</f7>
1364266	LOGIC=B functionality allows invalid combination of SI/SO transfers.
1358640	Checkpoint restart from z/OS to i5/OS creates duplicate records.
1365383	An invalid User Profile used in SNODEID causes RMYSTSEM to end abnormally. Invalid JOBD or invalid library in JOBD causes the issue.
1365707	An ASCII file with an extra 0D in the file, such as 0D0D25 in IFS, causes issues with EORCHAR.
1365500	Request to update the SLCU and DLCU XDR Keys, updated to 4 bytes long on VM system, on Connect:Direct for i5/OS.
1365724	After applying 705A, WRKCDUSR produces error CDE0317 when trying to add or change a user entry.
1365484	VM produces an error when restarting checkpoint, when sending multiple records in one record of the data buffer.
1365986	The WRKCDUSR produces the error CPF6A91 unmonitored by WRKUSRC2 when 1000 or more entries in the CDUSER file occurs.
1365383	If the SNODEID issues no JOBD or bad library in the JOBD commands, the RMTSYSTEM ends abnormally and CDSMGR hangs waiting for a response.
1367579	COPY to a fixed length file from a variable causes a ACOP070I RC=4 error, unlike other Connect:Direct platforms.
1368038	COPY 0 byte file from z/OS with COMPRESS causes a MCH3601 error. The second STEP fails.
1367616	After applying 3.5.00 maintenance updates, merging the Secure+ parameters failed. Sending to the 3.4.00 node resulted in the error CSPA080E.

# **Known Restrictions**

Connect:Direct for i5/OS version 3.6.00 has the following restrictions:

- ♦ The minimum bytes you can specify in CKPTINV(n) is 1K. If you specify a value between 1 and 1023, the value becomes 1024 or 1K.
- ◆ Checkpointing and restarting of IFS files is not supported.
- ◆ Connect:Direct for i5/OS supports SSL\_RSA\_WITH\_AES\_256\_CBC\_SHA, and no longer supports RSA\_EXPORT\_WITH\_RC2\_CBC\_40\_MD5.
- ◆ Connect:Direct for i5/OS does not support V5R1 128-character passwords. Connect:Direct for i5/OS is limited to 10-character password for i5/OS profiles.
- ◆ Connect:Direct for i5/OS does not support the System/36 environment.
- ♦ You cannot upgrade from a version prior to version 3.5.00. To migrate from an earlier version to version 3.6.00, follow the instructions for first-time installations in the *Installing Connect:Direct* chapter of *Connect:Direct for i5/OS Installation and Administration Guide*.
