# ***Sterling Secure Proxy Version 3.3.01 Release Notes***

The *Sterling Secure Proxy Version 3.3.01 Release Notes* provide instructions on how to access the product documentation, obtain the license key file required to use the product, access product updates, and download the product from the ESD portal.

The SSP package is distributed as a file downloaded from the Sterling Commerce Electronic Software Distribution Portal and a license key. See *Download SSP from the ESD Portal* on page 4 for instructions.

## **Access Documentation**

The SSP documentation is available at the Sterling Commerce Customer Center portal. The SSP Web site includes all information for the product, and includes links to documentation for related products, such as Sterling External Authorization Server, Sterling Integrator, Sterling File Gateway, and Connect:Direct. You need a Customer Center user name and password to access the portal.

To log in to the Customer Center, go to <https://customer.sterlingcommerce.com>. If you do not have a password, click **Join Now** and follow the instructions for new users. If you have a Support on Demand account, define a new password the first time you log on.

## Obtain the License Key File

The license key file identifies the product features that are available at a site. When you purchase SSP, a temporary key file is sent to you that enables operation of SSP for a limited time. You must replace the temporary key with a permanent key to continue running SSP.

See the *Sterling Secure Proxy License Management Guide* for instructions to obtain the permanent license key file and install the license key.

## Obtain Product Updates

Product updates and update summaries, including issues resolved for previous versions of SSP, are available at the Customer Center portal.

To obtain product updates:

1. Log on to your Customer Center account to display your customer Home page.
2. Click **Support Center**.

## Download SSP from the ESD Portal

The name of the file you download from the Sterling Commerce Electronic Software Distribution (ESD) Portal depends on your platform. ESD file refers to one of the following files:

These instructions assume that you download the ESD file to a computer running Windows and transfer it to another computer, unless Windows is the target system.

To download the ESD file:

1. Log in to the ESD Portal using the instructions in *Access the ESD Portal* in your Order Confirmation e-mail from Sterling Commerce. The Download Area is displayed.
2. Find the SSP version 3.3.01 download file for your platform and click **Download**.
3. In the **File Download** dialog box, click **Save**.
4. In the **Save As** dialog box, specify where to save the file, or save the file to your desktop.

**Note:** If Internet Explorer adds a number in brackets to the name of the downloaded file (for example, SSP.V3301.OSplatform[1].tar), rename the file on the Windows system before you transfer it in binary mode to the system where it will be installed.

5. Make a backup of the file and store it in a safe place to use in case of disaster recovery, hardware failure, or to reinstall the software.
6. If Windows is not the target system, transfer the file to the system where you will install it.
