Monitor Business Process Deadline Events

Overview

Application provides several ways to monitor business process deadline events, you can:

- ◆ Set up an event listener in your environment to get notifications.
- ◆ Run offline notifications (e-mail or file), when Application goes offline.
- ◆ View events on the Operator Console (dashboard view), see *Performance and Tuning* for more information on using the Operator Console.

In Application, business process deadline events are generated if a business process does not reach the completed or terminated state before its deadline is reached. Business process states include:

- ◆ Active (running or queued)
- ◆ Waiting or Waiting on IO
- ◆ Halted, interrupted_man, interrupted_auto
- ◆ Terminated or Completed

The bpdeadline.log file has been added to the System Logs. You can access this log from the **Operations > System > Logs > Workflow Deadline**.

Types of Notification for Business Process Deadlines

Application provides the following two types of notifications:

- ◆ Batch notifications, which consolidates notifications by the business process state, then consolidates:
 - ◆ All first notifications into a single event
 - ◆ All second notifications into a single event
 - ◆ All final notifications into a single event

Note: The default for the amount of business processes that can be batch notified is set at 100.

- ◆ Single notifications, which provides a single notification for each first, second, and final notifications per business process

Offline Notifications for Business Process Deadlines

Application provides you with the ability to have offline notifications, when your Application goes offline, for example to apply a maintenance patch. You can set up your offline notifications to have either:

- ◆ All notifications sent to you in e-mail. E-mail addresses are defined in the `bpdeadline.properties` file.
- ◆ All notifications put in a text file located at:
 - ◆ For UNIX, `install_dir/deadlines`
 - ◆ For Windows, `Drive:\install_dir\SI\deadlines`

Business Process Deadline Notifications

Business Process deadline notifications are defined during the Business process check-in process (Deadline Setting page). To define deadline notifications for business processes you must:

- ◆ Clear the Do not set deadline
- ◆ Enter the Complete by Deadline hours
- ◆ Enter the First Notification Hours (hours and minutes)
- ◆ Enter the Second Notification Hours (hours and minutes)

Application provides notifications at the following intervals:

- ◆ 1 - First notification
- ◆ 2 - Second notification
- ◆ 3 - Deadline notification completed (final)

Note: If your Application is offline during a notification interval, when the Application comes back online, you will get at least one final notice. *See [Offline Notifications for Business Process Deadlines](#) on page 2.*

Example of a Business Process Event Deadline

An example might be, if a business process deadline is reached when it is executing a service that consumes lots of time (like translation) or if Business process was errored or terminated, interrupted and deadlines were not issued and the business process owner was not alerted. This could cause businesses to run out of inventory or miss shipments, eventually impacting their bottom line profits. In this case, you might want to set up an event listener, so that you are notified when the inventory is low.

Example of Configuring the Event Listener for E-mail Notifications

You can set up an event listener in your environment to get business process deadline notifications by e-mail. The following is an example of how to set up an event listener for notifications by e-mail. The following properties are mentioned in the `lweventrules.properties` file. You would need to define the following rules in the `customer_overrides.properties` file:

Note: You could choose to be notified in a different manner, by replacing the following rule:

```
action.rule31.1=java:com.sterlingcommerce.woodstock.event.listeners.rule
```

The rule mentioned above can be replaced with the following:

```
action.rule31.1=java:com.sterlingcommerce.woodstock.dmi.routing.RouterEv
entNotifier
```

You may configure `dbDeadLineThread=true` (default value is false) in `noapp.properties`. You can override the same property in the `customer_overrides.properties` file.

To receive deadline notification for a business process, you should edit the business process to be monitored, enable business process deadline settings, and configure first notification and second notification times appropriately.

Example of e-mail Notification for Single Business Process

The following is an example of an e-mail notification for a business processed called looper.

```
eventType: Workflow.DeadlineEvent.SECOND_NOTIFY.1
ExceptionLevel: Abnormal
timestamp: 1158764871321
datestamp: 2006.09.20 11:07:51 EDT
STATUS: secondNotify
BP_STATE: ACTIVE
EVENT_TIME: Wed Sept 20 11:07:51 EDT
WFD_NAME: looper
EVENT_INFO: Firing deadline bp

Example of e-mail Notification for Batch Business Processes

The following is an example of an e-mail notification for batched notification. Two business processes were running, looper and inventory, and they both were in the active state.

STATUS: FinalNotify

WF_ID:8012

Example of Offline Notification File

The following is an example of offline notification that is put in a file:

```
OffLine DeadLine Notify Fri Oct 06 12:25:23 EDT 2006
Deadline :FinalNotify
Deadline Notify for wfs in state:ACTIVE
WF_ID:1006
```

Setting up Batch Notifications for Business Process Deadlines

To set up batch notifications for your business processes:

1. Add the following data to the `customer_overrides.properties` file using a text editor (See *Override Property File Settings* for further information):
 - ◆ `noapp.dbDeadLineThread=true`
 - ◆ `bpdeadline.deadlinePerBP=false`
 - ◆ `bpdeadline.includeBPstate=true`

Note: The default for `bpdeadline.includeBPstate` = `false`. By setting this to `true`, when the notification is fired, the event contains the most current state of the business process.
 - ◆ `bpdeadline.EmailTo=` (Use this parameter to define the e-mail addresses to be notified. You can enter multiple e-mail addresses by using a comma (,) to separate them.)
2. Save and close the `customer_overrides.properties` file.
3. Stop and restart Application in order for your customer property overrides to take effect.
4. Run the following command:
 - ◆ For UNIX, **setupfile.sh**
 - ◆ For Windows, **setupfiles.cmd**

Setting up for Single Notifications for Business Process Deadlines

To set up single notifications for your business processes:

1. Add the following data to the `customer_overrides.properties` file using a text editor:
 - ◆ `noapp.dbDeadLineThread=true`
 - ◆ `bpdeadline.deadlinePerBP=true`
 - ◆ `bpdeadline.includeBPstate=true`
 - ◆ `bpdeadline.EmailTo=` (Use this parameter to define the e-mail addresses to be notified. You can enter multiple e-mail addresses by using a comma (,) to separate them.)
2. Save and close the `customer_overrides.properties` file.
3. Stop and restart Application in order for your customer property overrides to take effect.
4. Run the following command:
 - ◆ For UNIX, **setupfile.sh**
 - ◆ For Windows, **setupfiles.cmd**

Setting Up Offline Notifications To Be Sent in E-mail

To set up offline notifications for e-mail delivery:

Note: Perform steps 1 to 4 prior to Application being taken offline.

1. Add the following data to the `customer_overrides.properties` file using a text editor:
 - ◆ `noapp.dbDeadLineThread=true`
 - ◆ `bpdeadline.deadlinePerBP=false`
 - ◆ `bpdeadline.includeBPstate=true`
 - ◆ `bpdeadline.dbDeadlineThreadOffline=true`
 - ◆ `bpdeadline.offlineEmail=true`
 - ◆ `bpdeadline.updateStatus=true`
 - ◆ `bpdeadline.EmailTo=` (Use this parameter to define the e-mail addresses to be notified. You can enter multiple e-mail addresses by using a comma (,) to separate them.)
2. Save and close the `customer_overrides.properties` file.
3. Stop and restart Application in order for your customer property overrides to take effect.
4. Run the following command:
 - ◆ For UNIX, **setupfile.sh**
 - ◆ For Windows, **setupfiles.cmd**
5. After Application is offline, run the following command to start offline notifications:
 - ◆ For UNIX, **install/bin/bpDeadlineOfflineNotification.sh**
 - ◆ For Windows, **install/bin/bpDeadlineOfflineNotification.cmd**
6. Check your e-mail to verify that you have received any deadline notifications.

Note: Depending on the amount of time between when Application goes offline and you run this offline notification command, you may miss a deadline notification.

Note: You may want to execute the command in step 5 again to generate another notification e-mail.

Note: Since the `bpdeadline.updateStatus=true` in the `customer_override.properties`, you may not get the final notification when Application comes back online.

Setting Up Offline Notifications to be Saved in a File

To set up offline notifications to be saved in a file:

1. Add the following data to the `customer_overrides.properties` file using a text editor:

- ◆ `noapp.dbDeadLineThread=true`
- ◆ `bpdeadline.deadlinePerBP=false`
- ◆ `bpdeadline.includeBPstate=true`
- ◆ `bpdeadline.dbDeadlineThreadOffline=true`
- ◆ `bpdeadline.offlineFile=true`
- ◆ `bpdeadline.updateStatus=true`

Note: Since the `bpdeadline.updateStatus=true`, you may not receive the final notification when Application comes back online.

2. Save and close the `customer_overrides.properties` file.

3. Stop and restart Application in order for your customer property overrides to take effect.

4. Run the following command:

- ◆ For UNIX, **`setupfile.sh`**
- ◆ For Windows, **`setupfiles.cmd`**

5. After Application is offline, run the following command to start offline notifications:

- ◆ For UNIX, **`install/bin/bpDeadlineOfflineNotification.sh`**
- ◆ For Windows, **`install/bin/bpDeadlineOfflineNotification.cmd`**

Note: Depending on the amount of time between when Application goes offline and you run this offline notification command, you may miss a deadline notification.

6. Check the contents of the file located at:

- ◆ For UNIX, `install_dir/deadlines`
- ◆ For Windows, Drive:\`install_dir\SI\deadlines`
