August 2008 EDI Standards for Sterling Integrator and Gentran Integration Suite

Overview

This document contains instructions for installing the August 2008 EDI Standards for use with Gentran Integration Suite[®] version 4.2 or higher and Sterling Integrator 5.0 or higher.

The EDI Standards databases are updated based upon market requirements, produced on a disc separate from the products, and are available at your request.

This document also contains instructions for installing the CII and HIPAA Standards for use with Gentran Integration Suite version 4.2 or higher and Sterling Integrator 5.0 or higher.

New and Updated Versions in this Release

See the *Readme.txt* file in the root directory on the EDI Standards disc for the most current list of updates to existing standards and new standards included in this release. CII users should also check the *CII Readme.htm* file provided in the CII folder for additional information about the CII Standards.

Prerequisites

- ◆ Install Gentran Integration Suite or Sterling Integrator before you install the EDI or CII Standards.
- ◆ Install Microsoft Data Access Components (MDAC) before you install the standards. See the Gentran Integration Suite or Sterling Integrator System Requirements to determine which version of MDAC to use.

Hard Drive Space Required

Ensure that there is sufficient free space on the drive where you are installing the standards. The following table contains the amount of hard drive space required to install the EDI, CII, or HIPAA Standards on your computer:

Standards Type	Hard Drive Space Required
EDI	507 MB
CII	7.2 MB
HIPAA	7 MB

Installing Standards in a UNIX Environment

You can install the standards in a UNIX environment either from the standards disc or by downloading the standards from the Customer Center and Support Web site.

Installing Standards in a UNIX Environment from the Standards disc

These instructions assume that the disc will be mounted and accessible from the environment running Gentran Integration Suite or Sterling Integrator. If this is not the case, the files from the disc should be transferred (for example by FTP) to a suitable directory on the environment, and that directory should be substituted for the disc in the following steps.

To update the EDI Standards and CII Standards on a Gentran Integration Suite or Sterling Integrator UNIX environment:

1. Place the Standards database disc in the appropriate drive.
2. Change directory to the bin subdirectory of your Gentran Integration Suite or Sterling Integrator installation.
3. From the bin directory of your Gentran Integration Suite or Sterling Integrator installation, run `deployStandards.sh`, including the paths to the updated standards database installer files on the disc, as shown in the following example:

```
./deployStandards.sh /path_to_disc/SI/SterlingIntegratorStandards.exe  
/path_to_disc/CII/GentranCIIStandards.exe
```

where *path_to_disc* is the path to the location where the disc is mounted or the directory where you copied the files.

Running this executable deploys the updated standards to your server.

4. Deploy the new standards to your client machines by following these instructions: *Updating Gentran Integration Suite or Sterling Integrator Client Machines* on page 7.

Installing Standards in a UNIX Environment from the Customer Center and Support Web Site

These instructions assume that you will download the standards from the Sterling Commerce Customer Center and Support Web site.

To update the EDI Standards and CII Standards on a Gentran Integration Suite or Sterling Integrator UNIX environment:

1. Create a temporary directory on your server to store the standards zip file that you will download from the Customer Center and Support Web site. All of the files needed for the upgrade will reside in this directory and the executable programs you run to install/update the standards must point to this directory.
2. On the Customer Center and Support Web site, select the Support Center tab. Under the **Product Support** menu on the left side, select **Sterling Integrator > Product Updates and Downloads or Gentran Integration Suite > Product Updates and Downloads**.
3. From the Sterling Integrator Product Updates/Downloads page, under Updating the standards database in Sterling Integrator, select **Sterling Integrator Standards**, or from the **Gentran Integration Suite Product Updates/Downloads** page, under **Updating the standards database in Gentran Integration Suite**, select **Gentran Integration Suite Standards**.
4. Click **Save** to save the `SI-GIS_Standards.zip` file to the directory you created in step 1. This zip file contains all the standards.

5. Unzip the SI-GIS_Standards.zip file and keep all the extracted files in the same directory as the zip file. The following files are extracted:
 - ◆ CII Readme.htm (this is the readme file for the CII Standards)
 - ◆ deployStandards.sh.in (required for Gentran Integration Suite version 2.0 only)
 - ◆ GentranCIIStandards.exe (this is the CII Standards executable)
 - ◆ SI-GIS_Standards_readme.pdf (a PDF copy of this documentation)
 - ◆ SterlingIntegratorStandards.exe (this is the Sterling Integrator and Gentran Integration Suite Standards executable)
6. Create a temporary directory on your UNIX server.
7. FTP the following files in binary mode to the temporary directory created in step 6.
 - ◆ GentranCIIStandards.exe
 - ◆ SterlingIntegratorStandards.exe
8. From the bin directory of your Sterling Integrator or Gentran Integration Suite installation, run deployStandards.sh, including the paths to the updated standards database installer files on the temporary directory created in step 6, as shown in the following example:

```
./deployStandards.sh  
/path_to_temporary_directory/SI/SterlingIntegratorStandards.exe  
/path_to_temporary_directory/CII/GentranCIIStandards.exe
```

where *path_to_temporary_directory* is the path to the location of the temporary directory where you copied the files in step 7.

Running this executable deploys the updated standards to your server.
9. When the install/upgrade process is complete, you can delete the directory you created in step 1.
10. Deploy the new standards to your client machines by following these instructions: *Updating Gentran Integration Suite or Sterling Integrator Client Machines* on page 7.

Installing Standards on a Windows Server

You can install the standards in a Windows environment either from the standards disc or by downloading the standards from the Customer Center and Support Web site.

Installing Standards in a Windows Environment from the Standards Disc

To update the EDI Standards and CII Standards on a Sterling Integrator or Gentran Integration Suite Windows server:

1. Place the Standards Database disc in the appropriate drive.
2. Change directory to the bin subdirectory of your Sterling Integrator or Gentran Integration Suite installation.
3. From the bin directory of your Sterling Integrator or Gentran Integration Suite installation, run deployStandards.cmd. Include the paths to the new standards database installer files on the disc. You

must include both files and specify the EDI file first, followed by the CII file, as shown in the following example:

```
\install_dir\si\bin\deployStandards.cmd  
DVD_DRIVE:\SI\SterlingIntegratorStandards.exe  
DVD_DRIVE:\CII\GentranCIIStandards.exe
```

where: *DVD_DRIVE* is the letter of the drive where the disc is located.

Running this executable deploys the updated standards to your server.

4. Deploy the new standards to your client machines by following these instructions: *Updating Gentran Integration Suite or Sterling Integrator Client Machines* on page 7.

Installing Standards in a Windows Environment from the Customer Center and Support Web Site

These instructions assume that you will download the standards from the Sterling Commerce Customer Center and Support Web site.

To update the EDI Standards and CII Standards on a Sterling Integrator or Gentran Integration Suite Windows environment:

1. Create a temporary directory on your server to store the standards zip file that you will download from the Customer Center and Support Web site. All of the files needed for the upgrade will reside in this directory and the executable programs you run to install/update the standards must point to this directory.
2. On the Customer Center and Support Web site, select the support center tab. Under the **Product Support** menu on the left side, select **Sterling Integrator > Product Updates and Downloads or Gentran Integration Suite > Product Updates and Downloads**.
3. From the Sterling Integrator Product Updates/Downloads page, under Updating the standards database in Sterling Integrator, select **Sterling Integrator Standards**, or from the **Gentran Integration Suite Product Updates/Downloads** page, under **Updating the standards database in Gentran Integration Suite**, select **Gentran Integration Suite Standards**.
4. Click **Save** to save the SI-GIS_Standards.zip file to the directory you created in step 1. This zip file contains all the standards.
5. Unzip the SI-GIS_Standards.zip file and keep all the extracted files in the same directory as the zip file. The following files are extracted:
 - ◆ CII Readme.htm (this is the readme file for the CII Standards)
 - ◆ deployStandards.sh.in (required for Gentran Integration Suite version 2.0 only)
 - ◆ GentranCIIStandards.exe (this is the CII Standards executable)
 - ◆ SI-GIS_Standards_readme.pdf (a PDF copy of this documentation)
 - ◆ SterlingIntegratorStandards.exe (this is the Sterling Integrator and Gentran Integration Suite Standards executable)
6. Create a temporary directory on your Windows server.
7. Copy the following files to the temporary directory created in step 6.
 - ◆ GentranCIIStandards.exe

- ◆ SterlingIntegratorStandards.exe

8. From the bin directory of your Sterling Integrator or Gentran Integration Suite installation, run `deployStandards.cmd`, including the paths to the updated standards database installer files on the temporary directory created in step 6, as shown in the following example:

```
\install_dir\si\bin\deployStandards.cmd
\path_to_temporary_directory\SI\SterlingIntegratorStandards.exe
\path_to_temporary_directory\CII\GentranCIISTandards.exe
```

where *path_to_temporary_directory* is the path to the location of the temporary directory where you copied the files in step 7.

Running this executable deploys the updated standards to your server.

9. When the install/upgrade process is complete, you can delete the directory you created in step 1.
10. Deploy the new standards to your client machines by following these instructions: *Updating Gentran Integration Suite or Sterling Integrator Client Machines* on page 7.

Updating Gentran Integration Suite or Sterling Integrator Client Machines

After you have installed the standards on a Sterling Integrator or Gentran Integration Suite UNIX or Windows server, deploy the new standards to client systems by using the Download EDI Standards and Download CII Standards options from the **Deployment > Maps** menu of the Gentran Integration Suite or Sterling Integrator user interface. Uninstalling Standards on a Windows Client

To uninstall the Gentran Integration Suite or Sterling Integrator standards on a Windows client, use the following procedure:

1. From the **Windows Start** menu, select **Settings > Control Panel > Add/Remove Programs**.
2. Select **Change or Remove Programs** in the left panel. The list of currently installed programs displays.
3. From the list, select **Gentran Integration Suite or Sterling Integrator Standards** and click **Change/Remove**.
4. The following prompt is displayed: Are you sure you want to completely remove 'Gentran Integration Suite or Sterling Integrator Standards' and all of its components?

Click **Yes** to uninstall the standards.

Log or View a Support Request

You can use the Customer Center to create a support request free of charge. You can also view any support request that you entered during the last 90 days.

Caution: Do not use Customer Center and Support to report a Severity Level 1 (production down) problem. In this case, Customer Support recommends that you call the toll-free, as explained in *Contacting Customer Support* on page 8.

To create or view a support request:

1. In your Internet browser, enter www.sterlingcommerce.com to display the Sterling Commerce Web site.
2. Select **Services > Customer Center and Support**.
3. Type your e-mail address and password and click **Sign In** on the Customer Center Login page. In the Customer Center Home Page, under the heading My support requests, select **Log and View Cases**.
4. Select the appropriate Severity level from the list and complete steps, as necessary:

Severity Level	Description/Step
2 – Critically Impacting	Product operational but severely restricting production
3 – Normal Question	General product questions
4 – Informational	Minor issue or question
5 – Evals/Enhancement Request	Enhancement requests for existing applications

5. From the list, select the appropriate Product/Service Family and the Product/Service.
6. Select the **Release** and the **Patch/Build Level**.
7. Type a **Summary** and in **Description**, enter a brief description of the problem or question.
8. Click **Submit**.

If your issue is not a production down issue, Sterling Commerce Customer Support will contact you accordingly.

If you are experiencing a production down issue, contact Sterling Commerce Customer Support by telephone. To obtain a list of Sterling Commerce Customer Support telephone numbers, on the Report A Case Web page, under Severity Guidelines, click **Please call your customer support group**.

Search the Knowledgebase

You can use Support On Demand to access a database containing solutions to technical support issues.

To access the Knowledgebase:

1. In your Internet browser, enter www.sterlingcommerce.com to display the Sterling Commerce Web site.
2. Select **Services > Customer Support**.
3. Type your e-mail address and password and click **Sign In** on the Customer Center Login page. Type your e-mail address and password and click **Login**.

To look up a trading partner:

1. In your Internet browser, enter www.sterlingcommerce.com to display the Sterling Commerce Web site.
2. Select **Services > Customer Support**.
3. Type your e-mail address and password and click **Sign In** on the Customer Center Login page. Type your e-mail address and password and click **Login**.
4. In the Customer Center Home page, select **Tools and Applications > Online Tools > Lookup Trading Partner**.
5. In the Lookup Trading Partner page, enter the business partner EDI ID and Qualifier in the appropriate boxes. The default Qualifier is ZZ.
6. Click **Look up** to display the search results (the company name and service provider for the business partner).

Download Product Documentation

Product-specific documentation is available for download from the Documentation Library on Support On Demand.

1. In your Internet browser, enter www.sterlingcommerce.com to display the Sterling Commerce Web site.
2. Select **Services > Customer Support**.
3. Type your e-mail address and password and click **Sign In** on the Customer Center Login page. Type your e-mail address and password and click **Login**.
4. In the Customer Center and Support Home Page, click on **Support Center**.
