Using Sterling e-Invoicing

Overview

Sterling e-Invoicing enables you to use electronic invoices (e-Invoices) while also maintaining the requisite legal compliance. This enables you to eliminate the paper trails that companies have to maintain for compliance with Value Added Tax (VAT) laws, including complying with all the audit requirements for tax purposes.

Sterling e-Invoicing uses the e-signature method of compliance, which uses digital signatures to allow the seller to sign an invoice digitally using keys approved by the government of the seller's country. The signature is then verified by the buyer and these signatures can be verified in future tax audits for their authenticity and integrity by re-verifying the signatures on archived invoices. The e-signature method of compliance is the preferred option of the tax authorities because it provides an unequivocal technical guarantee of the authenticity and integrity of the invoice.

Sterling Commerce has partnered with TrustWeaverTM to provide e-signature signing and verification through its on-demand service. All other e-Invoice functionality is created by Sterling Commerce. TrustWeaver offers products and on-demand services that support all of the necessary hardware and certificate authorities.

This documentation describes how to use Sterling e-Invoicing for your daily processing needs.

Prerequisites

The following are prerequisites to using Sterling e-Invoicing:

♦ The audience using this software should be familiar with the application, e-Invoicing, TrustWeaver, and Value Added Tax (VAT) compliance regulations.

Note: This documentation is not intended to explain e-Invoicing or how to use TrustWeaver software.

◆ You must have purchased an e-Invoicing license for use with the application.

Using Sterling e-Invoicing

Using Sterling e-Invoicing, you can perform many tasks, including the following:

- ◆ Edit, delete, import, export, search, and view agreements
- ♦ Edit and delete identities
- ♦ Edit global configuration information
- ♦ Use the Integrated Archive
- ◆ Create an external or custom archive
- ◆ Unpause your connection to TrustWeaver

Credentials Fulfillment

For Sterling e-Invoicing, you need to obtain credentials that establish your identity and authorize your install of the application to connect with the TrustWeaver server. Before you obtain a copy of Sterling e-Invoicing, you must provide an e-mail address and fax number for your technical contact to Sterling Commerce Sales.

Sterling Commerce will provide this contact information to TrustWeaver and TrustWeaver uses this contact information to send you the information you need to obtain credentials. This information will be provided in two parts for security purposes. The first part will be in an e-mail addressed to your technical contact, and the second part will be faxed to you from TrustWeaver. You will need both parts of this information to download the necessary digital certificates from a link that TrustWeaver will provide you in the e-mail they send to you. TrustWeaver will also add the e-mail address you provide to its list of subscribers, so they can notify you of critical product alerts and system status updates. For this reason, we recommend you provide an e-mail alias or group account that can be managed long-term, independent from an e-mail address of an individual employee.

To use these credentials, you must complete these tasks in sequential order:

Obtaining Digital Certificates from TrustWeaver

To obtain digital certificates from TrustWeaver:

- 1. Contact TrustWeaver and register for credential download.
 - You will receive notification from TrustWeaver with a web link to the location from which you can download the certificates. The link will contain an email code, which is half of the certificate password. The other half of the password, the Control Code, will be faxed to you at the fax number you supply during registration.
- 2. Once you have the link and your Control Code, you use the link to access the TrustWeaver web page from which you can download the CA certificate and the PKCS12 certificate. Download both certificates.
- 3. Rename the .p12 file that you downloaded from step 2 to use the file extension .pfx.
- 4. Follow the instructions below to check in the digital certificates.

Checking In Digital Certificates

To check in the CA and PKCS12 digital certificates so your invoices can be securely transported to and from TrustWeaver:

- 1. Save the certificate to a file on your local computer.
- 2. In the application, from the **Administration** menu, select **Trading Partner > Digital Certificates > CA**.
- 3. Next to Check in New Certificate, click **Go!** to check in the CA certificate.
- 4. In the Filename field, type or browse to the file name of the certificate and click Next.
- 5. Verify the name of the certificate you are checking in.

Note: For each certificate in the file you selected, the Certificate Name field contains a suggested name built out of the issuer relative distinguished name (RDN) and serial number of the certificate. Below the name is a summary of the identifying information in the certificate. For convenience, the application records the name of the certificate in its database. You can change the name to fit your file name conventions or to something easier to remember.

- 6. Next to **Validate When Used**, if you want to validate your certificate using one of the following options, select the appropriate validation options:
- ♦ Validity Verifies dates for the validity period of the certificate to check if they are still in effect. If the dates are not in effect, the certificate is not used.
- ♦ Auth Chain Constructs a chain of trust for certificates that are not self-signed. If a chain of trust cannot be constructed using valid certificates, the certificate is not used. If the certificate is self-signed, this option verifies only the certificate signature.
- ◆ CRL Cache Checks the Certificate Revocation List (CRL) in the CRL cache to ensure that the certificate is not revoked or in a held state.

Note: To use the CRL Cache option, you must have the CRL feature enabled and create business processes to download CRLs. The CRL Cache option displays only for certificates issued by a CA and does not display if you use a self-signed certificate.

- 7. If there is more than one CA certificate in the file you selected, you can check in each certificate by selecting the check box next to it.
- 8. Click **Finish** to check the CA certificate in to the application.
- 9. In the application, from the **Administration** menu, select **Trading Partner > Digital Certificates > System**.
- 10. Next to Check in PKCS12 Certificate, click Go! to check in the new PKCS12 certificate.
- 11. In the Specification page, complete the following fields and click **Next**.

Field	Description
Certificate Name	Type a unique and meaningful name for the PKCS12 certificate. Required

Field	Description
Private Key Password	Type the private key password. This is the password used to encrypt the PKCS12 certificate. Required.
	Note: The Private Key Password and Key Store Password are the same, and they are the concatenation of the email code and control code from Obtaining Digital Certificates from TrustWeaver on page 7. For example, if your password is xYKt and Control Code is A5hzTXpM, the concatenation of both is xYKtA5hzTXpM. You must retain the password and control code information because you will need it when you pick up renewed certificates two years after your initial install.
Key Store Password	Type the key store password. This is the password for the PKCS12 object. It may be the same as the private key password. Required.
	Note: The Private Key Password and Key Store Password are the same, and they are the concatenation of the email code and control code from Obtaining Digital Certificates from TrustWeaver on page 7. For example, if your password is xYKt and Control Code is A5hzTXpM, the concatenation of both is xYKtA5hzTXpM. You must retain the password and control code information because you will need it when you pick up renewed certificates two years after your initial install.
Filename (.pfx)	Type the filename of the certificate or click Browse to select the file name of the PKCS12 certificate. Required.

- 12. Next to **Validate When Used**, if you want to validate your certificate using one of the following options, select the appropriate validation options:
- ♦ Validity Verifies dates for the validity period of the certificate to check if they are still in effect. If the dates are not in effect, the certificate is not used.
- ♦ Auth Chain Constructs a chain of trust for certificates that are not self-signed. If a chain of trust cannot be constructed using valid certificates, the certificate is not used. If the certificate is self-signed, this option verifies only the certificate signature.
- 13. If there is more than one PKCS12 certificate in the file you selected, you can check in each certificate by selecting the check box next to it.
- 14. Click **Finish** to check the PKCS12 certificate in to the application.

Picking Up Renewed Certificates in Two Years

You can download the CA and PKCS12 digital certificates again at any time if you retain the information provided to you in the e-mail and fax you receive from TrustWeaver.

Additionally, two years after you have downloaded the digital certificates for the first time, you will need to pick up the renewed certificates. TrustWeaver automatically makes these certificates available for you to pick up sixty days prior to the expiration of the certificates, and TrustWeaver will e-mail your registered contact to inform you that the renewed certificates are available for you to pick up.

You need to pick up the renewed certificates from TrustWeaver, and then either you can check in the certificates or SCI Professional Services can assist you with checking in the certificates.

Configuring the Check Expire Service

The application Check Expire service alerts you when certificates are about to expire, or have expired. The Check Expire service runs on a schedule (by default it runs daily at 2:30 AM), and reviews each checked-in certificate to compare its expiration date against the value set in the application (the default is 14 days). Any certificates that have already expired or will expire within the specified number of days are listed on your Admin Console Home page in **System Alerts**, **System Alerts** on **Dashboard**, and the **Event Viewer** under the **Operator** menu. These alerts remain in the system for 60 days.

Note: You need to configure the Check Expire service so you will be warned using your preferred output method at least 14 days prior to when your certificates expire, to avoid the risk of downtime when these certificates expire. We recommend that you use e-mail as the output method for alerts. See *Managing Services and Adapters* for more information about configuring the Check Expire service.

If Your Technical Contact Information Changes

If your technical contact information changes (specifically, your e-mail address or fax number), open a Support Case requesting a change of record through Support on Demand. Sterling Commerce will verify that you are authorized to obtain credentials.

If You Lose the Password And/Or Control Code

If you ever lose the password and/or control code information sent to you by TrustWeaver, open a Support Case requesting a replacement through Support on Demand. Sterling Commerce will verify that you are authorized to obtain credentials.

Maintenance Updates

If TrustWeaver updates its software, Sterling Commerce may need to provide an update to Sterling e-Invoicing. If an update is necessary, it will be posted on Support on Demand like standard maintenance patches are posted.

To use the Support on Demand Web site (free of charge):

- 1. Open your Internet browser and go to http://www.sterlingcommerce.com.
- 2. Select Customer Support.
- 3. In the Support on Demand box, click **LOGIN**.
- 4. Type your E-mail address and password.
 - If you do not have a Support on Demand password, follow the instructions on Support on Demand to request one.
- 5. Click **Login** and follow the online instructions.

Editing Global Configuration Parameters for e-Invoicing

Overview

Sterling e-Invoicing enables you to set global parameters to limit the maximum number of connections that can be established by Sterling e-Invoicing with TrustWeaver and the maximum size of invoices that can be sent to the TrustWeaver Server for processing. You need to set these parameters or accept the defaults to ensure that the TrustWeaver Server is not overloaded when you send data for signing or verification.

Editing the Global Parameters

To edit the global e-Invoicing parameters:

- 1. From the **Administration** menu, select **eInvoicing > Configuration**.
- 2. Next to Edit Configuration Parameters, click Go!.
- 3. Update the following TrustWeaver Configuration parameters:

Parameter	Definition
TrustWeaver Host	The name of the TrustWeaver Server. Required.
TrustWeaver URI	The name of the TrustWeaver Universal Resource Indicator representing incoming requests. Required.
CA Certificate	The digital security certificate used to provide authentication to TrustWeaver. Required. Note: The client certificate must be valid. A client certificate is only required by the Sign method.
System Certificate	The system certificate contains the private key the SSL server will use to communicate with TrustWeaver. Required.
	Note: To access information from TrustWeaver Server, you must establish an encrypted channel (SSL) to the server to ensure that only the intended client can read the information sent to and from the server. SSL is also used to authenticate the server, and a client authenticates the server through the SSL server certificate.

- 4. Click Next.
- 5. Update the following EInvoice Configuration Parameters or accept the defaults:

Parameter	Definition	Default Value
Maximum Invoice Size (MB)	The Maximum size of the invoice message that can be sent to the TrustWeaver Server. Required.	4
	Note: If the size of the SOAP request created by the TrustWeaver Request service (when it retrieves the primary document from process data) is greater than the value specified here, the process is stopped and an error is generated.	

Parameter	Definition	Default Value
Maximum Open Connections	The maximum number of open connections that can be made with TrustWeaver Server. This parameter is used to ensure that the TrustWeaver Server is not overloaded with invoice messages. Required.	5
	Note: The number of open connections is limited by the Semaphore service.	
Immediate Retry	Number of retries allowed when a self-correcting, transient error (essentially a hiccup in the processing that is not expected to be repeated, or not expected to last for long) is returned by the TrustWeaver Server. This parameter specifies the number of times to loop with a small pause between each loop. Required.	3
Delayed Retry	Number of retries allowed when a delaying error (a self-correcting, transient error, but an error that is expected to take some time to resolve) is returned by the TrustWeaver Server. This parameter specifies the number of times to loop with a pause between each loop. Required.	24
Immediate Retry Wait (sec)	Number of seconds to pause before retrying when a self-correcting, transient error occurs. Required.	200
Delayed Retry Wait (min)	Number of minutes to pause before retrying when a handling error occurs (and the error is transient and self-correcting but not immediately fixable). Required.	60
Time to wait for an available connection (sec)	The maximum number of seconds to wait to get a connection with the TrustWeaver Server.	300
	Note: This allows for a controllable amount of access as required by the application or resource. This may be useful for performance implications, because of limited resources or any other reason.	

6. Click **Next**.

7. Click **Finish** to update the global parameters.

Managing TrustWeaver Connections

Overview

Sterling e-Invoicing enables you to set global parameters to specify the number of retries allowed when a self-correcting, transient error (essentially a hiccup in the processing that is not expected to be repeated, or not expected to last for long) is returned by the TrustWeaver Server. This parameter specifies the number of times to loop with a small pause between each loop. You are also able to configure the number of retries allowed when a delaying error (a self-correcting, transient error, but an error that is expected to take some time to resolve) is returned by the TrustWeaver Server. This parameter specifies the number of times to loop with a pause between each loop. Thus, Sterling e-Invoicing automatically pauses the connection to TrustWeaver when processing errors occur, but you can manually unpause the connection using the Lock Manager.

If there is a failure in connecting to the TrustWeaver Server for any reason, the error message "Not Found" is displayed, and re-validation is listed as failing.

When a resource is in use in Sterling e-Invoicing, the system locks the resource to prevent other users or resources from accessing it. When the resource is free, it is unlocked. However, with the necessary permission, you can unlock resources manually as well, even a resource that is currently in use for processing.

Resuming the Connection to TrustWeaver

If processing errors have occurred and the global e-Invoicing parameters you configured have caused Sterling e-Invoicing to suspend (pause) the connection to TrustWeaver, you can manually unpause the connection through the following:

- 1. From the **Administration** menu, select **Operations > Lock Manager**.
- 2. Use the search or list option to locate the locked resource you want to unlock.
- 3. In the Lock Manager search results page, under Lock, clear the check box next to the resource you want to unlock.
- 4. Click OK.

Editing and Deleting e-Invoice Identity Records

Overview

Every trading partner is represented by at least one record, referred to as an *identity*. An identity record describes the trading partner and contains information referenced when a business process involving the trading partner is executed. A trading partner can have more than one identity to represent the different ways it does business. For example, a company's central office procurement organization might be very different from its manufacturing supplies procurement organization, and in this case you need a separate identity record for each organization within the company.

A base identity is a regular identity that you can use as a starting point to create a new identity. The base identity maintains a link to the identity that inherited its properties. If you modify the base identity, all related identities (that is, ones that inherited the base identity properties) change, as well. When you create an identity record using a base identity, everything in the new identity is the same as in the base identity, except the identity name, description, and other unique parameters, such as unique identification numbers.

Note: If you plan to create many identities using the base identity, do not use the base identity in production. You should record the identities that are related to the base identity.

You must create an identity before you can create a transport, document exchange, delivery channel, packaging, profile, and (when required) a contract. Each of these components references an identity. For e-Invoicing, only an identity record is mandatory; the transport, document exchange, delivery channel, packaging, profile, and contract are only necessary if the standard you are using requires them.

You can edit or delete your identity records at any time.

Searching for Identity Records

To edit or delete an identity record, you must first specify the appropriate record. You can locate a specific identity record in two ways:

- ♦ Search for an identity by name.
- ◆ Select an identity from an alphabetical list.

Searching for an identity by name is more precise and provides fewer results. Searching from an alphabetical list will result in a list of all identities or all identities beginning with a specified letter or digit.

Searching for an Identity Record by Name

To search for an identity by name:

- 1. From the **Administration** menu, select **Trading Partners** > **Advanced** > **Identities**.
- 2. In the Search section, type the name of the identity. Case does not matter and you can type part of a name.

Sterling e-Invoicing returns a list of matches unless no identities meet the criteria you specified.

Searching for an Identity Record from a List

To select an identity from a list:

- 1. From the **Administration** menu, select **Trading Partners** > **Advanced** > **Identities**.
- 2. In the List section, select **All** or a specific letter or digit (0 9) and click **Go!** Sterling e-Invoicing returns a list of matches unless no identities meet your criteria.

Viewing or Editing an Identity Record

To view or edit an identity record:

- 1. From the Administration menu, select Trading Partners > Advanced > Identities.
- 2. In the Identities page, in the **Search** section next to **Identity Name**, type the name of the identity you want to edit and click **Go!**
- 3. In the Identities page, next to the Identity Record you want to edit, click edit.
- 4. In the Information page, complete the following fields and click **Next**:

Field	Description
Name	Name of your organization. Required.
Reference URL	Internet address of your organization. Optional.
DUNS	Unique 9-13 character identification number of your organization, as issued by Dun & Bradstreet Corporation. Optional.
Identifier	Primary ID of your organization. Use DUNS number. Required.
Address Line 1	Conventional mailing address of your organization. Required.
Address Line 2	Additional mailing address information of your organization. Optional.
City	City where your organization is located. Required.
State or Province	State or province where your organization is located. Optional.
Zip or Postal Code	ZIP Code or postal code where your organization is located. Optional.
E-mail Address	E-mail address of your organization. Optional.
Telephone Number	Telephone number of your organization. Optional.
Time Zone	Time zone where your organization is located. Optional.
Country	Country where your organization is located. Optional.
Federation Peers	Discovery point URL for the trading partner you want to associate this identity with. Optional.
VAT ID	The VAT transaction tax identifier. Optional.
	Note: When you add VAT IDs to an identity, an associated permission ID is created, and the user is assigned that permission ID.

Internal Notification E-Mail	The internal e-mail address to which you want error notifications to be sent. Optional.	
Lookup ID	The identifier used to look up the e-Invoice agreement. Optional.	
Lookup ID Comments	Any comments regarding the identifier used to look up the e-Invoice agreement. Optional.	

- 5. Click **Next** to access the Confirm page.
- 6. Click **Finish** to update the identity.

Deleting an Identity Record

To delete an identity record:

- 1. From the Administration menu, select Trading Partners > Advanced > Identities.
- 2. In the Identities page, in the **Search** section type the name of the identity for the identity you want to edit and click **Go!**
- 3. In the Identities page, next to the Identity Record you want to delete, click **delete**.

Using e-Invoice Agreements

Overview

An agreement is a configurable object that relates two e-Invoice parties (the "supplier" and the "buyer"), and stores their e-Invoice processing options (including any "on behalf" options). It is linked to the supplier and buyer identities.

Note: The agreement is a relationship object that enables the necessary legal separation of supplier and buyer e-Invoicing steps.

You must have an e-Invoice agreement for each trading partner with whom you will be exchanging e-Invoices.

Agreements are viewed as "resources" by Sterling e-Invoicing and, as such, they are versioned through the Version Manager, and importable and exportable through the Source Manager.

Source Manager

The Source Manager enables you to edit and delete agreements. It also displays the following information about an agreement:

- ◆ Date and time the agreement was created
- ♦ User name of the person who created the agreement
- ♦ Comments about changes that have been made to the agreement

Version Manager

The Version Manager enables you to select a default version of an agreement if there are two or more versions of the agreement.

The Version Manager also displays the following information about an agreement:

- ◆ Date and time the agreement was created
- ♦ User name of the person who created the agreement
- ♦ Comments about changes that have been made to the agreement

Searching for Agreements

To edit or delete an agreement, you must first specify the appropriate agreement. You can locate a specific agreement in five ways:

- ◆ Search for an agreement by name.
- ♦ Search for an agreement by associated identity.
- ◆ Search for an agreement by country code.
- ◆ Search for an agreement by VAT ID.
- ◆ Select an agreement from an alphabetical list.

Searching for an agreement by name, identity, country code, or VAT ID is more precise and provides fewer results. Searching from an alphabetical list will result in a list of all agreements or all agreements beginning with a specified letter or digit.

After you have found the appropriate agreement, you can manage it through the Source Manager and the Version Manager.

Searching for an Agreement by Name, Identity, Country Code, or VAT ID

To search for an agreement by name, identity, country code, or VAT ID:

- 1. From the **Administration** menu, select **eInvoicing** > **Agreements**.
- 2. In the Search section, type the name of the agreement, the identity, the country code, or the VAT ID. Case does not matter and you can type part of a search parameter.

Sterling e-Invoicing returns a list of matches unless no agreements meet the criteria you specified.

Note: A message is displayed if any agreements are not displayed in the search results page because the user does not have sufficient permissions assigned to his or her user account.

Searching for an Agreement from a List

To select an agreement from a list:

- 1. From the **Administration** menu, select **eInvoicing > Agreements**.
- 2. In the List section, select **All** or a specific letter or digit (0 9) and click **Go!**Sterling e-Invoicing returns a list of matches unless no agreements meet your criteria.

Creating an e-Invoice Agreement

To create an e-Invoice agreement:

- 1. From the Administration menu, select **eInvoicing** > **Agreements**.
- 2. In the Agreements page, in the Create section next to New Agreement, click Go!.

Specifying Default Agreements

The default agreement is the version of the agreement that is available at the start of a business process. You can specify a default agreement only if you have two or more versions of the agreement. One version must be selected as the default.

- Select the version you want to make the default and click Save.

Exporting an Agreement

In Sterling e-Invoicing, the agreement is considered to be a resource, and must be in the proper format. The Export feature copies and converts resources that you specify into a file in one of the following formats importable formats, according to your needs:

- ◆ XML Enables you to transfer data or resources between two existing systems.
- ◆ Installable bundle Optionally enables you to load the data during an installation on a new system.

When you perform an export, you select to export one or more types of resources to export (such as agreements). Then, the export wizard provides options for specifying by version and resource tag which copies of each selected resource you want to export. The version-related options are:

- ◆ Standard export For selected resources, the export copies non-versioned resources and the default version of versioned resources.
- ♦ Advanced export For your selected resources, the export copies non-versioned resources and, for versioned resources, enables you to choose either to export only default versions or all versions.

In any export procedure, you can export resources that are associated with a particular resource tag or choose to export resources independently of any association with a tag. Resources associated with a tag are not tied to the tag; you can export them without selecting the associated tag.

Note: Agreements are associated with the **eInvoicing** resource tag.

Exporting Agreements Associated with a Resource Tag

To export all agreements associated with a resource tag:

- 1. From the **Administration** menu, select **Deployment > Resource Manager > Import/Export**.
- 2. Next to Export Resources, click Go!
- 3. Indicate the type of format to export to, XML Document or Install Bundle, and click **Next**.
- 4. Select **Yes** to export resources associated with a tag, select the appropriate resource tag (such as eInvoicing), and click **Next**.
- 5. Does the system require a passphrase?
 - If Yes, enter the passphrase (the password you use when you log in to the application).
 - If No, the passphrase page does not display; proceed to the next step.
- 6. Are private certificates included in the resources associated with this tag?
 - If Yes, indicate whether to export private certificates that are associated with the resource tag.
 - If No, this page does not display; proceed to the next step.
- 7. Click **Finish** to create the export file.
- 8. When the message, *The system update completed successfully* is displayed:
 - Click **View Export Report** to see status information to confirm the export of each resource associated with the selected resource tag, if desired.
 - Click **Download Export data** to download the export file to a hard drive or disk where you will store it.
- 9. In the File Download dialog box, click Save.
- 10. In the Save As dialog box, select the location to which to save the file, and click Save.

Exporting Agreements Not Associated with a Resource Tag

To export agreements that are not associated with a resource tag:

- 1. From the Administration menu, select Deployment > Resource Manager > Import/Export.
- 2. Next to **Export Resources**, click **Go!**
- 3. Indicate the type of format to export to, XML Document or Install Bundle, and click Next.
- 4. Select **No** to indicate that you do not want to export resources associated with a tag.
- 5. On the Export Type page, indicate the type of export to perform for agreements that have multiple saved versions in the system. Options are:
 - Standard Export the default version of selected versioned resources.
 - Advanced Enables you to choose, through wizard selections, whether to export only default versions or all versions of selected resources.
- 6. Select the types of resources you want to export and click **Next**.
- 7. On the Agreement selection page, complete the following tasks:
 - Select the appropriate resource(s) from the Available box.

- If you selected Advanced export option and you want to export all versions of each resource you select on this page, select **Export All Versions**, located below the Available pane (this option does not display if you selected the Standard export option).
- Click Next.

If you selected Standard export option, the system automatically exports only the default version of the resources you select here.

- 8. Click **Finish** to create the export file.
- 9. When the message, *The system update completed successfully* is displayed:
 - Click **View Export Report** to see status information to confirm the export of each resource associated with the selected resource tag, if desired.
 - Click **Download Export data** to download the export file to a hard drive or disk where you will store it.
- 10. In the File Download dialog box, click **Save**.
- 11. In the Save As dialog box, select the location to which to save the file, and click **Save**.

Importing an Agreement

When you import resources, the process converts an XML file or installable bundle into the resources format. The import process replaces non-versioned resources with the new data and appends new versions of a resource to existing versioned resources, although you can choose whether to overwrite existing data as part of the import process selections.

During import, the application creates a backup .xml file of resources as they existed prior to import. This enables you to overwrite existing data without fear of losing the data permanently. Using the backup file, you can import the old data back into the application, if needed.

To import resources:

- 1. From the Administration menu, select Deployment > Resource Manager > Import/Export.
- 2. On the Import/Export page, next to **Import Resources**, click **Go!**
- 3. Type the path and name of the file to import, or use **Browse** to locate and select it, and click **Next**. If the import returns a message that the file contains errors, you can either select the file and click **Next** again to continue the import, or click **Cancel** to stop the import process.
- 4. Do you want to create a resource tag for the data being imported?
 - If Yes, type a name and description for the new resource tag and click **Next**.
 - If No, click **Next**.
- 5. Indicate whether you want to update objects that may already exist in the application with objects from the import, and click **Next**.
 - For each type of resource included in the import file, the wizard displays a corresponding resource selection page.
- 6. From the Agreement selection page, select the agreement or agreements to import and click **Next**.

Note: Agreements may require you to type the passphrase (the password you use to log in to the application) before completing the import.

- 7. To update the application with the imported data, click **Finish**.
 - This process may take several minutes, depending on the volume of resources being imported.
- 8. When the message, *The system update completed successfully* is displayed, click **View Import Report** to see the import report.
- 9. Does the option to download data that failed to import display?
 - If Yes, errors occurred during import. To view the XML file containing the names of objects that did not import, click **Download** next to **Data which failed to Import**.
 - If No, proceed to the next step.
- 10. Do you want to create a backup file containing the related resource data as it existed prior to your import procedure?

Note: We recommend that you create the backup file.

- If Yes, next to **Data in SI before Import**, click **Download**.
- If No, the import is complete. Skip the next step.

Caution: Completing this step is very important. If you do not download the backup file to a hard drive or disk, you will lose your record of the data as it existed prior to import.

11. In the Save As dialog box, change the default filename from backup.xml to a unique, meaningful name for this backup, and then click **Save**.

Using the Integrated Archive

Sterling e-Invoicing enables you to send a signed or an unsigned electronic invoice to your trading partners, and enables your trading partners to send the invoice to TrustWeaver to sign (if the invoice is not signed already), or to validate (if the invoice is signed). The signed and validated invoice is archived for future auditing by your company and tax auditors. This archiving can be performed using an internal database or an external database. If you wish to store the archive in your own database then you need to choose external archive.

The Integrated Archive is an invoice archive that stores signed and validated invoices for up to eleven years, including the original signed invoice and supporting auditable details created by TrustWeaver when signing or verifying the electronic signature. The access to this archive is based on permissions you set.

Note: An error is generated if the user is unable to access the Integrated Archive (for example, if your user account does not have required permissions such as EINV_VIEW_INVOICE (permission to view the invoice data), EINV_DOWNLOAD_INVOICE (permission to download the invoice data), or INV_REVALIDATE_INVOICE (permission to re-validate the invoice).

The Integrated Archive is not stored in the existing application database--all the invoice data is stored in a separate database. If you handle e-Invoicing on behalf of your trading partners, the Integrated Archive may contain invoices for many distinct legal entities.

Caution: Under no circumstances should you ever directly delete or update rows in your production integrated archive database.

In the online Integrated Archive and reports, the date format, time format, and decimal separators used are taken from the einvoicing properties file. See *einvoicing properties* on page 44 for more information on this properties file.

The Integrated Archive specifies if the invoice is archived from the buyer or supplier. If a user only has the buyer permission associated with his or her user account, he or she cannot access (even to view) the supplier side invoices, and vice versa. If a user has buyer and supplier permissions, the user can view all the invoices.

Sterling e-Invoicing automatically timestamps invoices, individually or in batches, based on a per-invoice expiration of the time period and parameters you specify in the agreement with that trading partner. Additionally, invoices that are signed and archived where the supplier or buyer country code is IT (Italy) must be timestamped by an accredited Italian timestamping authority.

Sterling e-Invoicing Integrated Archive feature offers the following benefits:

- ♦ You can search the archive for specific invoices.
- ◆ You can re-validate invoices or download the re-validation report.

Note: Invoice re-validation invokes TrustWeaver.

- ♦ View a human readable representation (canonical format) of the invoice, including mandatory business data fields required by EU115.
- ◆ View and download the original signed invoice data, including timestamp information.
- ♦ You can view audit entries for invoices.

Note: The audit trail is a log of every action a user performed on the invoice.

◆ You can view summary reports for the archived invoices.

Once an invoice on the buyer side has been validated, it must legally be archived. Therefore, the eInvoice Archive service supports archival when the key information generated by Sterling e-Invoicing (buyer VAT, supplier VAT, invoice number, invoice date) is missing or duplicated. If an invoice being archived has a key that matches an existing entry, the invoice report, summary report, and search page are populated with a Global Usage Identifier. Otherwise, it is populated with the string "0" (zero). And, if the key fields are missing, they will be populated as indicated in the table below.

In the Integrated Archive reports, a single asterisk (*) indicates a Missing or Invalid value (for the VAT IDs, the asterisk is followed by the VAT from the agreement), and a double asterisk (**) indicates a duplicate invoice. If the invoice number is missing and it is also a duplicate, the report will display a single asterisk, some whitespace, and then two asterisks.

In addition, for the invoice report, if an invoice is rejected because it is a duplicate or it contains missing or invalid data, then the word **REJECTED** appears at the top of the report.

- 3. Locate the invoice number that you want to re-validate and select the checkbox next to it. You can select multiple invoices or select all displayed invoices using the **Select All** checkbox.

Using an e-Invoice External or Custom Archive

Overview

Through the eInvoice Archive service, Sterling e-Invoicing supports the use of an external third party to archive e-Invoices by providing sufficient invoice data and details for the third party to use to construct the archive. This eInvoice Archive service generates the required jar contents and sets the binary stream as a primary document that can be used by a business process to write the jar file to a specific folder.

Note: The external entity (third party) hosting the external archive is responsible for any country-specific requirements, storing the data, and enabling tax auditors to review it in the future.

This allows you to leverage the TrustWeaver user interface or construct your own customized solution to archive e-Invoices. You may want to use an external archive or customized solution if, for example, you are signing or verifying invoices on behalf of a trading partner but not archiving on their behalf.

The archiving performed by Sterling e-Invoicing can use an internal database or an external database. If you wish to store the archive in your own database then you need to choose external archive.

The external jar file that Sterling e-Invoicing creates will contain the following entries:

You can use the Import functionality to import external archives created by your trading partners and review the archive import report.

Using an External or Custom Archive

To create a jar file containing the appropriate information for use by an external entity to create an e-Invoice archive (either using the TrustWeaver user interface or your own customized solution):

1. Specify field settings for the eInvoice Archive service configuration in the Graphic Process Modeler (GPM) as necessary, including the following (see the *eInvoice Archive Service* documentation for more information):

- Type of archive (Integrated/External/Custom)
- Mode (Store/Audit/Timestamp)

Note: Only Store mode is applicable for external archive, since the storage of audited and timestamped information is the responsibility of the application that maintains the archive.

- 2. Create a business process to supply the appropriate parameters to the service, including the following (see the *eInvoice Archive Service* documentation for more information):
 - Whether the archive is created by the buyer or supplier.
 - Whether the e-Invoices are signed or validated.
 - The archived document (RAW format).
 - Detail information about the archived e-Invoice.
 - The e-Invoice in canonical format.
 - Buyer or Supplier Globally Unique Identifiers (GUIDs) for the archive document and detailed information.
 - Whether the e-Invoice must be reprocessed from a jar file.
- 3. Name the business process according to the name supplied as a property in **einvoicing.properties** file (located in the **install_dir/properties** directory).
- 4. When you create the agreement you must supply the name of this business process in the **Business Process for Supplier Custom Archive (if applicable)** or **Business Process for Buyer Custom Archive (if applicable)** parameter. See Creating an e-Invoice Agreement for more information.

Importing an External Archive

If you have a hosted environment in which one side is running an application instance that creates an external archive file and other side is running the application and consuming this file (acting as an external archive), the consuming application can import the invoice information (if available) in the file into its archive database.

To import the archive information, you must create a business process that picks up the external archive file and passes it on to the eInvoice Archive service.

einvoicing.properties

Overview

Property files contain properties that control the operation of Sterling e-Invoicing. By modifying the settings of these properties, you can customize Sterling e-Invoicing, if necessary, to suit your business needs. Property files are located in the install_dir/properties directory and are usually named in the following manner: filename.properties. Some files have other suffixes including .xml, .xsl, .cfg, and .ini. Substitute the appropriate suffix for properties when needed in the instructions provided.

Caution: Since property files directly affect the operation of Sterling e-Invoicing, please ensure that you fully understand the impact of property file changes. When changing configuration files, be sure that you have a complete backup of your system and have fully tested the changes in a test or development environment before moving the changes into production. For more information about working with any property file or property, please contact Sterling Commerce Customer Support.

Leading or trailing whitespace in property files will be respected by Sterling e-Invoicing. This may cause a problem if the system is not expecting whitespace. When editing property files, be careful to trim leading and trailing whitespace before saving each file.

Overriding or Editing Property File Settings

Sterling e-Invoicing supports the use of a customer override (edit) property file to override default property settings in the property files. The customer override property file is not changed during installation of Sterling e-Invoicing or application upgrades or patches. To prevent having your customized settings overwritten, use overrides whenever possible rather than editing the einvoicing properties property file.

If you have made changes to the property file, either directly or by editing the associated .in files in a previous Sterling e-Invoicing version, your changes may be overwritten when a patch is applied. To prevent this, create a customer_overrides.properties file and reapply your modifications using overrides to the applicable property files in the customer_overrides.properties file.

For example, if you want to change the default date format in the einvoicing.properties to MM-dd-yyyy, you need to add the following line to the customer_overrides.properties file (and then this value can be overridden by setting the size directly in the envelope):

eInvoicing.IntegratedArchive.ui.dateformat.pattern=MM-dd-yyyy

In this example, **eInvoicing** represents the einvoicing.properties file, **IntegratedArchive.ui** represents the Integrated Archive user interface, **dateformat** represents the default global date format used in Sterling e-Invoicing, and **pattern** the actual default format (MM is the two-digit month, dd is the two-digit day, and yyyy is the four-digit year).

Properties in the einvoicing.properties File

The einvoicing.properties file is used to set global configuration parameters for Sterling e-Invoicing. These parameters include all the default settings for the Integrated Archive user interface as well as default settings for the e-Invoice services.

Note: This file should not be edited. Override property settings, if needed, using the customer_overrides.properties file. For detailed instructions on overriding property file settings, see the documentation for the customer_overrides.properties file.
