### **IBM Sterling Control Center**

Sterling Control Center is a system management solution for managing file transfer activity across multiple instances of IBM® Sterling Connect:Direct®, IBM Sterling Connect:Enterprise®, and/or IBM Sterling B2B Integrator.

Sterling Control Center can monitor several servers running different products and platforms. You can also monitor Sterling B2B Integrator using Sterling Control Center.

Sterling Control Center provides centralized monitoring, management for improved quality of service, and better compliance with service level agreements (SLAs).

Sterling Control Center provides enterprise-wide monitoring and management of IBM solutions, including:

- Monitoring of data transfer activities, adapter status, and perimeter server status
- Environment information such as operating system, database type, JDK, and license information
- Alert and event notification, including business process or file transfer failure
- · Centralized auditing and reporting
- · Centralized administration and configuration
- Monitoring quality of service using service level criteria (SLC)
- · License management

The benefits of using Sterling Control Center include:

- Lower operating costs by preventing downstream process interruptions and SLA penalties
- Detection of minor processing exceptions to prevent business problems
- Improved service levels and business relationships by ensuring critical processing windows are met
- Elevation of alerts to ESM tools such as Tivoli, HP OpenView, and BMC Patrol
- Optimized processing across the network
- Reports generated from consolidated log data

### **Sterling Control Center Components**


Sterling Control Center is a Java-based application that consists of three components:

- An engine that is installed on a network computer. This engine includes the modules that create and define rules, actions, SLCs, and Sterling Control Center configuration information.
- A relational database that stores statistics information from managed Sterling Connect:Enterprise, Sterling Connect:Direct, and Sterling B2B Integrator servers. This information is used by Sterling Control Center for server monitoring.Sterling Control Center supports MySQL, IBM DB2<sup>®</sup>, Oracle<sup>®</sup>, and Microsoft SQL Server<sup>™</sup> databases.

A graphical user interface (GUI) that can be installed on the same computer
where the engine is installed, or on a remote computer. The GUI visually shows
processing activity and enables you to perform Sterling Control Center
administration activities.

The engine and GUI can be installed on computers with different operating systems. See *Sterling Control Center Release Notes* for system requirements.

## Enable Sterling B2B Integrator for Monitoring by Sterling Control Center

#### About this task

An instance of the Sterling Control Center service is enabled by default when you install Sterling B2B Integrator. You must configure Web services to use this service.

**Note:** If you are running Sterling B2B Integrator in a vertical cluster environment, you can configure only one Web service. However, if you are running Sterling B2B Integrator in a horizontal cluster environment, you can configure one Web service for each available IP address.

**Note:** If you are using a cluster, a new SOA HTTP server adapter is required for each node beyond node 1. Copy the SOA HTTP server adapter assigned to node 1 and update the perimeter server name to match the node number.

To enable monitoring of Sterling B2B Integrator by Sterling Control Center:

#### **Procedure**

- From the Administration menu, select Deployment > Web Services > Manager.
- 2. In the Web Services Management page, under Create, next to Create a Web Service Configuration, click Go!
- 3. In the Web Service: Name page that is displayed, enter SCCInteropService as the name and enter a description that will help you identify the version of the Web service.
- 4. Click Next.
- 5. In the SOAP Transport Binding Settings page that is displayed, click Next.
- 6. In the Request Security Settings page that is displayed, click Next.
- 7. In the Response Security Settings page that is displayed, click Next.
- 8. In the Assign any Business Processes page that is displayed, click Next.
- 9. In the Assign Service Instances page that is displayed, select **Sterling Control Center Service**. Move the service instance to the **Selected** tab by clicking on the right arrow button that is displayed.
- 10. Click Next.
- 11. In the Assign Consumers page that is displayed, select the users to monitor Sterling B2B Integrator from Sterling Control Center. Move the selected users to the Selected tab by clicking on the right arrow button that is displayed.
- 12. Click Next.
- 13. In the Reliability Settings page that is displayed, select the required checkbox. (optional)
- 14. Click Next.
- 15. In the WS-I Basic profile 1.1 Conformance Settings page that is displayed, select the required checkbox. (optional)
- 16. Click Next.
- 17. In the Attachment Settings that is displayed, select the checkbox next to **Output Attachment**.
- 18. Click Next.
- 19. In the Confirm page that is displayed, review the settings, and click Finish.

20. Remember your Web service base URL, Sterling B2B Integrator user ID, and password. These must be entered into Sterling Control Center during configuration. Additionally, remember the Sterling B2B Integrator port number. You will need to specify it in Sterling Control Center.

#### **Results**

Sterling B2B Integrator is now ready for monitoring by Sterling Control Center.
