### Mass File Replay has been updated

Beginning in V2.2.5, the selected files are replayed and added to the list of arrived files, with a special icon to indicate it is a replay. In V2.2.6 or later, the original file is also updated with a different icon to indicate it failed and needed to be replayed. The file details of the original file contains a link to the replayed file.
