**Defect ID** 311944 **Case ID** 90048,999,000

**Description** When the ETL is run from OLTP to Staging and Staging to Datamart in a

sequential manner within the 15 minutes time interval, the data is not

fetched into the Datamart.

**Solution:** A new Offset parameter is provided. The Offset parameter

position depends on the target being run.

To introduce explicit offset value for ALL\_Incremental, the Offset parameter must be passed as a fifth argument (for example, load\_mngmt.cmd/sh as 1st, target as 2nd, package name as 3rd, and intervalInHours as 4th), a user must run the command in the following format:

<Command><target(ALL\_Incremental)><Incremental.pkg>
<IntervalInHours><offset Value>.

To introduce explicit offset value for Incremental\_Load, the Offset parameter must be passed as a sixth argument (for example, load\_mngmt.cmd/sh as 1st, target as 2nd, package name as 3rd, tablename as 4th, and intervalInHours as 5th), a user must run the command in the

following format:

<Command><target(Incremental\_Load)><Incremental.pkg>
<Table name><IntervalInHours><offset Value>.

**Note:** If a parameter is not passed the offsetdefault value is passed as 900 seconds by default. However, to pass the offset parameter it is mandatory to pass the 'Interval in Hours' parameter.

**Defect ID** 314557 **Case ID** 90039,999,000

#### Description

If the ETL runs successfully, but the data is loaded partially from the OLTP database to staging database, an option to re-run the ETL must be provided for certain period of time.

Solution: The UserStartTime and UserEndTime parameters has been provided. The user must include the parameters and run the ETL again to recover the data loss for the given period of time.

To introduce explicit Start and End time value for ALL Incremental, the UserStartTime and UserEndTime parameters must be passed as sixth and seventh argument respectively (for example, load mngmt.cmd/sh as 1st, target as 2nd, package name as 3rd, intervalInHours as 4th, and offset as 5th), a user must run the command in the following format:

<Command><target(ALL Incremental)><Incremental.pkg><IntervalInHours> <offset Value><User Start Time><User End Time>.

To introduce explicit Start and End time value for Incremental Load, the UserStartTime and UserEndTime parameters must be passed as seventh and eighth argument respectively (for example, load mngmt.cmd/sh as 1st, target as 2nd, package name as 3rd, intervalInHours as 4th, Table Name as 5th, and offset as 6th), a user must run the command in the following format:

<Load\_managment\_command><target(Incremental\_Load)><Incremental.pkg> <Table name><IntervalInHours><offset Value><User Start Time><User End Time>.

Note: If the parameters are not passed, the SBI\_Incremental\_history table does not get updated. The User Start and End Time stamp format should be 'YYYY-MM-DD HH24:MI:SS'. While running the .cmd double quotes (" ") must be used and while running .sh single quote (') must be used.

Description If the ETL run fails when loading the data from the OLTP database to

staging database, same data is extracted while triggering ETL for

processing the next batch of data.

Defect ID 311063 Case ID Internal

Description The filter criteria updated to the entity XML does not get applied to the

ETL SQL query that is fired on the database, and therefore, the filter

criteria does not get added to the appropriate place.

inserted into the YFS\_ORDER\_TS\_TAG table.

#### Hot Fix 7

**Defect ID** 250693 **Case ID** 00332284

**Description** The staging incremental ETL throws an "ORA-01555" error and hangs

when attempting to load huge number of records.

**Solution:** The time span of transaction job stream from last run to current timestamp is divided into multiple segment using time as parameter to prevent loading all the data at once. Multiple transaction jobs will be invoked in sequence with each segment of time interval.

A new parameter '<interval in hours>' has been exposed to enable a user to load data in the sequence.

Also, in the *Sterling Business Intelligence: Implementation Guide*, the command to load the incremental data for Windows and Linux or UNIX, must be read as follows:

For Windows;

staging\_load\_management.cmd ALL\_Incremental
<incremental load package file path> <interval in hours>

For Linux or UNIX;

staging\_load\_management.sh ALL\_Incremental

<incremental\_load\_package\_file path> <interval in hours>

**Note:** By default the <interval in hours> value will be 1 if not specified.

Defect ID 248540, 243025 Case ID Internal

Description When a user attempts to move a large number of records, the incremental load becomes slow.

> Solution: A filter has been provided at the data stream to reduce the record insertion.

**Defect ID** 249231 Case ID 00325452 Description

The system must allow the incremental load to be run on the master tables using MODIFYTS as the CDC (Changed Data Capture) filter.

Solution: A user must enable the CDC based on the incremental load to run the master table, by performing the following actions:

- 1. Create the sbi staging entities.xml file, if it does not already exist, in the <INSTALL DIR> /extensions/global/template/metadata directory.
- 2. Create a structure of the existing entity. For example, create a structure as follows:

<DBSchema> <Entities>

<Entity TableName="YFS ITEM" DriverEntity="">

<Entity> </Entities> </DBSchema>

3. Deploy the customization.

- 4. Regenerate the package file for incremental load.
- 5. Load the incremental data for a specific master table by running the following command:

staging\_load\_management.cmd Incremental\_Load Staging\_Incremental\_Load\_Package.pkg <Table Name>

Note: CDC for master table is assumed to be based on modified time stamp field.

**Description** The Sterling Business Intelligence: Implementation Guide must be updated

with the information about how to override the default filters provided in

the out-of-the-box sbi\_staging\_entities.xml.

Defect ID 185328 Case ID Internal

**Description** When a CDC filter is applied on a Fact and if the Load Management is

executed, the To Value of the CDC filter in the user interface of the Load

Management is set to the end of the previous run of the Load Management, and not the current time. Because of this, the Load

Management does not extract any records.

The Load Management functions correctly only if the To Value is manually

updated.

**Defect ID** 196670 Case ID Internal

Description The scripts generated from the AW Studio Framework cannot be reused,

because the "To" date in the scripts for the CDC filter is not being updated to the current date after the script is run. Therefore, the consecutive ETL runs from the same scripts will fail to pull the data created in the source

after the first ETL run.

This happens only in the AW runtime, and not in the Load Management in

the AA Studio Framework.

200705 Defect ID Case ID Internal

Description A user is unable to create an AA project on an Oracle 11g database.

**Defect ID** 202357 Case ID Internal

Description The application incorrectly inserts the change records of an enterprise into

the YFS\_ORDER\_TS\_TAG table of the DEFAULT colony instead of the

respective colony of the enterprise.

Defect ID 202421 Case ID Internal

Description The SO Modification Fact table contains several records with the blank

modification type code.

Solution: In the Order Entry Rules Configuration of the 'Channel Applications Manager' the "Tax Options" screen has been enhanced to

configure Tax Options for consumer customer also.

**Defect ID** 202749 Case ID Internal

Description When multiple colonies are configured in a multi-schema environment, the

records in the YFS\_ORDER\_AUDIT\_LEVEL table for some of the colonies is not being loaded into the staging database. Because of this, the SO Modification Fact does not contain the data for these colonies.

Solution: The YFS\_ORDER\_AUDIT query subject and the YFS\_ORDER\_TS\_TAG query subject are created inside the

YFS\_ORDER\_AUDIT\_LEVEL namespace such that duplicate relationships will not be created. The same modifications have been performed for the

YFS\_ORDER\_HOLD\_TYPE\_LOG.
