Chapter 2. Sterling Call Center and Sterling Store

Shared tasks

This section explains the various shared tasks that are registered with Sterling Call Center and Sterling Store.

For more information about shared tasks, see the section 6.4 Shared Tasks in the Sterling Call Center and Sterling Store Implementation Guide..

Add/Modify Service Option pop-up as a shared task

Sterling Call Center and Sterling Store provides the Add/Modify Service Option pop-up as a shared task. The shared task is used to open the Add/Modify Service Option screen as a pop-up window in any user interface that references Sterling Call Center and Sterling Store.

The shared task can be used in three modes. The following list provides details of the modes:

- ORDER_LINE_NO_ORDER use this mode for orderline that is not saved on order. The OrderLineOptions element in the input to the shared task must contain all the OrderLineOptions that are applicable for that orderline.
- ORDER_LINE use this mode for orderline that is saved on order. The OrderLineOptions element in the input to shared task must contain only the OrderLineOptions that are already selected and saved for that orderline.
- EDIT use this mode for orderline that is saved on order and have an associated work order. OrderLineOptions must contain only the OrderLineOption that are already selected and saved for that orderline. This mode additionally invokes the changeOrder API to save options on that order line. It is required to pass the WorkOrder details in the input to the shared task.

Note: It is recommended to use "ORDER_LINE" when used in the Order Modification flows for saved order lines.
