Drop Ship Option Pack - Known Issues

Following are the known issues when using Drop Ship Option Pack:

192636 - The Seller's Order Management system does not handle documents that are received out of sequence

For example, if an Advance Shipment Notice (ASN) for a Purchase Order (PO) is received before the acknowledgement, the information pertaining to the acknowledgement might not get updated in the PO as required.

Solution/Workaround - None.

196262 - When a Seller reships a sales order line, a Change PO is created along with the new order line

This Change PO is not reflected correctly in IBM® Sterling Supply Chain Visibility. The new order line overrides the earlier order line in the PO, and the status of the order line does not change to Created in Sterling Supply Chain Visibility.

Solution/Workaround - None.
