Description	Security fixes are implemented in Sterling Web (SWC) Fix Pack 2. A separate security fix pack (SWC91SHF1-Drop1) is also available. Refer to <i>SWC_Fix_Pack_Installation.txt</i> before you proceed with installation of SWC Fix Pack 2. <b>Note:</b> As part of the security fixes, the Apache Struts version that is used in the application is upgraded. The impact of this upgrade on customizations must be assessed. Remediation might be required before rolling out SWC Fix Pack 2 into production. For more information on the security issues fix, contact IBM Support.						
	The following known issues are observed due to the SWC Fix Pack 2:						
	• Advanced Search cannot be performed. Instead users can use the search box on the header to search items.						
	• The <b>Create New Cart</b> button in the Cart Management screen does not work as expected. Instead users can use the <b>Minicart</b> option to create a new cart.						
	<ul> <li>On the Item detail screen, the Add to Cart and Check Availability functionality are not available. Instead users can use the Catalog browsing screen to add items to cart.</li> </ul>						
	Customers can use SWC Fix Pack 2 to analyze the impact of change in Struts libraries. A new security fix pack is planned to be released shortly to include the updated version of Struts libraries. The known issues will be addressed in future fix packs.
