## **New Features**

There are no new features introduced in IBM® Sterling Web, Release 9.1.

## Known Issues

This section describes the known issues that you may encounter when using Sterling Web:

### IBM Sterling Web Related Issues

**208066:** When the user selects a price range in the Catalog List screen, a bundle item which qualifies in the price range is not displayed.

**Solution/Workaround:** None.

**212910:** User locale is not considered while displaying the dates in Sterling Web.

**Solution/Workaround:** None.

**213609:** User will not be able to login to Sterling Web when the cookies are turned off and the application server is jboss.

**Solution/Workaround:** None.

**215961:** In the variation tab of Product Details screen, the user is not provided with an option to choose “None”, when there is no value assigned for an attribute of type “Item with variation”.

**Solution/Workaround:** None.

**216036:** In the Catalog list screen, user cannot navigate to item detail page if the Item ID contains an ampersand (&).

**Solution/Workaround:** Avoid using ampersand (&) in the Item ID .

**217664:** Sterling Web throws `OutOfMemoryError` exception when heap size is 1GB.

**Solution/Workaround:** Increase the heap size to 2GB and above.

**234386:** When user tries to commit any changes by selecting the same button more than once, then “lock timeout detected” error is thrown.

**Solution/Workaround:** Do not click the button more than once.

**235920:** User login fails for the first time when the permissions to catalog browsing screen is revoked.

**Solution/Workaround:** Try logging in again.

**237657:** Approver user is not sent an e-mail when an order is awaiting for his approval and is put on hold.

**Solution/Workaround:** None.

**238124:** In the Catalog List screen, if the image name of a product contains a double quote, and when the image is not available in the image server then the image name is not displayed completely.

**Solution/Workaround:** None.

**238205:** In Product Details screen, when user takes a print-out of a configurable bundle product, the price of the bundle product does not consider the price of the components. This happens when the Bundle Pricing Strategy is either “Both Parent and Components” or “Components Only”.

**Solution/Workaround:** None.

**239111:**When a user tries to select tab button multiple times in any light box, the focus of the cursor is taken to the base screen. This should not happen. The same behavior not visible when the mouse is used.

**Solution/Workaround:** None.

**239374:** Product Configurator displays expired products as one of the options, when user tries to configure a bundle product.

**Solution/Workaround:** None.
