1. Configures a sometimes tag-controlled item with Lot Number as Tag Identifier.
2. Adjusts inventory for the item in pack location.
3. Creates a shipment for the item.
4. Logs in to the Sterling Mobile application.
5. Selects the "Pack Shipment" activity from the menu.
6. Scans the Shipment Number, Container SCM, and item ID.  
The system prompts the user to scan the Lot number (tag identifier).
7. Presses F3 or Tab key to proceed to next screen without entering the tag information.  
The system throws the Tag Attributes not Found error.
