### Solution Description

The EZswitch on-line ATM/debit solution provides an interface between the financial institution's core system and their selected electronic funds transfer (EFT) network to support on-line authorization of ATM and debit issuer transactions.

The u/SWITCHWARE enterprise transaction processing and management system provides in-house ATM/POS terminal support, an interface to a core financial system and connectivity to regional, national or international networks. The primary purpose of the system is to perform transaction processing and routing decisions. Functions include sending on-us transactions to a primary authorizer, switching foreign transactions to networks, performing PIN validation, standing in when the primary authorizer is unavailable and performing processing decisions according to predetermined financial-institution settings.

### Value Proposition

The main benefit of implementing the EZswitch on-line ATM/debit interface is to eliminate the financial institution's exposure by authorizing transactions against current account balances. Additional benefits include:

- On-line memo posting of ATM and debit card transactions.
- Reduced risk of authorizing ATM and debit transactions against outdated PBF/batch balances.
- Stand-in authorization when the core system is unavailable for authorization.

Some of the main benefits of implementing u/SWITCHWARE are as follows: substantial cost savings by processing the financial institution's own ATM transactions in-house, enabling the financial institution to generate fee income through acquired foreign transactions, autonomy and self determination in self-service functions, bringing selfservice products to market faster and improving customer service.
