### **Business Challenge**

ASDM provides robust visual reporting and review statuses that allow management to track progress and identify bottlenecks. A supplier data delivery portal allows suppliers to clearly understand (in real-time) all data delivery requirements.

The solution supports multidepartment review and approval processes and integrates with various systems and tools to automate data handling. ASDM utilizes supplier requirements templates so that standard requirements by type of contract/program or part can be easily and quickly established.

## Solution

Adaptive Supplier Data Management (ASDM) automates the scheduling, delivery, flow-down and review process associated with technical data submitted by suppliers during the acquisition and disposition of supply parts/assemblies. This enables a single

The system is flexible and can be easily modified over time to support evolving process requirements and industry regulations.

ASDM facilitates improved supplier data review and collaboration throughout the contract life cycle. The flow-down of requirements to all sub-contractors enables organizations to enforce supplier conformity for improved quality. The solution also addresses compliance and data security requirements.

ASDM provides clear metrics on supplier conformity; metrics that can be made available to decision makers for risk analysis and supplier performance. In addition, the captured data can be analyzed at various levels to identify the true business impact. As an example, ASDM can relate SDRL and milestone data to supplier conformity delays to predict the impact on specific programs or product lines.
