

- Fast or virtual close together with IPSAS
- Merger and acquisitions
- Higher turnover of key staff
- Greater awareness of stand alone limitations

Managing Structures – Multiple Dimensions


- Pre-defined dimensions

 - –Ownership (when bought, goodwill,...)
 - –Additional details (directors, dates,...)










Financial Consolidation Intelligence – Accounts

 - -Conversions
 - -Reconciliations
 - -Summations
 - –Text (Accounting Manual)











Collecting the Data

 - -Excel, ASCII, Text






- Via Manual Entry

 - -Accounts
 - -Forms
 - –Reporting entities
 - -Consolidation









Consolidation

- Currency conversion
 - -Different conversion methods
 - -Analysis of currency effects
- Support with intercompany reconciliations
 - Automatic intercompany eliminationen at every group level
 - Automatic intercompany profit eliminationen at every group level
- Acquisition calculation
- Deffered tax calculation









Audit Trail

- Audit trail on meta data
 - SOX Act.
 - Time, user, which change
- Audit trail on data
 - System reports for currency conversion, intercompany elimination ...






