Maintenance Renewal Scenarios - RISC and INTEL

iSeries Migration

The number of Capacity Units required to license iSeries servers were based on the 'Processor Group' that a machine fell into. In moving to the per-Processor licensing metric, entitlements must be converted to Processor License Units sufficient to cover the number of processors in the server. The standard entitlement conversion rate of two Capacity Units to one Processor License Unit will apply at Software Maintenance renewal. We expect that for the majority of customers, this ratio of conversion will provide sufficient processor entitlements to cover existing deployments. However additional licenses or entitlements may be required, and can be obtained through the Software Maintenance renewal reconciliation process. You will not be charged for additional entitlements granted in this process, where additional entitlements are required simply due to the migration between licensing models. For Software Maintenance renewals which require additional entitlements due to the change in models, you are eligible for special bid on the Software Maintenance.

Similarly, new purchases of software for iSeries servers are based on the number of processors in the machine, rather than Processor Groups. Where the price for a machine is increased due to the change in licensing models, you are eligible for special bid on the software.

Processor Group	Capacity Units Required
P05	2
P10 / P20	4
P30/P40	8
P50	16
P60	30

Machines in the above Processor Groups could have a range of numbers of processors. However, on average a two Capacity Unit to one Processor License Unit entitlement yields sufficient Processor entitlements to cover existing deployments.
