




Figure 1: IBM Rational Policy Tester executive dashboard

It can be difficult to stay on top of the many ways that your company's privacy policies can be violated: insecure data collection forms, missing privacy statements, cookies and pages populated with personally identifiable information (PII) can all lead to potential violations. IBM Rational Policy Tester Privacy Edition software is used to uncover and report oversights that may expose your organization to undue risk—issues including missing privacy statements, non-compliance pages collecting personally identifiable information, insecure data collection forms, and cookie presence—critical if you need to comply with privacy regulations such as GLBA, HIPAA, COPPA, Safe Harbor, Section 208, and California SB1386 and AB1950.

Reports included in the privacy edition

Rational Policy Tester Privacy Edition software includes data collection reports, privacy statement reports, visitor tracking reports and privacy regulatory compliance-related reports. Within these categories are additional, more detailed subcategories, so you can pinpoint the specific information you need to enforce your company's privacy policies.

- *Form inventory* identifies all pages collecting user input, which can help you identify forms that might be inconsistent with privacy policies or that might lead to information leaks.
- *Pages collecting PII* allow you to identify critical forms that might not have links to your privacy statement, proper levels of encryption or opt-out options.
- *Pages collecting PII using the GET method of form submission* show which pages are using a method with known privacy vulnerabilities.
- *Pages with/without privacy statement links* allow you to identify which pages link to your privacy statement and which pages don't.

- *Cookie inventory* lists first- and third-party cookies to help determine whether their usage aligns with organizational policies.
- *Web beacons inventory* identifies web beacons, including those paired with a third-party cookie.
- *Third-party links inventory* reports links to third-party sites, allowing users to monitor for undesirable or noncompliant links.




Figure 3: IBM Rational Policy Tester Quality Edition software
