



- You can obtain Zune software at http://www.xbox.com/en-US/Live/Partners/Zune
- After Zune software is installed, you can connect your Windows Phone 7.5 handset to your computer.
- Note: You cannot deploy and run an application on a device that is in sleep mode.

- You can register on the Microsoft App Hub at <u>http://create.msdn.com/en-US/</u>
- After you have registered, you must assemble the prerequisites for your application certification by Microsoft and submit your application for review.


