


### What is JSONStore?

- JSONStore is a JavaScript<sup>™</sup> API for data storage and manipulation.
- It provides the following key features:
  - Storage of new and existing data that you can search, update, and delete without network connectivity
  - Ability to pull and push data to your back-end system
  - Encryption for stored data
  - Tooling for you to get started



### **Documents and Collections**


- Collection A named logical grouping of related documents.
- Document JavaScript object with an auto-generated \_id and data in JSON format.
- The figure shows an example with two collections:
  - The Customer Collection stores customers' names.
  - The User Settings Collection stores a background color.
    - In this example, you store one piece of information (name or background) per document, but you might store more.





### Search Fields and Queries

- Search Fields Keys that are indexed, therefore determining what you can query in a collection.
- Query A JavaScript object that contains either \_id or a Search Field as a key.
- Example: On the figure, the search field is the string name. When you query the collection for name equals "carlos", it identifies what document to return.







### Architecture - Get and Store data


- JSONStore requests data from a Worklight® adapter.
- The adapter requests data from the back-end service.
- 3. The back-end service returns data.
- The adapter returns data in JSON format.
- Data is stored inside the device.





# Architecture - Send data back

- JSONStore requests data from the internal storage.
- The internal storage returns JSON documents.
- JSONStore sends those documents to an adapter.
- The Worklight adapter sends data to the backend service.

# JSONStore API

- API only in JavaScript, and mostly asynchronous.
  - You can use it only when you develop IBM Worklight hybrid applications and you must wait for callbacks to get results.
- Options An object that contains onSuccess and onFailure keys.
  - These keys might have functions as values that execute after the operation finishes.



### Initialization of the local store

12

```
initCollection (name, searchFields, [options]) JSONStoreInstance static
```

- The initialization process creates an object to interact with a single collection.
- A local store is created if one does not exist.
  - The store acts as a repository for all collections that are created within an app.
- You can optionally link collections to an adapter, and then use it to push data by invoking its procedures, depending on the local modifications that are performed.



# Handling data locally

- When your local store is initialized, you can start handling the data by using the JSONStore API.
- You can perform many functions on the local data, including:
  - Add
  - Remove
  - Count
  - Replace
  - Find
  - Store

```
add (data, [options] ) OnSuccess
remove (doc, [options] ) OnSuccess
count ([options] ) OnSuccess
replace (doc, [options] ) OnSuccess
find (query, [options] ) OnSuccess
store (data, [options] ) OnSuccess
```



# Securing the local store

```
usePassword (pwd) Boolean static
```

- The JSONStore API also simplifies the encryption of your entire local data store.
- To encrypt your data store, specify a password by using the usePassword method.
  - This method sets the password that is used to generate the keys that are required to encrypt the data that is stored locally on the device.
- Notice: The store is always encrypted.



# Pushing and pulling changes

```
push ([options]) OnSuccess
pushSelected (doc,[options])
load ([options]) OnSuccess
```

- If your application is connected to a back-end system via an adapter, then you can use the data push function that is included in JSONStore.
- With the API, you can:
  - Push all or selected documents to the back-end system
  - Load data from the back-end system into the local store initially, or refresh the local copy from the server
- Local collection data is pushed or loaded by using an IBM Worklight adapter.



# Comparing JSONStore and Worklight Encrypted Cache

	JSONStore	Encrypted Cache
Storage mechanism	File based storage	HTML5 Local Storage
Mobile OS supported	iOS, Android	iOS, Android, BlackBerry, and Windows Phone
Encryption support	Password or key based. AES256 and PBKDF2	Password or key based. AES256 and PBKDF2
Access/Sync	Rich JavaScript API to search, store, and update locally with synchronization with the server	JavaScript API for storing key value pairs



# Comparing JSONStore and Worklight Encrypted Cache

- If you are developing IBM Worklight hybrid apps that target iOS and Android, consider working with JSONStore instead of Encrypted Cache.
  - The key reason for this statement is Apple's position that HTML5 local storage is not guaranteed to be persistent on future iOS versions.
- JSONStore uses the same encryption form and security mechanisms (PBKDF2 for key derivation from user password and AES 256) as current Encrypted Cache.
