

Phase 1: Testing in your browser

 With the Worklight® Console, you can preview the BlackBerry 10 application in a web browser.



- Your BlackBerry app resources are previewed in the browser, and you can then debug the application by using the tools that the browser offers.
 - For example: Firebug, Developer toolbar, or Console.



Phase 2: Testing on BlackBerry Ripple (1 of 2)

- To test your application on BlackBerry Ripple, select the required environment from the Worklight console, as in phase 1, to open your application with the Worklight MBS (Mobile Browser Simulator).
- Then, click the Open Simple Preview at the top.





Phase 2: Testing on BlackBerry Ripple (2 of 2)

 As a second step, click the Ripple extension icon on the upper right of your browser, and then click – enable. The current URL opens inside Ripple.





Phase 3: Testing on the BlackBerry simulator and handset

- Use BlackBerry Ripple to package (and optionally to sign) your application.
- Load your application to a BlackBerry simulator or handset.
