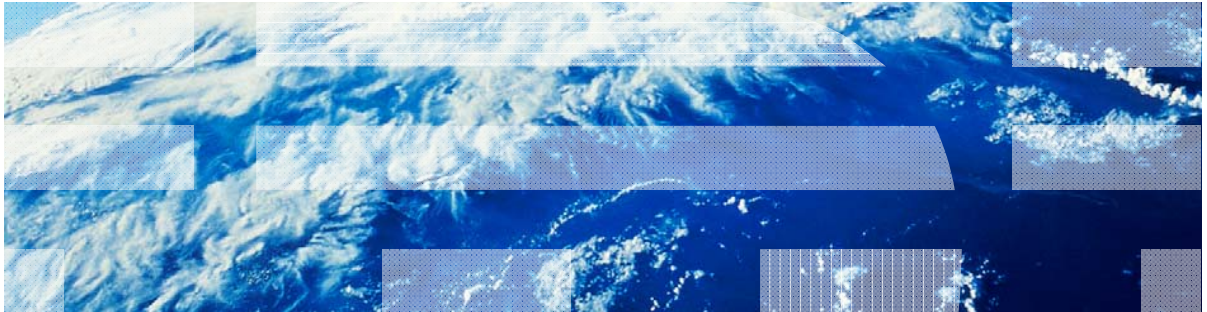

## Overview

- IBM® Tivoli® Directory Server is an enterprise directory for corporate intranets and the Internet.
- In this module, you learn how to integrate Tivoli Directory Server with IBM Mobile Application Platform Pattern on IBM PureApplication™ System.
- Specifically, you learn:
  - How to configure Tivoli Directory Server in IBM Worklight® Studio, and deploy onto PureApplication System.
  - How to configure Tivoli Directory Server in the PureApplication System console.

## Prerequisites

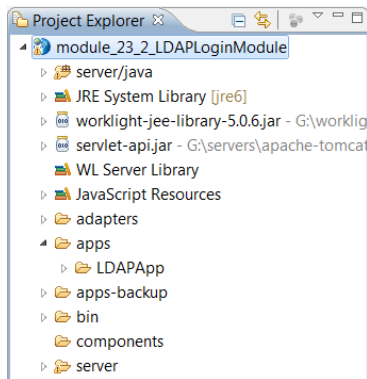
- Before you start, make sure that you have IBM Worklight® installed.
- To practice configuration in Worklight Studio, make sure that your application is tested in a local environment
  - In particular, make sure that the LDAP login module is tested.
- To practice configuration in the PureApplication System console, make sure that you have an IBM Mobile Application Platform Pattern on the PureApplication System server.
- This module uses the same sample as the module *Custom Authenticator and Login Module*, in the **Authentication and Security** category.
  - Optionally, download and import this sample to start with.

## Prepare the IBM Worklight project

- Make sure that you have a Worklight project with an LDAP login module.
- Test and make sure that this project works in a local environment.



## Update the authenticationConfig.xml file

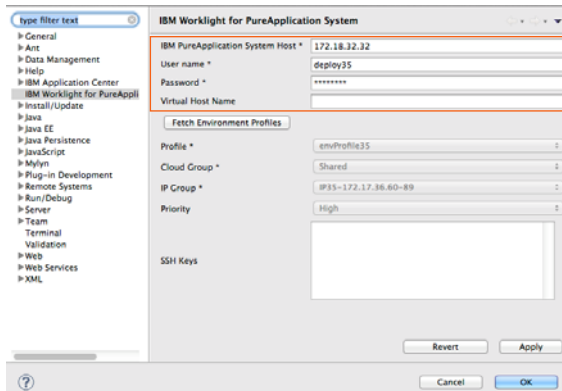
- Open the **authenticationConfig.xml** file that is under **server/conf**.
- Copy the LDAP login module in this file, and change its name to **LDAPLoginModuleIPAS**.
- To integrate with an existing Tivoli Directory Server, make sure that the **ldapProviderUrl** parameter exists, and that its value refers to this Tivoli Directory Server.

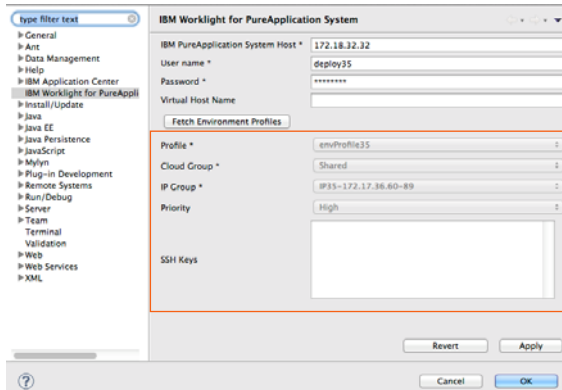
## Set the PureApplication System Preferences (1 of 2)

- Open the **Preferences** window.
- In the Preferences window:
  - Select **IBM Worklight for PureApplication System**.
  - Enter the login credentials of the PureApplication System server.
  - Click **Fetch Environment Profiles**.



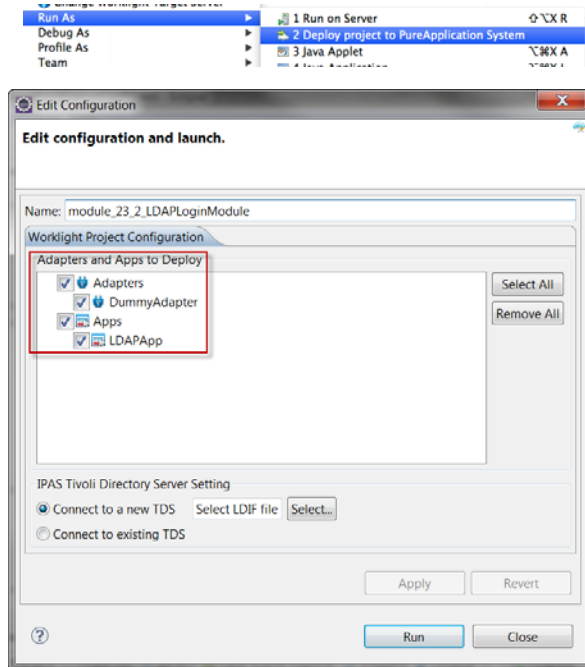
## Set the PureApplication System Preferences (2 of 2)

4. Configure the runtime profile.
5. Click **OK** to terminate.



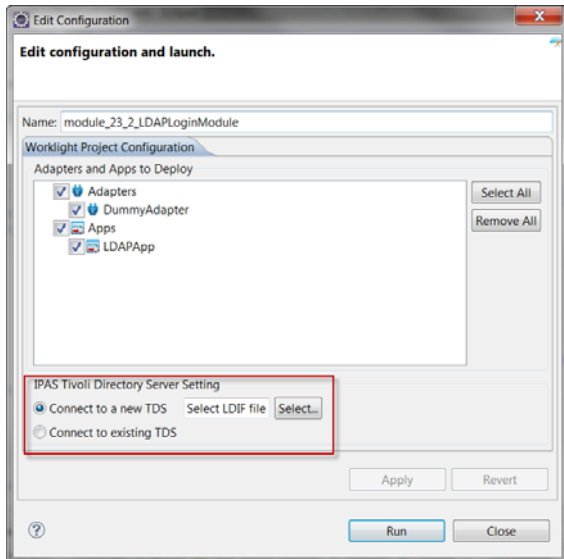
## Deploy to PureApplication System (1 of 2)

1. Right-click the project, and select **Run As > Deploy project to PureApplication System**.
2. In the dialog, select the adapters and the applications to deploy.



## Deploy to PureApplication System (2 of 2)

3. Select whether to connect to a new or an existing Tivoli Directory Server:
  - If you select **Connect to a new TDS**, you must specify an LDIF file.
  - If you select **Connect to existing TDS**, the value of the **ldapProviderUrl** parameter in the authenticationConfig.xml file gives the Tivoli Directory Server address.
4. Click **Run**.
  - The project is deployed onto PureApplication System.

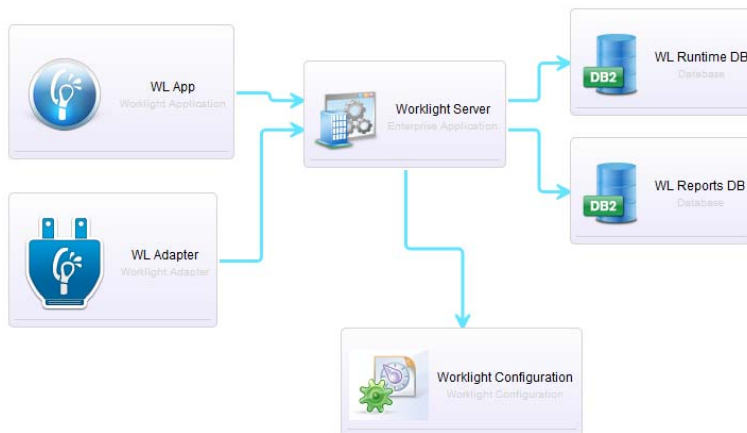

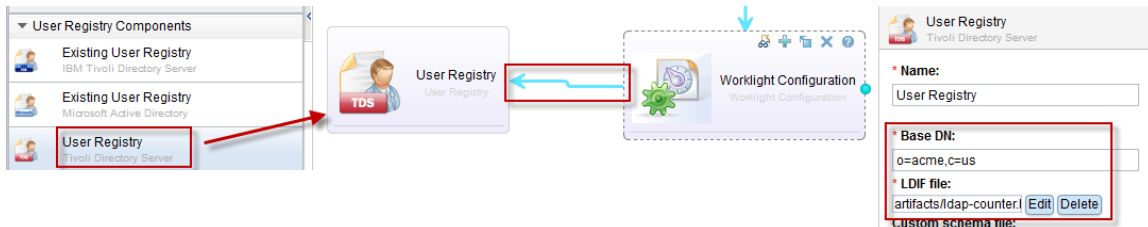
## Pattern Configuration

- Open the Worklight Virtual Application Pattern (VAP) on PureApplication System.
- The Worklight VAP looks like as it is shown here:



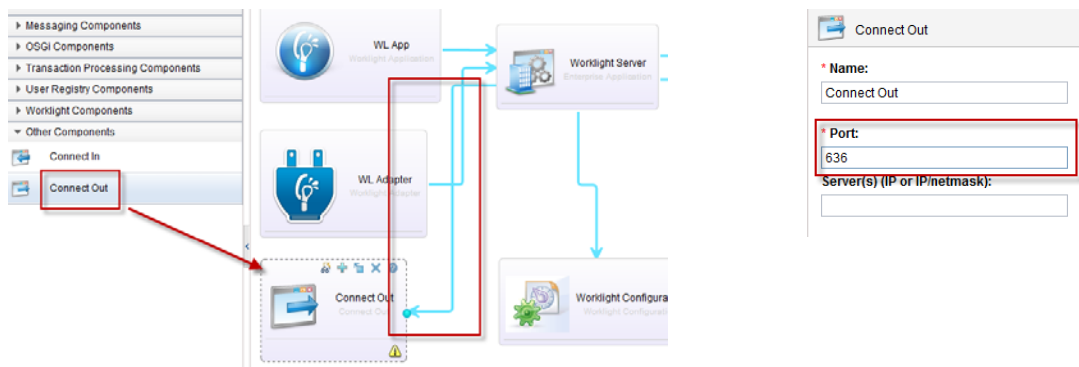
## Configure a new Tivoli Directory Server

- To connect to a new Tivoli Directory Server:
  1. Drag a **User Registry** component (under the **User Registry Components** category).
  2. Connect the **Worklight Configuration** component to the **User Registry** component.
  3. Define the **Base DN** and **LDIF file** of the User Registry component.



## Configure an existing Tivoli Directory Server

- To connect to an existing Tivoli Directory Server:
  1. Open a port on the PureApplication System firewall.
  2. Drag a **Connect Out** component.
  3. Connect the **Worklight Server** component to the **Connect Out** component.
  4. Defined the **Port** of the Connect Out component.
  5. Optionally, define the **Server IP** or IP netmask.
