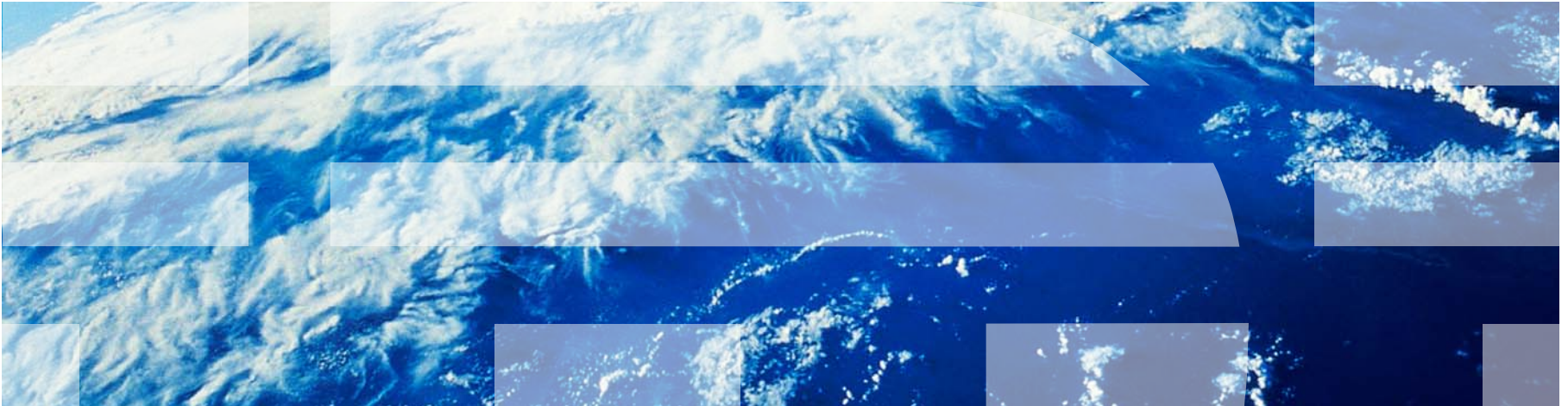

What is it?

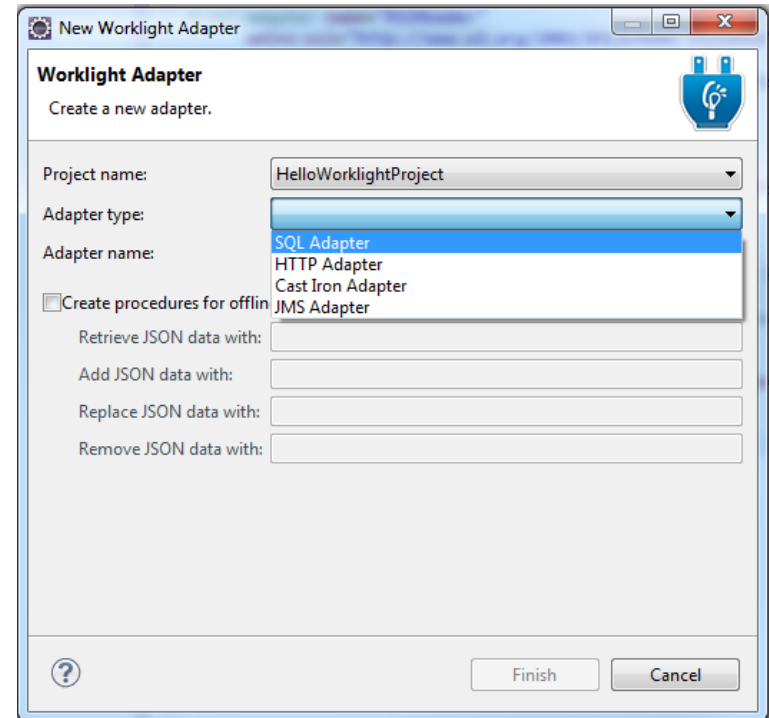
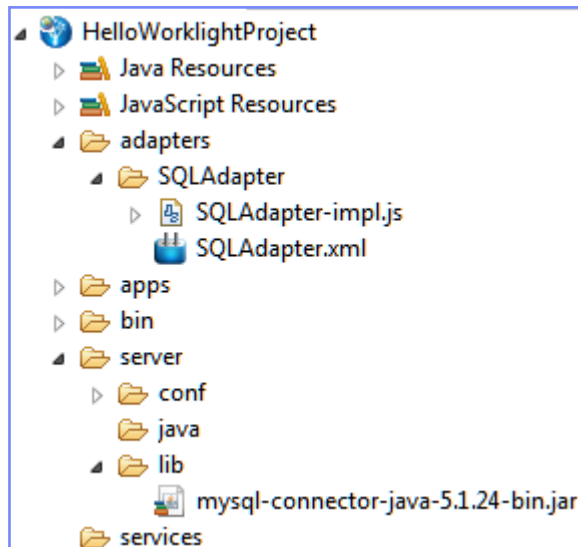
- An IBM Worklight® SQL adapter is designed to communicate with any SQL data source.
- Plain SQL queries or stored procedures can be used.
- Worklight supports MySQL, Oracle 11g and IBM DB2® databases.
- The JDBC connector driver for the specific database type must be downloaded separately by the developer and added to the `server\lib\` folder of a Worklight project.
- The JDBC connector driver can be downloaded at the appropriate MySQL, Oracle, or IBM DB2 website.
- In this module and in the accompanying sample, you learn how to use a Worklight Adapter to connect to a MySQL database.

Creating the adapter

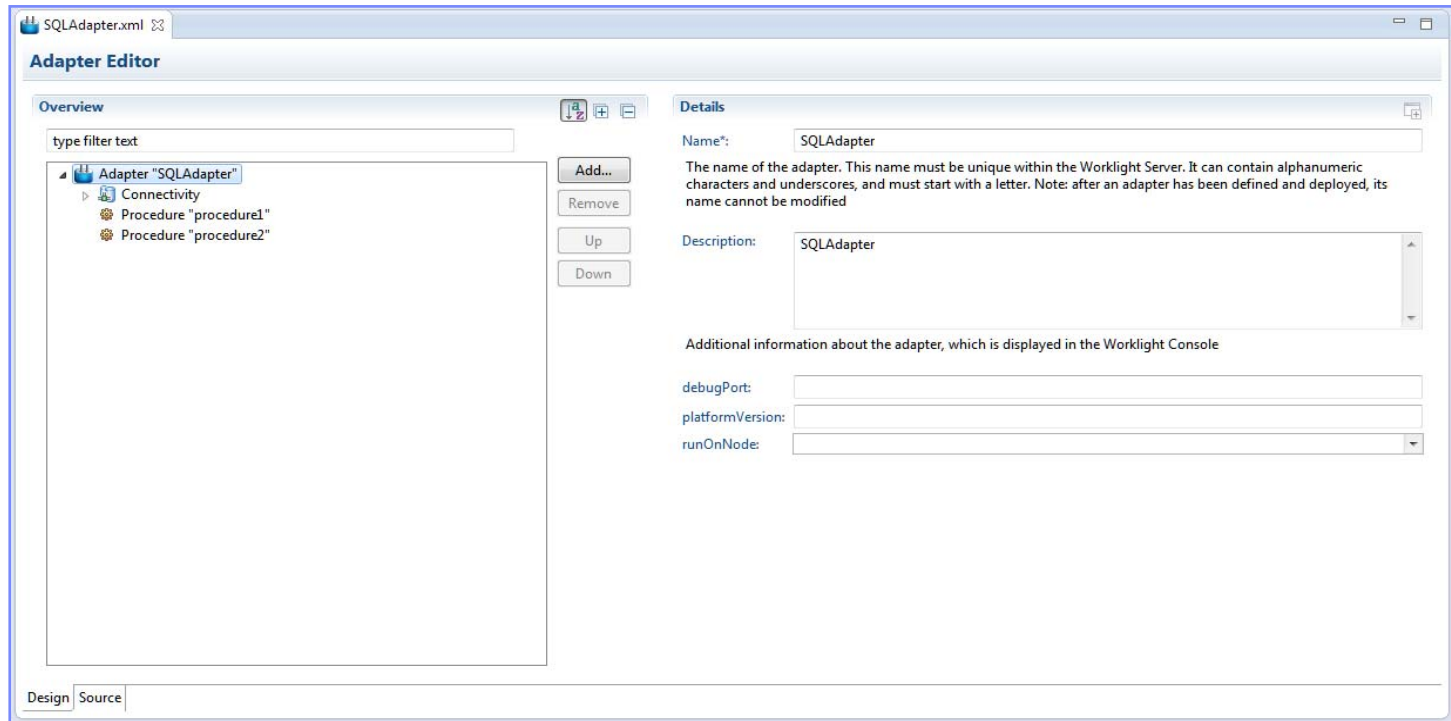
- In Worklight Studio, create a Worklight Adapter.
 - Choose the SQL Adapter type.
 - A standard SQL adapter structure is created.
- Save the downloaded JDBC connector file in the project's `server\lib\` folder.



Creating the adapter – continued

Adapter XML editor

- Settings and metadata are stored in the adapter XML file.
- You can use either the Design or the Source editor to modify the adapter XML file.



Creating the adapter – continued

XML file: connectivity settings

- Four parameters must be declared in the adapter XML file:
 - Driver Class
 - Database URL
 - Username
 - Password

```
<connectivity>
  <connectionPolicy xsi:type="sql:SQLConnectionPolicy">
    <dataSourceDefinition>
      <driverClass>com.mysql.jdbc.Driver</driverClass>
      <url>jdbc:mysql://localhost:3306/mydb</url>
      <user>myUsername</user>
      <password>myPassword</password>
    </dataSourceDefinition>
  </connectionPolicy>
  <loadConstraints maxConcurrentConnectionsPerNode="5" />
</connectivity>
```


Creating the adapter – continued

JS file: procedures implementation

- A procedure must be declared in the adapter XML file.

```
<procedure name="GetAccounts"/>
```

- The adapter JavaScript™ file is used to implement the procedure logic.
- **Important:** The name declared in the XML file must be used for the procedure JavaScript function.
- There are two ways of running SQL statements:
 - SQL statement query
 - SQL Stored Procedure

Creating the adapter – continued

JS file: SQL query

- To run a SQL query:
 - 1) Use the `WL.Server.createStatement` API method to prepare a SQL query.
 - 2) `WL.Server.createStatement` must **always** be called outside the function.
 - 3) Add more parameters, if required.
 - 4) Use the `WL.Server.invokeSQLStatement` API method to invoke prepared queries.
 - 5) Return the invocation result to the application or to another procedure.

```
var procedure1Statement =  
    WL.Server.createStatement("select FirstName, LastName from Customers where CustomerID = ?");  
function GetAccounts([param]) {  
    return WL.Server.invokeSQLStatement({  
        preparedStatement : procedure1Statement,  
        parameters : [param]  
    });  
}
```

Creating the adapter – continued

JS file: SQL stored procedure

- To run a SQL Stored Procedure:
 - 1) Use the `WL.Server.invokeSQLStoredProcedure` API method to run a Stored Procedure.
 - 2) Specify a SQL Stored Procedure name as an invocation parameter.
 - 3) Add more parameters, if required.
 - 4) Return the invocation result to the application or to another procedure.

```
function GetAccounts (param) {  
    return WL.Server.invokeSQLStoredProcedure ({  
        procedure : "GetAccountsByUsedID",  
        parameters : [param]  
    });  
}
```

Creating the adapter – continued

Invocation result

- Result that is retrieved as a JSON object.
- The `isSuccessful` property defines whether the invocation was successful.
- `resultSet` is an array of returned records.

Invocation Result from the WorkLight Server:

```
{
  "isSuccessful": true,
  "resultSet": [
    {
      "accountId": "12345",
      "accountType": "Checking",
      "userId": "bjones"
    },
    {
      "accountId": "54321",
      "accountType": "Savings",
      "userId": "bjones"
    }
  ]
}
```

Exercise preparation

Account Transactions

An adapter that retrieves account transactions details

- Create a fictitious bank schema.
- Run `worklightTraining.sql` (found under the Sever folder of the sample) on your local MySQL server to create a training database.
- Make sure that the `Worklight@%` user has all access permissions that are assigned to it.

```

/*!40101 SET NAMES utf8 */;

/*!40101 SET SQL_MODE=''*/;

CREATE DATABASE IF NOT EXISTS `WorkLight Training`;

USE `WorkLight Training`;

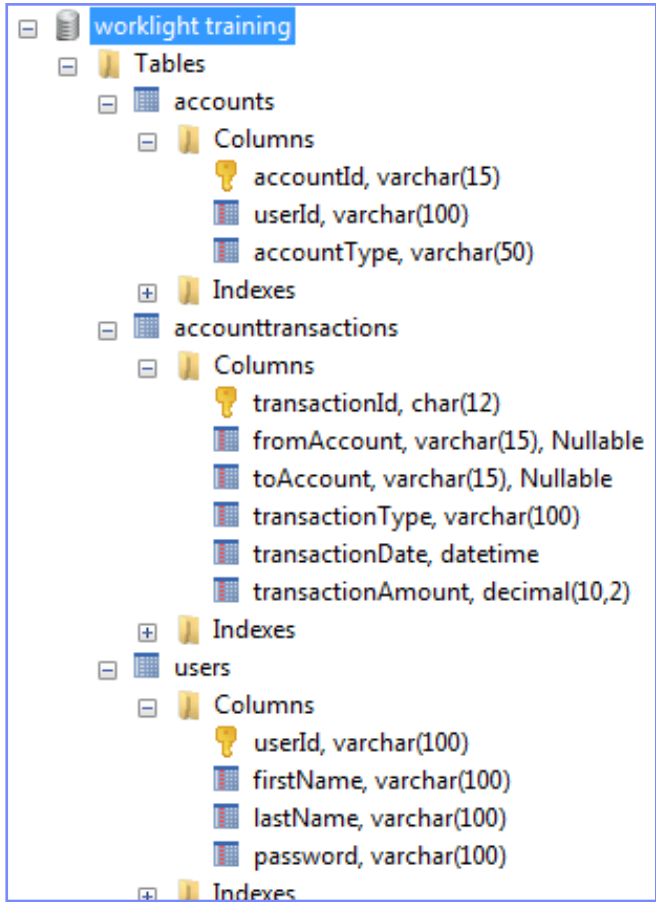
/*!40014 SET @OLD_FOREIGN_KEY_CHECKS=@@FOREIGN_KEY_CHECKS,
/*!40101 SET @OLD_SQL_MODE=@@SQL_MODE, SQL_MODE='NO_AUTO_VA

/*Table structure for table `accounts` */

DROP TABLE IF EXISTS `accounts`;

CREATE TABLE `accounts` (
  `accountId` VARCHAR(15) NOT NULL,
  `userId` VARCHAR(100) NOT NULL DEFAULT '',
  `accountType` VARCHAR(50) NOT NULL

```



Exercise

Account Transactions

An adapter that retrieves account transactions details

- Create an SQL adapter:
 - In the connectivity section, supply the JNDI name as follows:

```
<connectivity>
  <connectionPolicy xsi:type="sql:SQLConnectionPolicy">
    <dataSourceDefinition>
      <driverClass>com.mysql.jdbc.Driver</driverClass>
      <url>jdbc:mysql://127.0.0.1:3306/worklight_training</url>
      <user>Worklight</user>
      <password>Worklight</password>
    </dataSourceDefinition>
  </connectionPolicy>
  <loadConstraints maxConcurrentConnectionsPerNode="5" />
</connectivity>
```

- Create an adapter procedure `getAccountTransactions`:
 - Accepts a single parameter: `accountId`
 - Get `resultSet` with the following fields:
 - `transactionId`, `transactionType`, `transactionDate`,
`transactionAmount`, `fromAccount`, `toAccount`

Exercise

Account Transactions

An adapter that retrieves account transactions details

- Repeat the exercise with both options:
 - Write the SQL query inline, as a prepared statement.

```
var getAccountsTransactionsStatement = WL.Server.createStatement (  
    "SELECT transactionId, fromAccount, toAccount, transactionDate, transactionAmount, transactionType " +  
    "FROM accounttransactions " +  
    "WHERE accounttransactions.fromAccount = ? OR accounttransactions.toAccount = ? " +  
    "ORDER BY transactionDate DESC " +  
    "LIMIT 20;"  
);
```

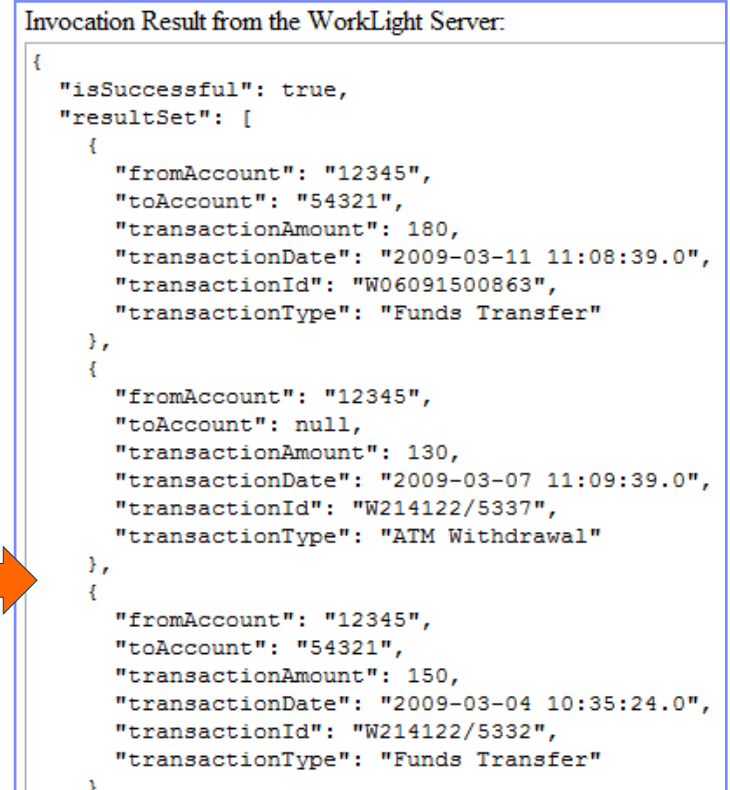
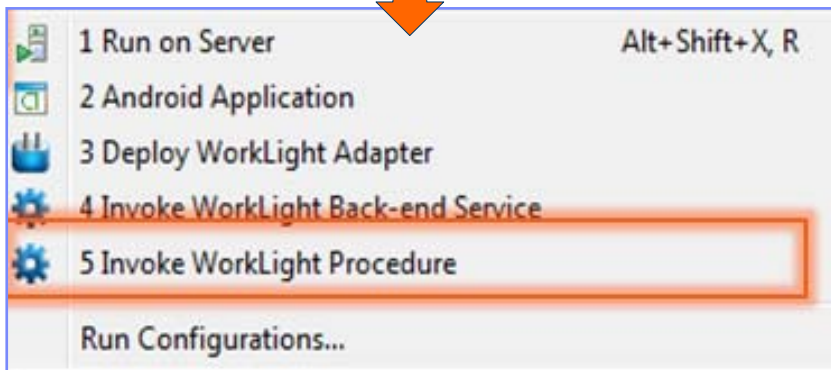
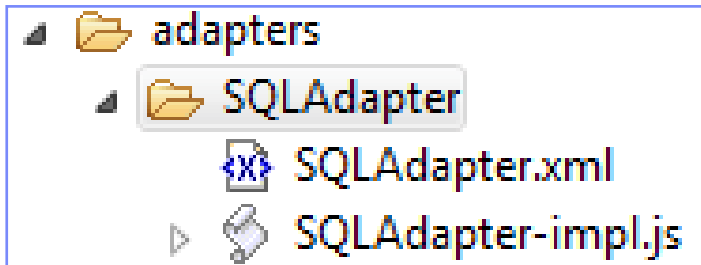
- Start the `getAccountTransactions` Stored Procedure that is created as part of the Worklight Training schema.

```
function getAccountTransactions2 (accountId) {  
    return WL.Server.invokeSQLStoredProcedure ({  
        procedure : "getAccountTransactions",  
        parameters : [accountId]  
    });  
}
```

- In both cases, use **12345** as an `accountId` parameter.
