#### **Overview**

- The IBM Mobile Test Workbench for Worklight® provides several unique resources to test Worklight applications.
- With the test workbench, you can create functional tests for IBM Worklight hybrid and native applications running on iOS or Android.
- The test workbench creates tests in a natural language, and provides visual test editing.
- The test workbench runs within Eclipse, and is integrated with Worklight Studio.







#### Overview - continued

- The testing approach with the test workbench consists of four stages:
  - Recording: You first play your test with the recording-ready app, and generate a test script.
  - Authoring: You edit and enhance the test script by adding verification points and others instructions.
  - Playback: You run the test script on a real device or a simulator.
  - Reporting: You generate an HTML report.



# Installing and configuring

- To use the IBM Mobile Test
   Workbench for Worklight, you must
   install an Eclipse plug-in into an
   exisiting instance of Worklight Studio.
- In Worklight Studio, use Help >
   Eclipse Marketplace, and search for Worklight.
- When you locate the IBM Mobile Test Workbench for Worklight, click Install.
- Note that both Worklight Studio V6.0 and IBM Mobile Test Workbench for Worklight run in Eclipse 4.2.2 (Juno).
- New installations of IBM Mobile Test Workbench for Worklight require the latest version of Worklight Studio.





#### Installing and configuring - continued

• After the test workbench is installed, you can see that a new Test Workbench perspective is available in Eclipse:



- Also note the following icons in the Eclipse toolbar:
  - opens the Mobile Applications view. This view lists all the applications that are available for testing.
  - opens the Mobile Devices view. This view lists the devices that you use to test your application.



#### The mobile client

- With the mobile client application, you can record tests, run test playbacks, and view reports on the mobile device.
- This mobile application must be installed on a real device or on a simulator.
- The mobile client communicates with the test workbench to install applications, to store test scripts, and to test results. Note the Workbench URL in the Mobile Devices view.

#### Installing the Android mobile client


- To install the mobile client on an Android device or a simulator:
  - Use the QR code that is available in the Mobile Devices view to open an installation page on the device.





#### Installing the Android mobile client – continued

On the device, the QR code opens a page that displays installation instructions:




 Follow the instructions to download and install the mobile application on your Android device.



#### Installing the Android mobile client – continued

- When the IBM Rational Test
   Workbench application is installed
   on your device, start the
   application.
- You start by configuring the address of the test workbench in the Workbench settings section.
- The URL is the same as the URL of the page opened by the QR code, without /mobile at the end.
  - The URL has the following structure: http://syour-ipaddress>:7878

If the connection is correctly established, you can see the connection icon at the bottom of the screen.

#### Installing the iOS mobile client

On iOS, the mobile client is a web application that runs in the Safari or Chrome browser on your device.
 To run the client, type the Workbench URL in the following format, in a browser on your device:

http://Workbench\_URL:port/mobile

• When using the mobile test client on an iOS device, make sure to enable pop-up windows. Pop-up windows must be allowed for the Workbench IP address. Safari silently disables pop-up windows, and Google Chrome prompts you to allow pop up windows.








# Creating a test project

- To start testing an IBM Worklight application, you must create a test project.
- You can create your test project at the same time as you create your IBM Worklight project, by clicking IBM Mobile Test Workbench in the New Worklight Project dialog, and by selecting Create a Test Project.





# Preparing the application for testing


- Before you can test an IBM Worklight hybrid application, you must make sure that:
  - (If you test an Android app) You created the native Android project in Worklight Studio by clicking Run As > Build Android Environment, and you created the application binary (the APK file) by using the Android tools.
    - For more information about Worklight Android applications, see the module
       Previewing your application on Android, under category 2 of the tutorials.
  - (If you test an iOS application) You created the Xcode project in Worklight Studio by clicking Run As > Build IPhone Environment, and the appropriate certificate is specified in the Xcode project in case you want to test on a real device.
    - For more information about Worklight iOS applications, see the module
       Previewing your application on iOS, under category 2 of the tutorials.
  - You performed a build and deployment action on your project by right-clicking the project name, and clicking Run As > Run on Worklight Development Server.



# Preparing the application for testing – continued

Right-click the android, iphone, or ipad environment in your IBM
 Worklight application, and click Run As > Test with IBM Mobile


Test Workbench.





# Preparing the application for testing – continued

You can now see the test-ready application in the Mobile
 Applications view in the test workbench, and on the mobile client.





 The status of the application must be Available in the Mobile Applications view before you can start recording a test.

# Creating a test

- To start recording a test on the Android client: select the application in the list of managed apps, and click **Record** in the mobile client on the device.
- To start recording a test on the iOS web client: select the application in the list of managed apps, install the app on the device by clicking the Install button. When the installation is completed, click Record.







# Creating a test – continued

- The application runs on the device or emulator.
- Everything you do with the application is recorded and sent to the test workbench. For example, the script records the moment when you press a button, or enter text in an entry field.
- Close the application to stop the recording using the Home (iOS) or Back (Android) buttons.
- A message indicating the availability of a new recording is displayed on the test workbench.
   There is a new incoming recording.
   Click here to generate a test.
- Follow the wizard instructions to generate a test from the recording. You will be asked to store the test in the test project.



#### Editing a test


 After the recording, you can edit the test in the natural language editor.





#### Editing a test - continued

 You can edit the test to insert verification points (for example, to verify the value of a user interface element), to replace recorded test values with variable test data, or to add dynamic data to the test.



#### Running a test

- Run a test to ensure that the app matches the expected behavior that is defined in the verification points.
- During the test, each verification point is checked, and receives a pass, fail, or inconclusive status.
- The available tests are visible in the mobile client, and you can run the test from this application.





#### Running a test - continued

- After the test is completed, a report is generated and shows the status of the test and all the verification points.
- You can read the report on the device, or on the Eclipse test workbench.
