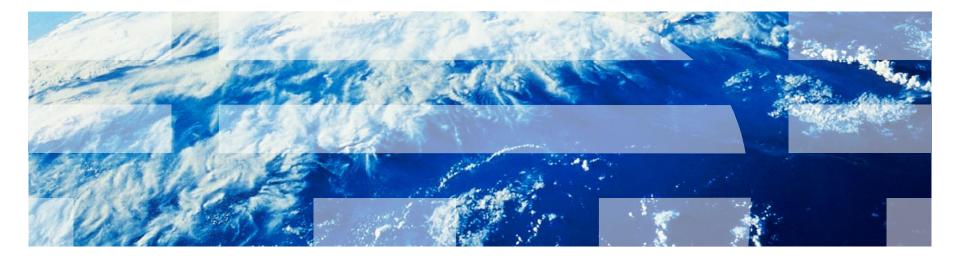




Install Microsoft Visual Studio Express 2012 for Windows Phone

- Microsoft Visual Studio Express 2012 for Windows Phone is an integrated development environment (IDE) that you can use to develop applications for the Windows Phone 8 platform.
 - Note: You must have a computer that runs Windows 8 OS to use it.
- To download Visual Studio Express 2012 for Windows Phone, go to the Microsoft Visual Studio download website:

http://www.microsoft.com/visualstudio/eng/downloads

- Click Install Now.
- Run the downloaded file.






Install Microsoft Visual Studio Express 2012 for Windows Phone

- Click Install Now to start the installation process.
 - The installation process downloads the required components from the Internet.
- Wait for the installation to complete.

- You can register on the Microsoft Dev Center at <u>http://create.msdn.com/en-US/</u>.
- After you register, you must assemble the prerequisites for your application certification by Microsoft and submit your application for review.
