Create Worklight Project via Command Line Interface

- Install the Worklight® Command Line interface (CLI).
 - For more information, see the Worklight Getting Started module "Using the Command Line Interface to Create Build and Manage Worklight Project Artifacts" at www.ibm.com/mobile-docs.
- Create a Worklight project from the CLI by using this command:
 - worklight create projectName>


Example:

Worklight Project Add Native API

- Add Native API for Android and iOS to your project.
 - wl add api --environment android androidApp
 - wl add api --environment ios iOSpp
 - Or -e for environment



/Users/user/Desktop/XtifyExample/WorklightXtifyProject\$ wl add api -- environment ios apiName
A new iOS API was added at

/Users/user/Desktop/XtifyExample/WorklightXtifyProject/apps/apiName



Worklight Project Add Native API

- Create and start the Worklight Server via CLI.
 - This action builds and deploys the Worklight native API folder.
- Create a native Android or iOS application and copy in the required Worklight files to your native application.

Worklight Xtify Android native application (1 of 2)

- Download the IBM Push Notification SDK for Android.
- Create a Google API Project with GCM.
 - Open the Google APIs Console page and create an API project.
 - Click the APIs menu link tab to enable Google Cloud Messaging for Android.
 - In the Credentials tab, click create New Key > Server Key. This key is used when you register your Android app with IBM Mobile Push Notification.
- Register your Android app with IBM Mobile Push Notification:
 - Create an Xtify[™] Account.
 - Add an Android app, and add your API key to the Google API key field.
 - Submit and copy your Application Key for use in your app.



Worklight Xtify Android native application (2 of 2)

- Implement the IBM Push Notification SDK for Android within your app.
 - Add IBM Push Notification SDK for Android to your project path.
 - Modify the Android version, permissions, and application components in the AndroidManifest.xml file.
 - Edit the Main Activity to start the IBM Mobile Push Notification registration process.
- Set up your emulator for testing your IBM-enabled Android app:
 - Make sure that the Google APIs are installed in Android SDK Manager.
 - Under AVD Manager, select New, and, under target, make sure to select an option that uses Google APIs.
 - In the launched device, add an active Google account to the device by using Settings > Accounts.

Worklight Xtify iOS native application (1 of 2)

- Download the IBM Push Notification SDK for iOS.
- Register your iOS app with Apple.
- Register your iOS app with IBM.
 - Select Add New Application on the Create/Manage Application Keys page.
 - Upload the .p12 certificate from Apple registration.
 - Submit and then copy your Application Key and Secret.
- Implement the IBM Push Notification SDK for Apple iOS within your app.



Worklight Xtify iOS native application (2 of 2)

- Build the IBM Push Notification SDK for Apple iOS Sample App.
- Test and prepare your iOS application for App Store Distribution.
