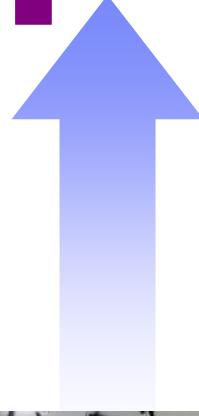

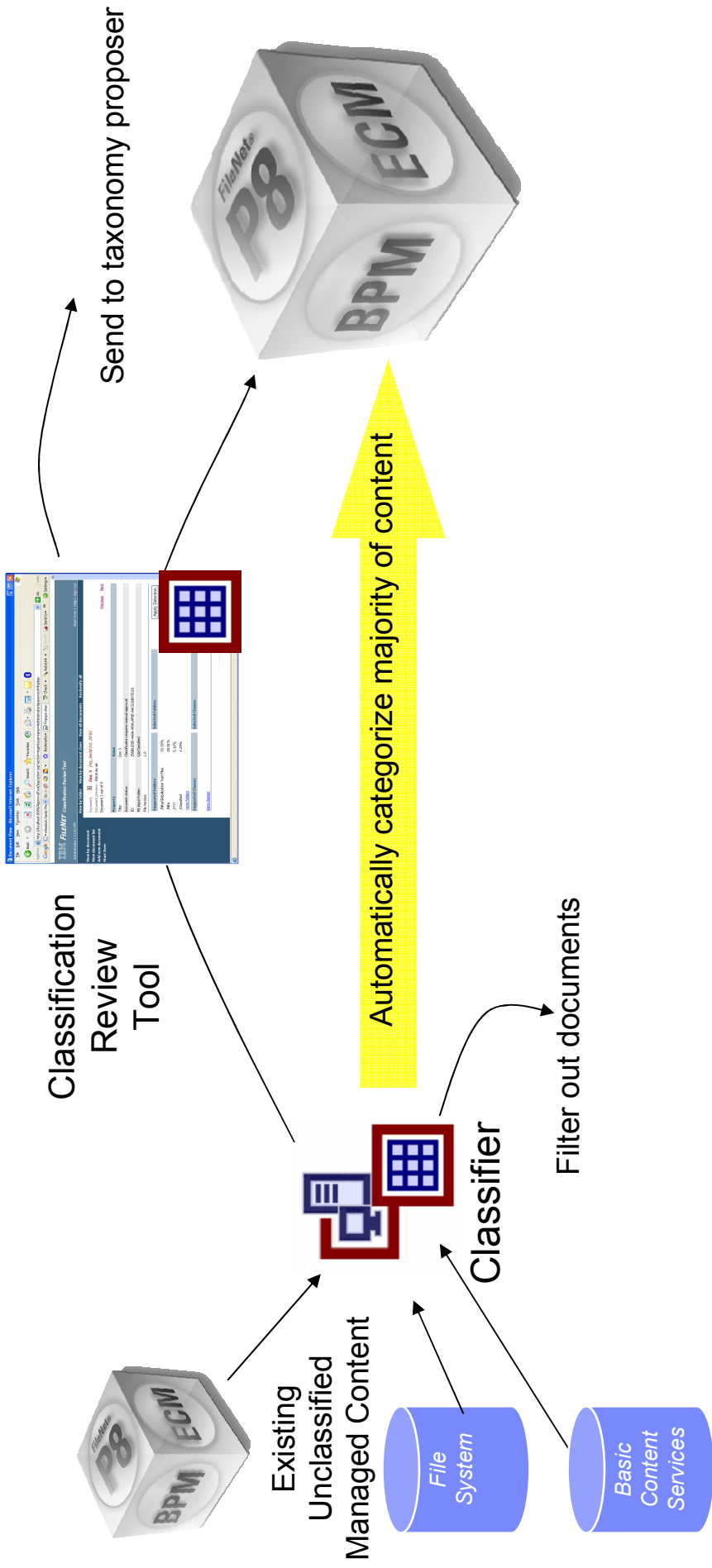


Trouble organizing your content?

Classification Workflow: Accelerating Content Organization

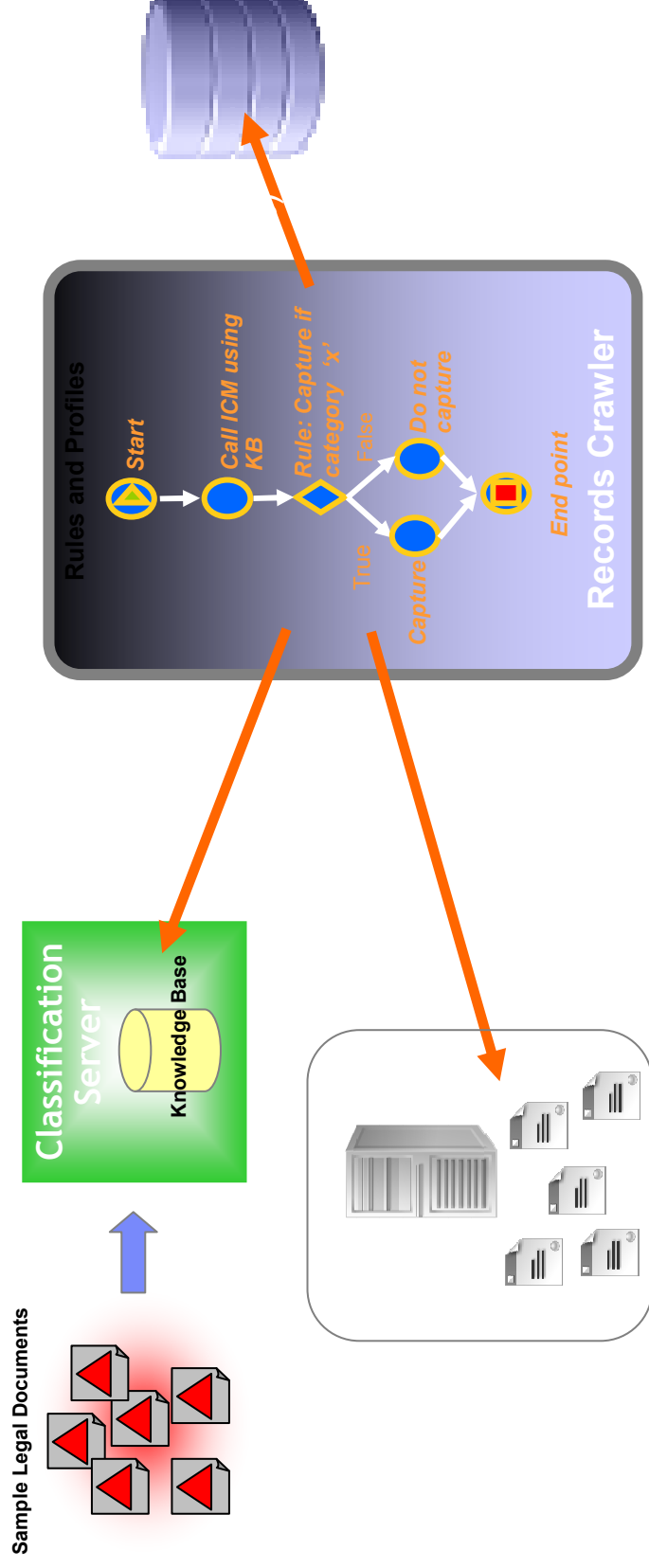


Reference: Integration Components

Use Case – Legal Discovery

- An organization wants to crawl their file system to look for documents that may be relevant to a legal case
- Documents could be anywhere or they could be in known locations.
- They need to find relevant documents and move them into a case folder in P8 where legal can review them.

 - Available soon



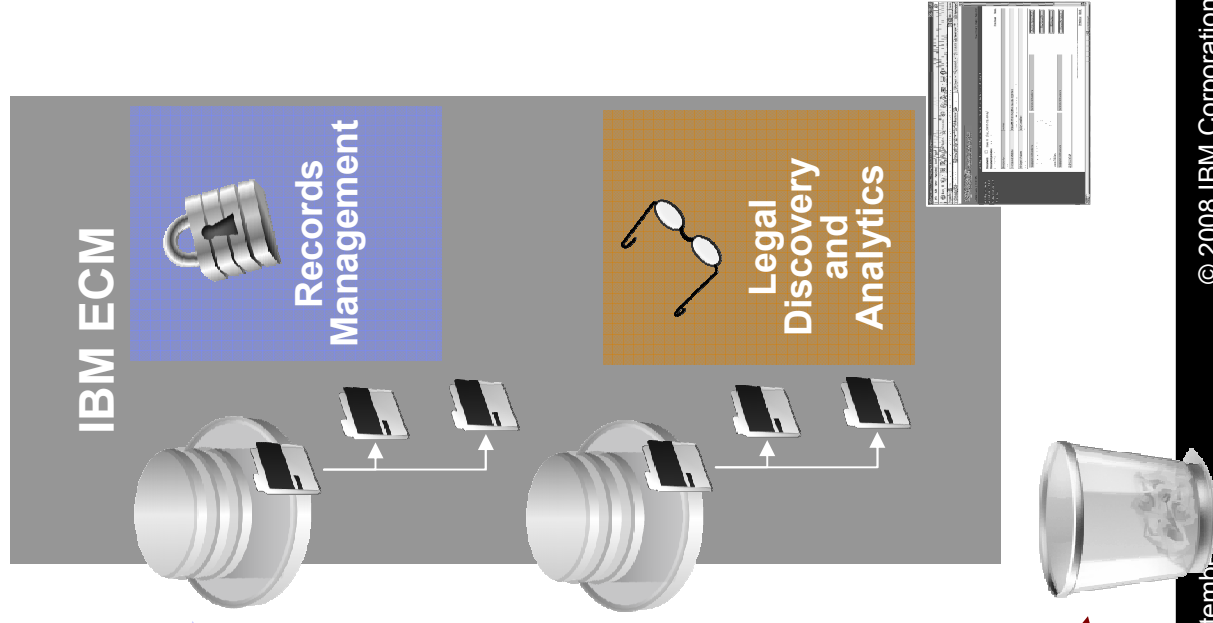

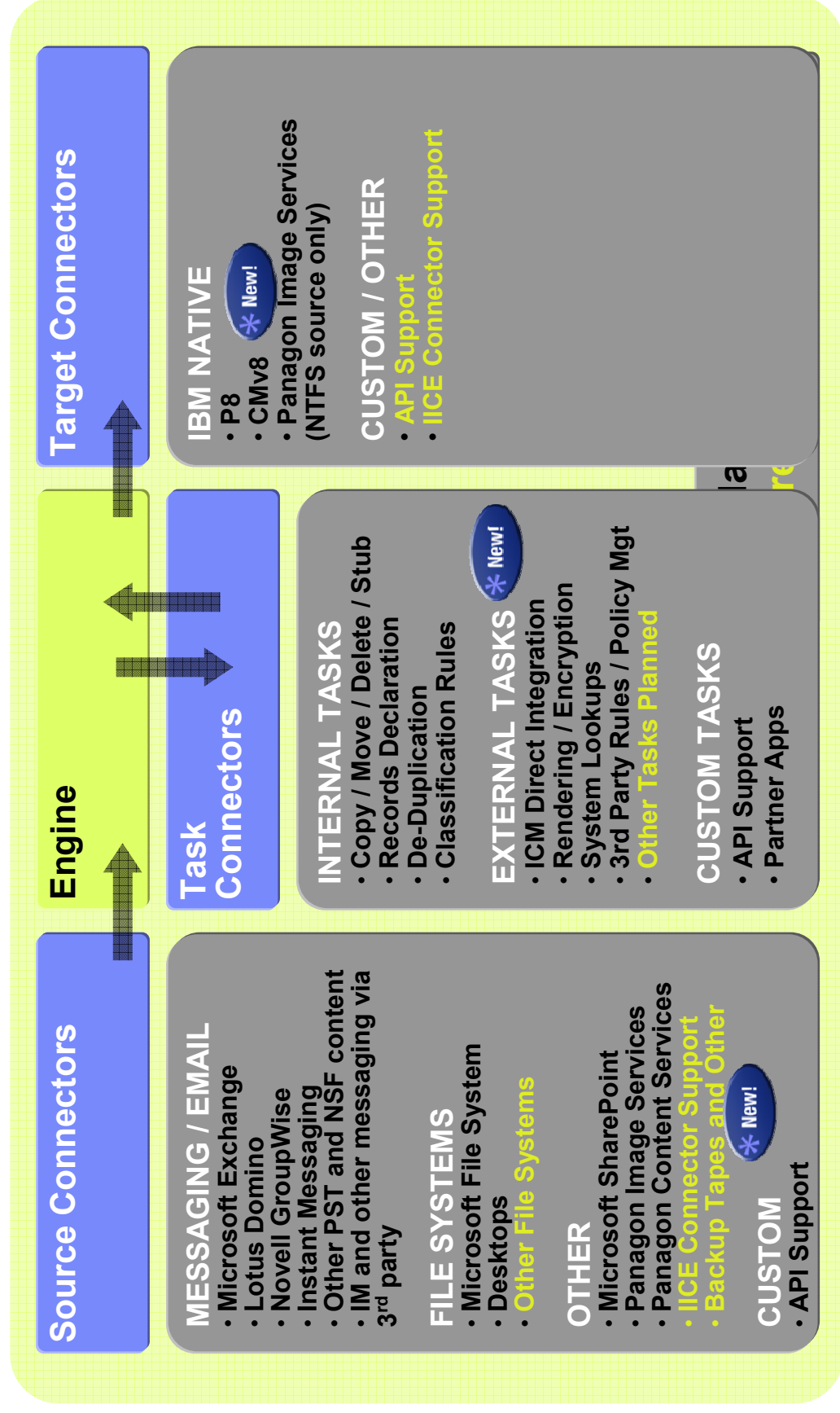

Why Keep The Paper?

Hypothesis

- *How do the new economics of Compliance combined with technology advances enable transformation of physical records storage?*
- *Does this same dynamic also enable new methods of business intelligence?*

IBM & Iron Mountain Accutrac Integration

- **What did IBM and Iron Mountain announce?**
 - On 20 May 2008, at the Managing Electronic Records (MER) Conference in Chicago, IL, IBM and Iron Mountain jointly announced plans to integrate the Iron Mountain Accutrac Software with IBM FileNet Records Manager.
 - The integration between Iron Mountain's Accutrac and IBM FileNet Records Manager will be focused on allowing customers to manage records consistently, whether in physical format managed with Accutrac or electronic format managed within IBM FileNet Records Manager. The goal is to allow customers to implement a compliant records program across the two platforms.
 - Central to achieving this goal is to enable the two applications to share a common retention policy and classification scheme, and to allow users to apply and manage retention and legal holds through either application interface.
 - Additionally, the integration will enable the declaration of records from one interface as well as the ability to view electronic records and request physical records.

Cornerstone: new IBM eDiscovery Manager v2.1 Integrated tool for managing ESI in an ECM environment

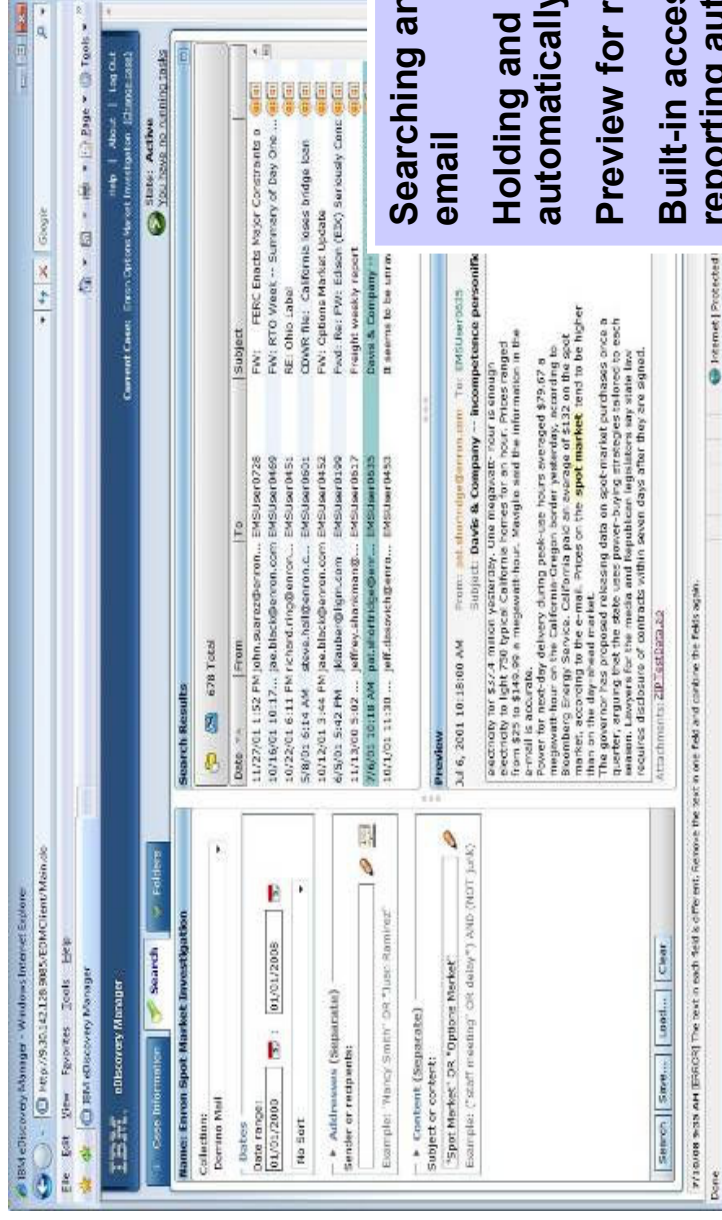

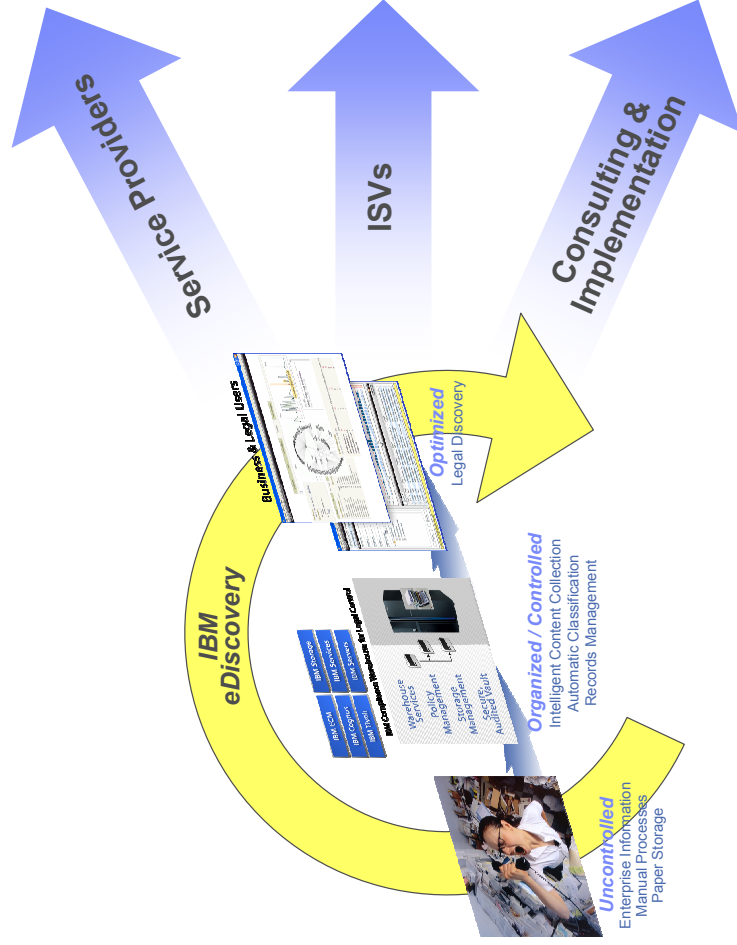

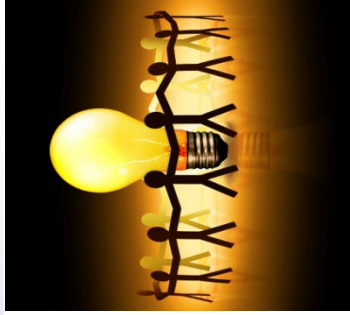
