1. ABOUT THIS FIX PACK

This fix pack contains major enhancements like support for new UCCNet Schema, additional product extensions and also has bug fixes from GDS V1.1.1.1

1.1 New in this release

- **Support for UCCNet new schemas**
- **Support for “Lowes” extension on the demand side:** In addition to the Hardlines, Office Supplies and FMCG extensions, a new type of extension called the “Lowes” extension.
- **Pagination done for notification screens:** You can set the number of notifications that you want to view in one page, by setting the parameter:
NOTIFICATION_CONSOLE_PAGINATION_SIZE = "" in gds.properties file.
- **Support for running the mass import export jobs:** This is a bug fixed regarding performance issue of running the mass job.
- **Support for CINs coming without extensions** on demand side.
- **Support for multiple extensions:** In the earlier releases the user could select only one product extension, but now the user will be able to select multiple product extensions, while creating an item.

1.2 Product fix history

The change requests listed in this section identify issues that have been reported and resolved with the application of this fix pack from fix pack release of IBM Global Data Synchronization for Websphere Product Center, version 1.1.1.1:

1.3 Enhancements

1.3.1 Script for mass jobs

In this release there is a new script which is a single entry point for all mass jobs. Using this script you can run any of the mass jobs by passing an id as a parameter .

Operation name and signature:

Description:

This operation is a single entry point for all the Mass Jobs. The type of mass job is identified by the ID.

A valid Mass Job ID can be anyone of the following values

User can also pass the search parameters to via hash map. The valid keys are as follows, and they are case sensitive.

1.3.2 Mass jobs performance enhancements:

Ensure the following setting in order to ensure better performance of the mass import export operations:

At the starting of the mass import/export script:

2. INSTALLATION, MIGRATION, UPGRADE, AND CONFIGURATION INFORMATION

Note: Ensure that the Websphere Product Center fix pack is applied before applying the IBM Global Data Synchronization for Websphere Product Center 1.1.1.2 fix pack. The Websphere Product Center fix pack to be used is, **Websphere product Center Version 5.1.1.1**.

2.1 Applying the Fix Pack

As mentioned above, ensure that the Websphere product Center Version 5.1.1.1 fixpack is applied.

Steps to apply the fix pack on demand - side

1. Run the script file loadDemandSideFixPackDataModel.sh (This script is available in the directory where IBM Global Data Synchronization for Websphere Product Center Demand Side is installed \$STOP/src/db/schema/gds)

2. From the underlying WPC instance, run the script "LowesHierarchySpecAssociation" from the script sandbox. (This script is available in the directory where IBM Global Data Synchronization for Websphere Product Center Demand Side is installed \$STOP/src/db/schema/gds/DEMAND-SIDE/scripts/reports")

Steps to apply supply-side fix pack

1. After loading the data model run the script file loadSupplySideFixPackDataModel.sh (This script is available in the directory where IBM Global Data Synchronization for Websphere Product Center Supply Side is installed \$TOP/src/db/schema/gds)

2.2 Changes in configuration

Pagination done for notification screens: You can set the number of notifications that you want to view in one page, by setting the parameter NOTIFICATION_CONSOLE_PAGINATION_SIZE = "" in gds.properties file.

3. KNOWN LIMITATIONS, PROBLEMS, AND WORKAROUNDS

This section identifies known issues for this release and provides a workaround, if one is available. These known issues will be addressed in a future release or Fix Pack.

WPC00018368	The Datapool Category Code Description field is not populated when we create a trade item using the scriptop, "TradeItemSS".	The tradeItem is getting created with just 5 parameters as mentioned in the script opts of the mentioned bug, so it will not populate the other fields. They need to be populated separately.
