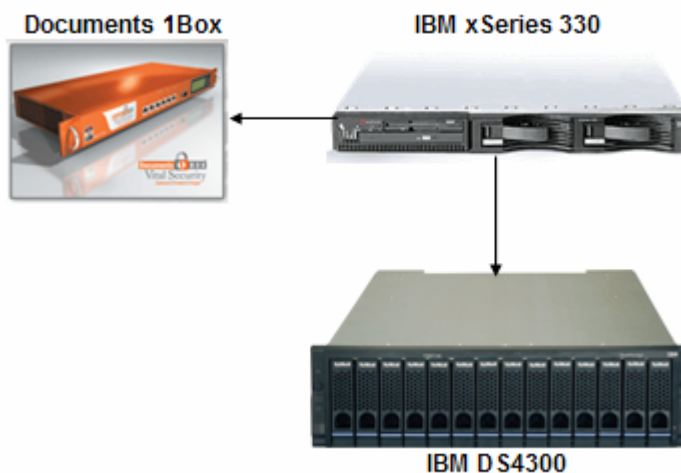
Testing Template:

IBM DS4300 storage connected to an IBM xSeries Model 330 server, which in turn connects to the Finjan Documents 1Box™.

Testing Overview:

The testing consisted of publishing the secured documents to the Documents 1Box™, accessing authorized documents on the Documents 1Box™ and generally using the system while, transparently to the end-users, all the documents are actually stored on the IBM storage.

This enables the customer to have the unique capabilities of the Documents 1Box™ together with all the benefits of IBM storage products, such as high-availability, increased performance etc.

Specific versions of products included in the testing with the configuration of specific hardware/software tested with specific hardware and software levels:

- IBM DS4300 / 1722-600, Storage Manager 9.10.G5.02
- IBM xSeries Model 330 (Microsoft Windows 2000 Server SP4)
- Finjan Documents 1Box™ 7.0.2 (hardened Microsoft Windows 2000 Server SP4)

The validation tests were performed from June 19-23, 2005. The install was a virtual "plug and play". Since the storage doesn't "see" the Documents 1Box. The only instructions that I had were from the Finjan team at the IIC. This was sufficient without any previous knowledge to install and operate the system. An installation manual was provided and there is also on-line help through the Documents 1Box GUI.
