Document information

Intended purpose and audience

This manual contains the instructions for installing and maintaining this appliance. The audience for this guide consists of those individuals responsible for installing IBM Cloud Object Storage System $^{\text{\tiny TM}}$ appliances.

Note:

- The equipment and device described for installation herein are sophisticated and relatively complex to install. The party or parties installing the equipment must be familiar with installations of computer hardware and disk drives prior to attempting this installation. Only personnel proficient in working with computer hardware and disk drives should attempt to install this appliance.
- After all appliances have been installed in the rack, refer to the *Appliance Configuration Guide* to configure the appliance settings required prior to setting up the system.
- After these appliances are configured, refer to the *System Manager Administration Guide* for information about how to configure, operate, and maintain your system.
- Both the *Appliance Configuration Guide* and the *System Manager Administration Guide* assume that all necessary appliances for the system are installed in the rack.

- Each rack cabinet might have more than one power cord. Be sure to disconnect all power cords in the rack cabinet when directed to disconnect power during servicing.



Chapter 1. Appliance safety precautions

Observe physical, electrical, and electronic component safety precautions.





DANGER: An electrical outlet that is not correctly wired could place hazardous voltage on the metal parts of the system or the devices that attach to the system. It is the responsibility of the customer to ensure that the outlet is correctly wired and grounded to prevent an electrical shock. (D004)

DANGER: Multiple power cords. The product might be equipped with multiple power cords. To remove all hazardous voltages, disconnect all power cords. (L003)

Physical

Ensure that your equipment rack is placed in a dust-free, well-ventilated area close to an uninterruptible power supply (UPS). Leave enough room behind and around the rack for services and sufficient airflow.

- Keep the area around the appliance clean and free of clutter.
- Place the appliance top cover and any appliance components that were removed away from the appliance or on a table so that they do not accidentally get damaged.
- While you are working on the appliance, do not wear loose clothing such as neckties and unbuttoned shirt sleeves. They can retain a charge even if you are wearing a wrist strap, or could be pulled into a fan.
- After you access the inside of the appliance, close the appliance and secure it to the rack unit with the retention screws after you ensure that all connections are made.
- Close the rack's front door and all panels and components on the appliances when not servicing to maintain proper cooling.

Electrical

Basic electrical safety precautions must be followed to protect yourself and the appliance:

- Do not work alone with high-voltage components.
- Be aware of the locations of the power switch on the appliance and the room's emergency power-off switch, disconnection switch, or electrical outlet. If an electrical accident occurs, quickly remove power from the system.

DANGER

A danger of explosion exists if the Onboard battery is installed upside down, which reverses its polarities. This battery must be replaced only with the same or an equivalent type that is recommended by the manufacturer. Dispose of used batteries according to the battery manufacturer's instructions.

Electronic components

Electrostatic discharge (ESD) is generated by two objects with different electrical charges when they come into contact with each other. An ESD neutralizes this difference, which can damage electronic components and printed circuit boards (PCBs). In general, the following measures are sufficient to neutralize this difference before contact is made to protect equipment from ESD:

- Use a grounded wrist strap that is designed to prevent ESDs.
- Keep all components in their antistatic containers until ready for installation.
- Touch a grounded metal object before you remove any board from its antistatic container.
- Remove any jewelry or metal objects from your body. They are excellent metal conductors that can
 create short circuits and harm you if they come into contact with printed circuit boards or areas where
 power is present.

Chapter 3. Install the appliance into a rack

Many racks are on the market, which means that the assembly procedure might differ slightly. This rail fits a rack between 26.5" and 34.5" deep.

Prepare for installation

Assemble tools

A #2 Phillips screwdriver and a cage nut tool are needed to install and secure the rails to the appliance.

Wear a set of leather work gloves when racking the appliance. They help to get a grip on the appliance and avoid injury from any metal edges.

CAUTION:

Do not use of any sort of hammer to secure the rails on the appliance. A hammer might damage the drives within the chassis and possibly void the warranty.

Choose a setup location

Decide on a suitable location for the rack unit that holds your appliance.

Table 5. Appliance location considerations

Factor	Comments
Restricted access location	Install this appliance in a physically secure, limited access location only, such as a service closet or data center.
Clean environment	Situate the appliance in a clean, well-ventilated, dust-free area.
Ambient operating temperature	If installed in a closed or multi-unit rack assembly, the ambient operating temperature of the rack environment might be greater than the ambient temperature of the room. Install the equipment in an environment compatible with the maximum rated ambient temperature (TMRA) for the appliance.
Sufficient airflow	Mount the equipment into a rack so that the amount of airflow that is needed for safe operation is not compromised. Leave enough clearance in front of the rack to open the front door completely (36 inches). Leave about 36 inches of clearance behind the rack for sufficient airflow and ease in servicing.
Mechanical loading	Mount the equipment into a rack so that a hazardous condition does not arise due to uneven mechanical loading. Install heavier items into the bottom of the equipment rack to keep the rack stable. Mount equipment in a rack evenly to prevent a later hazard.
Circuit overloading	Give consideration to the connection of the equipment to the power supply circuitry and the effect that any possible overloading of circuits might have on overcurrent protection and power supply wiring. Appropriate consideration of equipment nameplate ratings should be used when addressing this concern. Note: The maximum current draw is printed on a label on the appliance power supplies. The system can draw more than 15 Amps at startup (inrush current).
Reliable ground	A reliable ground must be maintained always. To ensure grounding, the rack itself should be grounded. Give particular attention to power supply connections other than the direct connections to the branch circuit, such as the use of power strips.
Power supply	Use a regulating uninterruptible power supply (UPS) to protect the appliance from power surges and voltage spikes, and to keep your system operating in a power failure.

Table 5. Appliance location considerations (continued)

Factor	Comments
Heat, electricity, and EMI	Avoid areas where heat, electrical noise, and electromagnetic fields are generated.

Prepare the rack

- 1. Ensure that the leveling jacks on the bottom of the rack are fully extended to the floor with the full weight of the rack resting on them.
 - In single rack installations, attach stabilizers to the rack.
 - In multiple rack installations, couple the racks together.
- 2. Check that the rack is stable before extending an appliance from the rack.
- 3. Extend only one appliance at a time. Extending two or more simultaneously can destabilize the rack.
- 4. Determine the placement of each appliance in the rack before you install the rails.
- 5. Install the heaviest appliances (usually the Slicestor® appliances) on the bottom of the rack first, and then work upward.

Unpack and inspect the box and its contents

- 1. Inspect outside of box for damage.
- 2. Note if the box was damaged in any way.
- 3. Open the top of the box and inspect for damage.
- 4. Remove all of the components from the packaging and inspect for damage.
- 5. Arrange for assistance when lifting or installing the appliance in a rack. Use a forklift or lift table to prevent possible injury.

CAUTION:

To prevent personal injury and equipment damage, have someone assist you during the equipment installation. If necessary, reduce the weight of the enclosure by removing the hard disk drives and power supply units during installation.

When using the lifting straps, keep them even and at the same level always. Otherwise, the system can slide to one side, and possibly out of the straps completely. Make sure that the rubberized sides of the lifting straps are against the chassis metal.

6. If the appliance itself shows damage, file a damage claim with the carrier who delivered it.

In addition to the appliance, the box includes:

- · Rail kits
- Cables
- Manual

Install the appliance

Attention: Allow the enclosure assembly to acclimate to room temperature before installation. Store disk drives at room temperature for at least 2 hours before use.

Identify the sections of the rack rails

The box contains two rail kits. Each rail kit contains three sections, as shown in the following figure:

- The outer rail mounts to the front rack vertical post and rear rack vertical post.
- The middle rail allows the outer rail to extend or shorten to accommodate racks of different depths.
- The inner rail mounts on the side of the appliance and slides into the outer rail that is mounted on the rack, if wanted.




Figure 2. Identifying the sections of the rack rails

Release the inner rail

Remove the inner rail from each rail kit, as shown in the following figure.




Figure 3. Remove the inner rails from both rail kits

- 1. Pull on the front release tab to unlock the inner rail from the rail kit.
- 2. Remove and set aside each inner rail.

Retract the outer rail

After releasing and removing the inner rail, retract the outer rail to its shortest length, as shown in the following figure.




Figure 4. Retracting the outer rail

Attach the inner rails to the appliance

- 1. Place the right inner rail on the right side of the appliance, making sure that the rail faces "outward" in the proper orientation so that it slides into the right outer rail.
- 2. Make sure that the inner rail screw holes and tabs are properly aligned with the matching screw holes and tab locators on the appliance.
- 3. Install the inner rail to the appliance by aligning the key holes on the rail with the studs on the side of the appliance.
- 4. Slide the inner rail towards the front of the appliance to hold it in place.
- 5. Secure the rail to the appliance with the screws that are provided in the rail kit, as shown in the following figure.




Figure 5. Attaching the sections of the rack inner rails

6. Repeat these steps for the left inner rail.

Install the outer rails

- 1. Measure the distance from the front rail to the rear rail of the rack.
- 2. Extend the left outer rail so that it fits snugly into the allotted distance.
- 3. Adjust both the short and long brackets to the proper distance so that the rail can fit snugly into the
- 4. Align the front tabs of the outer rail with the holes in the rack post, as shown in the following figure.




Figure 6. Aligning the outer rails with holes in rack post

5. Push the outer rail into the rack post so that the tabs go through the rack post and hold the rail in place, as shown in the following figure.




Figure 7. Push outer rail into rack post

6. Attach the back of the left outer rail to the rear rack post through a similar process, as shown in the following figure.




Figure 8. Attach back of outer rail

7. Repeat these steps for the right outer rail.

The final assembly of both outer rails is shown in the following figure.




Figure 9. Final outer rail assembly and mounting

Lock the rail tabs

Both chassis rails have a locking tab, which locks the appliance in place when:

- Installed and pushed fully into the rack.
- Extended fully from the rack so it does not come out of the rack when pulled out for service.

Install the appliance into the rack

The inner rails can now be attached to the appliance chassis and the outer rails to the rack.

CAUTION:

When you are ready to install the appliance in the rack, you might need a lifting device. Alternatively, use 2 - 4 individuals to place the appliance in position and begin inserting it into the rack rails.

To install the appliance into the rack:

- 1. Line up the rear of the chassis rails with the front of the rack rails.
- 2. Slide the chassis rails into the rack rails, keeping the pressure even on both sides, as shown in the following figure. You might have to depress the locking tabs when inserting. When the appliance is pushed completely into the rack, you can hear the locking tabs click into the locked position.




Figure 10. Push chassis into rack

3. Secure the chassis to the rails with the captive M6 thumbscrews on the server.

Cable the appliance

1. On the rear panel, connect the C13 end of the power cables to the C14 inlets in the PSU, as shown in the following figure.




Figure 11. Rear of appliance

- 2. The Ethernet connections are located just to the left of the center of the appliance and are next to each other. Connect a standard Ethernet cable from the left Ethernet port.
- 3. Press the power button on the top far right corner of the appliance front panel when the bezel is unscrewed and flipped down.
- 4. To ensure that the power is on, verify that the power and network link lights are lit and listen for running fans, as shown in the following figure.




Figure 12. Front of appliance

Chapter 4. Appliance physical interface

The physical interface for the appliance consists of buttons and LEDs on the front panel and ports and LEDs on the back panel.

Front control panel

The power status and the hard disk and network activity of the appliance can be read from its front control panel, as shown in the following figure.




Figure 13. Front panel buttons and LEDs for the appliance

Physical buttons

The appliance includes three push-buttons on the front panel:

NMI Issues a non-maskable interrupt to the server.

UID Facilitates finding a system in a rack that is viewed from the front. On the front panel, the LED is on the button. Similarly, a functioning UID button/LED is on the back panel.

Power Applies or removes power from the power supply to the appliance. Powering down the appliance removes the main power, but supplies stand-by power. The appliance must be unplugged before servicing.

LEDs

The control panel has five LEDs to provide critical information for different components:

Disk activity

One LED serves to indicate activity for any of the front-mount hard disk drives. When the green light is on or flashing, the hard disk is being accessed.

Unit identification LED (UID)

This LED facilitates finding a system in a rack that is viewed from the front. On the front panel, the LED is the button. Similarly, a functioning UID button/LED is on the back panel.

Power LED

Power supplied to PSUs; should be lit to indicate that power is applied to the server.

LAN active

When the green light is on, at least one of the LAN interfaces is active.

System Health

When the light is green, the system is working correctly. When the light is amber, a problem is detected with system hardware. When the light is off, the disk drive is operational.

Rear panel

The rear panel contains I/O ports.

I/O ports

The I/O ports are color-coded per the PC 99 specification. The locations of the various I/O ports are shown in the following figure.




Figure 14. Rear panel I/O ports for the appliance

Network interface ports

1 Gbps LAN LEDs

The LAN ports have two LEDs. One LED indicates activity when flashing. The other LED can be green, amber or off to indicate the speed of the connection, as shown in the following figure. See the following table for the functions that are associated with the connection speed LED.

10 Gbps LAN LEDs

The 10 Gbps LAN ports have two LEDs. One LED indicates activity when flashing while the other LED is green to indicate the existence of the connection, as shown in the following figure. The location of these LEDs can vary depending on the NIC model.

Intelligent Platform Management Interface (IPMI)

Each power supply includes one LED with five states in the rear.

Hard disk drive carrier

Each drive carrier has two LEDs, one to indicate activity (green) and the other to indicate status (blue/amber).

Replace external front components

Replace the operating system drive

- 1. Log in to the device as local admin.
- 2. At the command prompt, type poweroff. After the appliance is powered off, you can remove the power cord and network cables from the back of the chassis.
- 3. Locate the drive by location label or failure LED.
- 4. Press the release button on the drive carrier. This action extends the carrier handle, as shown in the following figure.




Figure 17. Removing a drive from the chassis

- 5. Pull the drive carrier out of the chassis by using the handle.
- 6. Make sure that the drive carrier latch on new drive is open.
- 7. Push the drive carrier with the new HDD into the chassis until significant resistance is encountered.
- 8. Reclose the latch to fully seat the drive carrier into the chassis.

9. Contact IBM Support to issue OS drive recovery.

Install an operating system on a drive

Note: To install an operating system (OS) on a drive, you need a USB flash drive, a computer that is running a Linux OS, a VGA-capable monitor, and a USB keyboard.

CAUTION:

The following procedure destroys any existing data on the USB flash drive.

- 1. Download the installation ISOs from IBM.
- 2. Insert the USB flash drive into the computer.
- 3. Determine the name of this drive.

#1sh1k

4. Determine that the drive is not mounted.

#mount

5. Copy the ClevOS ISO to the USB flash drive.

#dd if=/{path}/{ClevOS}.iso of=/dev/{drivename} bs=1M

- 6. When copying is done, remove the USB flash drive from the computer.
- 7. Power down the device on which you want to install the OS.
 - If the device is in an unresponsive state, it can be powered down by PDU or by removing the power cables.
 - If the device is still responding, do the following steps.
 - a. Log in to the device as local admin.
 - b. At the command prompt, type poweroff/
- 8. Attach the USB keyboard and VGA monitor to the device.
- 9. Insert the USB flash drive in the remaining USB port.
- 10. Restart the machine while pressing F11 to enter the boot menu.
- 11. In the boot menu, select **USB Key** and press **Enter**. The device loads the operating system, and the installer appears.
- 12. In the installer, choose **OS only install**. When installation completes, the device reboots.
- 13. After the device reboots, remove the USB flash drive.

Replace external rear components

Replace a power supply unit

If either of the two power supply units (PSU) fails, the other unit takes the full load and the system can continue operation without interruption. The Universal Information LED on the control panel flashes slowly until the failed unit is replaced.

The PSUs can be replaced without powering down the appliance. The redundant feature keeps the appliance active while the failed PSU is replaced.

1. Push the release tab on the rear of the PSU, as shown in the following figure.

- 2. Pull the PSU out using the provided handle. (The PSU wiring is designed to detach automatically when the PSU is pulled from the chassis).
- 3. Replace the failed PSU with another PSU.
- 4. Push the new PSU into the power bay until you hear a click.

Install an SFP+ / QSFP optical module

- 1. Log in to the device as local admin.
- 2. At the command prompt, type poweroff.
- 3. Remove the SFP+ / QSFP module from the packaging.
- 4. Remove the black plastic protective cap from the optical side of the module.
- 5. Insert the module into the network card until it clicks into place.
- 6. Insert the fiber optic cable into the SFP+ / QSFP module.
- 7. Restart system and configure the network interface. For more information, see the *Appliance Configuration Guide*.

Battery removal and installation

Battery removal

To remove the Onboard battery, follow these steps:

- 1. Power off your system and unplug your power cable.
- 2. Locate the Onboard battery, as shown in the figure.
- 3. Using a tool such as a pen or a small screwdriver, push the battery lock outwards to unlock it. When unlocked, the battery pops out from the holder.
- 4. Remove the battery, as shown in the following figure.




Figure 19. Remove the battery

Battery installation

To install an Onboard battery, follow these steps:

- 1. Identify the battery's polarity. The positive (+) side must be facing up.
- 2. Insert the battery into the battery holder. Push it down until you hear a click to ensure that the battery is securely locked, as shown in the following figure.
