### Chapter 1. Introduction to IBM IP Storage hardware

The IBM TotalStorage<sup>™</sup> IP Storage 200i is a series of products identified as the IBM 4125 IP Storage Models 100 and 200. It is designed for workgroups, departments, and solution providers that have storage area network requirements across heterogeneous Microsoft® Windows NT®, Windows® 2000, and Linux clients (iSCSI clients). It includes preloaded code, and offers virtually 'plug and go' IP-based storage.

The Model 100 is a tower unit that requires only power and network connections for setup. For the Model 100, a conversion kit is available to convert the tower for rack mounting. The Model 200 can be mounted in a 5U rack drawer. The Model 200 has external SCSI ports as well as power and network connections.

For additional storage, a Model EXP can be added to the Model 200. The Model EXP is a storage unit that supports up to 14 Ultra160 SCSI drives. It delivers fast, high-volume data transfer, retrieval, and storage functions across multiple drives. The Model EXP supports IBM Ultra160 SCSI for the host and drive interfaces. After you review the introductory information provided in this chapter, refer to "Installing a storage unit" on page 11 to begin the installation process.

### The IBM IP Storage appliance

As an appliance with redundant power supplies, the IBM IP Storage is shipped with three power cords. It does not come with a mouse, keyboard, or monitor. The appliance is already configured; aside from initial configuration to determine the IP address, you do not need to configure hardware or install code for the base model configurations. The Models 100 and 200 require two connections: power and network.

### iSCSI client

The Models 100 and 200 serve out local storage to iSCSI clients' requests. The IBM IP Storage acts as a single server to the physical disk drives on behalf of the iSCSI client. The physical disk drive storage is partitioned into multiple virtual logical units of storage (VLUNs) for storage assignments to individual iSCSI client. iSCSI clients use an assigned client ID and password to access assigned LUNs.

### Setting up the appliance

This section provides information about the initial installation and setup for the Models 100 and 200.

### Setting up the Model 100

The initial installation of the Model 100 consists of the following steps:

- 1. Installing optional features (see "Installing optional features" on page 11).
- 2. Connecting the power cords and communication cables (see "Cabling" on page 21).
- 3. Starting the appliance and verifying that the power-on diagnostics completed successfully (see "Starting the appliance" on page 23).
- 4. Performing the initial configuration (see "Performing initial configuration" on page 24).

### Setting up the Model 200

The initial installation of a Model 200 consists of the following steps:

- 1. Installing in a rack (see "Setting up the Model 200 in a rack").
- 2. Installing optional features (see "Installing optional features" on page 11 and "Installing a storage unit" on page 11).
- 3. Connecting the power cords and communication cables (see "Cabling" on page 21).
- 4. Starting the appliance and verifying that the power-on diagnostics completed successfully (see "Starting the appliance" on page 23).
- 5. Performing the initial configuration (see "Performing initial configuration" on page 24).

### Setting up the Model 200 in a rack

For Model 200, you must first install the appliance in a rack, using the rack-mounting kit provided.

The following reduced-size illustration of the front and the back of the rack mounting template shows where to place the clip nuts or cage nuts when installing your appliance in a rack.




Figure 1. Front and back of the rack mounting template

### **Rack Mounting Instructions**

- Review the documentation that comes with your rack enclosure.
- Maintain 15 cm (6 in.) of clearance around your appliance for air circulation.
- Ensure the room air temperature is below 35°C (95°F).
- Plan the appliance installation working from the bottom of the rack up.
- Remove the rack doors and the side panels during the installation, if necessary.
- Position the template to the rack so that the edges of the template do not overlap any other devices to be installed.
- Connect all power cords on the appliance and on other devices to properly wired and grounded electrical outlets.
- Take precautions to prevent the rack from overloading the power outlets when you install multiple devices in a rack.






- Do not place any object weighing more than 82 kg (180 lb) on top of rack-mounted devices.
- Use safe practices when lifting.








Use the attached stickers to mark the holes on the front and the rear of the rack in the locations indicated by the arrows on the template.




Use a screwdriver or the cage-nut-insertion tool to insert the cage nuts, or slide on the clip nuts, as required for your rack, into all the marked holes.


Figure 2. Rack mounting instructions




Use the pins on the slide rail to align the slide rail to the rack. Use the M6 screws to bolt the slide rail to the rack (left front of rack shown here). Repeat this step for the other slide rail.



Use the M6 screws to attach the hinge bracket A to the rear of the rack. Then, use the hinge pin to attach the cable-management assembly to the slide rail. (Right rear of rack shown here).




**Caution:** To avoid injury, do not place your fingers around the rack-support wheels when lowering the appliance onto the rails.




Use the M4 screws to secure the appliance to the rails. Unscrew the rack-support wheels **A** and store them in a safe place.


Note: Be sure the bracket notches on the front of the appliance fit securely on the tabs clocated on the front of the slide rails.



Press in on the safety latches A and slide the appliance halfway into the rack. Attach the power, keyboard, mouse, and monitor cables (if required) to the appliance and route them through the cable restraint bracket . Then, attach all other required cables to the appliance.



Route all the cables through the cablemanagement assembly as shown. Then, use the cable straps **A** or the cable ties to secure the cables to the cable-management assembly.



Slide the appliance into the rack until the release latches A snap shut. Then, insert the M6 screws **B** through the release-latch-bracket assembly. Note: Inserting the M6 screws is optional, unless you are moving the rack or the rack is in a vibration-prone area.

### **Installing optional features**

The appliance has several optional features available.

### Installing a storage unit

The Model 200 includes the option of installing up to three additional storage units, or Model EXPs. The internal hot-swap SCSI disks are connected internally to Channel 1 for both the ServeRAID-4H and ServeRAID-4L adapters. You cannot attach a storage unit to a Model 100 because ServeRAID-4L has only one channel connector.




Figure 3. ServeRAID-4H channel connector locations

**Important:** When adding storage units to the Model 200, connect the first additional storage unit to Channel 2, the second to Channel 3, and so forth.

#### Notes:

- 1. The ServeRAID-4L and ServeRAID-4H adapters do not support configurations that use both the internal and external connectors on the same channel *concurrently*. For example, you cannot use both external Channel 1 and internal Channel 1.
- 2. The battery-backup cache protects the data stored in the ServeRAID cache memory during a power outage or failure when using the write-back mode.
- 3. The ServeRAID-4H controller uses the module (part number 38L3386) containing a lithium battery.

#### Statement 2



#### **CAUTION:**

When replacing the lithium battery, use only IBM Part Number 33F8354 or an equivalent type battery recommended by the manufacturer. If your system has a module containing a lithium battery, replace it only with the same module type made by the same manufacturer. The battery contains lithium and can explode if not properly used, handled, or disposed of.

#### Do not:

- · Throw or immerse into water
- Heat to more than 100°C (212°F)
- · Repair or disassemble

Dispose of the battery as required by local ordinances or regulations.

**Note:** For translations of the safety notices that are included in this guide, refer to Safety Information.

To connect storage units to an external channel connector on the ServeRAID-4H controller:

1. Connect one end of a 68-pin very high density connector interface (VHDCI) SCSI cable to an external channel connector on the ServeRAID-4H adapter.

Note: See Figure 3 on page 11 for the channel connector locations.

2. Connect the other end of the SCSI cable to the storage unit. For detailed installation and cabling instructions for the storage unit, refer to the IBM TotalStorage IP Storage 200i Storage Unit Installation Guide.

### Installing a hot-swap hard drive




Figure 4. Installing a hot-swap hard drive

#### Attention:

- To maintain proper system cooling, do not operate the appliance for more than two minutes without either a drive or a filler panel installed for each bay.
- You do not need to switch off the Models 100 and 200 or remove covers to install or replace hot-swap power supplies or hot-swap hard drives.
- Back up all important data before you make changes to hard drives.
- When you handle electrostatic discharge-sensitive devices (ESDs), take
  precautions to avoid damage from static electricity. For details on handling these
  devices, refer to "Handling electrostatic discharge-sensitive devices" on page 31.

To install a hard disk drive in a hot-swap drive bay:

- 1. Review the safety precautions in "Safety precautions" on page ix.
- 2. Remove the filler panel from one of the empty hot-swap bays by inserting your finger into the depression at the left side of the filler panel and pulling it away from the appliance.
- 3. Install the hard disk drive in the hot-swap bay:
  - a. Ensure the tray handle is open (that is, perpendicular to the drive).
  - b. Align the rails on the drive assembly with the guide rails in the drive bay.
  - c. Gently push the drive assembly into the bay until the drive connects to the planar.
  - d. Push the tray handle toward the closed position until it locks the drive in place.
- 4. Check the hard disk drive status indicators to verify that the hard disk drives are operating properly:
  - When the amber LED is on continuously, the drive has failed.
  - When the green LED flashes slowly (one flash per second), the drive is being rebuilt.
  - When the green LED flashes rapidly (three flashes per second), the controller is identifying the drive.

### Installing memory modules (DIMMs)

You can increase the amount of memory in your appliance by installing options called memory-module kits. Each kit contains one industry-standard, dual-inline memory module (DIMM). Your appliance uses a noninterleaved memory configuration.

Your appliance comes with one or more dual inline memory modules (DIMM) installed on the system board in the DIMM connectors.

This section describes how to replace a memory module. It consists of four steps:

- 1. Prepare to install the memory module (see "Preparing to install a memory module").
- 2. Remove the cover (see "Removing the cover" on page 15).
- 3. Install the memory module (see "Adding the memory module" on page 17).
- 4. Replace the cover (see "Replacing the cover" on page 19).

#### Preparing to install a memory module

Read these notes before installing a memory module.

#### Note:

- · Become familiar with the safety and handling guidelines specified under "Handling electrostatic discharge-sensitive devices" on page 31.
- The blue color on components and labels inside your Models 100 and 200 identifies touch points where a component can be gripped, a latch moved, and so on. The only exception to this is the power supplies, which are orange.
- · Make sure that you have an adequate number of properly grounded electrical outlets for Models 100 and 200 and any other options that you intend to install.
- Have a small, flat-blade screwdriver available.
- · Before you begin installing components, read the safety information found in "Translated safety notices" on page 31.
- For translations of the safety notices that are included in this guide, refer to Safety Information.

### Removing the cover

#### Removing the Model 100 cover:




Figure 5. Removing the cover of the Model 100

To remove the left-side cover of the Model 100:

- 1. Review the information in "Preparing to install a memory module" on page 14.
- 2. Switch off the appliance and all attached devices and disconnect all external cables and power cords.
- 3. Slide the cover-release lever on the front of the appliance to release the cover; then, slide the cover toward the rear of the appliance about 25 mm (1 in.). Move the top edge of the cover out from the appliance; then, lift the cover off the appliance. Set the cover aside.

**Attention:** For proper cooling and airflow, replace the cover before switching on the appliance. Operating the appliance for extended periods of time (over 30 minutes) with the cover removed might damage appliance components.

#### Removing the Model 200 cover:




Figure 6. Removing the cover of the Model 200

To remove the appliance top cover:

- 1. Review the information in "Preparing to install a memory module" on page 14.
- 2. Switch OFF the appliance and all attached devices and disconnect all external cables and power cords.
- 3. Release the left and right side latches and pull the appliance out of the rack enclosure until both slide rails lock.

Note: When the appliance is in the locked position, you can reach the cables on the back of the appliance.

4. Move the cover-release lever down while sliding the top cover toward the rear of the appliance about 25 mm (1 in.). Lift the cover off the appliance and set the cover aside.

Attention: For proper cooling and airflow, replace the cover before switching on the appliance. Operating the appliance for extended periods of time (over 30 minutes) with the cover removed might damage appliance components.

### Adding the memory module

Read these notes before adding the memory module.

Note: The Model 100 supports additional 256-MB, 512-MB, and 1-GB DIMMs. The Model 200 supports additional 512-MB DIMMs. Both models support a maximum of 2-GB of memory.

To install a memory module (DIMM):

Attention: When you handle electrostatic discharge-sensitive devices (ESDs), take precautions to avoid damage from static electricity. For details on handling these devices, refer to "Handling electrostatic discharge-sensitive devices" on page 31.

- 1. Review the safety precautions listed in Statement 1 and Statement 5 in "Translated safety notices" on page 31.
- 2. Review the documentation that comes with your option.
- 3. Switch off the appliance and peripheral devices and disconnect all external cables and power cords.
- 4. Touch the static-protective package containing the DIMM to any unpainted metal surface on the appliance. Then, remove the DIMM from the package.

Note: To avoid breaking the retaining clips or damaging the DIMM connectors, handle the clips gently.

#### 5. Install the DIMM:

- a. Turn the DIMM so that the pins align correctly with the connector.
- b. Insert the DIMM into the connector by pressing on one edge of the DIMM and then on the other edge of the DIMM. Be sure to press straight into the connector. Be sure that the retaining clips snap into the closed positions.
- c. Make sure the retaining clips are in the closed position. If a gap exists between the DIMM and the retaining clips, the DIMM has not been properly installed. In this case, open the retaining clips and remove the DIMM; then, reinsert the DIMM.




Figure 7. Installing a DIMM

- 6. Install additional DIMMs in the order specified in the documentation that comes with your option. (See Figure 7 for memory connector locations.)
- 7. Continue with "Replacing the cover" on page 19.




Figure 8. Replacing the Model 100 cover

To replace the appliance left-side cover:

- 1. Align the cover with the left side of the appliance, about 25 mm (1 in.) from the front of the appliance; place the bottom of the cover on the bottom rail of the chassis.
- 2. Insert the tabs at the top of the cover into the slots at the top of the appliance.
- 3. Hold the cover against the appliance and slide the cover toward the front of the appliance until the cover clicks into place.
- 4. Connect a keyboard and monitor to the appliance.
- 5. Switch on the appliance.
- The system displays a message indicating that a configuration error occurred.
   Follow the onscreen prompts to review and save the new memory configuration.
   After you save changes and exit the Configuration/Setup Utility program, the appliance will restart.
- 7. Disconnect the keyboard and monitor.

#### Replacing the Model 200 cover:




Figure 9. Replacing the Model 200 cover

To replace the appliance top cover:

- 1. Align the top cover with the top of the appliance, about 25 mm (1 in.) from the front of the appliance; the flanges on the left and right sides of the cover should be on the outside of the appliance chassis.
- 2. Hold the cover against the appliance and slide the cover toward the front of the appliance until the cover clicks into place.
- 3. Connect a keyboard and monitor to the appliance.
- 4. Switch on the appliance.
- The system displays a message indicating that a configuration error occurred.
   Follow the onscreen prompts to review and save the new memory configuration.
   After you save changes and exit the Configuration/Setup Utility program, the appliance will restart.
- 6. Disconnect the keyboard and monitor.

### Installing the Tower-to-Rack Kit

Refer to the instructions that come with your Tower-to-Rack Kit for information on converting a tower to a rack.

### Cabling




Figure 10. Cabling the appliance

For each of the three power supplies, connect one end of the power cord to the power supply and the other end to an appropriate outlet. Connect one end of the Gigabit Ethernet cable to the Gigabit Ethernet Adapter located in one of the expansion slots (see Figure 10) and the other to the system network.

**Note:** You may use a 10/100 Ethernet cable if your network does not support Gigabit Ethernet.

When you cable the appliance, be sure to route the power and network cables through the cable-restraint bracket on the rear of the appliance.




Figure 11. Routing cables through cable-management assembly

Additionally, for Model 200, be sure to thread the cables through the cable-restraint bracket and then route the cables through the cable-management assembly on the rack (see Figure 11).

## Starting the appliance




Figure 12. Locations of the Information LED, System Error LED, POST Complete (OK) LED, and Power-on LED

Complete the installation by switching on the appliance and running the power-on diagnostics. Each time the appliance is switched on, it runs a self-testing program to ensure that it is running correctly. If the power-on diagnostics complete successfully, the Information LED and the System Error LED are off; the POST Complete (OK) LED and Power-on LED are on. See Figure 12 for the locations of the Information LED, System Error LED, POST Complete (OK) LED, and Power-on LED.

**Note:** Depending on the system status, other LEDs may be on.

If a problem is detected during the diagnostics, refer to the *IBM TotalStorage IP Storage 200i Administrator's Guide.* 

After you plug the power cord of the appliance into the power supply and an electrical outlet, start the appliance by pressing the power button on the front of the appliance.

**Note:** After you plug the power cord of the appliance into an electrical outlet, wait approximately 20 seconds before pressing the power button. During this time, the system-management processor is initializing and the power button does not respond.

**Attention:** The operating system undergoes a series of initialization operations upon start up. The first time you start the appliance, a series of configuration and system preparation programs are run automatically. These programs must finish running before you use any included applications to connect to or configure your appliance. Wait at least 5 minutes to connect to or configure the appliance after the initial system start.

## Performing initial configuration

The IBM IP Storage is configured and managed through the Web-based appliance management utility. This utility can be accessed through a Web browser, either Netscape 4.5+ or Internet Explorer 5.x. The browser must be configured to connect to the Internet directly rather than through a proxy appliance. Because the appliance is headless, configuration must be completed from another machine, known as the management workstation.

Note: The appliance is equipped with two Ethernet ports: the Gigabit Ethernet and the Service Ethernet. The Gigabit Ethernet is used primarily for storage traffic but can also be used for configuration purposes. The Service Ethernet is used only for service and configuration purposes; no storage traffic occurs over the Service Ethernet. It is recommended that you use the Gigabit Ethernet for configuring the appliance; the Service Ethernet is provided as a backup method.

## **Prerequisites**

The IBM TotalStorage IP Storage 200i supports the following browsers to access the appliance management utility:

- · Microsoft Internet Explorer 5.0 only
- Netscape 4.7 4.76 only
- Java<sup>™</sup> Swing 2
- Sun's Java Plug-in 1.3 (available at www.java.sun.com/j2se/1.3/jre)

Because the appliance management utility uses frames, some views might appear different depending on the browser that you use.

Note: Some panels in the appliance management utility require Java Swing support in your browser. At your first visit to these panels, your browser will be checked for this plug-in. If it is not present, you are presented with a dialog that allows you to download the appropriate software from the Internet.

## Logging in to the appliance management utility

To log into the appliance management utility, use the following user ID and password. Note that these fields are case-sensitive.

## Obtaining the initial IP address

You can obtain the initial IP address through two different ways:

# Obtaining the IP address through the Gigabit Ethernet (ARP)

Before the IP Storage can be fully functional as an iSCSI server, you must complete a set of required configuration tasks using the appliance management utility. To configure the IP address:

1. Launch the Web browser from the management workstation.

Note: For information on browser requirements, see the IBM TotalStorage IP Storage 200i Administrator's Guide.

2. Point the browser to the appliance you are configuring using the following URL:

http://IP\_address:3939/

where *IP\_address* is the unique *IP* address you wish to assign to the appliance. For example:

#### http://128.1.3.1:3939/

3. When the workstation connects successfully to the appliance, a pop-up window appears for login and password. (See "Logging in to the appliance management utility" on page 24 and the IBM TotalStorage IP Storage 200i Administrator's Guide for more for instructions on logging into the appliance management utility and configuring the IBM IP Storage.)

Note: If the browser times out, the IP-address assignment was not successful. Go to a command line in the management workstation. Type arp -a [n] (where n is the desired IP address) and press Enter. If the corresponding MAC address does not match the appliance's MAC address, then the IP address is used by another host; repeat this step using another IP address. If the ARP entry is resolved to the correct appliance:

- a. Delete the resolved entry by typing arp -d IP\_address.
- b. Press Enter.
- c. Retry step 3.

If multiple appliances are being set up simultaneously, retry with a different address after deleting the resolved entry.

After you configure the IP address through the appliance management utility, use port number 1959 to access the appliance management utility. For example:

http://128.1.3.1:1959/IBM200i

## Obtaining the IP Address through the Service Ethernet

The Service Ethernet is preconfigured with IP address:

#### 192.9.200.1:1959/IBM200i

The management workstation must be configured on the 192.9.200 subnet. To use the Service Ethernet to launch the appliance management utility from the management workstation, point the browser to:

A popup window appears for login and password. Refer to "Logging in to the appliance management utility" on page 24 and the IBM TotalStorage IP Storage 200i Administrator's Guide for instructions for logging into the appliance management utility and configuring the IBM IP Storage.

## Configuring the network

To configure the network:

- 1. Click **System** → **Date and time**, and set the date and time on the appliance. Then, click Apply.
- 2. Click **Network** → **Data Ports**. A Ports window will appear; select the port you want to edit and click Edit. Set the IP address, network mask, and host name. Then, click Apply.
- Click Network → Settings. Set the domain name server (DNS) address, domain and the gateway address. Then, click **Apply**.

Note: After completing the installation, back up your configuration. See the IBM TotalStorage IP Storage 200i Administrator's Guide for details on configuring the network and backing up the configuration.

4. Continue with "Assigning virtual disks".

## Assigning virtual disks

The IBM IP Storage is partitioned into virtual disks that are assigned to clients. The iSCSI client code installed on the client machines allows clients to access the virtual disks as directly attached devices.

To create and assign virtual disks:

- 1. Click Storage → Virtualization.
- Select a logical disk, and click Add VLUN.
- 3. Specify the size and number of the virtual disks, and then click Add.
- 4. Click a virtual disk, and then click Assign Client.
- 5. Specify a client identifier and password, and click **Add**.
- Click Apply.
- 7. Click System Reset, and then click Reboot to reboot the appliance and activate the configuration changes.

See the IBM TotalStorage IP Storage 200i Administrator's Guide for more information about assigning virtual disks.

## **Electrical safety**

> Many customers have, near their equipment, rubber floor mats that contain small conductive fibers to decrease electrostatic discharges. Do not use this type of mat to protect yourself from electrical shock.

- Find the room emergency power-off (EPO) switch, disconnecting switch, or electrical outlet. If an electrical accident occurs, you can then operate the switch or unplug the power cord quickly.
- Do not work alone under hazardous conditions or near equipment that has hazardous voltages.
- · Disconnect all power before:
  - Performing a mechanical inspection
  - Working near power supplies
  - Removing or installing main units
- Before you start to work on the machine, unplug the power cord. If you cannot unplug it, ask the customer to power-off the wall box that supplies power to the machine and to lock the wall box in the off position.
- If you need to work on a machine that has exposed electrical circuits, observe the following precautions:

## Safety inspection guide

The intent of this inspection guide is to assist you in identifying potentially unsafe conditions on these products. Each machine, as it was designed and built, had required safety items installed to protect users and service personnel from injury. This guide addresses only those items. However, good judgment should be used to identify potential safety hazards due to attachment of non-IBM features or options not covered by this inspection guide.

If any unsafe conditions are present, you must determine how serious the apparent hazard could be and whether you can continue without first correcting the problem.

Consider these conditions and the safety hazards they present:

The guide consists of a series of steps presented in a checklist. Begin the checks with the power off, and the power cord disconnected.

#### Checklist:

- 1. Check exterior covers for damage (loose, broken, or sharp edges).
- 2. Power-off the computer. Disconnect the power cord.
- 3. Check the power cord for:
  - a. A third-wire ground connector in good condition. Use a meter to measure third-wire ground continuity for 0.1 ohm or less between the external ground pin and frame ground.

- b. The power cord should be the appropriate type as specified in the parts listings.
- c. Insulation must not be frayed or worn.
- 4. Remove the cover.
- 5. Check for any obvious non-IBM alterations. Use good judgment as to the safety of any non-IBM alterations.
- 6. Check inside the unit for any obvious unsafe conditions, such as metal filings, contamination, water or other liquids, or signs of fire or smoke damage.
- 7. Check for worn, frayed, or pinched cables.
- 8. Check that the power-supply cover fasteners (screws or rivets) have not been removed or tampered with.

## Handling electrostatic discharge-sensitive devices

Any computer part containing transistors or integrated circuits (ICs) should be considered sensitive to electrostatic discharge (ESD). ESD damage can occur when there is a difference in charge between objects. Protect against ESD damage by equalizing the charge so that the machine, the part, the work mat, and the person handling the part are all at the same charge.

#### Notes:

- 1. Use product-specific ESD procedures when they exceed the requirements noted
- 2. Make sure that the ESD protective devices you use have been certified (ISO 9000) as fully effective.

When handling ESD-sensitive parts:

- Use an ESD common ground or reference point when working on a double-insulated or battery-operated system. You can use coax or connector-outside shells on these systems.
- Use the round ground-prong of the AC plug on AC-operated computers.

Electrical grounding of the computer is required for operator safety and correct system function. Proper grounding of the electrical outlet can be verified by a certified electrician.
