ARTICLES OF INCORPORATION

OF

SELF REALIZATION PELLOWSHIP CHURCH

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, the majority of whom are citizens and residents of the State of California, have voluntarily associated ourselves together for the purpose of forming a religious corporation under the laws of the State of California,

And we hereby certify:

ARTICLE 1.

That the name of the corporation shall be "SPLF REALIZATION FELLOWSHIP CHURCH"

ARTICLE 11.

That the purposes for which this corporation is formed are as follows:

(a) To acquire by gift or contribution both real and personal

property of any kind or nature whatsoever, or any right, title or
interest therein.

- (b) To buy, sell or otherwise acquire, hold, own, use, manage, improve, maintain, develop, rent, mortgage, or otherwise encumber, and to transfer and to exchange real estate of every kind or any interest therein, to trade real estate of every kind and of any interest therein, and to trade in real property improved and unimproved in the state of Californie, and elsewhere.
- (c) To borrow and lend money and to make and issue promissory notes, bonds, debentures and evidence of indebtedness and to secure the payment or performance of its obligation by mortgage, deed of trust, pledge or otherwise.

- (d) To teach a religion or preach a religion known as "Self-Realization Fellowship" (Yogoda Sat-Sanga), the practical sim of which is to make lasting youth and arrest old age by using the unlimited power of God and Cosmic Energy instead of trying to obtain health only from the use of the physical means of food and exercise.
- (e) To teach the following religious or spiritual philosophy in the State of California and the United States of America, to-wit:
- Universal all-round education, and establishment of Self Realization Fellowship institutions for the development of men's physical, mental and spiritual natures.
- Contacting Cosmic Consciousness—the ever-new, ever-existing, ever-conscious Bliss-God, through the scientific technique of concentration and meditation taught by the Masters of ell ages.
- Attaining bodily and spiritual health through the Self Realization Fellowship (Yogoda Sat-Banga) technique of recharging the body battery from inner life energy, concentration and meditation respectively.
- Intelligently maintaining the physical body on unadulterated foods, including a large percentage of ran funits, vegetables and nuts.
- 5. Physical, mental end spiritual healing.
- Establishing, by a scientific system of realization, the absolute bosic harmony and oneness of Christianity, Hinou Yoga teachings, and all true religions.
- 7. Serving all mankind as one's Larger Self.
- Demonstrating the superiority of mind over body, and of soul over mind.
- 9. Fighting the Saten of Ignorance-man's common energy.
- 10. Establishing a spiritual unity among all nations.
- Overcoming evil by good; overcoming sorrow by joy; overcoming cruelty by kindness.
- Realization of the purpose of life as being the evolution from human consciousness into divine consciousness, through individual struggle.
- 15. Realization of the truth that human life is given to man to afford him opportunity to manifest his inner divine qualities, and not for physical pleasure nor salfish gratifications.
- 14. Furthering the cultural end spiritual understanding between East end West, and the constactive exchange of the distinctive features of their civilizations.
- Uniting science and religion through study and practical realization of the unity of their underlying principles.
- 16. Finding the common scientific art of super-living underlying all religions.

ARTICLE VA.

That the authorised number and qualifications of members of this corporation, the different classes of membership, if any, the property, voting and other rights and privileges of such class of membership, and the liability of each or all classes to dues or assessments, and the method of collection thereof shall be set forth in the by-lass of this corporation; that there shall be issued to each member a certificate of membership which shall be assignable and transferable as provided in the by-lass of this corporation.

ARTICLE VII.

That the by-laws of this corporation shall be adopted by the directors named in the articles of incorporation and may thereafter be spended or repealed by any means provided in the by-laws.
